# Energy savings come in lower than expected Trash talk dominates Board of Supervisors meeting

Remain calm.

Public Works Director Wayne Stephens opened his comments on the results of the first three months of the county's new energy savings contract with the admonition, "I don't want anyone to get into panic mode, because we are at the beginning."

Looking at 14 county buildings that had received energy-saving upgrades like LED lighting, weather-stripping, and HVAC improvements, Stephens found that 10 of the 14 had seen a reduction in energy costs compared to the previous December through February, for a total of \$4,000 in savings.

This was less than hoped, but Stephens cited several reasons for the shortfall, including added power consumption due to renovations and upgrades, and this winter's exceptionally cold weather.

"You said to remain calm and not panic," Supervisor Don Weaver said. "And I'm not, because it's a contract we can't lose in."

Under the agreement with an energy services company, the county will be reimbursed if expected cost reductions are not met.

Both Stephens and Eric Dahl, finance director and deputy county administrator, pointed out that the contract has a caveat: People have to follow the rules.

"We may need to have some education for our tenants," said Stephens. "We haven't laid down the law," with firm parameters on issues like heating and cooling ranges.

Still, he said, "We're confident we're going to make it." He assured the Board he would report again in a couple of months with more data.

Other items on the agenda included an amendment to county code updating the fee schedule for the leasing of telecommunications facilities. The new contractor managing the leasing process charges much lower fees than the previous provider. County Attorney Fred Payne said the new schedule was fairer and more flexible.

Supervisors approved the publication of a public hearing set for next month regarding the Virginia Department of Transportation's secondary six year plan. They also voted to set an \$18 annual fee for trailers that will become effective Jan. 1, 2019.

While not on the agenda, the meeting began and ended with talk of trash.

Residents of a cul-de-sac off Oliver Creek Road commented on the large amount of garbage littering the creek and surrounding area. They say many in the area dump bags of garbage, junk cars, dead appliances and other debris pretty much anywhere they can toss them.

"It makes you ashamed to have company," said one speaker. It also creates potential health and safety hazards, drawing vermin, snakes, and predators to the area.

Board Chair Mike Sheridan assured the residents someone from the county would look into the situation.

Supervisor Mozell Booker revisited the issue late in the session. Despite changes to the compliance code, she said

she remains disturbed by the amount of trash and general decay around the county. "People get in a mindset that this is all right," she said.

"Trash does not violate the [compliance] code," said County Administrator Steve Nichols. "There are places around the county that I think look terrible, but they don't fit the code," which focuses on health and safety.

He said a compliance enforcement officer had visited Oliver Creek Road in the past, and found that the situation didn't violate the code. Under the recent changes, it might now be enforceable.

Nichols proposed that one or more of the supervisors do a ride-along with the compliance officer to get a hands-on sense of the challenges of issuing these types of citations.

# Human trafficking hits close to home

More than 20 million people worldwide are victims of human trafficking. Bought and sold for sex or labor, these modern-day slaves are part of a massive global economy estimated at \$32 billion annually.

It seems like an issue far removed from Central Virginia, but Cathy Easter, executive director of Safe Harbor Shelter in Richmond, said it's very much a regional problem. Interstates 81 and 64 are major routes for traffickers in the U.S., and Henrico County now leads the nation in trafficking arrests.

Speaking to the Rotary Club of Fluvanna County last Tuesday (April 17), Easter explained some of the “myths and misconceptions” of human trafficking and the efforts her organization and others are making to meet the challenge of assisting trafficking victims.

Safe Harbor was designed primarily for victims of domestic violence, but over the last three years has started a shelter and program specifically for women released from trafficking.

“These clients are very fragile,” she said. Most suffer from addiction issues. Almost all of them have infections from years of sexual abuse and forced prosti-

tution. Many still have a “trauma bond” with their victimizers that makes it difficult for them to heal emotionally.

“There are some really sad stories,” Easter said. “But it’s really rewarding.”

She recalled one woman moved to tears by an impromptu 21st birthday party at the shelter.

At the age of 14, the woman had begun “dating” an older man who turned out to be a trafficker. He got her hooked on drugs and spent nearly seven years selling her from New York to Kentucky. This was the first birthday she had celebrated since she was a child. “It’s going to take a lot of time for her to heal,” Easter said.

One of the primary myths Easter runs into is that these women are like any other prostitutes. Instead, she said, they are prostituted. Their traffickers sell access to their bodies and keep all the money. They don’t have the option to leave.

Trafficking victims are also not “kidnapped” in the traditional sense of the word, Easter said. They are instead groomed by traffickers, who exploit their vulnerabilities and then trap them into sex slavery through fear, abuse, and

other controlling tactics.

Finally, most trafficking victims are not foreign-born. Easter’s shelter has served around 30 women in the last three years, and all but one has been a U.S. citizen. About 70 percent are white, and they range in age from 18 to 41.

Asked if she thought trafficking was on the rise, she said, “I think what’s increasing is awareness. What was once thought of as prostitution is now being identified as trafficking.”

Law enforcement is also getting better at identifying the mechanisms of trafficking. Perpetrators target schools, malls, parks, social media, even online gaming – places where they can target vulnerable young victims, “especially young girls trying to fit in,” she said.

The public has a role in helping potential trafficking victims.

One example was a “horrible, horrible story” out of New Kent County in 2015, when a trucker called in a report of suspicious activity around an RV parked at a truck stop. Police found a young woman coerced into prostitution by acquaintances who beat and tortured her to force her to comply.

Both traffickers went to prison. The

trucker, Kevin Kimmel, now works with Truckers Against Trafficking, a nonprofit that trains its members to spot potential trafficking.

It can be difficult for people to report what seems to them to be odd behavior, because there’s always the chance it’s just a “weird family dynamic,” Easter said.

But she encourages people to speak up when they sense something is off. When it comes to potential human trafficking, she said, “It’s really better to be safe than sorry.”

# Troxell pleads guilty in bank robbery

A Chesterfield County man charged in the October 2017 robbery of the Union Bank & Trust entered a plea of guilty in Fluvanna County Circuit Court on Friday (April 20).

Under the plea agreement, Jeffery W. Troxell, Jr., 27, was sentenced to 20 years in prison, with 10 years suspended. Judge Richard E. Moore also ordered Troxell to three years supervised probation and to pay restitution to the bank following his release.

Commonwealth's Attorney Jeff Haislip gave the court a brief summary of the evidence in the case.

At around 4 p.m. on Oct. 10, a witness saw Troxell park in the lot near the Union Bank & Trust and walk into the bank lobby.

Once inside, Troxell walked up to the teller and said, "This is how it's going to go," before handing her a note demanding money. She gave him \$1,350 from her drawer, and he exited the building.

He was taped walking toward his car by the dashcam of a Fluvanna County Sheriff's vehicle parked a short distance away in the same Food Lion parking lot. The deputy, unaware of the robbery, was working on his laptop at the time.

The sheriff's office released bank surveillance photos later that evening. Troxell wore no mask nor disguise during the robbery and had a distinctive tattoo on his neck. "Very quickly, numerous people identified the suspect," Haislip said.

Troxell dumped his car in a wooded area behind a Wawa gas station outside Short Pump and called his mother for a ride home to Chesterfield, where he was taken into custody the following day. He confessed to the crime under questioning.

Troxell faced a maximum sentence of life, but Haislip said the mid-range of the sentencing guidelines fit the circumstances, particularly since he hadn't used a weapon and had confessed to his

actions.

"I'm not going to downplay at all the impact on the teller," Haislip said, describing her as traumatized by the robbery.

"People often don't think about the fear," Moore told the defendant. Even if no weapon was used and nobody was hurt, those moments had a deep and lingering impact on the victims. "Some people, sadly, don't ever get over it. That's what you're being punished for."

Troxell is also facing a potential 17-year sentence in Chesterfield County for probation violations on earlier convictions.

## Dismissal of Hardy sex charges denied

Moore also heard a defense motion to dismiss some of the charges in the case of Alfonso Lewis Hardy.

Hardy was indicted late last year on 31 counts, including rape, sex trafficking, and the production of child pornography.

Defense attorney Michael Hallahan argued that the wording of the statutes on the production of pornography was vague, allowing multiple charges from a single event.

In this case, Hardy is alleged to have

engaged in consensual sex with a 15-year-old girl, and during the encounter took three short videos and seven still photos.

Each photo and video resulted in a separate charge, each with a mandatory minimum sentence. Hallahan argued that this was over-charging, as all occurred during the same event.

"Did the legislature really intend for each frame to be a separate charge?" he asked.

"I can imagine them intending that," Moore said.

Assistant Commonwealth's Attorney

Todd Shockley argued that that is what the law intended. "Each click of that shutter is the production of pornography," Shockley said.

Moore said the similarity of language in statutes involving the possession and the production of pornography indicated to him that the Commonwealth was following the law.

"If possession can be charged image-by-image, it stands that production can be charged image-by-image," he said, denying the motion to dismiss the charges.

Hardy is set for arraignment June 8.

Beth Sherk, the president of the Per-simmon Tree Players and a Fluvanna County Arts Council board member, thought that those who attend performances at Carysbrook Performing Arts Center should have a full art experience. “Going to the theater or an exhibit is becoming more of an experience,” said Sherk. She asked her brother, Kevin

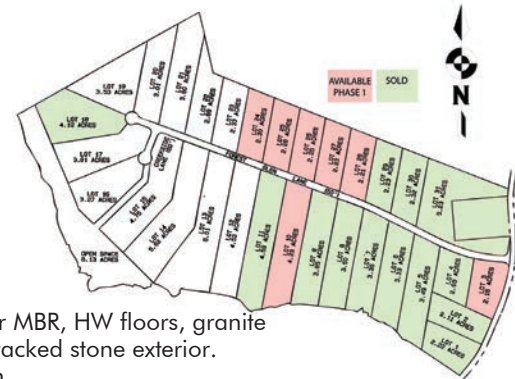

# Fluco girls lacrosse falls to Albemarle 0-10 at home

The Fluco girls' lacrosse team was not able to generate offense in their home contest against the Albemarle Patriots last Tuesday (April 17). Albemarle is a much bigger school than Fluvanna and its girls' lacrosse team is ranked in the top 25 in the state by MaxPreps. The Flucos are still new to lacrosse and have not yet generated the success they have hoped for. Accordingly, the outcome was not unexpected.

The game started with the Patriots scoring, winning face-offs, and scoring again. They scored their first two goals from point blank range in the first minute and 15 seconds. Then a penalty was called on the Flucos and with 23:00 left on the clock in a 25-minute half, the Patriots scored again for a 3-0 lead after two minutes of play. The Flucos got some better results on face-offs and started to handle the ball better, but Albemarle was still able to control the field.

Fluco goaltender, senior Morgan Maupin, made several good saves in the middle of the first half, but the Patriots managed to take the score up to 9-0 with goals at 22:26, 17:28, 16:37, 14:12, 10:21 and 9:01. The Fluco defense stiffened and Albemarle was only able to pass the ball around the perimeter for the last nine minutes of the first half. In the final seconds of the half, Maupin made an excellent save for the Flucos.

The second half of the game was much closer than the first. The Flucos were unable to score, but they did show some more offensive prowess. Freshman Anne Snoddy made an excellent length of the

field run, only to be turned away at the end, and senior Haley Smith was able to fire a shot that just missed.

The Fluco defense also rose up and played a strong positional game, keeping the Patriots from breaking through for long stretches. Unfortunately, the Patriots used huge chunks of clock, methodically passing the ball around the perimeter looking for scoring opportunities.

Fluco coach Meredith Locascio said after the game that the defenders who were chiefly responsible for cutting the Patriots' second-half scoring down to only three goals were sophomore Charlie Lesocki, junior Kyra Shelly, and sophomore Sheridan Smith. She also praised Maupin for her play in goal and sophomore Amy Hughes for her face-off performance in the second half.

Albemarle scored its first goal in the second half at 18:21, so the Flucos held for 16 minutes. The next goal came at 4:00, so for the final nine minutes of the first half and the first 21 minutes of the second half, the score was only 2-0 for Albemarle. The final Albemarle score came with 12 seconds left in the game.

On April 24 the girls played at Monticello. They will be home for three games in a row starting April 27, when they host Liberty-Bealeton. On May 2 the Black Knights from Charlottesville High will visit Fluvanna, and May 4 the Flucos will take on Monticello again. The final game on the Flucos' schedule is May 15 at Powhatan.

# Local collector has a passion for pewter

Artist William Snow has a passion for collecting pewter, as well as other odds and ends easily overlooked in an antique store. But of course, he pointed out, you have to know what you're looking for.

His house has areas dedicated to all things pewter, including the classic porringers, plates, mugs and cooking utensils. He also collects offbeat items, including a pewter fluid lamp, a bed lamp, sometimes called a "sparkling" lamp, and a ship's lantern, which was designed to prevent fire in case the ship was rolling

in heavy seas. Many of these things are eye-openers into the past and how people lived.

"I have always loved antiques and what fascinates my wife and I is who used these things," Snow said.

Snow, who has been collecting for 26 years, is an honorary member of The Pewter Collectors Club of America. The club has been around for 75 years, has 200 to 300 members, and will be meeting in Charlottesville on Friday (April 27) and Saturday (April 28), for one of its two

annual meetings.

Snow has a modest collection compared to some of the club's members, who boast of 500- to 600-piece collections.

He has also co-authored and took photos for a book titled *Collecting Antique Pewter: What to Look for and What to Avoid*. The book is detailed and gives an excellent overview in clear terms. The book covers many key points including styles, periods, rarity and function.

"Rarity is an important factor in collecting and is a strong influence on desirability and cost of certain items," said Snow. He explained that every period had attributes as a result of design, construction, fabrication, casting, finishing techniques and assembly. This is key to spotting fakes, forgeries

and reproductions.

"Today's pewter is made from tin and three to four other elements, including bismuth, antimony and copper," said Snow. "Older pewter had some lead but by the mid-18<sup>th</sup> century there was very little, if any."

Early civilizations such as the Egyptians, Romans and Chinese all made pewter. "Its heyday was the end of the 14<sup>th</sup> century through the late 18<sup>th</sup> century. [Pewter was] made in Germany, Austria, many Slavic countries, France, England and Ireland." Late in the 18<sup>th</sup> century, the English had the best tin mines and dominated manufacturing and trade. In those

days, pewter was equated with today's Corningware or plastic and was less expensive than porcelain. It was used in a variety of things from plates and utensils, mugs, baby bottles and even chamber pots. It was everywhere, in churches for communion, to taverns, inns and households.

By the late 19<sup>th</sup> century it was being overtaken by porcelain and china since manufacturing made it less expensive for the average person.

"Most of the U.S. pewter came by shiploads from England and swamped the market. It was the Worshipful Company of Pewterers in England that monopolized the pewter market from 1500 to the late 1800s," Snow said.

He described the method of manufacturing. Up until the late 18<sup>th</sup> century, pewter was cast in bronze molds, but silversmiths set the trends and the English learned to make sheets of metal and spin them into a form on a lathe, instead of casting. American pewter is rare and was often melted down from worn out English pewter. Most of it was made in the Northeast, in places like New York, Boston, Hartford, Providence and Rhode Island, and began the move down South to North Carolina, Georgia, Virginia and even out to Ohio.

American pieces, being as rare as they are, can range in price from \$350 to \$2,500, but a collector can pay as little as \$30 for a tanker, or a mug with a lid.

"Condition, manufacturer markings, and decoration can add significant value. [For example,] engraving required exceptional talent and considerable skill," he said.

"I am nothing more than a caretaker," Snow said. "If you collect anything it's not for its value but for the love of collecting."
