





# Teachers receive surprise 4 percent raise Cafeteria debt tops last year

Fluvanna County Public Schools staff can expect a 4 percent raise in their next paycheck.

Superintendent Chuck Winkler suggested the move to the School Board at Wednesday's (June 12) meeting.

"We will use funds that have been allocated within the payroll lines to provide an additional 1 percent raise," Winkler

said in an email Thursday. "It will now equal approximately 4 percent total for fiscal year 2020 (FY20) contracts."

In April the board voted to give staff a 3 percent raise.

Chair Perrie Johnson (Fork Union) and Winkler had an earlier discussion about the FY20 budget.

When building a budget the administra-

tion tries to put in a 1-3 percent cushion for contingencies such as decreased state and local funding, increased utility, health care, technology, instruction and transportation costs.

In a \$41.8 million budget that cushion is between \$420,000 and \$1.2 million.

Winkler said Johnson suggested the board be "less conservative" and use part





# Straight talk from departing county administrator Steve Nichols reveals what he'll miss - and what he won't

Fluvanna County Administrator Steve Nichols, 65, will retire July 3 after seven years as the county's most powerful employee.

Eric Dahl, former assistant county administrator and finance director, will take his spot in the corner office.

Widely credited with fostering professionalism and transparency between county government, the Board of Supervisors and citizens, Nichols cited strides on water and sewer infrastructure as the greatest accomplishment of his tenure.

In order for a rural county to grow, a "core requirement is to make sure that anything you have to fund is not paid for completely just by the homeowner," Nichols said in an exit interview with the Fluvanna Review. "Today, most of the funding for county government comes from the pockets of homeowners in our county. That's not unusual in a rural county, but we are a little bit out of whack because we have very little business and commercial interests in the county relative to what we would like to have."

Fluvanna has two main sources of income: real estate and personal property taxes, Nichols said. If businesses start carrying more of the tax burden, "regular taxpayers" don't have to shoulder as much of the weight. But businesses have a difficult time moving into the county without water and sewer infrastructure.

To combat this problem, county government has developed two water projects: the \$11.6 million Zion Crossroads water and sewer system and the \$11.1 million James River pipeline. "Infrastructure costs money," Nichols said.

The first will connect the Zion Crossroads area with up to 75,000 gallons per day of treated water from the women's prison on Route 250. It will also route between 100,000 and 125,000 gallons per day of sewage back to the prison for treatment.

The James River water project will pipe water northwest through Fluvanna to Louisa County with the provision that Louisa will eventually supply up to 400,000 gallons of treated water per day to Fluvanna's Zion Crossroads area. The historic nature of some of the land slated for construction, however, has delayed the issuance of a necessary permit.

The projects have required a massive amount of communication between county government and the Board of Supervisors - a board that Nichols said is "spectacularly good to work with."

"It wasn't always fantastic" working for the board, Nichols said. "But this board for the last several years - is a really strong, collaborative, professional, respectful board. They appreciate the efforts of staff. They are professional and collegial to each other even when they disagree... And they don't do it with any nastiness or any subterfuge. They may strongly and vehemently disagree, but they do it as professional colleagues, not as enemies."

Nichols heaped similar praise on his staff. "I could not ask for a more dedicated, amazing group of people that [impress] me all the time with the stuff that they think of, do and get done," he said. "Whether you agree with the policies and how we do things in the community, or whether you

like all the laws that are set, this county staff cares about our citizens and works really hard to provide great service to meet their needs. We want to know when we do well, and we equally want to know if we're not meeting expectations because we want to fix it."

# Challenges

The difficulties of not having enough money, people or space are common to all public service roles, Nichols said. Instead, he pinpointed communication as his biggest challenge as county administrator.

"Keeping the people we serve informed - it is really hard," he said. "It's really hard to communicate with everyone effectively... It's hard for people to be positive about local government - or critical of local government – without the facts. And our job is to get them the facts... We're never going to please everyone, but oftentimes when people know the true story, and know the facts, it informs their opinion."

Nichols pointed to a quote by John Maynard Keynes he keeps on the wall of his office: "When the facts change, I change my mind."

"I wish I could convince everybody of that," he said.

Then he nodded at a second quote by Nelson Mandela: "I never lose, I either win or learn."

"I love that one; I live by that one," he said. "I think it's the most positive way to look at life. I didn't get my way or I didn't get what I wanted – does that really matter as much as what you do after that? And when you go through and experience life and learn from it, that's a positive to me. I just love that outlook. I use it around here all the time"

In order to improve communication, Nichols asked supervisors to approve a new assistant county administrator position that includes "a variety of programs that we've always done piecemeal - we've never had somebody fulltime dedicated to them." In this role, Kelly Harris will act as the public information and Freedom of Information Act officer, as well as the officer for special projects and internal controls. "It's an incredibly good fit for the county," Nichols said. "It's a great way for us to improve the things that we have not been able to do as well."

# Highlights

Nichols took the job in 2012 after retiring from almost 40 years in the military.

"This was a chance to serve in my community," he said. "In the military you're always serving in someone else's community your country or someone else's country but not in your community. You only live there for a year, or a year and a half, or two years. In my almost 40 years we moved 23 times around the world."

The longest Nichols and his wife, Brenda, were ever in one location was for three years and one month. Taking the county administrator job "was a chance to serve my friends, colleagues, neighbors in my community. And so that's why it was an incredible privilege for me, because I got to serve my neighbors."

# Surprises

But moving into a small community had some surprising elements.

"When you didn't grow up in a small rural county, you don't have a clue how many relationships there are," Nichols said. "Neighbor relationships, familial relationships, marriage relationships, former teammate relationships – you don't know that this person is that person's cousin. Still to this day - I've been here in the job over seven years - I still find every week, 'Oh my God, I didn't know you were related to that person.

"You have to be very careful and sensitive to that, because it's not that way in the military," he continued. "We're all a mix and a blend and we come from all over the world, but your sister, your brother, your uncle, your cousin is not in the seat next to you because you're not in your hometown."

When asked if he was ever bitten by that dynamic, Nichols laughed. "It's a pleasant minefield - that's kind of how you have to look at it," he said. "I'm not much to mince my words. I'm about mission, about getting things done. I'd like to be softer about it sometimes, but I'm mission driven, and when we have a task to get done, that's really important... You can really step on something and say the wrong thing to the wrong person, but it's also pleasant to know we have such strong relationships in our community."

Those very relationships are Nichols' favorite thing about the county. "That's the most rewarding thing about living here the collective neighborliness of the people around," he said. "If you need help - if you don't get it – it's because either you didn't ask, or no one knew you needed help, because here it is just an automatic thing."

# Moving

Nichols and his wife bought their home in Lake Monticello in 2007. She moved in while Nichols was deployed to Afghanistan, then he arrived in August 2008, retiring from the military soon after.

"My daughter and son-in-law lived here; that's why we moved here," Nichols said. "She's our only child. Our son-in-law is from Fluvanna and they went to college together. When they settled here we knew we would be here as soon as I retired from the military. Wherever our daughter was going to be, we were going to be."

Steve and Brenda Nichols moved to Nahor Village in 2012, just after he became county administrator, and lived there until this past April. Now they live in the Pantops area of Charlottesville.

"Again, we're following our daughter," he said. "Our daughter and son-in-law built a house at Pantops three years ago, so we knew when we retired we were going to follow them. We're just down the hill from them, and our granddaughter. It's wonderful."

# **Adventure**

Nichols has been harboring a retirement dream ever since he saw *The Way,* a film featuring the Camino de Santiago, a trek that pilgrims have undertaken for 2,000 years.

He leaves Sept. 1 to join the pilgrims, walking 500 miles across France and northern Spain to the cathedral in Santiago where the remains of St. James are said to be buried. "You stay in hostels along the way. Everything you need is on your back," he said. "It'll be four to six weeks depending on how many detours I take."

Nichols will walk by himself, but looks forward to meeting pilgrims along the way. "When I saw that movie, it just intrigued me. I started researching and reading. It's a way to experience the world in a totally different way than when you're riding in a car or flying on a plane," he said. "I think it's going to be spectacular."

# Words of wisdom

While Nichols is hiking the Camino, Eric Dahl will be learning the ropes of the county's top job. Nichols has already passed along his words of wisdom, which he called "the most important advice a senior leader can get."

"Be a lot more worried about doing your job than keeping your job," Nichols said he told Dahl. "If I were worried about keeping my job every day, I wouldn't have taken the same challenges or the same risks or tried to get as much done. If you're worried about keeping your job you want to please everybody all the time, and you cannot please everybody all the time."

Nichols said he came by that piece of wisdom honestly. "I've always been of that bent because I'm a little bit reckless compared to some others," he said. "I'm not

worried about making a mistake. I worry about getting stuff done. And the only way you're going to get stuff done is to try, to experiment, to make an effort. If you sit and wait and try to find the perfect time, the perfect circumstance, or the perfect information before you make a decision, you're never going to get anything done."

Nichols said he doesn't remember a time in his 30 years of senior leadership roles in which he deliberately decided not to worry about keeping his job in favor of doing what he felt was right. "I'm self-confident enough, and always have been, to not really worry about...keeping my job," he said. "If I'm worried about my job, I must not be doing my job very well. There's not very many times when you're going to get canned just because the person didn't like you. Who cares if they like you or not? Are you doing a good job?"

This maxim may not be a universal truth, Nichols acknowledged. "After the bad things that happened in 2012 when the five most senior people in the county lost their jobs, just before I got hired, that was a huge trauma, a huge shock," he said. "The staff was wound up, worried and upset. But that was because of a specific circumstance. I still think that if you do your job well every day, you're not going to have to worry about keeping your job."

Nichols pointed to another secret of success. "There's an old saying my staff has heard me use: 'When my boss is interested in something, I'm absolutely fascinated.' Because I should be," he said. "I may not want to do it personally; it may not be my personal choice. So what?"

# Saying goodbye

Nichols had an immediate answer when asked what he'll miss about the job. "The people. Always the people," he said. "It's the relationships you build. It's the people you know. It's the teamwork, the *esprit de corps*, the feeling of accomplishment alongside someone else, that is really important. I'll miss that."

That doesn't mean there aren't any elements of the job Nichols won't mind leaving behind.

"I will not miss having so darn many evening and weekend meetings," he said. "It's an incredibly strong and heavy time commitment away from family. When you're working five 12- or 14-hour days, and you've got four evening meetings and one weekend event, it doesn't leave a lot of time for yourself or for others."

Nichols joked that his top priority when he returns from the Camino is to stay out of his wife's kitchen. "Honestly, I don't know," he said. "I'm certain I will be involved in organizations, on boards, commissions, committees...but I don't have any specific plans other than playing golf and traveling. It will be nice to take a breather. I love being in the outdoors. If I want to take a walk at 2 in the afternoon, I can."

- Professional development and training: 61.26 percent felt professional development days provide applicable strategies and useful tools for improvement;
- Professional responsibilities: Opinions ranged from a low of 60 percent who felt there were enough instructional assistants and a high of 88.3 percent who felt additional duties were manageable:
- Climate and culture: 89.96 percent felt satisfied working for FCPS, down from 93.26 percent in 2018;
- Superintendent's office: 94.74 percent were happy with being made aware of new job opportunities within the division in a timely manner; and
- · School Board: Scores dropped in all three categories polled, with the highest being 69.83 percent who felt the board supports them and their profession.

The board asked that survey comments be made public after names are redacted. Several retiring staff members were honored: Susan Brown, Nancy Heins, Nancy Hutcherson, Cheryl Daidone, Doug Campbell, Feda Coleman, Delores Palmer, Judy Raviotta, Michelle Shinaberry, Lisa Lucas, Jane Ford and Clinton Estes. During public comments, Andrea Overweg took the board to task.

"I am here tonight because I care about our community, our schools, our children and our valued teachers and staff," Overweg said. "I am here tonight because the board has continued in a deleterious trajectory. It is plainly evident to any attendee of a School Board meeting that this board is dysfunctional."

Overweg cited a few examples of

recent board conduct.

"With community members and teachers present for a School Board meeting, what message does it send when a School Board member objects to the acquisition of a textbook because it references 'white privilege,' which he asserts is recent terminology, when in fact it is a historical reality grounded in factual events?" she said. "What message does it send when a board member fundamentally does not


comprehend how a budget operates or is allocated for a school system?"

Overweg talked about declining elementary school enrollment and linked it to parent dissatisfaction with policies and practice.

"People talk to each other and it's more important than a Yelp review," she said.

# Fluco baseball wins first-ever State championships in 16-10 blowout

The Flying Fluco baseball team did it all. Every time they needed outstanding pitching, they got outstanding pitching.

Every time they needed searing bats, they got them. throughout the playoffs, typical of a championship team, they got great fielding.

In their run to the State Class 3 title. the Flucos won three straight in the Region playoffs, followed by three straight wins in the State tournament.

On Friday (June playing 14) Kiwanis Field in

Salem, Va., the Flucos jumped to a 5-0 lead in the top of the first against the Tabb Tigers from just north of Newport News. The Tigers were forced to play catch-up the rest of the game as the Fluco offense was firing on all cylinders and just kept pouring on the runs.

In the first, senior third baseman Ryan Groome led off and made it to first on an infield error. Junior first baseman

Andrew Ward singled sharply. Senior catcher Jacob Critzer walked to load the bases. Junior DH Kevin Ward singled to drive in one. Junior shortstop Cameron Shields grounded to short and the Tigers tried for a double play. Shields beat the throw to first, as a run scored. Sophomore

outfielder Mason Gross singled to make it 3-0. Junior outfielder Toby Sherman walked to load the bases again. Batting in

> the eighth slot, senior second baseman Kyle Algieri then came through with one of the biggest hits of the game – a fly ball to right that just eluded the right fielder and landed for a two run double. Psychologically, a five-run first inning is much bigger than a three-run first inning.

Fluco starting pitcher junior Wyatt Dansey managed to hold the Tigers scoreless in the first and second, although they had two baserunners in each inning. The Flucos really blew things open with four in the top of the third. Algieri opened the inning with a single. He stole


second and scored on a two-out single by Andrew Ward, his third of five hits. Jacob Critzer and Kevin Ward then launched back-to-back home runs. Dansey ran into some control problems in the third and the Tigers scored two with only one hit.

The Flucos were far from done. Sherman led off the fourth inning with a home run to left field. Two walks and singles by each of the Wards resulted in two more runs for an 12-2 lead. The Tigers got a two-run home run in the bottom of the fourth, but the Flucos again responded with three in the top of the fifth. Singles by Sherman, Algieri and A.J. Brown resulted in one run and Andrew Ward's double down the right field line drove in two more.

The Tigers would not give up and they scored three in the sixth and three in the seventh, but it was way too late. In the seventh with three in, Algieri was pitching and he induced three consecutive ground balls. Shields made nice plays on the first two and Groome handled a bad hop on a hard shot and threw to Kevin Ward for the final out.

In this game, Andrew Ward was five for six with three RBI. Kevin Ward was three for four with a home run, a walk and

four RBI. He also made several excellent picks on low throws at first base. Critzer was two for three with a home run and three walks. Algieri had three hits and Sherman a home run. In a statistic for baseball fanatics, all nine line-up positions recorded at least one RBI.

After the game, Coach Joel Gray noted that his squad demonstrated all year that it can come back after a low scoring game and "tear the cover

off." He noted that due to VHSL rules to prevent overuse of pitchers, he was not able to use either of the Ward brothers on the mound in the championship game, so he had to do a little juggling with his staff. Starter Dansey and relievers Kristian Negron and Algieri did have some control difficulties, but they restricted a strong Tabb squad to only seven hits, while the Flucos recorded 19 hits and also benefitted from wild pitching by Tabb.

# June 13 semifinal

In order to reach the finals, the Flucos had to top the Brentsville Tigers, near Manassas, on Wednesday (June 13), also

in Salem. This was a tense, hard-fought game from start to finish.

The Tigers scored one in the first. The Flucos bounced back with two in the third, with runs scored on an error and a sacrifice fly.

The Tigers scored two in the top of the fifth to go up 3-2; however, the Flucos responded with two runs as Shields drove in one with a single and Gross plated the other with a sacrifice fly. Brentsville came right back with a run in the sixth to tie the score. The Flucos went up and down in order in the bottom of the sixth. Andrew Ward, on the mound in relief of Kevin Ward, struck out the side in order in the

top of the seventh. The stage was set.

With one out, Critzer stepped in. With two strikes on him, Critzer noted later that he was "just trying to put the ball in play." However, he got a "low fast ball," and at the crack of the bat everyone in the stadium knew the game was over. It was a foregone conclusion that the ball would clear the

left field fence with plenty of room to spare, for a walk-off home run to send the Flucos to the final.

Critzer had quite a State playoff run. In three games, he was 6-8 at the plate with five walks. He had two home runs – one a game winner. In the crucial semifinal game, he scored three of the Flucos' five runs. He was also steady and reliable behind the game for all the innings of every game. Groome was the defensive standout against Brentsville, as he made outstanding plays at third base in the first inning and the sixth to shut down rallies by the Tigers.

# Men's member-guest tournament ends in soaking rain

The shootout to determine the overall winner in the Lake Monticello men's member-guest golf tournament started in a light drizzle and five rounds later ended in a soaking rain.

The member-guest, which is one of the biggest tournaments on the Lake golf calendar, is played on the second weekend in June (June 8-9 this year). Thirty two-man teams play in five flights. Each team plays five nine-hole matches, once against each team in its flight. In each nine-hole match, one point is awarded per hole for the best score on the hole on a gross score basis and on a net score basis. The team in each flight with the highest overall point total qualifies for the shootout to determine the tournament's overall winner.

This year the team of Eric Parlet and Boston Craddock won the overall title. Their win might be considered appropriate as they were the lowest handicapped team in the tournament. However, their win was far from a foregone conclusion. The shootout is always an exciting conclusion to the tournament. Golf pro Mark Marshall takes the five flight winning teams to the 18th hole and all 10 players shoot to the green from a designated distance. This requires a shot over the small pond that guards the front of the green.

This year, the best score of the two players on each team was the determining factor as to who qualified for the next round. As it turned out, a three by either player moved his team to the next round. Two fours put a team out, and it took a two to win.

In each round, a number of players hit the green with their first shot, but no one could make a two. The pin was in the middle of the green, but in a difficult position because of the significant slopes in the 18th green. Other longest drive winners were Leidich and Parlet. Closest to the pin winners were Craddock, Mundell, Atkinson and Leap.



# Brand-new FAST swimmers make waves

The Fluvanna Aquatics Sports Team (FAST) kicked off the 2019 summer swim season with a tri-meet against the Elks and the Louisa Gators at Louisa's aquatic facilities Wednesday (June 12) at 6 p.m. It was a rainy and cool night for a swim meet, but FAST swimmers, coaches and families warmed things up by donning aloha shirts and leis in support of the team's Hawaiian theme.

As the first meet of the season, it was unscored, thus giving new swimmers and families a chance to experience how a meet operates and to prepare them for the remainder of the season. spent the last few years cheering from the pool deck for her older brother. Ryan made her meet debut with second place finishes in both the girls 6-and-under 25-yard backstroke and 25-yard freestyle. Johnson pointed out how calm, cool and level-headed she remained at the meet. He noted that first meets are often anxiety-inducing, particularly for younger swimmers, but said, "Ryan was ready to hop in and swim her hardest."

When asked if there was one swimmer who stood out for the night, Johnson quickly named 14-year-old Jackson Kinsella. According to Johnson, Jackson worked exceptionally hard over the winter swim season. "His hard work is paying dividends in the form of amazing swimming and dramatic transformation of his physique," Johnson said. "His 100yard freestyle was amazing to watch." Jackson swam the Boys 13-14 100-yard freestyle in an impressive 1:00:38, a 4.72 second drop since last summer. Jackson is also recognized by the other swimmers and parents for being kind and supportive of the entire team.

Overall, Johnson expressed his satisfaction with how everyone swam. "All our swimmers, both new and returning, gave it their all and performed well," Johnson said. "First meets have a habit of being chaotic, but our swimmers did an excellent job of staying focused and performing their best. I look forward to a successful and fun season."

FAST hosted the Culpeper Country Club at Fairview Swim Club on Wednesday (June 19) and will host the Elks at their pool Tuesday (June 25).




