Republicans hold fall picnic to rally Fluvanna base

About 80 Fluvanna Republicans gathered under stormy skies at Pleasant Grove on Saturday, Sept. 28, for their party's annual fall picnic. Attendees heard speeches from Delegates Rob Bell and Lee Ware, state Senator Mark Peake, and Kim Hyland, who is campaigning for the office of Fluvanna Treasurer. Congressman Denver Riggleman, who had been slated to speak, canceled because of a scheduling conflict.

Local Republicans had the chance to

chat with their elected officials one-on-one, and sat under the pole barn to eat before the speeches began.

Fluvanna Republican Party Chair Darrell Byers said the purpose of the annual event is to rally the Republican base in Fluvanna. "The 2019 election cycle is really critical," Byers said, "particularly as it relates to our Commonwealth. It will definitely change the political landscape if one seat is lost or one seat is won," he emphasized. He added, "We are really

just trying to maintain what we have in the House as well as the Senate."

Byers explained that guest speaker Kim Hyland, the only candidate for local office to speak at the picnic, had not won the endorsement of the Fluvanna Republican Party, but rather was invited to speak when she attended their most recent committee meeting. The other candidates for treasurer did not attend that committee meeting, and so were not invited to the event.

Delegate Rob Bell, who has represented the 58th district in the Virginia House of Delegates since 2002 and who is up for re-election in November of this year, said these annual local political gatherings are a chance for elected officials to talk to the people that are likely going to be volunteering for their campaigns and working at the precincts. "Traditionally the people that come are the ones that are excited to meet the candidates," he explained.

Bell added that he has always felt welcome in Fluvanna and commented on the unity he sees among his constituents here. "When something happens in the community, the whole community comes together," he observed. "For instance, when Dakota Riggsby passed;

that was a time when the whole community came together - he was a Fluvanna son," Bell emphasized. And certainly," he added, "when good things happen - like when they won the state title," he smiled, "all the Flucos were happy that day."

Delegate Lee Ware, a Powhatan resident, has represented the 65th district in the House of Delegates for 21 years, and is up for election this November. He described Fluvanna as "a wonderful part of the heart of Virginia."

Ware is currently focused on Virginia's financial standing. "As chairman of the House Finance Committee, which deals with tax policy - not the spending policy, but tax policy - obviously I am continually focused on the budget," he said. He added that he wants to "make sure we maintain that solid Triple A rating and sensible budget that we have been known for historically." Ware said he looks forward to serving and representing Fluvanna again in the coming term.

Later in the evening, Byers said he was "very pleased with the turnout and encouraged by the engagement" of those who attended.

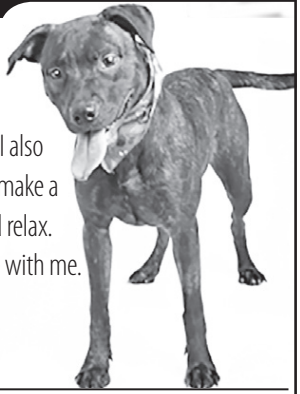

Palmyra man dies in motorcycle accident

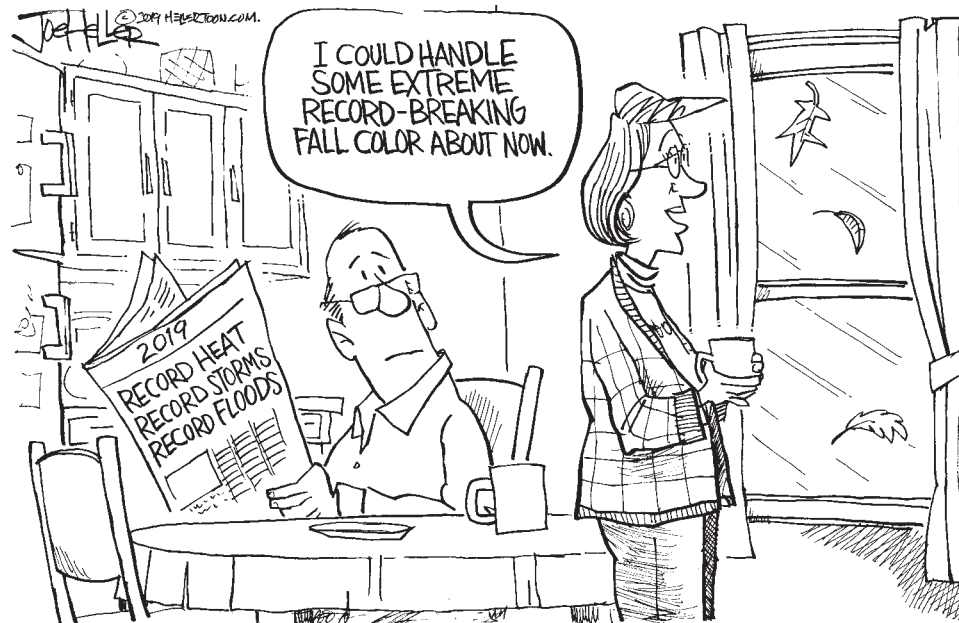
Virginia State Police Trooper J.A. Paxton is investigating a motorcycle crash which resulted in a fatality. The crash occurred Sunday (Sept. 29) at 3:05 p.m. on Tye River Turnpike, one tenth of a mile west of Narrow Passage Lane in Rockbridge County.

A 2005 Suzuki motorcycle was travel-

ing east on Tye River Turnpike, when the motorcycle ran off the right side of the roadway and struck a tree.

The driver of the Suzuki was identified as Jack Arthur Pincombe, 20, of Palmyra, according to State Police. He was wearing a helmet and died at the scene.

The crash remains under investigation.

"It's difficult because they feel disenfranchised because of the politics on the national level," then Richardson role-played an imaginary conversation between a millennial and a politician in power:

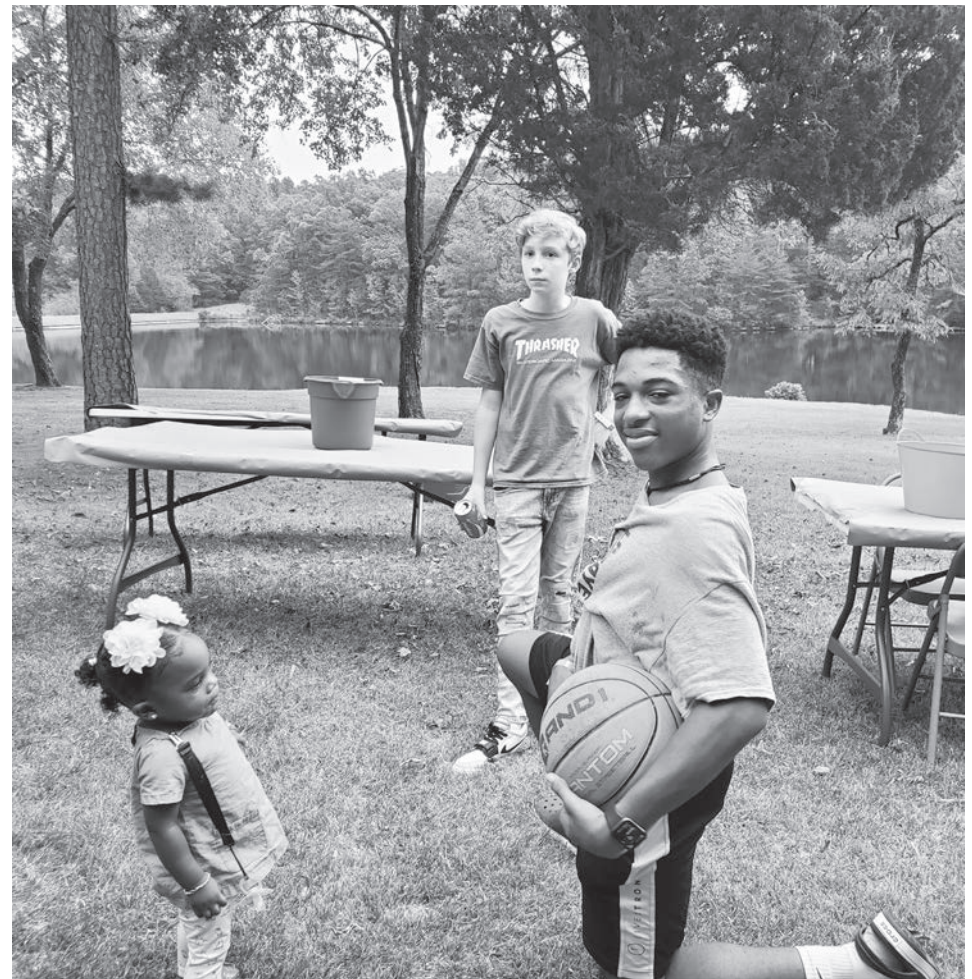
"Oh, you're buried in student loan debt? Oh well, come out and vote anyway."

Born and raised in Fluvanna County, owner of Fluvanna's newest restaurant, Wahoo BBQ, Howie Brown is a home-taught chef. He grew up surrounded by his parents cooking but became especially interested in the joy his dad got from grilling.

"My dad is my left and right hand," said Brown. "He got me into grilling for sure."

Brown then started to grill on his own and after trying many different grills, he swears by the Big Green Egg. The Big Green Egg is the brand name of a kamado-style ceramic charcoal barbecue cooker that can act as a grill, oven, or smoker.

"It was what really fueled my barbecue addiction," said Brown. "Grilling and the store are going to be my main focus and I cannot wait to give back to the community that I grew up in."

Before opening his new location, which will be right off Rt. 53 near Cunningham Methodist Church and where the old Cunningham Market used to be, customers and commu-

nity members may have already had a taste of Brown's barbecue. Wahoo BBQ has been spotted at Cunningham Creek Winery, which is located not that far from the new location, as well as the James River Rivanna Rafting Barbecue Competition.

"Cunningham Creek Winery really helped build my following," said Brown. "The business started off small a few years ago, but really took off after winning the barbecue competition in Scottsville."

For the past two years, Brown has taken home first place in people's choice from the James River Reeling and Rafting Barbecue Competition. He has one signature rub that he has for the pork, and that alone he says is enough, and so believe his customers. The awards will be proudly displayed in the new location. And for those who enjoy sauce with their pork, Wahoo BBQ will also offer different sauces to add even more flavor.

And how did it get the name Wahoo BBQ when located in Fluvanna County? While most customers

think Wahoo BBQ got its name associated from the University of Virginia (U.Va.), they are not entirely wrong. Brown grew up watching U.Va. sports and is still a fan of the Cavaliers, one of the inspirations behind the name. The other is it named after the Wahoo fish, which is similar to the swordfish.

"Two of my favorite things are fishing and being a U.Va. fan," said Brown. "My wife designed the first logo with a fish and a pig on it, but then we realized that the fish was a tuna and it needed to change."

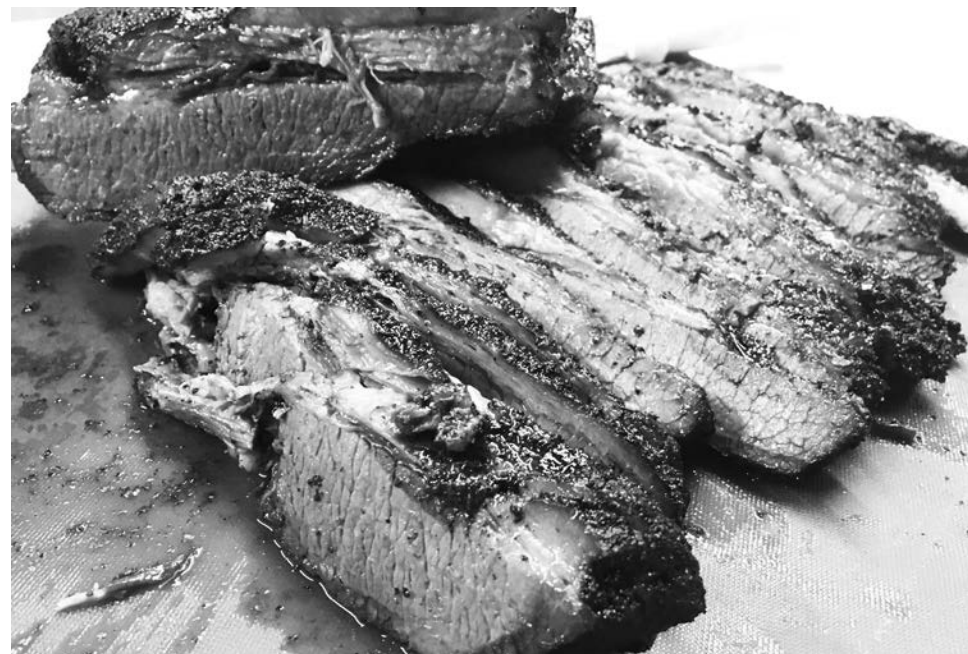
In addition to lunch and dinner, Wahoo BBQ will also be serving breakfast for those who heading into work early. Even students can stop by before school since the hours of operation will be from 6 a.m. on Monday-Thursday to 8 p.m. Friday and Saturday will have longer hours and Sunday will have short hours. The menu consists of pulled pork BBQ, brisket, pulled chicken BBQ, ribs, and smoked wings. Side dishes and spe-

I have a permit to use the gas pumps that were previously here, but for now, I won't use them and focus on the business."

While there is no set date for the grand opening of Wahoo BBQ, Brown is hoping to have a grand opening event in mid-October.

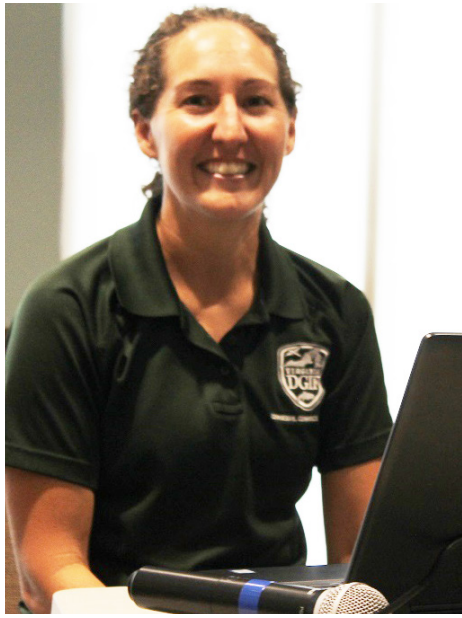

Bears in our backyard

The Lake Monticello Wildlife Committee sponsored a program on Virginia black bears on Sept. 7 in celebration of Smokey the Bear's 75th birthday. The original Smokey was a bear cub found during a wildfire in 1950 and became the mascot for U.S. state forestry departments promoting the prevention of forest fires. Smokey died in 1976.

Katie Martin, a district biologist with the Virginia Department of Game and Inland Fisheries gave the presentation on bears. With a bachelor's degree in science and a master's in forestry, Martin has an extensive background working with wildlife, particularly bears.

"What color are Virginia bears?" she asked. Everyone correctly answered that the bears were black." In a survey we (VDGIF) had done, less than 70 percent of the people answered that correctly. Some thought they were white like polar bears or there were brown grizzly bears around here. They are black but can be a dark brown or have a little cinnamon color or a white blaze." Her excitement and knowledge of bears set an enlightening tone for the education of the audience.

She added that a female (sow) bear weighs between 125-250 pounds and is about five feet tall. The male (boar) weighs between 200-400 pounds but occasionally exceeds 600 pounds. Yearling cubs weigh about 60 pounds. The largest known black bear in Virginia weighed 740 pounds but one wild black bear weighed 880 pounds and was found in North Carolina.

"Black bears are shy, gentle, usually solitary and smart animals and are rarely known to be aggressive. They will often attempt to avoid humans and stay away from homes," Martin said. She added that their claws may be more lethal than their teeth and they just as soon swat you as eat you. "Their claws serve a purpose, they are tree climbers and the mother will keep her cubs in the trees while she forages for food." The audience asked

about a mother defending her cubs. "She huffs when strangers approach and the cubs will stay up in the tree. She will run off hoping to lead the strangers away. Once everything is clear, she returns and slaps the tree, signaling them that it's okay to come down."

She then told the story of a property owner who kept hearing cries and saw a cub with its head stuck in the hole of a tree. He called the VDGIF for help and they came out and helped the cub out of his predicament while mama was nearby, watching. They were left in the tree and she eventually returned to get them. They usually return within a few hours she said. If she does not return, the cubs are considered orphaned and the VDGIF will locate another sow and she will care for them and raise them along with her own cubs.

"The female black bear begin breeding between two to four years and breed every other year. The male will mate in July through August and leave. She sets up her den in December and gives birth early January to February while in the den. She gives birth to one to four cubs, the average is two to three." At birth the bears look like rats but begin to develop between 10-14 days. They reach maturity by three and one-half years.

She explained that bears are known for hibernation, but it is warm in Virginia for hibernation so the male will roam year round but the female remains in her den until she emerges in April. While in the den, her body temperature lowers, she does not eat, drink, urinate or defecate but she can be active.

"During nursing cubs make an interesting purring noise you can hear as you approach the den." She will not mate again until after 18 months and the cubs are out on their own.

Their diet consists of mostly insects, grubs. "There are basically lazy and do not like to hunt." They are most active at dusk and at night but can be sighted during daytime.

"Bears will not attack you, but they might look as if they will by pacing, swinging their head, or vocalizing with moaning, huffing or woofing. This is a bluff so you will go away and they can leave," she said. "When hiking pay attention to the bear signs along the trail and avoid conflict."

"Food is a great motivator for bears." She adds that it important for property owners play a pro-active role in preventing bears from becoming a nuisance and remain wild. "Do not feed bears or any wildlife in Virginia, it is against the law."

The bear population is reduced through hunting and vehicle accidents, between 2,000 -2,500 are harvested during hunting season in Virginia and the present population is stable at 7,000-

9,000. The VDGIF will work with property owners on issues with bears.

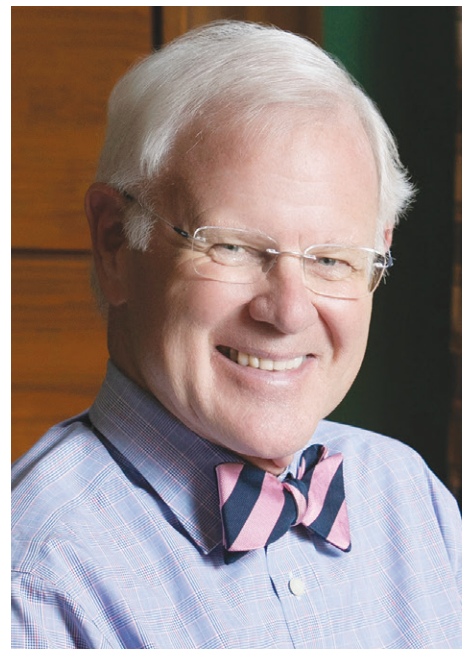
"Food is what they are looking for and this is what causes property damage." She told the story of the hot tub covers that get torn up or eaten because bears do not have good eyesight. Their scent is seven times better than a blood hound. So, the hot tub covers smell like ants to them and they want the ants.

She gave some tips for deterrents, in-

cluding securing garbage cans if they are getting into them, and removing bird feeders for two weeks. The best time to put out bird feeders is in the winter. Don't leave food out and don't leave food in your car with windows open. Practice food management while camping.

The Little Giants went three and out and punted. The Flucos gained 19 on a pass from Edmonds to senior Cameron Holland. Freshman running back Jaden Ferguson then broke loose for a long touchdown run. Bullock converted on the extra point for a 14-0 lead with 4:06 left in the quarter.

Waynesboro fumbled on its first play and the Flucos recovered at the 18-yard line. Junior running back Keontae Hearn took the ball into the end zone on the Flucos first play and Bullock got the extra point for a 21-0 lead with 3:43 left in the quarter. After a kick-off into the end zone, Waynesboro again was unable to move the ball. Their punt was poor and the Flucos started on Waynesboro 38-yard line. Edmonds passed to senior running back Malachi Hill who fought his way to the six-yard line but fumbled as he went down. However, Ferguson was there to scoop up the ball and take it into the end zone. Senior running back Justin Sullivan ran the ball into the end zone on a two-point conversion try for a 29-0 lead.

The second quarter started with Fluco defensive tackle Walt Stribling making a tackle in the back field for a two-yard loss, contributing to another punting situation for the Little Giants. This time the punt was good, but everything was going wrong for Waynesboro. Bullock took the punt, swept to the left and follow-

ing good blocking, returned the punt for a touchdown. Bullock, a 6-4, 190 lb. senior, has a quite unusual combination of roles for the Flucos. It is rare for a football player to be both the kicker and the kick return man. Junior back-up kicker Rocco Calderone booted the football through the uprights for a 36-0 lead with 9:33 left in the half.

The Fluco defense continued to dominate the Waynesboro offense. Three plays by the Little Giants netted minus five yards and they punted again. The Flucos started at the Waynesboro 39. After a first down by penalty, Edmonds found Holland near the right sideline. Holland broke a tackle and took it in for another Fluco touchdown. Calderone's kick hit the upright and bounced out. The Flucos led 42-0. After another Waynesboro punt, the Flucos started at their own 35 with 2:20 remaining in the half. With senior Mikey Brown in at quarterback, Hearn broke off a long run to the Waynesboro six-yard line. Two plays later junior fullback Jamorris Lewis scored from the four. The kick was good and the Flucos were done with their scoring, with a 49-0 lead. The Flucos had seven touchdowns, two by the freshman Ferguson and the other five by five different offensive players.

The second half went by quickly, as the Flucos kept the ball on the ground, running down the clock. The Little Giants made a couple of big gains and managed to punch in a touchdown early in the fourth quarter. A two-point attempt was successful, resulting in a final score of 49-8.

After the game, Coach Morris noted that his defense was helped in its preparation for the game by the Fluco JV squad. The JV did not have a game of its own due to Waynesboro not having a JV team. As a result, Morris had the JV work against the varsity, running the Waynesboro offense. The Fluco defense certainly played like it knew what was coming from the Little Giants offense. The Flucos are now 3-1, while the Little Giants fall to 0-5.

On Oct.12, the Flucos will host Charlottesville and on Oct. 18 they host Western Albemarle in their Homecoming game. That will be the Flucos' fourth home game in a row. They then go on the road for three games at Albemarle Louisa and Orange, all bigger schools than Fluvanna. The Flucos final game of the regular season is at home on Nov. 8 against Monticello, and it is Senior Night.
