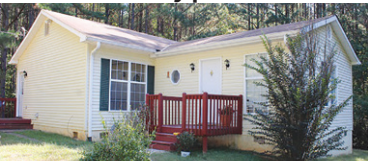

Election Day Nov. 5

This year, Election Day will fall on Tuesday, Nov. 5, and voters will have plenty of candidates from whom to choose. Here's some background on the candidates.

Fluvanna County Treasurer

Ben Hudson

Ben Hudson is a retired U.S. Army lieutenant colonel, business owner, and currently works as a math and engineering teacher at Fluvanna County High School. Hudson holds a BS from Tuskegee University in Alabama and an MS from the Naval Postgraduate School (NPS) in California, both in electrical engineering. After the military, he spent several years in business and later became a teacher. He is also president of the Fluvanna chapter of the NAACP. He and his wife Brenda have three sons and two grandchildren.

Linda H. Lenherr

Linda Lenherr has served as Treasurer since January 1984 and has run

unopposed since at least 1999. A Fluvanna native, Lenherr graduated Fluvanna County High School at Carysbrook and started with the county government in June 1971 as a legal secretary for the commonwealth's attorney and the county attorney. At a recent candidates' forum, Lenherr said she began to learn the basics of tax collection as part of her secretarial responsibilities and decided to run for office in 1983. She is a lifelong member of Wesley's Chapel United Methodist Church, where she serves as a lay leader and on several committees. She and her husband, Richard, have three sons, seven grandchildren, and three great-grandchildren.

Kim Oliver-Hyland

Kim Oliver-Hyland has a background in business, real estate, and insurance. A graduate of George Mason University with a degree in international relations, she spent several years working as a defense contractor and finance manager, managing

multimillion-dollar accounts and contracts. She is a relative newcomer to Fluvanna County, purchasing a small horse farm in Cunningham District, near Scottsville, where she raises Chincoteague ponies. She lives there with her husband Brian and a young daughter.

Other contested races in Fluvanna:

Virginia House of Delegates 58th District

Delegate Rob Bell (R) has served the district since 2002. Bell, a trial attorney, has crafted a number of bills addressing needs in the criminal justice system, including last session's HB 1942 which creates standards for the treatment of mentally ill prisoners in the Commonwealth. Bell is proud to have worked with Senator Deeds in getting this legislation passed. Says Bell, "I'm in court every day and I can tell you, the system isn't perfect, and we can't do everything. What we can do is fix what's broken, improve

what isn't working." Besides issues of criminal law, Bell is passionate about mass incarceration/supportive housing, and their relation to the availability of jobs and housing. He has plans in the works, if elected, to improve school, and school bus safety. Bell relishes the complex minutiae that goes into the crafting of good law, and hopes that his constituents will send him back to Richmond to do just that.

Elizabeth Alcorn (D) is, and has been, a small business owner in Virginia. She raised her daughters as a single mom, and currently lives with her husband in rural Dyke. This is her first run for public office. Like Elliot Harding, she believes that the incumbent has lost touch with his constituents and would like a chance to show that she can do a better job serving the district. In particular, Alcorn points to the high premiums carried by some medical insurance policies in

the 58th (Bell's) district. "They are the highest in the nation." says Alcorn. Alcorn's other departures from Bell's record include tighter controls on both insurers and pharmaceuticals providers, increasing state funding of education including tuition for so called Dreamers, passage of the Equal Rights Amendment, legalization of marijuana, and promotion of wind and solar power in the Commonwealth. As Alcorn sums it up, "I'll work for families in the district and not big corporations."

Virginia House of Delegates District 65

Mike Asip is the Democratic candidate for Virginia House District 65. Asip recently retired after 38 years as

an educator with a focus on special education. In over a decade with Chesterfield County Public Schools, he served as assistant director of special education, and later as director for exceptional education. He is a past president of the Virginia Council of Administrators of Special Education and is an adjunct assistant professor at the University of Richmond. He was appointed by Gov. Terry McAuliffe to the Board of Visitors for the Virginia School of the Deaf and Blind. Asip lives in Powhatan with his wife, Leslie.

Lee Ware is the incumbent delegate for Virginia House District 65, which he has held since 1998. A Massachusetts native, Ware came to Virginia in 1981 as editor of the Powhatan Gazette. He later moved into

education, teaching history and government at Powhatan High School for 14 years and later as an academic dean at Benedictine College Preparatory School. He served two terms on the Powhatan County Board of Supervisors before winning a special election for delegate in January 1998. His current committee assignments include Agriculture, Rules, Commerce and Labor, Chesapeake and Natural Resources, and Finance and has been appointed to several commissions and advisory councils. He lives in Powhatan with his wife, Kathleen.

Virginia State Senate District 22

Mark Peake (R) represents the 22nd district. He won a special election held on Jan. 10, 2017, to succeed Tom Garrett Jr., who had been elected to the United States House of Representatives.

He is 56, born in Greensboro North Carolina and now lives in Lynchburg.

He is married to Lila Ann Gober.

He supports abolishing the individual state income tax, supports the right to bear arms, and reducing government regulations.

Dakota Claytor (D) went to Amherst County Public Schools where he participated in both theater and show choir. He is a freelance hair stylist and private music educator. He has also been actively involved in community theater where he can be often be found on stage.

He is in favor of expanding Medicaid and plans to shift focus to job training and trade school to develop a more skilled work force.

Statewide candidates participate in local forum

Four candidates for the General Assembly whose districts include Fluvanna County met at the school administration building in Palmyra on Monday night (Oct 21).

In attendance were incumbents Sen. Mark Peake (R-22nd) and Del. Rob Bell (R-58th) and challengers Elizabeth Alcorn, Democratic candidate for Bell's 58th District seat, and Mike Asip, Democratic candidate for the 65th District.

Asip's opponent, incumbent Del. R. Lee Ware and Peake's challenger, Dakota Claytor, did not attend.

The event, hosted by the Fluvanna Chamber of Commerce, was structured as a forum, rather than a debate. This format limited the interaction between candidates and kept answers focused on the issues.

But as each candidate stated their position on hot-button issues like health care, reproductive rights, legalization of marijuana, and gun control, some deep ideological divisions became clear.

The audience of about 60 people seemed to split fairly evenly between Republican and Democratic lines, with each side occasionally breaking out in loud cheers—and occasional boos—as their preferred candidates made their points.

Health care

The sharpest exchange of the evening was between Dr. Alcorn and Sen. Peake over the Affordable Care Act.

Bell said he did not support the Affordable Care Act because of the way it forced people into the system and the lack of focus on cost reduction. He believes more focus should be put on lowering costs, tort reform, and strengthening the state's insurance monopolies.

Alcorn said she and her husband, who both run small businesses, lost their insurance last year when one of those monopolies wanted to charge them \$6,000 per month for coverage. She argued that the State Corporation Commission (SCC) simply rubber-stamped insurance companies' requests to increase rates and believes it's necessary to start reining in monopolies and putting in guardrails to keep costs down for consumers.

Peake said the spiraling costs were "because of the ACA."

"Liar," Alcorn interjected.

"They weren't charging anyone \$6,000 a month before the ACA passed. It didn't happen until the ACA passed. It didn't happen until two or three years ago, after the ACA passed, and that's the damn

truth. Somebody called me a liar—"

"That was me," said Alcorn.

"You're wrong, because that didn't happen until the ACA passed, and you know that," he concluded.

"It happened because Trump undermined the system," she said.

Peake remained firm. "The federal government," he later said, "does not do much efficiently."

Candidates also followed party lines on reproductive rights, which Bell and especially Peake believing in pro-life restrictions, and Alcorn and Asip supporting a woman's right to choose.

Similarly, on the legalization of marijuana, the Democratic candidates were open to the idea of decriminalization "provided Virginia really took a hard look at the impacts," said Asip. The Republican candidates were less open, with Peake saying he didn't support legalization, and Bell saying might support the medical use of marijuana.

Gerrymandering

Advocacy groups have been working for years to overhaul the process by which Virginia draws its political lines. Called gerrymandering, the process tends to consolidate power in the hands of whatever party was in control of the General Assembly during the census year.

A resolution calling for an amendment to the state constitution which would take the process out of the hands of the statehouse and establish an independent redistricting commission passed in the Assembly in 2019; if it passes again in 2020, it could go to the voters for approval just in time for the decennial redrawing of the electoral map in 2021.

Bell said he had voted for the resolution and would do so again in 2020. "If it doesn't pass this (coming) year," he said, "that's the end of the constitutional amendment."

Peake said he didn't believe the Democrats would support the amendment if they win the majority in November. If that happens, they would be in control of the redistricting for the first time in years and "they will gerrymander the heck out of it to ensure that they have a Democratic majority for the next 10 years and they've been whining about it for eight."

Asip and Alcorn both said they supported the amendment

Unfunded mandates

Candidates were quizzed about their positions on unfunded mandates—

regulations or rules requiring localities to perform actions without providing money to pay for them.

Asip said he was "concerned about unfunded mandates" but added, "I will not rule out looking at each bill individually" to see if the action was absolutely necessary.

Alcorn gave the example of a recent bill requiring school districts to hire more counselors. "It's a good idea," she said, it ended up creating a real burden for the school budgets. "If we're going to make these decisions on the state level that this is important for our students and our communities, we need to stand behind these laws and give the funding to the counties."

"I have voted on all sides of those," said Bell, who explained that sometimes the state feels a bill has to be passed even though there may not be money to give to the localities for implementation until later. "Not every good idea has to be passed as a law, especially if we don't have the money to pay for it," he added.

Higher education

The candidates generally agreed that more needed to be done to give students access to technical and career training and community colleges, and to lower the overall burden of paying for higher education.

Peake, who currently has five children in college, quipped "I don't think there's anybody that has any better understanding of how expensive that is."

However, while supporting trade and community college programs, he said he was against the idea of the government paying for someone's college education. He was also concerned about the impact of for-profit colleges on the overall cost of tuition and student loans.

Alcorn wants to see lower costs at the community college level and added "we need to put a little pressure" on public colleges and universities to reduce costs for middle- and lower-class students.

Asip, who spent nearly four decades working in special education, said he would also want to see more job training programs for people with developmental challenges.

The election will be held on Tuesday, Nov. 5 and the polls will be open from 6 a.m. to 7 p.m.

Fire destroys house near Columbia

Fire destroyed a single-family home on Stage Junction Road near Columbia on Monday (Oct 21).

Chief Andrew Pullen of the Kent's Store Volunteer Fire Department said all four Fluvanna fire companies and units from Goochland responded to a call reporting a fire at 3:18 pm. Crews were on the scene within 15 minutes and found flames on both levels of the large, two-story home.

Teams went inside to check for occupants and begin fighting the fire, but Pullen said "low visibility, high heat, and rapidly deteriorating condition" caused the team to retreat until it could be knocked down from the outside.

It took several hours and tens of thousands of gallons of water to fully extinguish the blaze.

Pullen said one firefighter received minor burns but refused medical transport.

During the initial search of the home, firefighters rescued a dog, which was transported to an emer-

gency veterinary hospital. Unfortunately, the animal died of its injuries the following day.

Teams salvaged some personal items from the house, but the structure itself was "a total loss," said Pullen.

A GoFundMe campaign has been started by the family. Jessica Evans of Mechanicsville said in her post that her youngest daughter and her babysitter came home to find the house already on fire.

"My youngest had to watch her home burn as they waited for the fire dept. My son found out as soon as he got home from school. They also lost the family dog, as well as my daughter's hamster," Evans wrote. "We're devastated, and they need all the help they can."

The cause of the fire is currently undetermined.

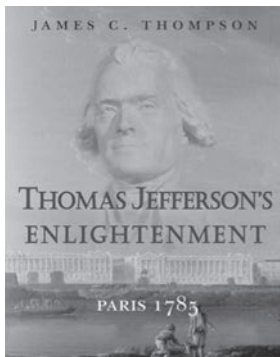

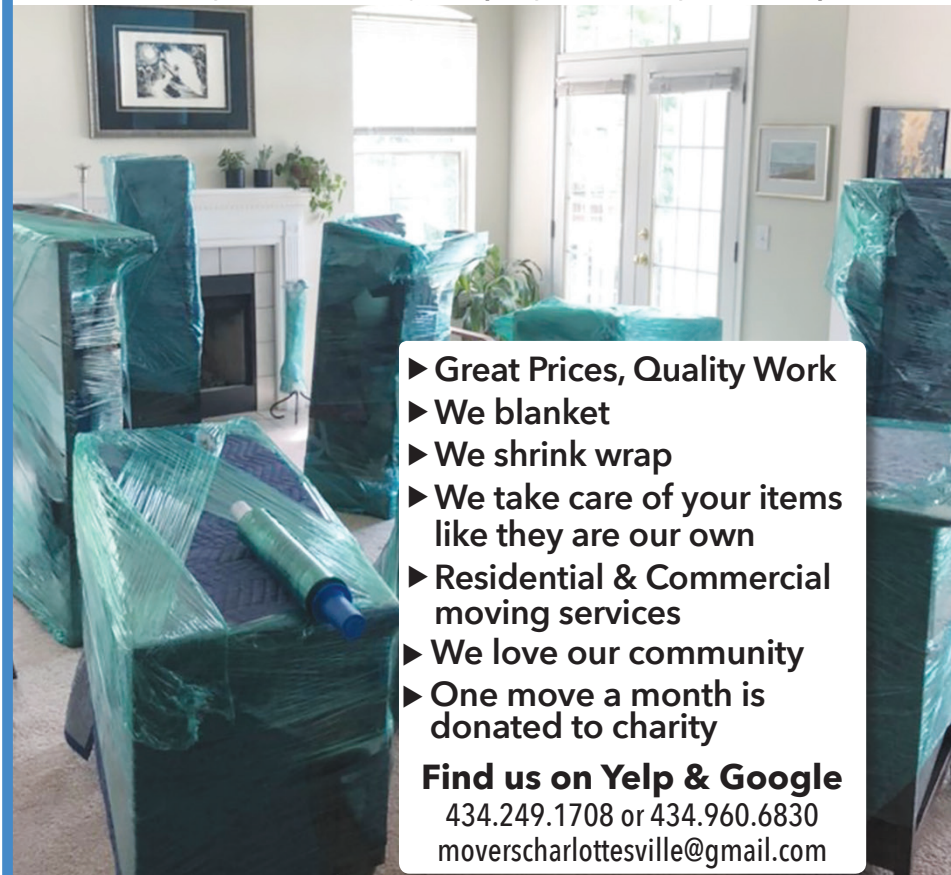

Fluco cross country teams run in Jefferson District event

The Jefferson District year end meet was held on Wednesday, Oct. 23, over the Fluvanna County High School course at Pleasant Grove. Runners from seven high schools took part. The Fluco girls' team turned in a very competitive performance, finishing in third place.

The girls' team was led by junior Emily Smeds who took second place, covering the course in an impressive time of 19:30.45. This time was a full 50 seconds better than the third place finisher. In this race, seven runners competed for each school and the team competition was decided by adding the finishing position of the first five finishers of each team. The Flucos' second through fifth finishers all came in close together in the middle of the pack.

Freshman Madeline Creasy finished eighteenth in a time of 21:46.71. Senior Hattie Lintecum finished eleven seconds later for 20th place. Junior Summer Craig took 22nd, coming in 15 seconds after Lintecum. Senior Kieri Hart was 24th finishing 17 seconds behind Craig. Added together, 2+18+20+22+24 total 86, which equaled the score of Albemarle High. The average time for the Fluco top five was 21:36, which was slightly faster than the average time for Albemarle High. The Fluco teams' average time was only 24 seconds behind the time of the winning Western Albemarle team. Fluvanna's sixth and

seventh runners also came in close to the team's top five, as junior Emily Beckman finished 28th and senior McKenzie Morris was 33rd. Beckman's finishing place broke the tie for third place with Albemarle. This proves again that in cross country it is not just the elite few top finishers that count for a team. The Fluco girls' team now goes on to the Region meet on Nov. 6 at the Rockingham Fair Grounds.

The boys' cross-country squad did not finish as well as the girls', but it was a very young contingent with no seniors running. Junior Troy Stephens finished best for the boys at 26th with a time of 18:40.57. He will go on to the Region meet on Nov. 6. The other members of the boys' team were all sophomores and freshman. Freshman Cole LaRochelle was next to finish for the Flucos followed by sophomore Matthew Cantagallo. The fourth Fluco to finish was sophomore Nathan Valentin who was followed by freshman Alex Pleasants, sophomore Richard Hall and freshman Mitchel Messier.

Because cross country events usually involve multiple schools, teams are traveling to other sites to run, more often than they host meets. The Jefferson District event was only the second meet of the season that was run over the Fluvanna County home course at Pleasant Grove.

Whistleblower claims archaeological survey of Point of Fork “illegal, unethical, and unscientific”

An archaeologist who participated in the survey of a proposed water pumping station on the James River at Point of Fork said in a sworn statement that work conducted at the site was “illegal, unethical, and unscientific” and that the company’s owner lied to state investigators, used unqualified and untrained staff, misrepresented professional credentials, and minimized significant archaeological discoveries.

The sworn statement is being proffered by Marion Werkheiser of Cultural Heritage Partners, the law firm representing the Monacan Nation, in an Oct. 21 letter to the Army Corps of Engineers, asking that a permit to develop the site be denied.

Point of Fork is believed by many historians and archaeologists to be the site of Rassawek, the primary settlement for the Monacan Indian Nation at the time of the English arrival at Jamestown in 1603.

Eric Mai worked for Circa Cultural Resource Management as a field technician for six years and was on-site at Point of Fork from May 2017 to January 2018. He resigned from in May 2018, in part because of the mismanagement he said he saw on the project.

Last month, the Virginia Department of Historic Resources (VDHR) informed the James River Water Authority (JRWA) that they had learned that Circa’s owner and principal, Carol Tyrer, did not meet the professional qualifications required by law to conduct a valid survey. As a result, VDHR said they were denying a necessary permit for the site, and the Army Corps of

Engineers likewise said they would need to reevaluate the project.

Mai’s statement, however, goes well beyond a lack of credentials. Among his allegations:

- Tyrer failed to give the team background on Rassawek or the Monacan tribe. None of the crew members had specific training in Native American history or archaeology. While Mai has a Master’s degree, the two other team members did not have college degrees and “were hired as a result of family friendships with Tyrer.” Not only did they lack training, they also lacked the technology to map or analyze the site. Tyrer gave them only a hand-drawn map with notes on where to dig test pits.
 - Tyrer was usually absent from the site. When a VDHR employee made a surprise visit in October 2017, Tyrer allegedly told the staff to lie and say she was normally there. After that, “Tyrer was present more frequently on-site, though she typically sat in her vehicle completing reports for other projects.”
 - Tyrer enlisted construction workers to dig some of the pits and screen for artifacts, “although they told me they had no idea what they were looking for.” The workers were employed by Falconer Construction, which, like Circa, was subcontracted by the engineering firm Timmons Group for work on the site.
- Despite all this, Mai said that the archaeological remains they found “were among the most impressive I saw during my more than six years with Circa.” He said

they found evidence of “significant human habitation” in almost every deep trench they built.

“It is a testament to how special this place is that one could perform tests as purposefully incompetently as Circa did and still find nine National Register eligible sites in an area a few acres in size,” said Werkheiser.

In the letter, Werkheiser argued that Tyrer’s work constituted “anticipatory demolition” of a historic property. If they agree with her argument, the Corps would not be able to issue a permit according to the rules of the National Historic Preservation Act, which prevents the issuing of grants and permit to anyone found to have deliberately damaged a historic site.

The James River Water Project is

a multimillion-dollar joint venture between Louisa and Fluvanna counties to carry millions of gallons of James River water per day to Zion Crossroads and other parts of Louisa County.

Both Fluvanna and Louisa counties have issued statements saying they are taking the new allegations “very seriously.”

“A thorough review will be conducted in order to determine whether or not these allegations will be contested,” Fluvanna County officials said in a recent press release. “If the allegations are founded, the Fluvanna County Board of Supervisors will pursue necessary and appropriate action to ensure the protection of taxpayer dollars.”

Artist talks about the principles of art

shadow to give a picture mood.

"Contrast will get your attention," she said. "Repetition and pattern add interest. Using a variety of patterns creates rhythm and excitement for the viewer." This is connected to movement, drawing the onlooker further into the painting not just looking at it.

"These basic principles of art are to be used with intention." She added the basic elements of art can be used in conjunction with the rules to achieve intention. The elements are the foundation of art, its structure, using line, color, values, texture, space, and form. The elements are the nuts and bolts while the principles are the guidelines for making exceptional art.

"This is not a checklist, you don't need all of them (elements) but they will help you reach your goal." She showed various photos and discussed symmetry. "Look at your photos can they make better paintings or do the photos stand on their own?"

She said the beginning of any planned art requires intention which is telling a story and creating a relationship. She strongly suggested drawing thumbnails, using the principles to get the best composition and angles.

"Look at your negative shapes, they can give you the visual you're looking for," she said. "Watch your edges and lines. If they are hard the eye can't rest and use implied lines, roads, paths, streams, are all implied lines." By using the famous rule of thirds for landscapes, she reminded them of foreground, middle-ground, and background, otherwise everything appears flat and lacks depth.

"Watch color, let it pop enough but not too much by letting the chroma overwhelm your piece. It pops too much, alter it. And always have drama in your work. Find the flow, tension, and balance." Understanding the components of good art may have seemed intense for some, but a worthwhile lesson for most.

She reminded the members that "Artists are illusionists."

Artist Leah Olivier made her third appearance Friday at the monthly Fluvanna Art Association meeting. Her topic was about the principles of art and their influence on the composition. Her underlying message was about intent when designing artwork.

"Your art needs to be more, make your mark, it needs to have you in it, it needs your intention." To accomplish this and create artwork that has meaning, Olivier discussed in depth the principles of art.

"We are not going back to art school," she told the members who looked reluctant to accept a new concept in art. Without extensive art training or study, this was new to some. Olivier has a way of using humorous honesty to get her point across clearly and concisely. "The principles of art create better work," she said. "Overworked art that is realistic down to every last detail has no emotion, no message, no intent."

She briefly mentioned reference photos, cautioning not to copy every

detail but use it for a starting point for creation, an idea.

"Loosen-up, don't be so tight or perfect. That first sketch is the beginning of a painting and should not be your final. It's not your baby, let it go, it's paint on a canvas, and if this is not happening, you missed the concept," she said. "The goal is to get people to feel what you meant."

She showed examples, including a large canvas of a dog content and happy, bright, alert eyes and tongue hanging out to the side, conveying an expression of joy. Upon seeing it, everyone laughed and Olivier got the response she wanted from the work. It was not overdone and the details were few but enough to be realistic.

"The principles of art are rules that help you analyze art. There has to be balance and harmony in a piece." She added that the piece needs a focal point to draw the eye inward.

Color is key but contrast is important in seeing the difference in values. This is central to rendering light and

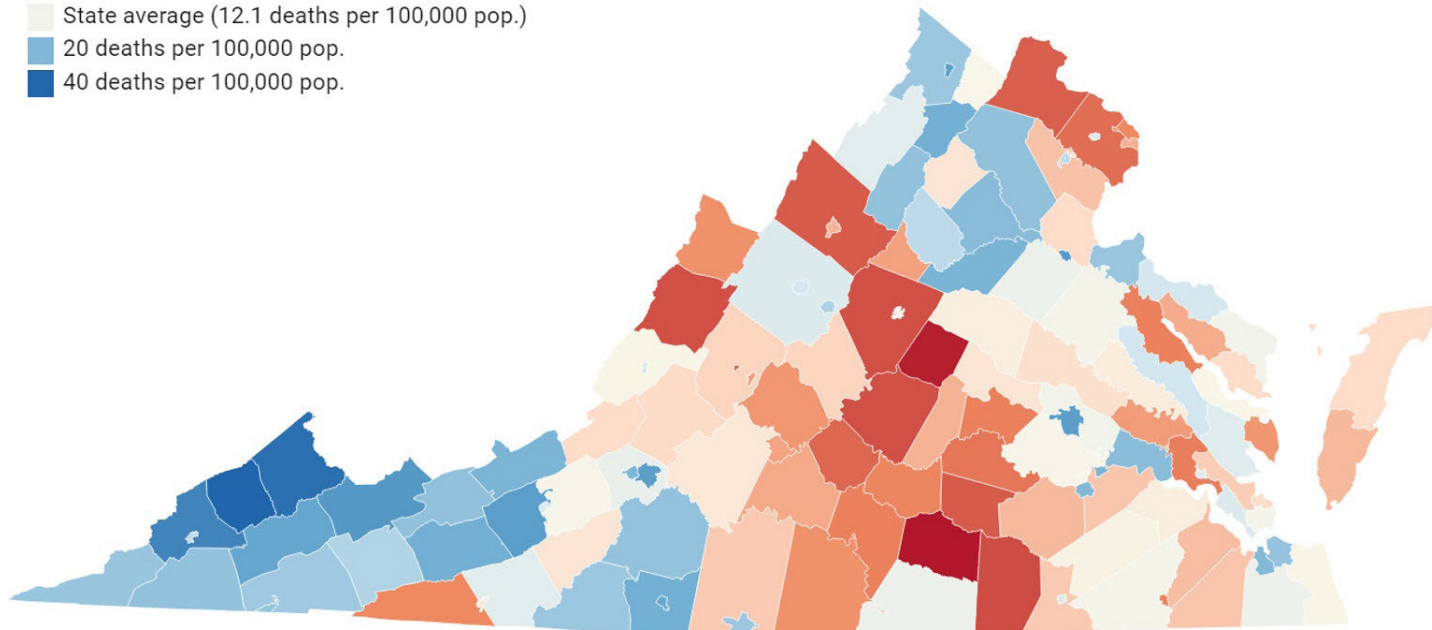
Drug overdose death rates in Virginia

Drug overdose death rates in Virginia

The highest rates were in western and southern Virginia, certain localities in Northern Virginia and urban centers such as Richmond. The map shows fatalities per 100,000 population in 2007-18. After a spike in deaths during the first half of the year, Virginia officials are projecting a record number of drug overdose fatalities in 2019.

Data released Friday by Virginia's chief medical examiner shows a big increase in deaths between January and June from overdoses of methamphetamine, heroin and fentanyl, a synthetic prescription painkiller.

As a result, the Office of the Chief Medical Examiner expects total drug fatalities in 2019 to approach 1,550 — a 4% jump from the previous year.

Fentanyl, which is more lethal than heroin and cocaine, is often combined with street drugs. "By late 2013 and early 2014, some heroin being sold on the street was actually completely fentanyl unbeknownst to the user," the office said in its latest quarterly report. "Fentanyl caused or contributed to death in nearly 55% of all fatal overdoses in 2018."

During the first half of 2019, Fairfax County and the city of Richmond had the most drug deaths in the state — 49. Most of Richmond's overdoses involved heroin and fentanyl, which is often produced overseas and trafficked into the U.S.

"We saw drug overdoses and drug-re-

lated deaths really rise when we started to notice more and more fentanyl in toxicology reports in 2015," said Capt. Emmett Williams of the Richmond Police Department. "The thing that is causing these overdoses is fentanyl being mixed with drugs like cocaine and heroin."

Just a pinch of fentanyl can be deadly, Williams said. "About 35% of seized drugs in Richmond have trace amounts of fentanyl mixed in with it," he said.

Authorities say one of the main ways fentanyl enters the U.S. is by street dealers ordering the drug on the internet's "dark web" and having it delivered through the mail.

"We're developing technology in package screening to detect fentanyl coming through the post office to combat the issue," William said. "Fentanyl is also being shipped to Mexico and being trafficked across the border into the U.S. from there."

In 2012, only 50 drug overdose deaths in Virginia involved fentanyl. That number jumped to 624 in 2016, 770 in 2017 and 813 last year.

Between Jan. 1 and June 30 of this year, the medical examiner said, 441 people died in Virginia from fentanyl overdoses. That compared with 371

such deaths during the first half of 2018.

The medical examiner projects that fentanyl will contribute to 883 deaths in the state in 2019.

Deaths involving heroin are expected to rise from 556 last year to 585 this year. And the medical examiner projects that fatalities involving methamphetamine will increase from 127 in 2018 to 152 this year.

Overall, the number of drug overdose fatalities in the commonwealth has gone from 799 in 2012 to a record high of 1,536 in 2017. The death toll dropped slightly to 1,485 last year. With the recent upswing in drug overdose deaths, the medical examiner's office projects Virginia will hit a new record of 1,547 in 2019.

Kathrin Hobron, a forensic epidemiologist with the Virginia Department of Health, said a multifaceted approach is needed to address the problem.

Besides putting an emphasis on law enforcement, she said, there should be an emphasis on drug treatment. "Other than focusing on opioids or one drug, we should be focusing on the addiction of drugs and helping drug addicts get off drugs," Hobron said.

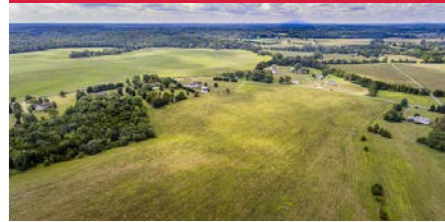

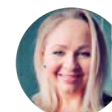

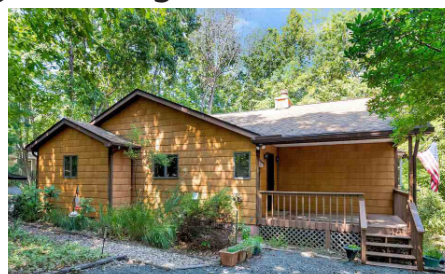
