# Monticello viticultural area expands into Fluvanna

Their hard work paid off. Fluvanna winery owners George Cushnie (Thistle Gate) and Bruce Deal (Cunningham Creek) waited for close to five years to have Fluvanna included in the Monticello American Viticultural

Area. On Friday (Dec. 14) the Alcohol and Tobacco Tax and Trade Bureau (TTB) of the U.S. Department of the Treasury published a final rule that expands the Monticello American Viticultural Area (AVA) to include a section of Fluvanna County.

The area of Fluvanna designated as part of the Monticello AVA includes both Thistle Gate and Cunningham Creek wineries, said Cushnie. "Virginia is now the fifth-highest producing wine state in the U.S.," he said. "Within our state, there are seven AVAs. The Monticello AVA is easily the best. Wineries within Monticello AVA have probably won more Governor's Cup Gold Medals than the other six AVAs combined."

Deal said he and Cushnie worked on the petition for a year before submitting it in March 2015.

"It took almost four years to have the government do something about it but it was worth the wait," Deal said. "Fluvanna County is now part of a world-recognized grape-growing region and shares



its qualities."

Leslie and George Cushnie started Thistle Gate in 2011 and had a banner inaugural year. They earned two medals in the Governor's Cup: a silver for their Chardonnay and a bronze for their St. George Chambourcin.

When they opened their tasting room in 2012, Thistle Gate became a gathering place with live music, displays by local artists, craft shows and of course, award-winning wine.

Thistle Gate, on Route 6 near Scottsville, also hosts weddings and community events.

# Horse ministry builds bonds

Scooter's chestnut coat glistened in the morning sun as he stood, without a bridle or any restraint, and watched Katy Pistole.

Scooter moved in any direction Pistole indicated, including spinning, trotting around her a number of times, and then climbing on a wooden box in the center of the ring on the Louisa farm where the horses are boarded.

Their communication and bond are especially remarkable given his background. Pistole rescued him more than 17 years ago when he was three and had been beaten by his owner who didn't understand horses. "Scooter had a lot of fear when I bought him," she said.

Pistole uses a relationship-building method of communication called natural horsemanship. The results are amazing to watch.

This relationship with Scooter and her other horses is shared through Pistole's

described Beautiful Brokenness as "a horse-themed discipleship ministry that helps God's children see who and whose they are."

Her experiences with horses provide metaphors for healing and developing a personal relationship with God, she said.

"Jesus has allowed horses to help me understand his amazing love and passion for me and all his kids. He has used horses to help me experience the heart of the shepherd," Pistole said.

Her father, Sam Thomsen, was named the first American ambassador to the Marshall Islands from 1987-90. In his career working for the State Department, he and the family lived overseas for most of Pistole's life. She was born in Alexandria, but the family moved to Vietnam in 1963 when she was 6 weeks old. They evacuated in 1965 when the violence escalated. Her father stayed behind and was in the American Embassy in Saigon when it was blown up during an attack. He was initially feared dead, but fortunately survived.

Pistole said she had always loved horses.

With occasional stays in the United States, the family then lived in Laos, Botswana and Nigeria. When Pistole was 12 and in Botswana, she received her first horse, Black Jack, and had an experience that changed the course of her life.

Pistole had been part of a church-going family but did not understand God's desire for relationship, she said. That changed when Black Jack came down with a fatal disease. Her parents and their friends offered to pray for the horse's recovery. When Pistole went to check on him the next day, he was fully cured.

That was a life-altering event, she said, to have such a personal experience with God. "I knew then that there was a God. He was good, powerful and I've belonged to him ever since," she said. "I started enjoying church."

Beautiful Brokenness is the story of rescue, redemption and reconciliation for both animals and people. It's a story of working with both people and horses.

# Fluvanna residents top most Virginians in net worth

Fluvanna County residents have among the highest per capita net worth in Virginia, according to the financial services company SmartAsset.com.

“Our study aims to find the places in the United States where residents have the highest net worth,” the company said in reporting its findings. “To do this, we calculated the ratio of net worth to per capita income for every county.”

Their analysis found Fluvannians have a per capita net worth of \$60,275.

Net worth is defined as the value of

things you own (assets) minus what you owe in debts (liabilities).

Per capita income in Fluvanna is \$30,220 and per capita debt is \$51,807.

Looking at the percentages of net worth to income and net worth to debt, SmartAsset.com created an index, on which Fluvanna ranked ninth out of the top 10 counties.

At the top of the list were Posequon, near Hampton Roads, and Fairfax, in Northern Virginia.

- Weddings and local events.

Becoming a part of the Monticello AVA comes with a certain cachet that is sure to boost the vineyards' bottom line.

That was what Cushnie and Deal hoped for when starting the process years ago.

"Being located in Fluvanna County, just a few miles from the Monticello AVA border, we suspected that Thistle Gate Vineyard's growing conditions

were very similar to the AVA," Cushnie said. "Working with Cunningham Creek Winery and our county agent [John Thompson], we did the research over a two-year period and developed a petition to include a slice of Fluvanna County into the Monticello AVA. This week that hard work paid off."

TTB designates viticultural areas to allow vintners and consumers to attribute a given quality, reputation, or other characteristic of a wine made from

necting Fluvanna's viticultural properties, such as climate and soils, and historical relevance to the existing Monticello AVA. It was supported by the Jeffersonian Wine Grape Growers Society, an organization of over 30 wineries within the Monticello AVA.

Will and Leah Wentz wrote letters of support as well.

The couple moved from Bethlehem, Penn., to Fluvanna in 2017 to live their dream of starting a vineyard.

the area.' We visited a few wineries and started looking for some land. Fluvanna was more affordable [than Albemarle] but it has the same soil structure. We wanted to get away from the hustle and bustle and the madness."

Wentz said Cushnie mentored them and in the process, they learned of the petition to have Fluvanna named part of the Monticello AVA.

The newly designated area includes the Wentz property just south of Palmyra.

"George made us aware of the AVA, helped us construct our letter and we put our own spin on it," he said. "I was thrilled when he sent me the news Friday. We have him to thank for that, that's for sure."

In the summer, the Wentzes planted one acre of cabernet franc grapes and plan to continue planting yearly until their 10 acres are full of grapevines.

Because of the new designation, their grapes will be worth more, Cushnie said.

"My wife Leslie is the vineyard manager," Cushnie said. "From now on, the wines made from the grapes she grows will be labeled as Monticello AVA. For us that is very satisfying. Generally, we grow more grapes than we actually use. The surplus grapes are sold on the open market. Because they are now Monticello AVA grapes they will bring a higher price."

# Locals share Christmas traditions and memories

said. She described the complexities of making this dish. She also joked about “the Swedish meatballs, which are also a killer nightmare until you figure out how to go to IKEA and get them pre-made and frozen.” No one said it had to be homemade.

“We never made the famous lutefisk, that Garrison Keillor made famous – the fish cured in vats of lye and then rinsed and steamed into a gelatinous mass,” Sherk said. “They recommend drinking copious amounts of beer with that one. Apparently the smell is quite something.”

“When I think about how much effort my sainted mother put into all the Christmas preparations, even while working a full time job, I am humbled into submission. I mean, we’re talking every kind of cookie

In the midst of the Christmas season, several locals took time to share their favorite Christmas traditions and memories. Some recalled traditions based on ancestral customs and past generations. At the core of most of these traditions was the concept of being with family.

“Every year my family would visit my grandmother. Other family members would gather there and we always read the Christmas story before having our meal,” said student Jhen Sullivan, who lit up at the thought of once again being with her family for the holidays.

The Reverend Tom Frost from Cunningham United Methodist Church said that religion has always been the essence of his Christmas holiday, even long

before he became a minister.

“Even before I became a pastor, I love the energy, the worship from beginning to end,” he said. “I will go with my son to the 11 p.m. service on Christmas Eve, then go home and wrap packages, so by Christmas Day, I am exhausted.”

Kyle Wheaton, Cuppa Joe’s weekend coffee barista, likes to spend time with his family reflecting on the past year. He told about the custom practiced by a Russian friend of his: “On Christmas Day, he opens the wrapped-up foil balls hanging on the tree which contain fruit. Fruit is considered to be a great gift.”

Rebekkah Youngblood and her sister, Hannah, have always joined in a real family tradition.

“Every year we go to the Grand Illumination in Williamsburg and have been doing it for 14 years,” she said. “We do it in the rain, snow, or in 20 degree weather and always bring along with us homemade sausage balls and puppy chow.” The snack may look like puppy chow but is made with Chex cereal, chocolate, peanut butter and powdered sugar. “Christmas isn’t Christmas without doing this.”

Beth Sherk, Persimmon Tree Players president, shared some Swedish customs. “Our family was big on the Norwegian and Swedish foods like lefse, a potato pancake type thing that is a pain to make until you learn the tricks from your mom and your Aunt Gladys,” she

and fudge. I am deadly afraid to bake so many cookies and never fudge.” Since most cooks like to sample their finished products, Sherk is afraid she would weigh more at the end of the season. This is why people who bake at holiday time often give their treats away. Her solution is her husband hides them after she bakes three dozen.

“Never look too closely at anything I wrap because they’re going to have that crinkled, mashed up look,” she said. “My dad was the big wrapper in the family. He’d set up a factory with a bow making gadget on the ping pong table in the basement. His gifts were works of art.”

Sherk prefers to stick to decorating the house, using some of her parents’ ornaments and figurines, and her collection

of Santa Clauses.

“For me Christmas is mostly about the lights and the music. The food is a danger zone so I tread with caution,” she said. Some of Sherk’s best memories are sledding and sitting by the fireplace eating homemade cookies and drinking hot chocolate. “I’d have a stomach ache if I did that now – too much sugar – but it worked for me then.”

Mo Perkins, from the heart of Maine, remembers the warm, wonderful smell of his mother’s Boston brown bread.

“Oranges were a treat because we didn’t always get them,” he said. “We would put on our snow shoes and tramp through the snow to get our Christmas tree but we had to leave it in the basement to thaw out before bringing it in the house.” He recalled untangling lights and his dislike for artificial snow. “That fiberglass snow – you’d throw it on the trees, it was awful.”

Marianne Hill recalled her Christmas memories.

“It was the early ’70s and my sister, Catherine, and I had outgrown our bikes. Our father took us to the Western Auto Store on the Boulevard in Colonial Heights to pick out new three speed bikes for Christmas. We picked beautiful blue StarJet Sports Tourists and Christmas morning couldn’t get here soon enough for my sister. Every day she would try to guess where the bikes were stored. ‘Are they at Mrs. Barfield’s house next door?’ ‘No,’ came the answer. ‘Are they at Mrs.

Jefferson’s house?’ Again the answer was no. Every guess had the answer no. Dad had more fun that Christmas keeping her guessing. It was years later that we found out that the bikes were hidden next door at Mrs. Barfield’s house.

“One year the family went to Atlanta to have Christmas with my mom’s sister, Aunt Mildred,” Hill continued. “We didn’t have live Christmas trees at our house because of my allergies. Aunt Mildred had a live one that year. She had musical instrument ornaments that actually made noise. To this day, whenever I smell a live tree I am transported back to that Christmas at Aunt Mildred’s.”

Alden Bigelow remembers Christmas of 1952 and selling mutt puppies as “Albemarle beagles.”

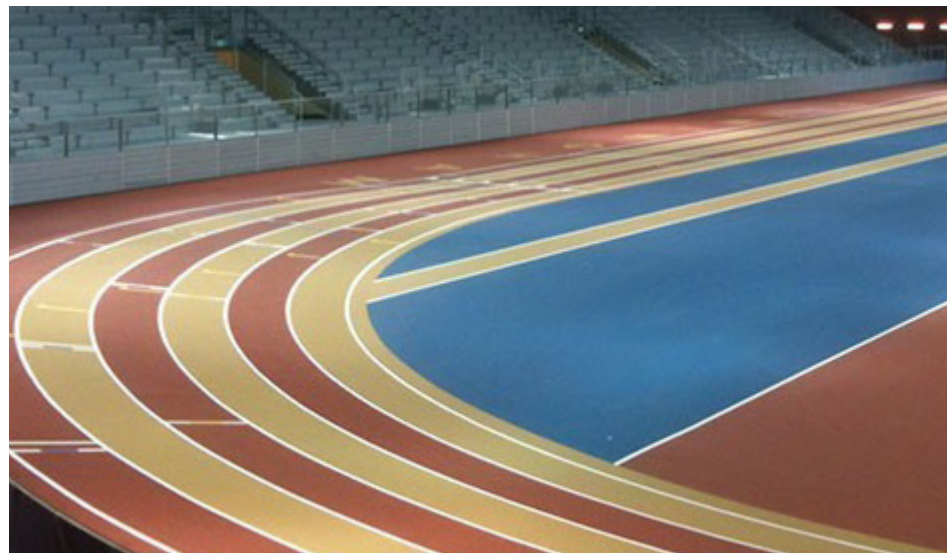
“It was on Main Street in Charlottesville. With a little coaching from my father, my brother Dennis, age 8, and me, age 6, sold the beagle mix pups we called Albemarle beagles for \$5 apiece when my father couldn’t give them away as mutts,” he said. “One lady bought an Albemarle beagle pup but had refused the same when Dad had offered it to her earlier as a mutt.”

Looking back, the memories, the traditions, and most of all, the storytelling, remind us of what Christmas is all about.



# Fluco track and field teams excel

The Fluvanna County High School boys’ and girls’ indoor track and field teams traveled to Lynchburg Dec. 8 to compete in a huge 26-school meet hosted by Heritage High.

The meet, which is held annually at the start of the indoor season, is known as the Wally Gilbert Invitational and is named for a highly successful former track and field coach at Heritage High.

The Fluco teams were extraordinarily successful. The boys’ team finished first and the girls’ team took second place. The girls’ team under Coach Rose Brogan had a number of athletes score points, and most were underclassmen.

The only first place finisher for the girls was sophomore Emily Beckman who won the 3,200-meter run by a wide margin. She finished in 13:03.47. 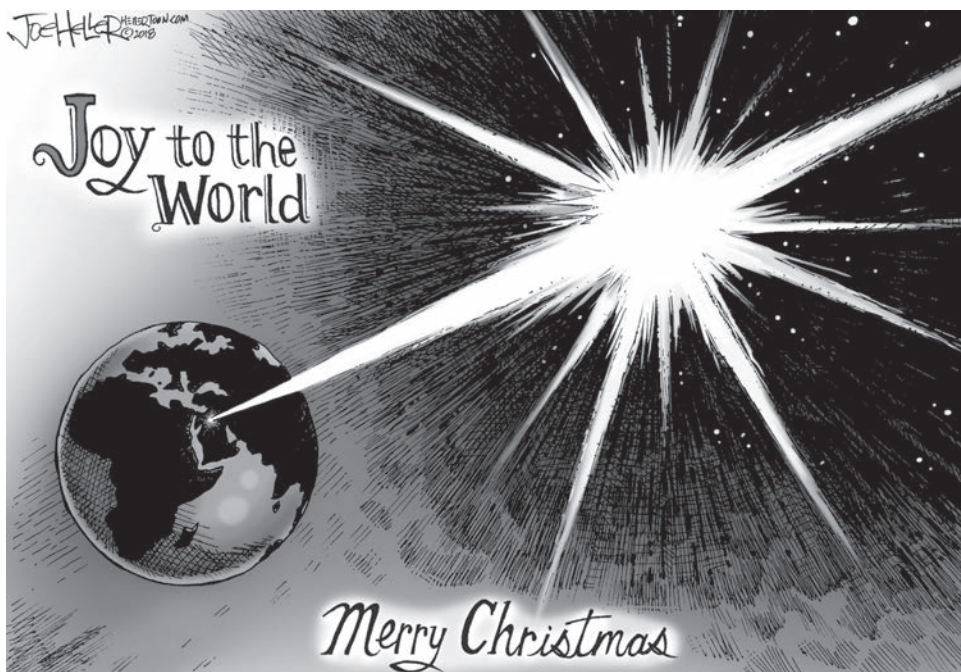

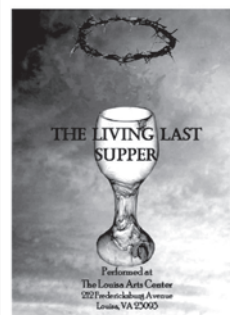

# Boys' basketball

## Last-second buzzer beater bests Flucos

The Fluco boys' basketball team led 46-39 with 5:50 left in the game Thursday (Dec. 13).

Unfortunately, five minutes later they trailed 46-52. During that five-minute stretch, the Madison County Mountaineers sank 11 free throws.

In the final 50 seconds, the Flucos came alive and managed to erase a six-point deficit. Freshman guard Kobe Edmonds, who led the Flucos in scoring with 27 points, hit a driving lay-up to cut the lead to four. Madison made one of two from the line to up its lead to five. A technical foul called on Madison put Edmonds on the line for two free throws and he sank them both. With 33 seconds left, senior forward Drew Pace scored on a rebound to cut the lead to one.

The Flucos were forced to foul, and Madison converted on two tries from the line, upping their lead back to three with 29 seconds left. The Flucos worked the ball to Pace for the shot that Coach Jason Davis said they were looking for. Pace delivered, sinking a three pointer from the left side to tie the game at 55-55 with six seconds remaining.

The Flucos defended well and Madison had to take a very long three at the buzzer that was certainly not the shot they planned, but it went in, and the game was over.

It was the second loss in a row for the Flucos on a last-second buzzer beater. They are now 1-4.

This game was close throughout. The Flucos led by one 16-15 at the end of the first quarter. The Mountaineers led by one 24-25 at half time and the Flucos were back on top by one 37-36 after three quarters. Edmonds had seven in the first quarter, including three from the line after being fouled on a quarter-ending three point attempt. Pace and senior forward Brandon Lytton had three point baskets.

In the second quarter the Flucos managed only eight points; Edmonds had five of them. In the third quarter the Flucos managed to get back in the lead. Sophomore John Boy Rittenhouse had five in the quarter, including a three pointer. The fourth quarter started with Madison hitting a three point shot to retake the lead, but the Flucos ran off nine straight to pull ahead at 46-39,

before their five-minute dry spell. Edmonds scored seven in the Flucos' nine-point run, on two driving lay-ups and three for three from the line. Pace had the other two points on a lay-in off a nice pass from Edmonds.

After the game Davis noted that his team is coming along, but that they still need to play well for 48 minutes, not 38 – an apparent reference to the five-minute dry spell in the fourth quarter.

Edmonds was very impressive in this game, driving hard to the basket and making steals at the top of the key. The Flucos have had some strong guards in recent years, but 27 points by a freshman is not a common occurrence. Pace was the only other Fluco in double figures, with 11. Junior center Walt Stribling contributed six and some strong rebounding. Rittenhouse had five.

The Flucos played at Powhatan Dec. 14 and they hosted Charlottesville Dec. 18. On Dec. 20 they will be at Waynesboro. They will be home Dec. 21, hosting Louisa County. They are then off for the holidays and return to action Jan. 2, hosting William Monroe.
