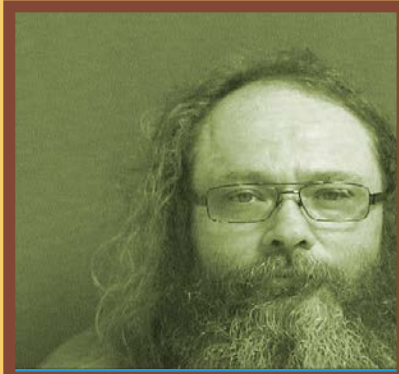

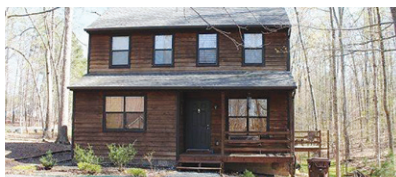

# Rainbow F controversy pushed another month

## *School Board vote ends in a tie*

Even after a month of study, the Fluvanna School Board still isn't any closer to an answer about allowing the Alliance Club to rainbow-color the Fluco logo.

With Andrew Pullen (Columbia) absent from Wednesday's (Dec. 19) meeting, the four members split the vote. The matter will be taken up at the Jan. 9 meeting.

Pullen did not respond to requests for comment as to why he did not attend.

Perrie Johnson (Fork Union) and Shirley Stewart (Rivanna) voted to allow the rainbow logo; Charles Rittenhouse (Cunningham) and Brenda Pace (Palmyra) voted against.

The Alliance Club is a school-sanctioned group supporting LGBTQ (lesbian, gay, bisexual, transgender and queer) students and their allies.

In an October closed session meeting, Superintendent Chuck Winkler presented to the Board the club's request

to create a rainbow F logo for the group to use to "encourage a safe, accepting space in our school." Originally the group wanted to offer stickers to teachers and staff to display in their room as a "safe space" for LGBTQ students.

Somehow Rob Schilling, a radio host and blogger for the conservative Bearing Drift website, got hold of a color picture of the formal request letter. On Nov. 2, five days before the request was brought before the public in an open meeting, Schilling posted a column entitled "The culture wars come to Fluvanna."

By the time the issue was addressed in the November meeting, the Alliance Club amended the request to say they would not offer stickers made with the revised logo to teachers and would not use it to make money.

Many parents and other community members spoke their mind during the November meeting public comments. Of those who spoke, about one-quarter was against the logo change.

The one uniting issue between both sides seemed to be anger at who passed

# Arrest made in threatened school shooting

Fluvanna County Sheriff's Office deputies arrested a student who they say threatened to commit a school shooting.

The sheriff's office was notified Friday (Dec. 21) at 7:24 p.m. of a threatening post on social media regarding the Fluvanna County High School. The post was a picture of the high school with a

caption that read, "im bout to shoot this bitch up," according to a sheriff's office press release.

"Deputies worked quickly to identify and arrest the threat maker, who was a 16-year-old student of the school," according to the release.

Deputies obtained a petition for a vio-

lation of the section of Virginia code that pertains to threats to commit serious bodily harm to persons on school property, and a detention order was issued, according to the release.

The juvenile was arrested later that evening, according to Capt. Von Hill of the sheriff's office.

The student is being held at the Blue Ridge Detention Center, according to the release.

"As this case involves a juvenile and is pending court, no further information will be released," the release stated.



along the request letter to Schilling. Almost every speaker asked for an investigation.

A much smaller and less vocal crowd attended Wednesday's meeting. At the beginning, Chair Johnson read a message from the board:

*"Every year, all members of the Fluvanna County School Board approve a Code of Conduct whereby we renew our commitment to advocate for students and staff, and to improve public education. The code includes a specific provision with respect to honoring the confidentiality of privileged information.*

*We understand that there have been some recent concerns regarding privileged information being shared inappropriately with a local radio show host. The Board has conducted an inquiry, beginning more than a month ago. Based on the findings, the Fluvanna County School Board states that no School Board member gave any confidential information to this outlet. Furthermore, no Fluvanna County School Board member has any knowledge of who shared this information with this media outlet or any public entity.*

*The board respectfully understands that even the perception of a member violating the tenets encompassed within the Code of Conduct raises questions about the integrity of all that we do. Given this sentiment, it has compelled us to investigate the situation and share this information with you tonight."*

Several people spoke, upset with the conclusion.

**Andrea Overweg:** "I feel very strongly that any investigation should be a little more transparent. I believe that people sitting up here pointing and saying 'We didn't do it' is nebulous and not sufficient. What happened is absolutely the most horrible thing that could happen to children already vulnerable, marginalized, subject to bullying, subject to ridicule. I am very displeased. And had this been my child, we would have sought legal recourse. I feel very strongly an investigation is owed to the community with a conclusion, not just 'The board didn't do it.' I find that to be inadequate and an apology is inadequate reparation for the damage wrought... I want more from the investigation.... I believe there's only two options... whoever leaked it is removed from that position of trust or they recuse themselves with honor... Somebody leaked this when no one was looking. This is wrong. Wrong is

wrong. And Martin Luther King, Jr., one of the greatest civil rights leaders we've ever known, said, 'The time is always right to do what is right.' Now you know how I feel. The time is right now to take action."

**Melissa Irvin:** "I have no faith in any integrity of any investigation that you claim to have made. I urge you to get a third party in here to do this investigation."

**John Atkins:** "In 2012 I came out to myself. I had no one – no one to go to. I was varsity captain of the Fluvanna County swim team and I had no one. I was an Eagle Scout of Boy Scout Troop 154. I was on the executive board of the student government association and I felt like I did not belong at this school. I had no place to go. It is your duty as members of this board to understand you're here to develop; you're here to nurture; you're here to be a safe space for all students."

Atkins said it was only through the Safe Zone program at Mary Washington College that he found the strength to tell his parents about his sexual identity. He encouraged the board to bring such a program to Fluvanna schools.

After the stalemate vote, other members of the public spoke out:

**Eve Gaige:** "Children in this county are entitled to safety and support. They are entitled to a School Board that can be trusted to protect them. That trust has been violated. This is about accountability. You are accountable to us. For the board to have a private and opaque investigation into its own integrity and expect the community to accept it is frankly absurd. I urge you to arrange for an independent investigation into this matter and restore the integrity of this board."

**Kerry Murphy-Hammond:** "Clearly I'm in favor of the logo. But I'm in favor of any sanctioned group – you brought up the Fellowship of Christian Athletes putting a cross in the middle of the F. What am I missing here? I'm Christian and an ally. I don't understand that argument. I've seen it in camo, the American flag. I've seen it on the side of the Kents Store fire truck."

**Craig Edgerton:** "I teach theater and speech at the high school... I'm not understanding this trademark thing. The shape of the Fluco F is the logo. I design t-shirts and have been playing with this Fluco F. I've made them in white, pink,

blue, yellow, purple. It's not about the color. The Fluco F is the shape. Why are we worrying about the color of the F? I'm wearing a hat here of my favorite baseball team: the Boston Red Sox. I normally wear a red hat. But this is the pride hat. If the Boston Red Sox can show the pride logo why can't the Flucos? I don't understand the problem here."

**Haden Parrish:** "I'm here to support the logo. I hope you guys will pass it next month... I'd love for us to challenge our own policies of whether or not teachers can display it because it's 'political.' I don't think supporting a person's identity is political. Supporting an LGBTQ+ community isn't a political stance, it's a stance of humanity and whether we're going to allow them to express themselves and be who they are in our education system."

Only **Amber Kidd** spoke against the rainbow F logo. Before the vote she said, "I want to say to the club that I'm not against them. I feel that every student should feel safe and comfortable in our school system. But by allowing one club to change the logo for its purposes means we would have to allow all the clubs to do it. Allowing this would possibly open doors we could not shut."

After the vote, she said, "I don't understand the vote. The legal representation that we have for the School Board is advising you to vote no on this. This could cause legal matters that county taxpayers do not want to deal with."

After the second round of public comments, Johnson thanked everyone who spoke. "I'm so proud," she said. "I'm so proud to live in Fluvanna and be part of this community and people who respect other's points of view."

In other board news, Winkler said he wanted the Board to consider a proposal from SunTribe to put solar panels on each of the schools. The Board asked him to bring representatives to the next meeting to discuss their proposal in open session.

Winkler said because of recent issues of losing power at the schools, he is exploring the possibilities and costs of installing generators at the schools and the office.

Gary Greenwood and FCHS were awarded first place from the Virginia Economic Council for their work on innovative lesson design.

Brenda Gilliam, executive director of finance and instruction, gave a presen-

tation on the budget. She said that the utility savings promised by Trane and used to build the 2018 budget have not been realized. They budgeted for a savings of \$142,817 and the actual savings was \$66,657.

Winkler said when he presented this information to the Board of Supervisors, County Administrator Steve Nichols assured him if the budget was short because of unrealized utility savings, the county would cover the cost.

But Winkler said the board may have to look in other categories of the budget to move money to cover the shortfall.

Gilliam outlined the key proposals in Governor Ralph Northam's budget:

- Updating the direct aid accounts for enrollment changes, program participation, and other technical changes in fiscal years 2019 and 2020;
- Updating sales tax and lottery revenue estimates dedicated to public education in fiscal years 2019 and 2020;
- Increasing the compensation supplement effective July 1, 2019, from 3.0 percent to 5.0 percent;
- Providing additional state funding for school counselors in fiscal year 2020;
- Providing additional state funding to support students that are educationally at-risk in fiscal years 2019 and 2020;
- Increasing the supplemental lottery per pupil amount in fiscal years 2019 and 2020; and
- Providing state funding to continue support for students enrolled in the federal Virginia Preschool Initiative Plus program in fiscal year 2020.

# For the love of art: Remembering Alice Clifford

At the end of a rustic gravel driveway off of Stoneleigh Road in Palmyra is a charming old house tucked away in a grove of trees. Inside, remnants of the old house remain, from the original brick in the fireplaces to the sliding doors to the living room. Everything about the house is wonderfully antiquated.

This is just the way artist Alice Clifford liked it. It had been her haven for almost 50 years of her life. She sequestered herself in solitude, never flinching at what would appear a lonely existence to most. Rather, she embraced it. This is the way she lived her life until she passed away this year, in solitude and with her art.

Always quick-witted with a sly smile, Clifford discussed the history of the

house and her late husband's reaction at first seeing it.

"When we considered buying the house, it had been empty for 35 years and my husband said, 'I'm not buying a dump like this,'" she recalled. Years later the house featured renovations but was filled with Clifford's collections of art books, dolls and teddy bears. The majority of her books are related to art and art instruction. "If the house were on fire, I would grab my *Artist's Manual*, *Helen Van Wyk's Mixing Colors* and *History of the Renaissance*," said Clifford.

Her doll collection fills three glass cabinets in the hallway upstairs. Clifford wasn't exaggerating when she spoke of her immense doll collection that features dolls handed down to her from her

grandmother and great-grandmother. There is even King Henry VIII and Anne Boleyn in elaborate and detailed attire. Dolls as old as 100 years or more, and even some Clifford cast herself, occupy the three enormous ceiling-to-floor shelves on the second floor.

Downstairs, she converted her dining room into an art studio and against the wall is a curio cabinet regenerated into a doll house. Clifford laughed as she described the different miniatures she collected and the offbeat stories she created to describe the display. Each shelf was divided into a room with curious characters, from a drunken old man to a medieval knight. It was clear that Clifford had fun with her collection and was always inventing something different. After

saying something surprising, she would never say, "You know what I mean?" She never had to, all she did was give a sly smile and a wink and you knew exactly what she meant.

One of the founders and a longtime member of the Fluvanna Art Association (FAA), Clifford took her art seriously. Raised with art since she was a child, she learned sculpture, creating her first statue at the age of 10, as well as sketching, watercolor, pastel, graphite, pottery, and her first love – painting. She even played classical piano.

"My husband loved it when I played *Clair de Lune*. I always told him, 'You don't want to hear the way I play it,'" she said. She may have dabbled in music but she was not a weekend dabbler when it



came to her art. Art was her quiet uninterrupted haven against the world.

Those that knew Clifford understood her intense passion for painting and drawing. All around her house, in hallways and various rooms, are her paintings. Postmodern impressionistic, Clifford described her work as flowing and dreamy with no hard edges. Her work was seamless; like music, it proceeded into the next phase without pause. She wallowed in the wonderful discoveries she made along her artistic journey, never afraid to challenge herself to grow and explore.

Clifford was eclectic and humorous but was candid in her appraisal of artists who never dare to take risks and experiment with new ideas in their art. Clifford would spend hours in her studio mixing all kinds of paints and other media, experimenting, reaching beyond the familiar and safe limits of her art, challenging herself and discovering new ideas. She was content with the past, rested and reflected on the present, but was restless in pursuing future ideas, intrigued with where it would lead. Her belief was that nothing was ever gained in being safe when it came to using the imagination.

In later years, as Clifford's health took a toll and she was less able to participate in the FAA, she was made an honorable member and made an appearance at the 40<sup>th</sup> anniversary celebration of the group's founding. She was clearly proud of being part of the visual arts in Fluvanna County. In turn, she was an inspiration to other artists, bestowing her years of experience, wisdom and knowledge to those willing to be a maverick like she was.

Clifford lived a life she was pleased with, and at the age of 88 left on her final journey, but not after looking back those few years ago, reminiscing about her life in a wistful haze of memories. She glimpsed the past, remembering her husband, her stepdaughter, Judy, and other members of her family. She had been a nurse, ridden horses, and loved her garden and life itself.

Her art will remain as a reminder of her dedication, not to perfection, but rather to searching out new ways to create and enjoy art.

"For serious artists, they should take lessons, study and get better. After all, the masters were old when they achieved their greatness," she said. "I love art. It is my driving force. It's always on my mind. It never ends... It never ends."

# Looking back: Noteworthy crimes and court cases in 2018

It was a busy year for the Fluvanna County courts, with two major trials and dozens of other hearings, sentencings and dramas. Here's a look back at the year inside the courtroom.

## Shootout

The year began with the two-day trial of Gary N. Blowe for his part in a November 2016 shootout off Lake Monticello Road.

Blowe, along with John Morton Abbitt, Thomas Andrew Jackson and Dante Givens, was charged with multiple felonies stemming from the incident, which began as an attempt to steal some guns they believed were in an apartment over a garage on the property of Garnette Bourne.

Bourne, along with his brother, Scott, and former Fluvanna County Sheriff Jackie Gillespie, returned unexpectedly to the garage and a shootout began. Garnette Bourne was shot in the leg during the altercation. Commonwealth's Attorney Jeff Haislip produced evidence showing that Blowe had shot Bourne before fleeing the scene.

Abbitt, Jackson and Givens all testified against Blowe during the trial and later entered guilty pleas for their part in the incident. Blowe was sentenced to 42 years in prison, with Abbitt and Givens both receiving four years, and Jackson six years.

## Bank robbery

Jeffrey W. Troxell, 27, of Chesterfield County, pleaded guilty in an October 2017 bank robbery at the Union Bank & Trust on Thomas Jefferson Parkway.

Troxell stole about \$1,300 before fleeing the scene. He made no real attempt to disguise his appearance or cover up a prominent neck tattoo and was quickly identified and taken into custody in Chesterfield.

He was sentenced to serve 20 years with 10 years suspended.

## Joyride

One unusual incident made national headlines in July when a 10-year-old boy and his 7-year-old brother took their foster family's Lexus on a road trip.

The children left the home near Wilmington very early in the morning on July 24, and it was unclear how they even made it to Interstate 64. They were spotted driving erratically near the Shannon Hill exit and finally stopped after clipping another car and sliding into a ditch near the Gum Springs exit. Neither the boys nor the other driver was injured.

Capt. David Wells of the Fluvanna County Sheriff's Office said he received calls from media all over the country when news of the boys' adventure hit the newswires. The children told investigators they were trying to get to Virginia Beach.

## Record-setting DUI

In July, Jason Breeden pleaded guilty to a charge of driving under the influence. He had been stopped for making an illegal U-turn in front of E.W. Thomas Dec. 8, 2017, and the arresting office quickly suspected he was intoxicated.

Breeden was found to have a blood alcohol content (BAC) of 0.373 percent, a level of intoxication that is generally considered life-threatening. "This is the highest BAC I believe I've seen," said Haislip during sentencing. "Mr. Breeden has to be a very seasoned alcoholic."

Breeden's attorney, James Cooke, told the judge that it was amazing Breeden had been as functional as he was that night. "That's not really meant as a defense," he added. "More of an observation."

While Judge Richard Moore praised Breeden for finally seeking help for his long-term alcohol problem, he ended up sentencing him to 12 months with all but 90 days suspended, and five years of probation, during which he is prohibited from using alcohol or other substances.

## Shooting spree and standoff


One long-running drama came to a close as Joe Kain Roach, Jr., was found guilty on multiple counts stemming from an April 2017 shooting spree in Scottsville that left one woman injured and sparked a seven-hour standoff with law enforcement.

After a day-long bench trial, Judge Moore found Roach guilty of all but three of a dozen counts, including aggravated malicious wounding, maliciously firing on an occupied dwelling, and assault and battery against two Fluvanna County sheriff's deputies.

In November Roach was sentenced to 102 years in prison, with 44 years suspended. His active sentence was 58 years. If he is ever given geriatric release, the judge additionally ordered 10 years of supervised probation and three years of electronic monitoring.

"I'm not speaking in hyperbole," Haislip said during his arguments at sentencing. "This is the most dangerous man in Fluvanna County."

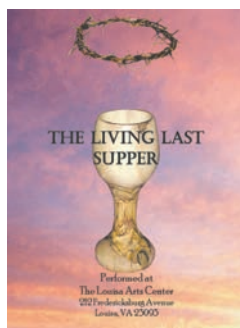

# County Administrator Steve Nichols announces retirement

## County applies for broadband grant

County Administrator Steve Nichols began the Wednesday (Dec. 19) meeting of the Fluvanna County Board of Supervisors by announcing his retirement.

Nichols will retire July 5, 2019, after serving over seven years as Fluvanna's county administrator.

"I will always look back with pride at Fluvanna's path over the last decade, and for my small part in the positive changes that have occurred," Nichols wrote in his resignation letter. "I also look forward to fewer meetings, more travel, and the time to become a more accomplished goof off, gopher and golfer in my retirement years."

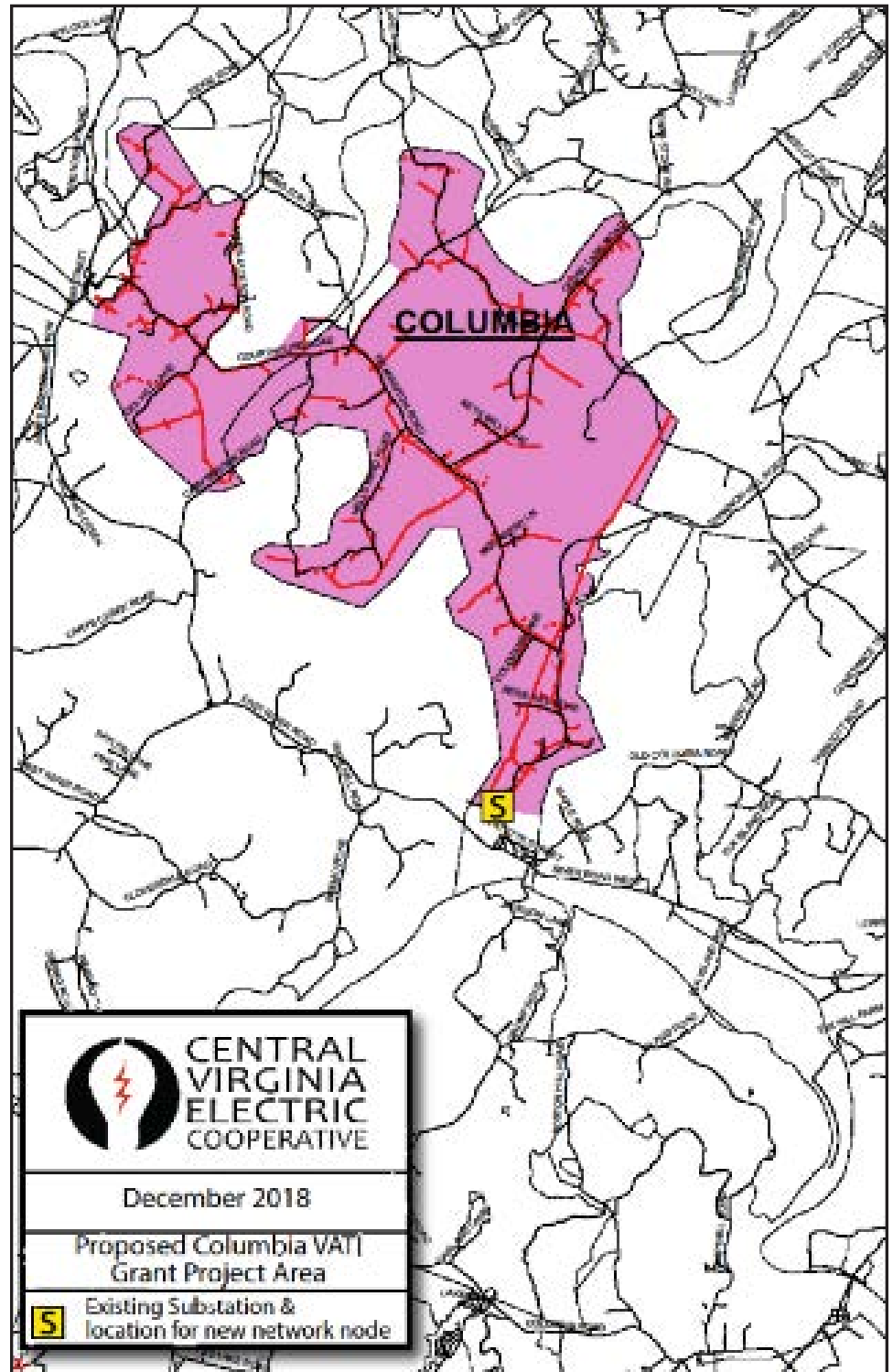
"The earlier you can do it, the better you are because you never know what the future holds," said Supervisor Don Weaver.

"You've got great staff here already," said Nichols. He recommended that Eric Dahl, deputy county administrator and finance director, take over as his replacement.

Nichols will turn 65 years old in June.

### County applies for broadband grant

The county has applied for a broadband grant from the Virginia Telecommunications Initiative grant program for broadband, Dahl told supervisors. The



program has \$4 million to offer underserved areas.

Fluvanna partnered with Central Virginia Electric Cooperative (CVEC) to apply for \$641,967 to install broadband in the Columbia District.

The grant helps to supplement construction costs by private broadband providers, such as CVEC, who work in partnership with local governments.

"There's no tail to this one, because CVEC will be paying any matching requirements," said Nichols, referring to

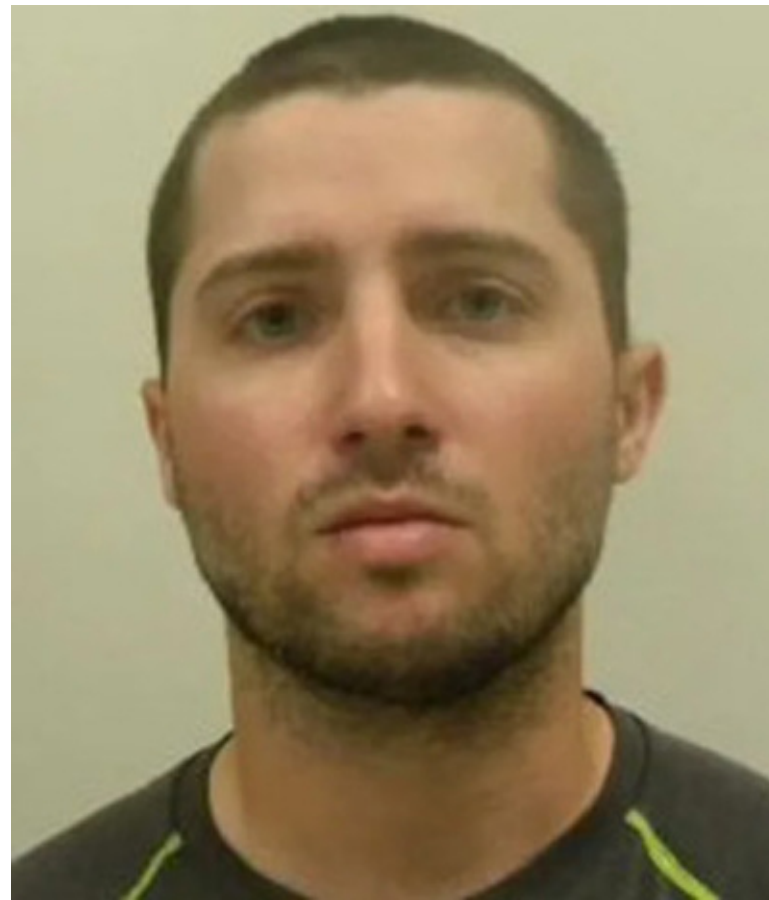

# Man indicted in arson, attempted murder

A Mechanicsville man accused in a June arson attempt was indicted by a Fluvanna County grand jury Wednesday (Dec. 19) on three counts of attempted first-degree murder, one count of arson, and use of a false ID.

Cole Spencer Augustus Carter, 26, is accused of having set fire to a home on Miles Jackson Road in Palmyra early in the morning of June 3, 2018.

The three people inside the home at the time escaped without serious injury,

although the home itself sustained heavy damage. The occupants quickly named Carter as the man they believe set the blaze, and he was taken into custody by Fluvanna County deputies later that day.

Carter is also facing a half-dozen violations of protective orders and a charge of breaking and entering.

He is currently being held at Central Virginia Regional Jail in Orange County.

Carter will return to court for arraignment on all 10 charges Jan. 25.

extra costs that sometimes come along with “free” money.

If Fluvanna receives the grant, CVEC will have one year to complete the work. The county expects to find out sometime this spring whether it was selected.

Supervisors voted unanimously to ratify the submitted grant application.

### FUSD close to paying off loan

The Fork Union Sanitary District (FUSD) will soon pay off the entirety of its loan from the county.

Currently FUSD owes the county \$67,100. The sanitary district pays on this loan every year.

When FUSD hit financial trouble in fiscal year 2010 (FY20), it borrowed \$40,000 from the county. It then borrowed \$30,000 in FY13, \$39,000 in FY14, and \$9,000 in FY15.

But thanks to a rate increase and careful cost accounting, FUSD is now on much better financial footing. “I think you’re going to see with the rate increase and with this new method for better, accurate cost accounting for what’s attributed to each system, you’re going to see the cash balance continue to go up,” said Dahl.

“Their finances are stabilized,” said Nichols.

FUSD repaid the county \$18,000 in FY16, \$17,867 in FY17, and \$15,033 in FY18.

Supervisors directed staff to prepare the documentation necessary for FUSD to pay off its \$67,100 balance in full.

### Annual financial report

Dahl delivered the comprehensive annual financial report, diving into detail regarding the county’s revenue and expenses for FY18, which spanned July 1, 2017 through June 30, 2018.

David Foley of Robinson, Farmer and Cox conducted Fluvanna’s FY18 audit and said he found no issues.

Dahl pointed out that the county brought in almost \$200,000 more in sales tax than it budgeted for FY18. “We’ve had a pretty steady incline [since] the recession,” he said.

Sales tax in FY18 was just under \$1.8 million, compared to about \$1.7 million in FY17 and a little over \$1.5 million in FY16.

The total FY18 adopted budget was \$75.6 million.

# Swim teams excel at Woodberry Forest meet

## Girls win first place; boys take second

The Fluvanna County High School girls' and boys' swim teams traveled Dec. 18 to Woodberry Forest, an all-boys private school in Orange County, for an invitational meet. The girls' team took first place, topping five schools from Central Virginia: Madison County, Orange County, Louisa County, Culpeper and Eastern View. The boys' team also topped all these nearby public schools to finish in second place, beaten only by the host school.

Coach Feda Morton said that a number of Fluvanna high school records were eclipsed at this meet.

In the boys' competition, Hunter Strickland swam the 100-yard freestyle in 50.75, easily besting the old record of 51.44. Gus Jones similarly crushed the former school mark in the 100-meter breaststroke, finishing in 1:06.20. The prior record was 1:08.39. The boys' 200-meter freestyle relay team also set a new school record. The team, which

consisted of Hunter Strickland, Connor Bridge, Owen Strickland and Jones, finished in 1:35.22. They beat the previous record by 0:01.62.

The girls' team also set a school record in the 200-meter free relay. The team of Emma DiFazio, Abigail Harlow, Maialen Zabaleta and Abigail Fuller finished in 1:41.74. "We are blessed to have Maialen, our Spanish exchange student, who is one of Spain's national-level swimmers," said Morton.

A number of swimmers and relay teams had State qualifying times. In a sport like swimming, the determination of who is qualified to compete in post-season events is determined by setting elite times that swimmers from all schools in the state aspire to reach. Those who do meet these times during the regular season qualify to compete in the year-end State meet and vie for State titles in their events.

At this meet, on the girls' side, State-

qualifying times were achieved by Harlow in the 100-meter butterfly and 100-meter breaststroke, Zabaleta in the 100-meter backstroke, and Fuller in the 100-meter freestyle. The above-mentioned 200-meter free relay team established a State-qualifying time, as did the girls' 400-meter free relay team. That team consisted of the same four swimmers.

For the boys' team, Hunter Strickland had a State-qualifying time in the 100-meter freestyle, and the above-mentioned 200-meter relay team also had a State-qualifying time.


There were a host of other outstanding performances by Fluco swimmers. First place in the girls' 200-meter IM went to Fuller, and Zabaleta took first in the 50-meter free sprint. The girls' 200-meter medley relay team also finished first. That team consisted of Megan Farist, Olivia Strickland, Grace Farist and Allyson Lounsbury. Second place

finishes were achieved by Lounsbury in the 50-meter free, Olivia Strickland in the 100-meter free and the 100-meter breaststroke, DiFazio in the 100-meter backstroke, Meghan Dech in the 500-meter free, and by the 200-meter free relay team consisting of Olivia Strickland, the two Farist girls and Lounsbury.

For boys, second place finishes were achieved by Hunter Strickland in both the 100-meter IM and the 100-meter free, and by Owen Strickland in the 50-meter free.

Morton said that her swimmers have been working very hard, training before and after school at the Fork Union Military Academy pool.

Next up for the swim team is a busy January schedule. On Jan. 4 they will be at Chancellor. On Jan. 8-9 they compete in the prestigious Ben Hair swim and dive meet. On Jan. 18 they host a three team meet, and Jan. 25 they travel to Harrisonburg.

## Fluco girls lose in double overtime

The Flucos' high-scoring shooting guard Nevaeh Ivory was out injured, so junior point guard Jules Shepherd really stepped up big time. She repeatedly drove hard to the basket late in the game for important lay-ups. Shepherd scored 10 of her team-high 14 in the fourth quarter and overtime.

Freshman post player Khamare Steppe also had an outstanding game with 12 points, including four each in the fourth quarter and the first overtime. She also was a strong rebounder throughout a long game.

This game was a defensive struggle through the first three quarters, but the pace picked up significantly in the fourth quarter and the first overtime.

The Flucos took an early 5-2 lead in the middle of the first quarter on back-to-back driving baskets by Shepherd and junior wing player Mya Wright. A driving basket by the Little Giants at the buzzer put them ahead after one period by 8-7. It was a low-scoring quarter, but not the lowest.

In the second quarter, the Flucos were about the same on offense, scoring only eight points. The highlight for the Flucos was a corner three pointer by junior sharpshooter Maggie Wentz. Waynesboro made a three pointer at the buzzer for a 15-20 halftime score.

Waynesboro scored on lay-up and then on one of two from the line to go ahead by two at 29-31. Steppe then scored on a rebound and the game was tied.

With just under two minutes left, Shepherd hit Steppe underneath with a

nice pass for a lay-up to put the Flucos up 34-33. Waynesboro hit a free throw and a jump shot in the lane to go up 36-34. With 1:45 left, Shepherd drove coast to coast for a very clutch lay-in to tie the score. No one scored in the final minute and a half. Coach White credited Bishop and Shepherd for strong defense on Waynesboro's high scoring guards.

Fluco sophomore Kelise Thomas opened the scoring in the first overtime with one of two from the line. Then, Shepherd again hit Steppe underneath for a lay-in and the Fluco led by three. The Flucos fouled on a three point shot and Waynesboro made all three free throws to tie the score. Shepherd made another coast to coast drive for the lead but Waynesboro made two free throws for another tie. Steppe scored on a rebound as the clock wound down.

However the Little Giants would not give up and found an opening for a jump shot in the lane to force a second overtime.

Both teams worked hard to get good shots in the second overtime. Unfortunately for the Flucos, Waynesboro converted the first two baskets of the session. Shepherd scored on a drive but the Flucos were then forced to send the Little Giants to the line, from which they converted repeatedly. Final score in the overtime was Waynesboro 10 to Flucos 2.

# Reserve academy celebrates graduation

The Fluvanna County Sheriff's Office held its 2018 Sheriff's Reserve Academy graduation at Lake Christian Church Thursday, Dec. 6. The event honored 13 Fluvanna County residents that were chosen among a group of over 50 candidates to become sworn reserve deputies for the agency.

The sheriff's office has increased its reserve division from six to 22 deputies and will max out at 25 for 2019.

The academy consisted of 125 hours of classroom and hands-on training ranging from Virginia law to defense tactics and conducting traffic stops. The academy ended with a culmination event of practical exercises and a final exam.

Beginning in January, the newly minted reserve deputies will conduct 12 months (120 hours) of field training with agency field training officers before they become a functional unit in patrol.

Lt. Sean L. Peterson, reserve opera-

tions commander, assisted in developing the program into what it has become. From early stages of recruitment to a robust academy training outline and instruction, the training was billed as top notch and mirrored similar reserve programs from around the state.

The primary mission of the FCSO Reserves is to assist as a second deputy on patrol, as another sworn asset to the full-time deputy on duty. Additionally, reserve deputies may be called upon to assist with courts, special events in the county, natural disasters, or other needs as directed by the sheriff.

Each reserve deputy is required to purchase all of his or her own gear and uniforms as authorized by the sheriff. This amounts to about a \$1,500 to \$2,000 personal investment. Along with the personal investment in dollars, each reserve deputy is required to maintain a minimum of eight hours per month of volunteer service.

"There is no greater asset to the community than a volunteer," said Peterson. "I am honored and humbled to welcome them all to our law enforcement family. This group of careered county residents stepped up and took an oath to defend, protect, and serve this community, and they are doing it out of selfless service, with zero compensation. Fluvanna County is safer today because of their sacrifice to serve. My goal is to maintain this division at 25 sworn reserve deputies and to continue to foster the best training possible for them."

"What better way to serve your community?" said Sheriff Eric Hess. "Reserve deputies will have the inimitable opportunity to serve their community by helping build trust and legitimacy between the sheriff's office and the citizens of Fluvanna County."

Reserve graduate and Commissioner of Revenue Mel Sheridan said, "My opportunity to spend three months train-

ing with the sheriff's office proved to be both demanding and a tremendous learning experience. I was amazed by the sheer volume of information our deputies are required to know in order to do their jobs. They are professional and dedicated, committed to keeping the citizens of Fluvanna safe. I'm grateful for the chance to support and assist them in my new role as a reserve deputy."
