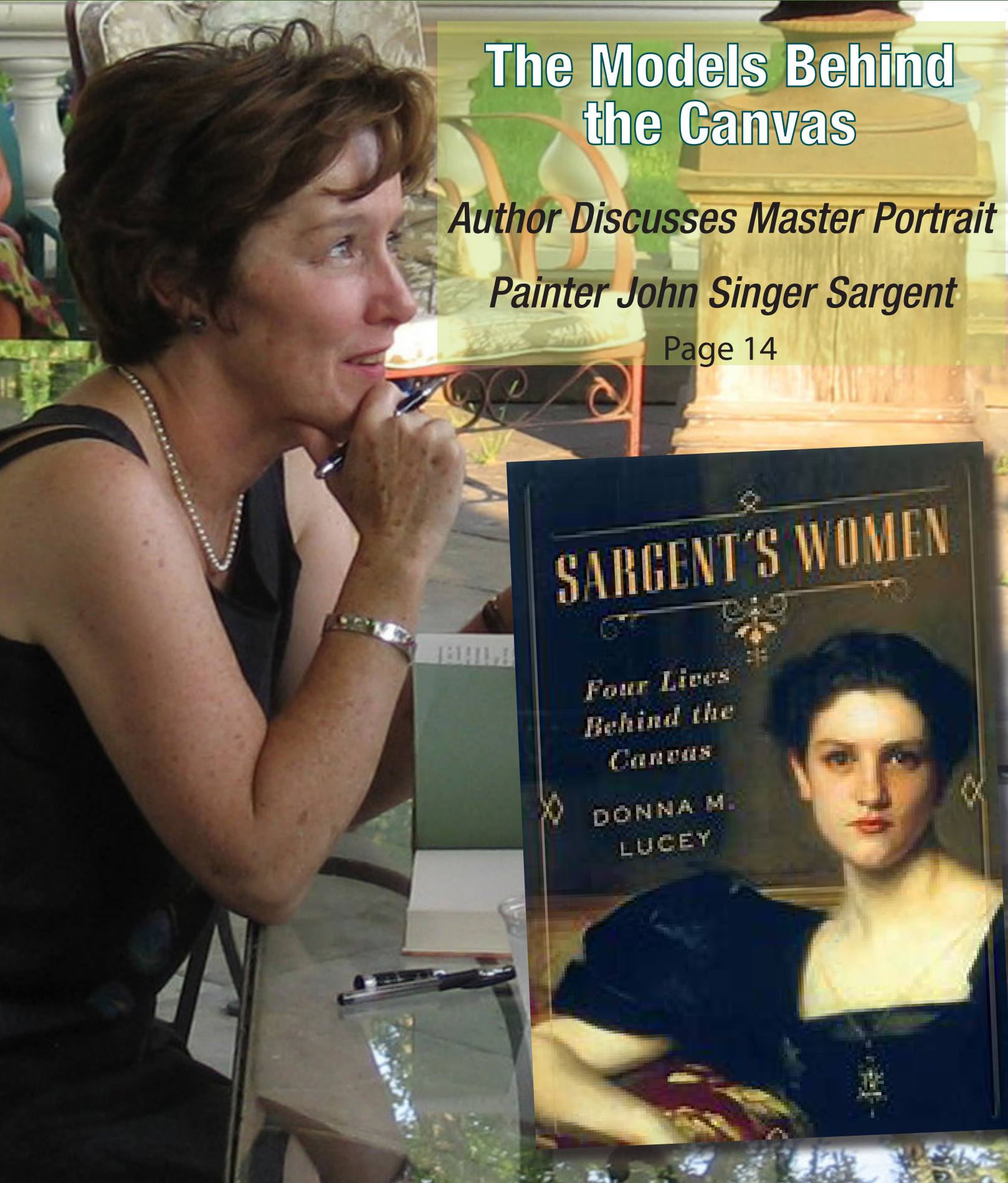

# Cockburn and Riggleman to debate

The University of Virginia Center for Effective Lawmaking (CEL), College Republicans at U.Va., University Democrats at U.Va., and the Frank Batten School of Leadership and Public Policy will co-host a nonpartisan debate between the Democratic and Republican candidates vying for Virginia's 5<sup>th</sup> Congressional District seat in the November midterm elections.

Democrat Leslie Cockburn and Republican Denver Riggleman will face off on Friday, Sept. 28, at 6 p.m. in U.Va.'s Garrett Hall. The debate will be moderated by CEL Director Craig Volden and Batten School professor Gerald Warburg.

"The Center for Effective Lawmaking is delighted to co-host this debate, in order to facilitate dialogue, educate voters, build relationships, and learn more about our future lawmakers," said Volden. "The Center strives to support all representatives who wish to become ef-

fective lawmakers, starting with their first campaigns for Congress and continuing throughout their legislative careers."

The 5<sup>th</sup> Congressional District is of national importance in a midterm election year when control of the House is at stake. President Trump carried the district by 11 points in 2016 while Democrat Hillary Clinton won the Commonwealth by 5.3 points. Virginia has 11 House seats, four of which are currently held by Democrats and seven by Republicans.

"The University Democrats at U.Va. are excited to partner with the Batten School of Leadership and Public Policy, Center for Effective Lawmaking, and the College Republicans to host the VA-05 Congressional District Debate between Leslie Cockburn and Denver Riggleman," said Mary Alice Kukoski, President of the University Democrats at U.Va.. "We hope this debate fosters a lively, policy-focused discussion and encourages Virginians to vote come Nov. 6."

the 5<sup>th</sup> Congressional District an opportunity to see the dichotomy of ideas and positions between the two candidates running for office. Our organization is always ready to promote the exchange of free ideas between differing platforms and we are grateful to the candidates for their willingness to participate."

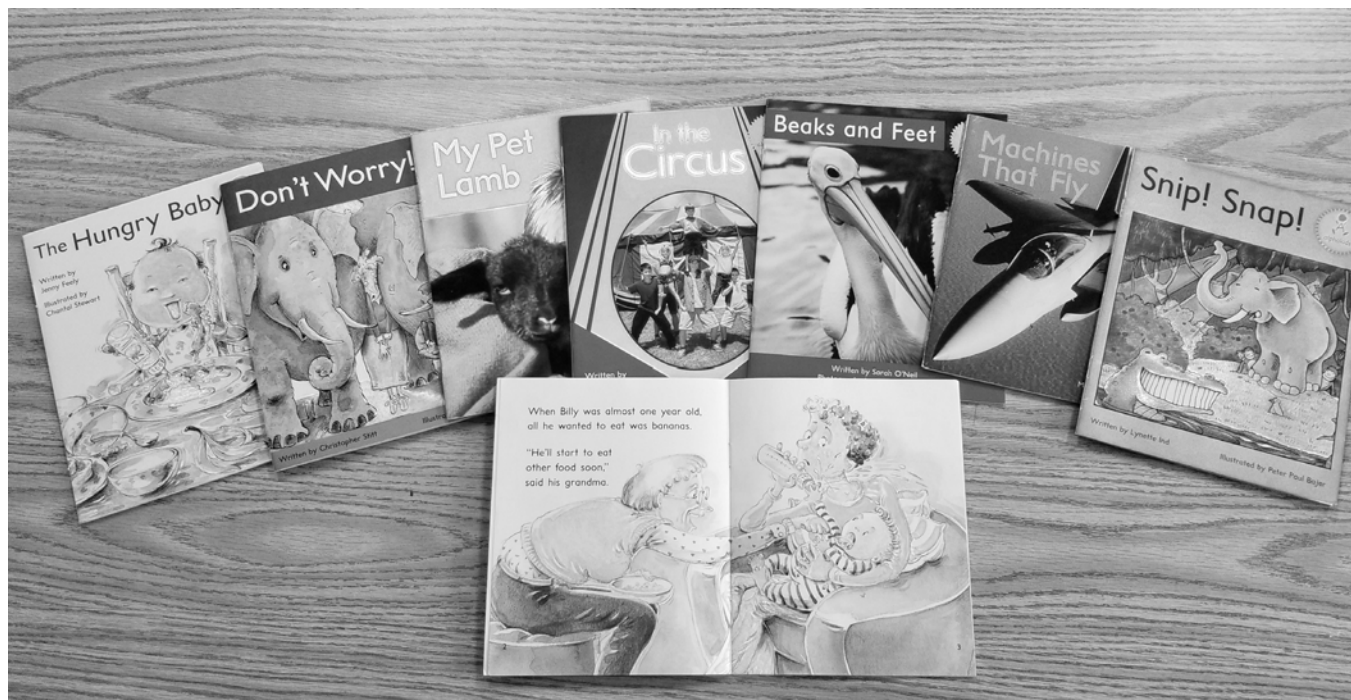
The debate is free and open to the public but tickets will be required due to limited seating. The ticket request portal will open through the U.Va. Arts Box Office at 9 a.m. on Friday, Sept. 14, and remain open until all tickets are distributed. Tickets will be required for entry, along with a valid government photo ID. Tickets may be printed at home or picked up at the Arts Box Office (located within the lobby of the Drama Building at 109 Culbreth Road) beginning Monday, Sept. 17 through Friday, Sept. 28 between noon and 5 p.m.

To foster widespread participation in the debate, any interested individual can submit questions for moderator consideration through an online question submission form until 5 p.m. on Thursday, Sept. 27. Ticketholders will have another opportunity to submit questions in person prior to the start of the debate.



# Community volunteers make a difference for early readers

Children who are read to, who are surrounded by adults who cherish books, have an advantage.

Unfortunately, many children come to school having rarely been read to.

Book Buddies at Central Elementary is on a mission to change that.

Carol O'Dell said Book Buddies is a school-based tutoring program that uses community volunteers to help build life-long reading habits with their students.

She said first and second grade teachers spend the initial weeks of school figuring out which students might benefit most from the program.

"It's not always a child who struggles with reading, it could be a child who just needs one-on-one attention," O'Dell said.

The program has structured, monitored, lesson plans – written by reading specialists – that focus on reading comprehension, sight words, and writing.

Volunteers are trained to work one-on-one with students weekly to foster a love of reading and to strengthen their reading skills, O'Dell said.

During the 2017-18 school year there were 36 students in the Book Buddy program reading with 10 volunteers.

Perhaps one of the best benefits of the program is the bond developed between the volunteers and their students, said Megan Snoddy, a second-grade teacher.

She said she loves having these volunteers working with her students.

"The book buddy volunteers who have served my students have not only helped

them improve their reading skills, they have enhanced the students' self-confidence and love of reading," Snoddy said. "All my students who have been privileged to work with a book buddy have always been excited about the special time they could spend with an adult and the new relationship they formed."

It's enough to keep the volunteers coming back, O'Dell said.

"Many of our volunteers return faithfully each year and have now been working with our Book Buddy program for over five years," she said. "We are so appreciative of the time they give to support our students and always welcome new volunteers."

The students enjoy it, too.

O'Dell asked one of Doug Wylie's students about the program and he said, "I liked how he helped me read the words."

A student who worked with volunteer Suzanne Dolan said: "I was doing fun stuff. I liked reading to her."

At the end of the school year, Central recognizes volunteers for their dedication and service, said Amy Barnabei, principal.

"A brunch at the end of the year provides yet another opportunity for our staff and students to thank them personally for their diligent service to our school," Barnabei said.

**According to the National Center for Education Statistics (NCES), a division of the U.S. Department of Education, children who are read to at home enjoy a substantial advantage over children who are not:**

Twenty-six percent of children who were read to three or four times in the last week by a family member recognized all letters of the alphabet. This is compared to 14 percent of children who were read to less frequently. The NCES also reported that children who were read to frequently are also more likely to:

- Count to 20, or higher than those who were not (60 percent vs. 44 percent)
- Write their own names (54 percent vs. 40 percent)
- Read or pretend to read (77 percent vs. 57 percent)

# Attempted child abduction at Lake Monticello

A man attempted to abduct a child Friday (Sept. 7) at around 7 a.m. as the boy was walking toward a school bus stop, according to a press release from the Fluvanna County Sheriff's Office.

The Fluvanna County Emergency Communications Center received a call from a parent who said that an unknown white male with a beard had grabbed her child and attempted to pull him into a black sedan, according to the press release.

The child was able to break free and fled to his home. This incident occurred in the 800 block of Jefferson Drive inside the Lake Monticello community.

Lake Monticello Police and the Fluvanna County Sheriff's Office responded to the area to investigate but were unable to locate the suspect vehicle in the area. The investigation is ongoing.

The sheriff's office released an update Monday (Sept. 10) stating that the suspect vehicle may be a dark-colored

sedan with white stripes, dark windows, peeling paint on the door and possibly spoked-style wheels.

According to a Facebook post by the mother, the man asked the boy if he "wanted to go somewhere with him." When the boy refused, the man grabbed his wrist and tried to pull him into his car. The boy "kneaded" the man in the stomach and ran. The man followed in his car but the boy managed to escape.

Anyone who may have seen this incident or noticed any person or vehicle matching that description in the Lake Monticello area during the morning hours of Sept. 7 is asked to call Investigator Brandon Bryant with the Fluvanna County Sheriff's Office at 434-589-8211.

The sheriff's office and the Lake Monticello police will be conducting extra patrols in the area around bus time for an extended period of time to help ensure the safety of the children getting off the bus, according to the release.

## Pub discount snubs homeowners

As a Lake Monticello homeowner, I was stunned to see the latest ad for The Pub on page 13 of the Sept. 6 issue.

"Welcoming" Fluvanna County (and others) with a 10 percent discount, the ad singles out "non-Lake diners" for this special discount to the exclusion of all homeowners paying LMOA dues and fees and subsidizing the money-losing food operations at the Lake.

From the treasurer's notes, food and beverage update, July 31, 2018:

- Loss (2018): Payroll/COGS = \$60,888
- Loss including indirect costs (not counting depreciation of \$34,538) = \$142,184.

The Pub accounts for 74 percent of total food and beverage losses, and we are on track for a nearly \$300,000 loss for the year, subsidized by Lake homeowners. In my five years at the Lake, I have been dismayed by the turnover in food and beverage management and staff, funds spent on expensive kitchen improvements only to have the operator leave, and directors describing our food and beverage facilities as a "goldmine." The presence of a director behind the bar at The Pub was soon followed by the departure of the restaurant manager. The most recent departure, of Robert White for his "job of a lifetime," was opaque to say the least. Why did he leave? Where did he go?

The LMOA is ill-suited to be in the highly competitive restaurant business and is not likely to turn a profit in the foreseeable future. And to snub the homeowners who are footing the

bill for this misadventure is beyond the pale. This outrageous discrimination is enough to give one indigestion.

On August 15, 2018, Columbia Gas of Virginia, Inc. (“CVA” or “Company”), filed with the State Corporation Commission (“Commission”), pursuant to the Steps to Advance Virginia’s Energy Plan (SAVE) Act, Chapter 26 of Title 56 (“SAVE Act”) of the Code of Virginia (“Code”), an application (“Application”) for approval to implement a 2019 Infrastructure Reliability and Replacement Adjustment (“IRRA”).

Section 56-604 A of the SAVE Act allows CVA to recover SAVE eligible infrastructure costs (as defined in Code § 56-603) through a SAVE Rider, which is defined in the Company’s tariff as the IRRA. Accordingly, CVA requests authority to implement a 2019 IRRA in accordance with Section 20 of its General Terms and Conditions, as contemplated in the Commission’s November 28, 2011 Order Approving SAVE Plan and Rider in Case No. PUE 2011-00049, and most recently modified by the December 13, 2017 Order Approving Amended SAVE Rider for Calendar Year 2018 in Case No. PUR-2017-00095. The 2019 IRRA comprises a 2017 Infrastructure Replacement Reconciliation Rate (“IRRR”) and a 2019 Infrastructure Replacement Current Rate (“IRCR”) and is billed as a combined fixed charge each month. The 2017 IRRR is designed to true-up, on an annual basis, the actual IRRA revenues against the preceding year’s actual cost of service as determined from actual SAVE-eligible expenditures. The 2019 IRCR is designed to recover projected costs associated with SAVE-eligible infrastructure replacements during calendar year 2019.

In its Application, the Company seeks approval of the following: (1) the Company’s 2017 IRRR credit in the amount of \$57,361; (2) the Company’s 2019 IRCR in the amount of \$2,201,015; and (3) the filing of rate sheets implementing the 2019 IRCR and 2017 IRRR. The 2019 IRCR and the 2017 IRRR result in an IRRA total net charge to customers of \$2,143,654 for 2019. The Company requests that the 2019 IRRA be effective with the first billing unit of January 2019 through the last billing unit of December 2019. The Company’s 2019 IRRA proposed monthly rates by rate schedule are as follows: Residential Sales Service/Residential Transportation Service, \$0.53; Small General Service 1/ Small General Transportation Service 1, \$0.56; Small General Service 2/Small General Transportation Service 2, \$1.58; Small General Service 3/Small General Transportation Service 3, \$4.87; Large General Service 1/Transportation Service 1, \$46.25; and Large General Service 2/Transportation Service 2, \$221.78.

In its Application, the Company further requests that the Commission deem sufficient the schedules provided as Attachments A and B to the Application for this and future SAVE Plan filings. Additionally, the Company requests that the Commission relieve the Company of the requirement to submit to the Division of Utility and Railroad Safety a prioritized list of M&R Stations to be addressed using SAVE funds within 60 days prior to the initiation of any SAVE-related work.

The details of these and other proposals are set forth in the Company’s Application. Interested persons are encouraged to review the Company’s Application and supporting testimony and exhibits for the details of these proposals. While the total revenue that may be approved by the Commission is limited to the amount produced by the Company’s proposed rates, TAKE NOTICE that the Commission may approve revenues and adopt rates, fees, charges, tariff revisions, and terms and conditions of service that differ from those appearing in the Application and supporting documents and may apportion revenues among customer classes 96and/or design rates in a manner differing from that shown in the Application and supporting documents.

The Commission entered an Order for Notice and Comment that, among other things, directed the Company to provide notice to the public and provided interested persons an opportunity to comment on the Company’s Application.

A copy of the Company’s Application may be obtained at no charge by requesting a copy of the same from the Company’s counsel, T. Borden Ellis, Esquire, and Bryan D. # Smeds leads girls' cross country at Ragged Mountain run

One of the premiere events of the local cross country running season is the Ragged Mountain run held each year at Panorama Farms in Earlysville. This year the event was held Sept. 5.

Teams of four runners per squad compete in a two mile per runner relay. Times are also recorded on an individual basis so that there is a ranking for teams and a ranking for individual participants.

This year Fluco sophomore running standout Emily Smeds recorded the fastest time of any of the female runners. She turned in a two-mile time of 12:31, which was the fastest time by eight seconds. A winning margin of eight seconds is impressive in an event such as Ragged Mountain which includes many elite runners.

Schools in this competition may enter multiple teams, and running powerhouses Albemarle and Western Albemarle each took two of the four top team spots in the relay. The Fluco top relay team took seventh place, out of 22 teams in the relay race. Therefore, the Fluco finished fifth on a school by school basis.

The other three runners on the Fluvanna relay team turned in very credit-

able times. The second runner in the relay for Fluvanna was senior Brianna Parker, who finished in 15:25. The third runner for the Flucos was sophomore Emily Beckman, whose time was 14:11, which was good for 24th overall out of 88 runners. The fourth leg for the Flucos was run by junior Hallie Lintecum, who completed the two miles in 15:20.

The Flucos also entered a B and a C team in this event. Although these teams finished fairly well down in the standings, three of the runners came in at under 16 minutes. Running on the B team, junior MaryAnn Chittenden finished in 15:14, a slightly faster time than two of the A team runners. Competing on the C team, junior Kieri Hart finished in 15:53, while sophomore Samantha Clarke ran two miles in 15:56.

While this is probably a building year for Coach Rose Brogan after the loss of several top runners to graduation, Smeds and her teammates appear to be able to compete on the high level that Brogan's team has achieved for many years.

# USA Today names Barboursville Vineyards as top-10 winery restaurant and hotel

When travel writers for *USA Today* got together to think about their best wine country experiences, both culinary and restful, they put together an impressive list that stretched across America.

Places like Napa, Calif., Geneva, N.Y., Paso Robles, Calif., and Eugene, Ore., were chosen.

But there was only one place that earned a place on both lists: Barboursville, Va.

*USA Today* listed Barboursville Vineyards' Palladio among its top 10 Winery Restaurants in America. Not only that, but Barboursville's 1804 Inn also made the top 10 for Best Wine Country Hotels in America – the only instance where a single entity made both lists.

Here's what the writers said about Pal-

ladio: "Virginia ingredients meet northern Italian recipes at Palladio Restaurant, with the duo of Executive Chef Spencer Crawford and Sommelier Alessandro Medici at the helm. A hearty meal here might include estate-raised Berkshire speck with melon, chilled green tomato gazpacho with Chesapeake blue crab, roasted Cornish game hen with warm potato salad and a seasonal tiramisu to polish it off."

This is what they said about The 1804 Inn: "Occupying several historic plantation houses and cottages next to the National Landmark ruins of a Thomas Jefferson-designed mansion, The 1804 Inn is owned and operated by Barboursville Vineyards. It's a perfect base for exploring the rest of the estate, as well as

the surrounding Virginia Piedmont wine region."

It was the latest instance of national recognition for the vineyard and winery that was established in 1976 by Gianni Zonin as his first and only vineyard outside of his native Italy, where his family has been making wine since 1821.

Barboursville Vineyards is frequently recognized among the leading winemaking entities not only in Virginia, but in the nation. Its signature Octagon blend and other varietal wines have taken medals from major competitions on both the east and west coasts and received special recognition from nationally known wine critics.

For Luca Paschina, winemaker and general manager of Barboursville, it all

begins and ends with the wine, though world-class dining and accommodations dovetail with the viticulture.

"We started with the 1997 and 1998 vintages to produce what we considered to be a world-class wine with Octagon, cabernet franc and Nebbiolo, and so I strongly suggested to the owners that the best way for us to promote the wine was to open a restaurant," Paschina said.

"It wasn't to just open a restaurant and make some money on a restaurant. We believed that when people come, they would not only find great wines, they would also find the type of hospitality you see in the old-world wine country."

The Inn, a Georgian dwelling in two parts on the property that was once a plantation owned by former Virginia Governor and Senator James Barbour, contains three suites and was established almost simultaneously with Palladio.

All three of Barboursville's efforts – wine making, fine dining and luxury accommodations – continue Zonin's dedication to preserving the heritage of a remarkable farm that dates back more than two centuries.

The winemaking follows through on Thomas Jefferson's dream that someday world-class wines could be produced in the nation he helped found, even though he was unsuccessful in his efforts to establish a vineyard on his own property just a few miles away from that of his friend Barbour.

Palladio borrows the surname of

# The models behind the canvas

## Author discusses John Singer Sargent

It took author Donna M. Lucey eight years to write her book about master portrait painter John Singer Sargent and the high-society women of the gilded age he immortalized on canvas. Lucey discussed her latest book, *Sargent's Women: Four Lives Behind the Canvas*, with the Friends of the Library at their Sept. 5 meeting.

Lucey is an award-winning author and scholar. She is the recipient of two NEH grants and is a 2017 writer-in-residence at Edith Wharton's home, The Mount. She chose four women out of the 900 women Sargent painted, because they were American and because of their geographical locations.

"I visited the places where these women lived, rummaged through attics, read letters and diaries and discovered many twists and turns in their stories," said Lucey. She conveyed the excitement she experienced as she read their innermost thoughts and compared them with what Sargent saw as he painted.

She began by reading the exquisitely written introduction to the book. Lucey brings her readers back into a time when women lived in the shadows of their fathers and husbands and their social standing was defined by wealth. She showed Sargent's defining moments when he is commissioned to paint these women, spending time with them and befriending them.

Sargent captured the passions, desires and character of these women who defied the norms of their times, testing the limits of impropriety and engaging in the unexpected. After a while, Sargent himself grew to despise portraiture. Some may wonder if he had any relations with these women but Lucey stated it was rumored he was homosexual.

### Elsie Palmer

"Elsie Palmer was 17 when Sargent painted her and it took him over a year to complete it," she said. She had changed

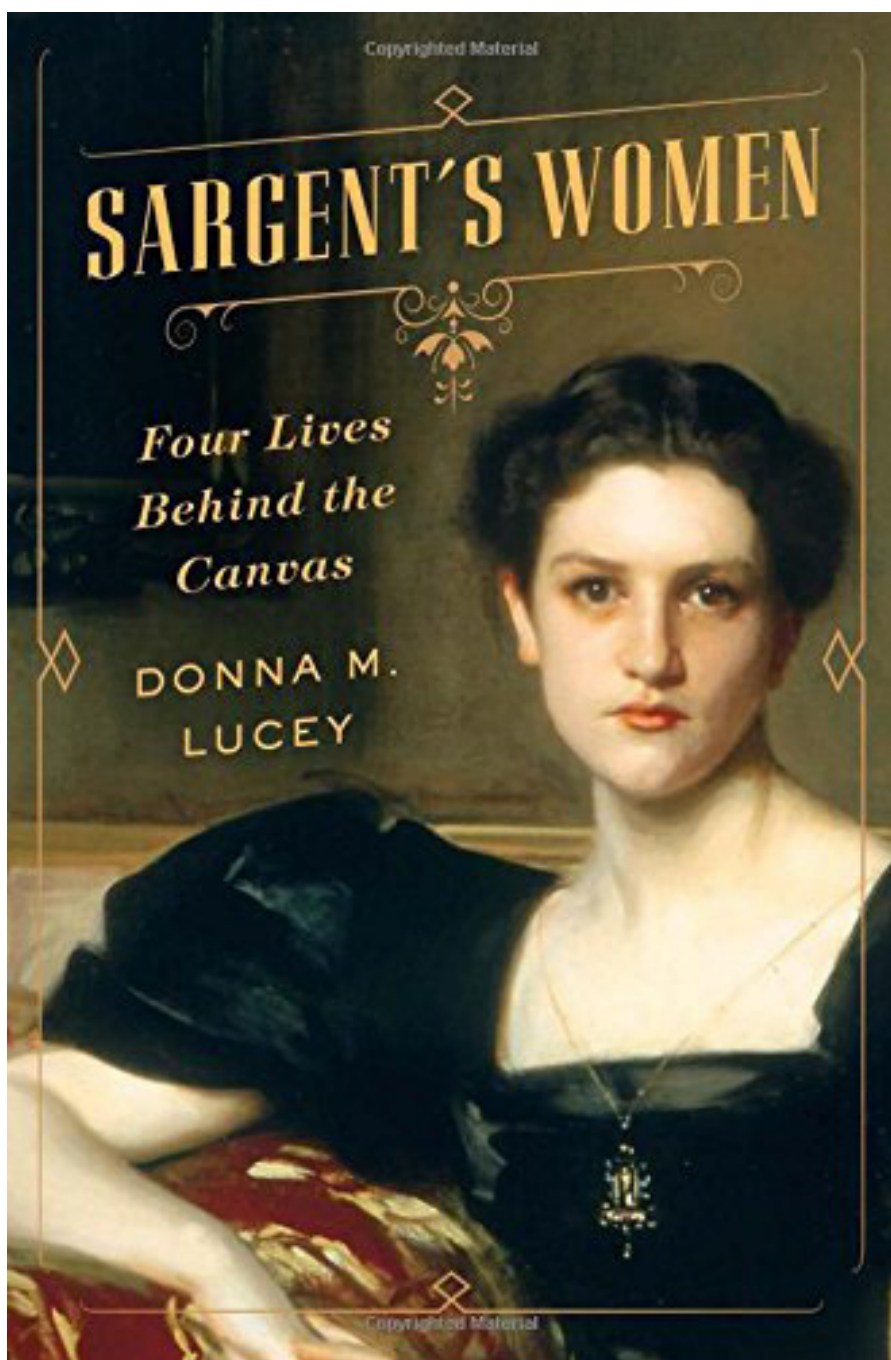
a lot in that year from when Sargent began until he finished it. Elsie's father and grandfather's wealth came from the railroads and mining and her grandfather founded Colorado Springs. "Elsie Palmer had lived in New York City at the Dakota but mostly traveled between her father's Rocky Mountain castle and the 14<sup>th</sup> century English manor house where her mother took refuge, surrounded by artists, writers, and actors." This was a common thread among these women who were surrounded by writers and artists like Sargent; they were influenced by ideals larger than what they knew and yearned for something outside their current lives.

"Elsie falls in love with her mother's friend, Peter Harrison, who is also falling in love with her and takes her back to New York and becomes her guardian," said Lucey. "Not a good thing – but then he falls in love with her younger sister and dumps Elsie." She then ended up taking care of her father when he became a quadriplegic as a result of a riding accident. "She later married Leo Howard, a

spiritualist from England. It was an epistolary romance.” She added that it was the fad then to engage in seances and spiritualism. “When she married him she wore a wrap adorned with bronze buckles and little animals. Elsie was considered strange and led a strange life.”

### Sally and Lucia Fairchild

Sargent’s painting of Sally Fairchild at 21 was one of a few he painted of her, but this one was outdoors, and she had a veil over her face. Sally was considered the more beautiful of the two sisters; her younger sister, Lucia, was known as the ugly duckling. Yet, as they matured, Lucia was just as beautiful. Lucia adored the workaholic Sargent, who became her friend and mentor when she took up art. Later, she attended the Cowles Art School and the Art Students League of New York, and became an accomplished American artist in her own right.

“When she became interested in Henry Fuller, she asked Sargent if she should marry for love and Sargent replied, ‘Absolutely not;’” Lucey said. She married Harry and both of them abandoned the conventions of their wealthy lives and

went to live a Bohemian life in an artist’s colony in Cornish, N.H. Lucey described the colony as one of those places where being free of societal norms, progressive thought and being risqué was acceptable. “Harry’s models were all naked,” she said. She showed one of his paintings featuring his wife and daughter Clair, both naked.

By 1889, Lucia began painting professionally and produced mainly miniatures. She was awarded numerous medals for her work at expositions and founded the American Society of Miniature Painters. She was also a member of the New York Watercolor Club.

“She painted miniatures for many wealthy families, but they never paid her a decent price for her work.” Lucia didn’t limit herself to small scale work and exhibited at the Palace of Fine Arts and her mural *Women of Plymouth* in The Woman’s Building at the 1893 World’s Columbian Exposition in Chicago.

Eventually, she hit hard times; Fuller proved to be a womanizer and she found herself stranded in New York with her two daughters. She wasn’t feeling well herself and eventually lost her sight to

multiple sclerosis.

She died in 1924 of MS and Harry ended up in a trailer park.

### Elizabeth Astor Winthrop Chanler

“Elizabeth Astor Winthrop Chanler limped into his studio at the age of 27,” Lucey said.

She grew up in Rokeby, in the Hudson Valley of New York, while her father lived in New York City. She lived in a chaotic household with 10 children as the third oldest, and was raised by a cousin and servants.

As was the trend back in those days, wealthy families married their daughters to English noblemen for their titles, and in turn the English noblemen gained vast wealth through marriage to keep the estates going. At the same time, many sons of wealthy Americans were schooled in England as were two older brothers whom the 11-year-old accompanied to England.

“She was then enrolled in Bonchurch, a school on the Isle of Wight, off the southern coast of England,” said Lucey. “The school was run by three old maid sisters who frowned upon wearing anything scarlet or reading Dickens.” The school housed eight girls aged 14 to 18, all English, and this left Elizabeth feeling out of place and homesick. After her father died, the family left her at the school, making her one of the Astor orphans.

To make things worse, because of her physical problems and difficulty walking, she was sent to the Royal Orthopedic Hospital in London for treatment, which included the use of a backboard. She returned to the school and wanted to return to Rokeby but everyone felt the house was too chaotic for someone so fragile.

“At 21 she inherited money from her father and then she became close friends with John Jay Chapman (related to Justice John Jay), and his wife, and she fell in love with him,” she said. “He was an intense man, and while he was at Harvard studying law, he took a cane and almost struck a fellow student. When he went home, he was so horrified at what he almost had done he put his arm in the fire and burned most of it off.” Gasps rose from the audience trying to imagine why anyone would do this.

“His wife died in childbirth but both realized at the time that because of the time it took to mourn, a year or so, it was frowned upon to be seen together after the death of a spouse so they met in secret and finally married when the Spanish-American War broke out because it was an uncertain time and marriages were permitted,” Lucey said.

The next installment of Elizabeth’s life took one of those unexpected turns when her husband had a complete mental breakdown, lying in a fetal position in the attic, and she ended up caring for her son and her two step children.

### Isabella Stewart Gardner

The New Yorker, iron-willed Isabella Stewart Gardner, shocked Boston society and at first Sargent loathed her. Later, however, she became Sargent’s greatest patron and friend.

“She’s not a woman but a locomotive,” said Sargent. She broke through the stuffy, provincial norms of Boston society with her scandalous portrait and stylish New York fashions, not to mention dancing with men who were not her husband. She was not as attractive as the other three women Lucey spoke about, but she made up for it with her flamboyancy.

After she married, she lost her first child before two years of age and miscarried the next and was told she would never have any more. She took to her bed and became sickly, but then the old Isabella emerged when she began to travel. She also studied classical education.

“Traveling was normal for the wealthy in those days and sometimes you would be gone for over a year,” Lucey said. While in Egypt, Gardner would play in the sand, “feeling ancient Egypt.” Both she and her husband, John Lowell Gardner II, became patrons of the arts. While he funded her trips, she collected art from all over Europe, beginning with a Vermeer. In later years she created and built a museum out of her sprawling home in Boston. And the Isabella Stewart Gardner Museum remains a tribute to her effort to preserve great works of art.

“In her will she stated that nothing was to be moved in the museum except for cleaning or restoration. If it was then everything would be sold in Paris and donated to Harvard.” She added that every year an official from Harvard checks to see that everything is in place and there is no violation.

Like many famous women of the gilded age, she left a legacy in the arts and culture that would educate future generations. Breaking through the barriers that suppressed women of her time midst the gossip and scandal of a provincial Boston society, she brought European culture to the Back Bay. It is only fitting that Lucey’s story of these three women all circle back to the man who first painted them, John Singer Sargent. His last portrait of Gardner was after she suffered a stroke and, trying to hide the fact, he draped her all in white and painted her for the last time. Today, his work hangs in her museum.

Emelie Palladio, an Italian Renaissance architect whose works and writings greatly influenced Jefferson’s own architectural endeavors, including the manor house that he designed for Barbour. That manor house burned on Christmas Day in 1884, and the ruins have been preserved on the Barboursville estate.

It is the octagon-shaped sitting room of that manor house that contributes the name of Barboursville’s flagship wine.

“It’s still a working farm,” Paschina said of the property. “So we live off viticulture, and that’s what makes the place unique.”

The recognition of Barboursville as an exceptional wine country destination is especially important and gratifying for Paschina, who has been at the helm since 1990.

“We have invested in featuring our wines in great restaurants in the U.S. and some in Europe. It puts us in front of potential customers. We have people who have come here just because they have tasted a great glass of wine,” he said.

The Palladio’s wine and food pairings that fuse northern Italian cuisine with local Virginia ingredients are accomplished by Crawford and his team in the kitchen, along with Sommelier Professionalista Alessandro Medici.

The 1804 Inn immerses clients in the property’s history – a history that is recorded in its various original dwellings.

At the top of the list is a classic Georgian villa, The 1804 Inn, that predates by a generation the construction of Governor Barbour’s mansion which it overlooks. The villa’s three suites are each named for one of the vineyard’s signature wines: Octagon, Malvaxia and Philéo.

The 18<sup>th</sup> century Vineyard Cottage, originally constructed for domestic servants, is one of the oldest dwellings in continuous occupancy at Barboursville. It is partitioned into two bedroom-sitting room accommodations and is named for two wines, the Barbera and Nebbiolo suites.

The “newest,” dating from the early 20<sup>th</sup> century, is a gardener’s cottage from the estate’s sheep-grazing days. The Sangiovese Cottage offers the scale and facilities to accommodate longer stays.

The Blue Run Cottage is a 19<sup>th</sup> century frame residence and dispensary for a physician and his family. The cottage was then Barboursville’s winemaker’s house for 30 years, and now offers three suites, named for three grapes: Pinot Grigio, Moscato and Vermentino.
