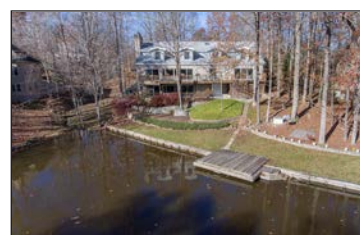

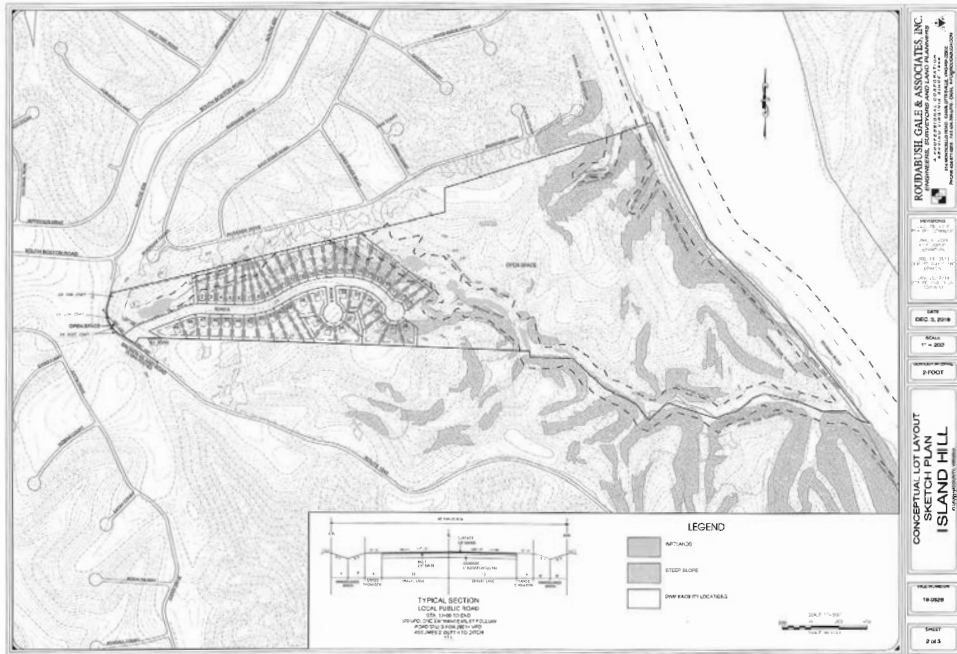

New Island Hill development upsets neighbors

Residents from two neighborhoods met at Fluvanna County Public Library last Monday (March 25) to discuss Island Hill, a controversial new housing development planned for

the entrance to Broken Island Road.

Southern Development bought the 115-acre parcel earlier this year. According to planning documents submitted to the

county in January, the company envisions 49 homes built on approximately 25 acres, with the 90 remaining acres left undeveloped.

The Planning Commission preliminarily approved Island Hill Feb. 12.

About 40 residents from Broken Island Road and Lake Monticello's Riverside section met to talk about their concerns regarding the impact the development might have on local traffic, the environment, and the view from their own backyards.

Lee Hinkle, who just moved near the entrance of Broken Island Road, could find her five-acre property abutting up to six new houses. She said she's had lengthy discussions with members of the county Planning Commission and representatives of Southern Development about their plans for the land.

Hinkle's son, Eric Quackenbush, is a Richmond-based architect. He gave a presentation on how rural cluster developments can be planned to best preserve the natural

landscape.

"It doesn't seem like a cluster development," said one resident, looking at the plans submitted to the Planning Commission. "It seems more like a clump development."

"I do not disagree with you," said Quackenbush. Local jurisdictions decide what they think a cluster development should be, he said, and "Fluvanna County zoning has some holes in it."

Residents expressed anger that there had been no prior warning a development was in the works.

Under county zoning rules, a rural cluster development is allowed for the parcel as a "by right" use, and the developer was not required to hold a public meeting.

Supervisors Tony O'Brien (Rivanna) and Trish Eager (Palmyra) were on hand to answer questions about county's role in the planning process.

Asked if community pressure on the Board of Supervisors might have an effect, O'Brien explained that, while they received presentations on the development, their part in the process was limited.

"It'll never even come to us," said O'Brien. "It's an administrative decision."

O'Brien added that supervisors could use community input and recommendations to potentially improve county zoning rules regarding rural clusters in the future – but cautioned those rules couldn't be applied retroactively to developments like Island Hill.

After more than an hour of discussion, the group decided to start a petition to the county about their concerns, and there were tentative suggestions about hiring a lawyer to represent the residents going forward.

Most seemed resigned to the inevitability of the development.

"It sounds like it's a done deal and there's nothing we can do about it," said one Riverside Drive resident.

Hinkle struck an optimistic note. She agreed that it probably wasn't possible to stop the construction, but they might be able to play a role in Island Hill's final design and implementation.

"I think if there's enough pressure we could have an impact," she said.

Is Home Equity Loan Interest Still Deductible?

There is a lot of confusion about home equity loans following the passage of the Tax Cuts and Jobs Act (TCJA). The act changes the rules on whether the interest on these loans is deductible. So is it?

The short answer: Not unless you've used the money to buy, build or substantially improve your home!

THE IRS INDEBTEDNESS RULES

Taxpayers have been using home equity loans to finance home improvements for decades. But they've also used them for alternative purposes, such as paying off credit card debt, paying for big purchases, or simply to finance living expenses.

Beginning in 2018 these alternative purposes are no longer allowed! Previously, you could deduct up to \$100,000 interest from a home equity loan not spent on your home. Now only **acquisition indebtedness** interest, i.e., used to buy, build or substantially improve your home, is deductible.

Example: Sam took out a \$100,000 home equity loan to consolidate his debts 2015, lowering his annual interest rate from 12% to 6% and allowing him a \$6,000 itemized interest deduction. In 2018, Sam will no longer be able to deduct those interest payments because the loan was not used to for **acquisition indebtedness!**

WHAT YOU NEED TO KNOW

- **Lower debt limits.** The limits on home mortgage for loans after Dec.

15, 2017 drops from \$1 million to \$750,000.

- **Less deductible interest.** Only interest on home equity loans used to build, purchase or substantially improve your home is deductible.
- **Enforcement challenge.** We don't yet know how the IRS will enforce this rule. Your best bet is to document and retain any receipts for home improvements in case of an audit or challenge to the deduction.
- **Don't confuse terminology.** Don't get confused by the different terms the IRS and your bank use to refer to your loan. The IRS doesn't care what the bank calls the loan; it only cares how you use the funds.

When you get ready to file your tax return, make sure a review of interest is on your list. Please call or email us with any questions you may have about preparing your taxes. Remember, we are here to help take the complications out of filing your taxes!

Eight years marked since Hourihan disappeared

April 8 marks the eight-year anniversary of the disappearance of Robert Lee Hourihan.

Hourihan was last seen April 8, 2011, around 8 a.m. at E.W. Thomas Grocery Store in Palmyra. He was wearing blue work pants and a gray work shirt with brown boots, and driving his wife's 2004 white Chevy Cavalier with a Virginia personalized tag reading TARAMAE.

It was initially believed that Hourihan was traveling to work in Richmond that morning, but the investigation has revealed that may not have been the case.

While investigating his disappearance, the Fluvanna County Sheriff's Office has learned that Hourihan was to meet an acquaintance, Daniel Boyd Fennel of Palmyra, on the morning of April 8, 2011, in Fluvanna. Fennel told investigators that Hourihan never arrived for their meeting.

Hourihan's vehicle was later discovered

abandoned in a Target store parking lot in La Plata, Md., on May 28, 2011. Even though eight years have passed, investigators still believe that there are people out there with critical information regarding this case. Foul play is suspected in Hourihan's disappearance.

Hourihan's wife, daughter, parents and brother are still desperately seeking answers as to what happened to him. The sheriff's office is saddened it has not been able to provide the family with closure in this case and asks anyone with information to contact CrimeStoppers at 434-977-4000 or Capt. David Wells of the Fluvanna County Sheriff's Office at 434-589-8211.

A cash reward is available for information that leads to the whereabouts of Robert Lee Hourihan. Please help bring closure to the Hourihan family.

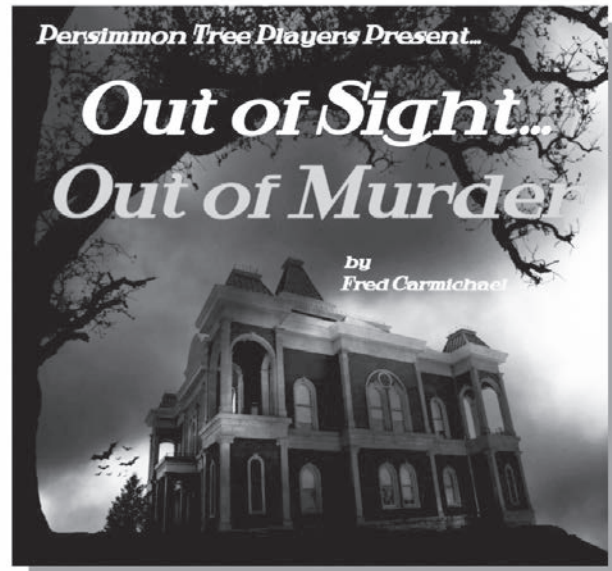

Supervisors advertise 4.7 percent tax increase

The Fluvanna County Board of Supervisors decided Wednesday (March 27) to advertise a real property tax rate of 93.5 cents per \$100 valuation.

The current equalized tax rate is 89.3 cents, so if supervisors adopt the advertised rate, taxes will increase by about 4.7 percent.

Supervisors are not locked into this rate and may decide to set taxes lower than 93.5 cents. They cannot set the rate higher, however, without restarting the advertising process.

At 93.5 cents, the budget includes about \$450,000 in additional money for the schools, a new sheriff's deputy and vehicles, and three new vehicles for the fire department.

Supervisor Don Weaver was the only one to vote against the advertised rate.

The board will hold a public hearing on the budget and tax rates April 17 at 7 p.m. in the Fluvanna Circuit Courtroom. They are scheduled to finalize the budget and tax rates April 24.

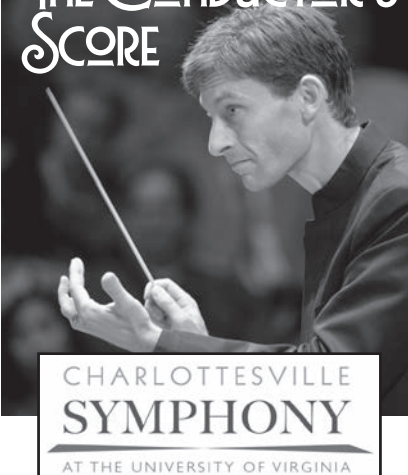

School Board considers new social studies textbooks

At the March 13 School Board meeting the administration presented the high school social studies textbook recommendations from the review committee for purchase.

It was a first look for the board.

Andrew Pullen (Columbia) said he wanted to get copies to look over.

Brenda Gilliam, executive director of instruction and finance, said copies were at the administration office and the high school. Anyone can stop in and read through the proposed textbooks.

The board plans to take a second look at the proposal at its April 10 meeting. Any Fluvanna resident wanting to speak to the board can do so at that meeting.

The recommended books are:

- *Civics* – Houghton, Mifflin, Harcourt;
- *World Culture and Geography Survey* – Cengage/National Geographic;
- *America, A Narrative Story* – W.W. Norton;
- *Sociology* – Houghton, Mifflin, Harcourt; and
- *Virginia and United States History* – Pearson.

The total cost for teacher's editions and copies for students is \$49,031.40.

The *Fluvanna Review* sent an email to Gilliam asking about the process of choosing textbooks. It also asked her how many times she'd been through the textbook selection process.

Gilliam replied that the state offers a list of approved textbooks but schools are not required to use books on that list. Any choice is expected to meet the Virginia Standards of Learning.

The school forms a committee of parents, teachers, administrators and community members to review the books, then makes a recommendation to the board.

Gilliam said she's done this many times in her career.

"This is probably the eighth time I

have gone through the textbook adoption process," she wrote in an email. "The level of feedback that we have received from the School Board or public has varied over that time. We had originally planned to ask for action on the item at the April School Board meeting. Since there have been some concerns expressed we are planning to move the action until May. This will give the committee time to address any concerns or questions that have been raised."

Pullen posted on his Pullen for Fluvanna School Board Facebook page that he found "issues" with one of the textbooks.

"This is why it is incumbent upon us to ensure that we know exactly what is being taught to our children, that what they're reading is objective and that history lessons are not being motivated by outside political [sic] forces," Pullen stated in his post.

When prompted by a commenter to cite what his concerns were and on what page, Pullen said, "I've found a lot of historical inaccuracies and discussion about 'privilege' or other terms that are politically, rather than historically driven."

Asked several more times from readers of his page to cite specifics, Pullen did not respond.

The *Fluvanna Review* emailed each School Board member asking what they understood about FCPS textbook selection process, if they agreed with it and if they had any concerns. If they had concerns, they were asked to cite specifics.

Neither Pullen nor Charles Rittenhouse (Cunningham) responded.

Perrie Johnson (Fork Union) explained in detail the selection process: "Eight teachers and eight community members serve on the selection committee. They began meeting in October. The committee established a timeline, chose books to review and submitted the recommendations at the March meeting."

Johnson said she was comfortable with the process, mainly because it is a thought-out policy and a wide range of people vet selections. Added to that, the opportunity for the public to weigh in satisfies Johnson.

"I think it's a good system of checks and balances," Johnson wrote. "I've reviewed all of the recommended texts (not all that were under consideration) and have no significant concerns. Since these are social studies/civics texts, I reviewed them with a particular interest in neutrality of political views and religious information, and the absence of gender and racial stereotypes."

Shirley Stewart (Rivanna) and Brenda Pace (Palmyra) also replied to the email stating they were satisfied with the selection process.

"I have reviewed all of the textbooks that are being recommended for purchase," Stewart wrote. "I find them to be engaging, stressed higher order thinking, and provided resources for students to draw their own conclusions about a variety of topics. I have no doubt that teachers will need to supplement the text, have activities they have used in the past that they plan to continue, and will decide over time which parts of each text will be successful without modification. I trust that the recommendation of the committee was made with careful consideration of our students' needs and their ability to address the curriculum."

Pace said in the eight years she's served on the School Board she didn't recall any "major issues" with textbook selection.

"The fact that staff, parents, and community members have the opportunity to review text books provides options for concerns to come before the board," Pace wrote. "I feel the availability to review the textbooks is important, especially for parents."

Social studies textbooks available for review

The Fluvanna County School Board will take a second look at the textbook committee's recommendation at its Wednesday (April 10) meeting.

The recommended textbooks and instructional materials will be on public display at the School Board Office weekdays from 8 a.m. to 4 p.m. through April 9. Questions about the evaluation and adoption process should be directed to Brenda Gilliam at bgilliam@mail.fluco.org or 434-589-8208.

Author discusses centenarian who fled Nazi Germany

It wasn't until his mother, Margarete Sobel Hermann, was 100 years of age that her son, Richard Hermann, interviewed her about the history she had witnessed throughout her life.

In his latest book, *Mother's Century*, Hermann tells the story from her view of living life in Imperial Austria. She witnessed historic events that changed cultures, people, countries, and relations worldwide for years to come.

Hermann discussed the premise of the book with members of the Lake Monticello Progressive Club. The members understood the parallel between the era his mother lived in and the present and voiced concerns about the rise of Nazism in Europe and anti-Semitism here in America. Hermann spoke to the issue with the knowledge he gained through his mother's eyes via his interview of her three years before she died.

In her lifetime she was a witness to the assassination of Archduke Franz Ferdinand and the collapse of a 500-year-old empire and the onset of World War I – events that had historic proportions. Expedited by the Germans, Vladimir Ulyanov (Lenin) launched the Bolshevik Revolution and Russia saw the end of the Romanov rule and communism take its place.

During her life, Lindbergh landed in Paris and later Sputnik and Apollo 11 landed on the moon. She saw Kennedy assassinated and Nixon resign. She saw the Civil Rights marches and the advent of women's rights, which was strange for a woman who became a medical doctor in Austria long

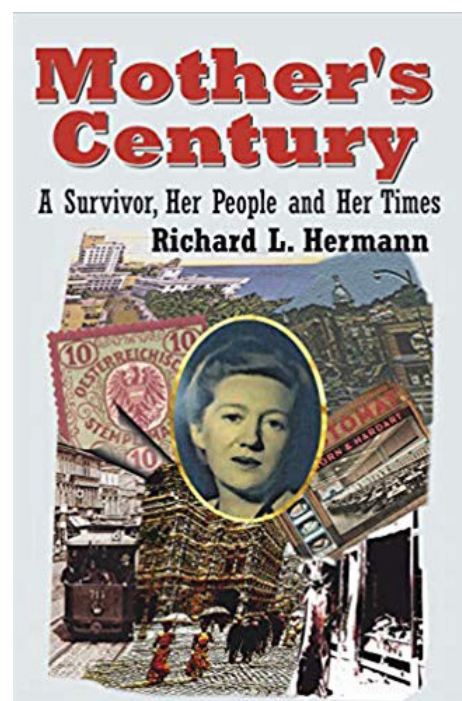
before it was accepted in America.

She experienced all kinds of inventions and watched the evolution of the car, the radio, movies, the phonograph, and eventually TV. What she remembered the most, however, was what she most wanted to forget. But like other Jewish people, the memories of the Nazi occupation of Austria and Germany forever haunted her.

This was the moment that shaped Margarete Sobel's life more than any other in her long existence: the Nazi occupation of her homeland. Growing up she had seen the changes that took place in the aftermath of World War I and the Bolshevik Revolution that altered Russia's outlook, resulting in the communist regime which would set the tone for foreign policy for years to come.

"She lived 95 percent of her life in the 20th century," said Hermann. By the time of the Nazi occupation in Austria, Sobel was in her early 30s and had already survived famine and rapidly rising inflation, as well as discrimination as a Jew and as a woman struggling to become a doctor in medical school. When the Nazis took power, Sobel realized she and her family needed to get out of Austria.

"It was very difficult to leave. Many of the Jews were rounded up and sent to Auschwitz and eventually to the gas chambers where they died," Hermann said. In 1938 his mother had a close encounter with the notorious Adolf Eichmann when he was director of the Central Office for Jewish Emigration.



"She was arrested by the Gestapo for illegally practicing medicine and was in violation of the Nazi decree prohibiting Jewish doctors from practicing medicine on non-Jews. One of her Gentile patients turned her in after she performed an abortion. She endured 72 hours of interrogation and never wanted to talk about it," he said.

She made it out of Austria and survived one of the most tumultuous and violent eras in history.

"Once in America, she met my father, who was also a doctor, and eventually had her only child, which was me," Hermann said. Sobel settled into her life in America and continued to practice medicine. She watched her son graduate from Yale, Cornell Law School and JAG School.

Hermann has written extensively on the law, including several books. *Mother's Century* is available on Amazon.

Get to know extension agent Kim Mayo

The Virginia Cooperative Extension (VCE) brings resources to the community from Virginia's land grant universities, Virginia Tech and Virginia State University. VCE works with public and private partners and volunteers to reach larger and more diverse audiences.

Extension agents form a network of educators who bring research-based solutions to communities, homes and businesses to tackle problems that the people of Virginia face. They educate through classes, workshops and programs within the community.

Kim Mayo, Fluvanna's Virginia Cooperative Extension unit coordinator, started in her position in 2017, but her role in Fluvanna began much earlier.

Mayo grew up on a farm on the Louisa County line and went through the Louisa County school system. She earned her bachelors in English language and literature from the University of Virginia and her masters from Virginia Tech in education curriculum and instruction with an emphasis on instructional technology.

Beginning in 1999 Mayo taught language arts at Fluvanna Middle School, but almost 10 years later when the 4-H extension agent

position opened in 2008, Mayo was thrilled to have the opportunity to combine her passion for 4-H and youth development while continuing her career in education.

"My first 4-H experience was in the Fluvanna colts and fillies 4-H club over 30 years ago, and I have been involved with 4-H in some form ever since," said Mayo. "The leadership, citizenship, and life skills I learned from participating in 4-H as a youth have helped me become successful in my career as an extension agent."

Having both roles keeps Mayo's hands busy. As a 4-H extension agent, she recruits and manages a network of volunteers to develop and implement youth programs. Programs include after-school and short-term educational programs and working with volunteers who lead clubs. As unit coordinator she works with her team to identify and meet the needs of Fluvanna residents.

"After a record rainfall in 2018, we received several calls regarding water quality concerns. As a result, we recently coordinated a drinking water clinic through Virginia Tech's Virginia Household Water Quality Program for residents who rely on a private water supply," said Mayo. "In addition to allowing residents to affordably test their drinking water, we provided two educational programs on common sources of contamination, and provided information on maintaining a well. We had not conducted a drinking water clinic in Fluvanna in several years."

One of the many projects Mayo and her team work on is the Holiday Lake 4-H camp. Each summer, kids spend a week at Holiday Lake in Appomattox and participate in numerous activities that help inspire confidence and growth.

Another program is the annual fourth grade Agriculture Day at Carysbrook Elementary. Students spend a day outside interacting with

over 30 volunteers who share the importance of agriculture. Students have the opportunity to learn about pollinators and watersheds, enjoy hands-on planting practice, and interact with sheep, horses and cows.

While these programs have been a success, some of the time has been tough. When John Thompson, the former agriculture and natural resources extension agent and unit coordinator, was promoted to the role of district director of VCE, Mayo and her team were left with a vacancy that remained unfilled due to budget constraints from the state.

Without having someone on site to field questions from the public, it has been difficult for the team since a large majority of the questions are centered on agriculture.

However, they have recently hired Rick Hernandez in a part-time role. While Mayo said a full-time position is necessary to meet the needs of the county, the team works rigorously to help as much as possible.

The VCE team is also working with the county to develop a rentable commercial kitchen in the Fluvanna Community Center.

"We have equipment in place and a few minor details to attend to before applying for certification from the Health Department and Virginia Department of Agriculture and Consumer Services," said Mayo. "While this has been a three-year process, we hope to have the kitchen open for business by the start of

the new fiscal year" in July.

Mayo wants every resident to be aware of the services that VCE offers.

"At public events such as the county fair or Old Farm Day, participants are often surprised to learn that the extension office is not just for those with a farm," said Mayo. "We offer education in the areas of family and consumer science (nutrition and financial management), agriculture and natural resources, 4-H youth development, and community viability."

VCE works with over 150 volunteers each year, including master gardeners, master naturalists, master food volunteers, 4-H volunteers, and additional community partners who allow the team to expand its reach past the staff members in the office.

Further down the road Mayo wants to see more civic engagement in Fluvanna. She believes giving back to the community is important.

Mayo's love for animals continues at home. She lives on a small farm with her husband Dwayne, who also serves as chief of the Palmyra Volunteer Fire Company; their daughter Cameron, who is in ninth grade at FCHS and is in the marching band; and cows, sheep and chickens.

Mayo's job requires her to work nights and weekends in order to reach the youth audience, but when she is not working on a weekend program, she will likely be out on her farm.

Elite rowing competition comes to Lake Monticello

It's spring, the air is warming, the trees are in bloom and the collegiate women are rowing at Lake Monticello.

In the only Division 1 sports event held in Fluvanna County, the University of Virginia (U.Va.) women's rowing team will host the ACC – Big Ten rowing competition Saturday

(April 6). Four visiting rowing squads will be on hand to test their prowess over the Lake Monticello course.

U.Va. rowing Coach Kevin Sauer, the only rowing coach the U.Va. women have ever had, said that the schedule calls for U.Va. to row against the University of Michigan in the 9-11

a.m. session, and then compete against Ohio State in the 12-2 p.m. session.

Teams from Syracuse and Duke will also be on hand, but U.Va. will not compete against either of these squads. In the morning session, Ohio State, Duke and Syracuse will compete against each other, while in the afternoon Michigan, Duke and Syracuse will row against each other. Teams will practice at the Lake Friday (April 5).

This is clearly an elite college rowing competition as U.Va., Ohio State and Michigan are all ranked in the top 10 in the country. An early season online ranking has U.Va. at number 7, Michigan at number 9 and Ohio State at number 5.

Most spectators view the competition from the main beach, which is where most of the activity takes place. All the teams put their boats in the water there with the coxswains barking out their orders to the rowers. Visiting parents and rowing fans tend to set up their picnics there. Pool construction may be a little constrictive this year, but the diehard fans will

certainly be there in force as usual. The finish line for the races is close to the marina, so that is also a popular viewing location.

The U.Va. rowing team has women from all over the country and from overseas. It also has a local rower. Sophie Kershner of Fluvanna County is on the roster, although she did not row in high school. There are high school rowing programs in some parts of the country, but rowing is very definitely not a sport on the Fluvanna County High School sports calendar.

Sauer said, however, that his program is always looking for young women who were outstanding athletes in high school, who could be developed into high quality rowers. Kershner, who is now a sophomore at U.Va., was a standout in softball, volleyball and swimming for the Flying Flucos. Her U.Va. bio also notes that Kershner was student body president at Fluvanna and the salutatorian of her graduating class.

Fluco number one player senior Adora

Gamage and number three player freshman Anja Baja were not able to come up with singles wins in this match, but Coach Feda Morton noted that Gamage has been very successful for the Flucos as their number one player for the past three years. Morton also noted that Baja is an excellent prospect, moving in at number three as a freshman.

This win takes the Fluco girls' tennis

team to an overall record of 3-1. Due to spring break, the team does not play again until April 9 when they travel to Charlottesville. On April 11 they will be at Powhatan. The girls' team then returns home April 16 to host Albemarle High. On April 18 they travel to Western Albemarle.

NOTICE OF PROPOSED REAL PROPERTY TAX RATE INCREASE FLUVANNA COUNTY BOARD OF SUPERVISORS

Per Virginia Code Section 58.1-3321, notice is hereby given that the Board of Supervisors of Fluvanna County proposes to increase property tax levies.

- Assessment Increase:** Total assessed value of real property, excluding additional assessments due to new construction or improvements to property, exceeds last year's total assessed value of real property by 3.36% percent.
- Lowered Rate Necessary to Offset Increased Assessment:** The tax rate which would levy the same amount of real estate tax as last year, when multiplied by the new total assessed value of real estate with the exclusions mentioned above would be \$0.893 per \$100 of assessed value. This rate will be known as the "lowered tax rate".

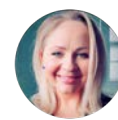
