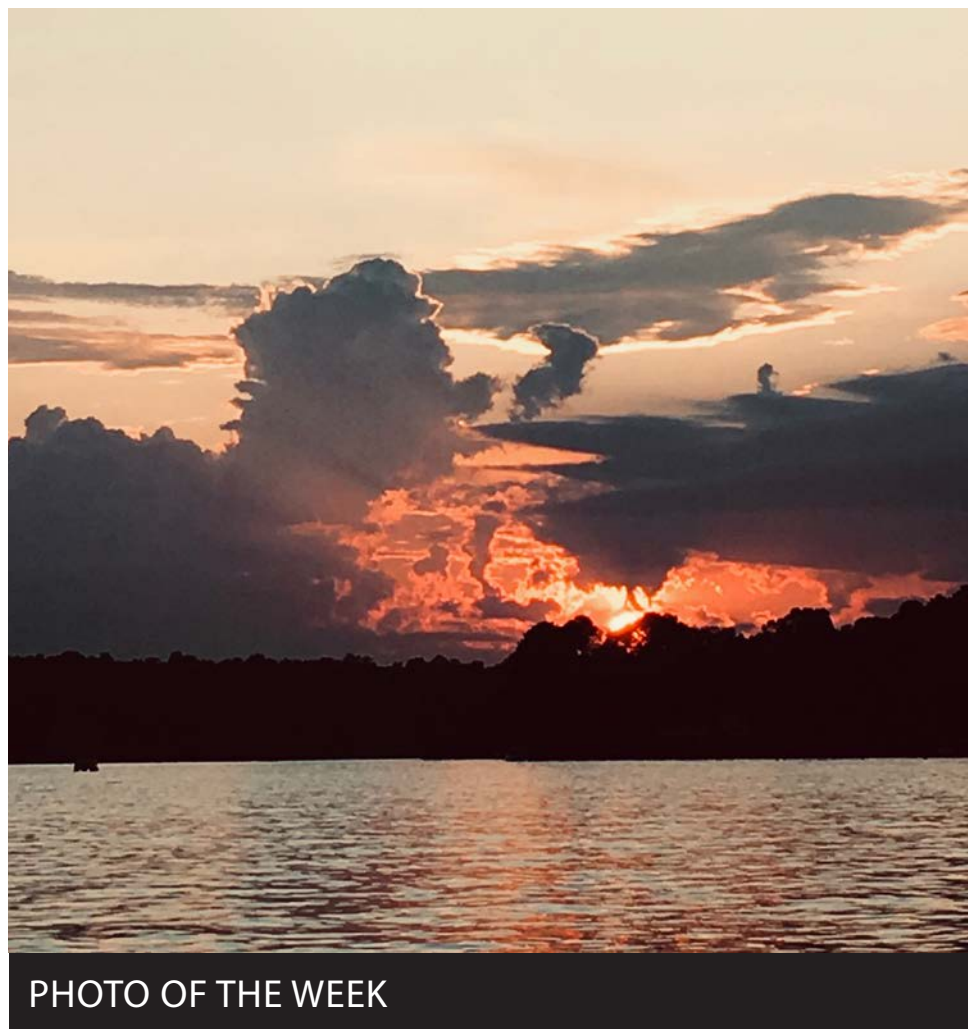

County approves amendment to ordinance on political and temporary signs

The Fluvanna Board of Supervisors voted Wednesday (Aug. 21) to amend a county ordinance regarding political and temporary signs.

Previously, the ordinance restricted signs to be displayed no more than 60 days prior to an event.

In late June, the county received a letter from The Rutherford Institute in Charlottesville on behalf of Dr. Elizabeth Alcorn, Democratic challenger to incumbent Delegate Rob Bell for the 58th District House seat. The Institute argued that the 60-day limit restricted her First Amendment right to political speech and impaired her ability "to promote her candidacy and establish name recognition in her campaign."

At the July 2 supervisors meeting, County Attorney Fred Payne recommended that rather than risk possible

litigation, enforcement of the ordinance be suspended while the Planning Commission explored a Zoning Text Amendment to remove the 60-day limitation.

The commission voted unanimously on Aug. 13 to approve the text saying signs may only be put up "a reasonable time" before an event or election.

"I have a question," said Supervisor Don Weaver. "What's a 'reasonable time' Two months, three months, four months, five months...?"

"It's going to be determined by the facts," explained Payne. Political signs put up for a primary in the spring could now simply be left up until the general election in November. "Donald Weaver for President 2047, I wouldn't consider a reasonable time," he joked.

A sign with no clear time limit would still need special permission and all signs still need to be removed within 10 days of an event or election.

Supervisors approved the change 4-0, with Tony O'Brien absent for the evening.

Ambulance 49

Supervisors also resolved an issue left over from their Aug. 7 meeting: what to do with Fluvanna Rescue Squad's Ambulance 49.

While the fiscal year 2020 (FY20) budget allocated \$190,000 to remount the current box on a new vehicle chassis, the squad later asked that the county approve the purchase of a new, smaller, gas-fueled ambulance within the same price range.

Faced with a dizzying array of price options, a number of pros and cons,

and funding issues, the supervisors finally decided to defer any decision until the Aug. 21 meeting.

Chief Crystal Mayo was on hand to argue in favor of a new vehicle. Her feeling was that a gas vehicle was easier to maintain and better able to navigate the area's narrow driveways. She also advocated for a Power Load device to automate loading and unloading stretchers.

After a lengthy discussion, the supervisors voted 3-1 to purchase a new ambulance, with Supervisor Trish Eager voting no. Eager did join the majority in separate votes to accept up to \$48,000 in grant money for the Power Load, and in shifting the budgeted \$190,000 from unassigned funds to the capital improvements project (CIP).

Strategic initiatives update

"This is a little different," Kelly Belanger Harris, who was until recently clerk for the Board of Supervisors, said as she made her first appearance as Assistant County Administrator to update the members on the status of the 2018-2019 Strategic Initiatives and Actions list.

The county has identified areas for improvement in service delivery, communications, project management, economic development and tourism, and financial stewardship and efficiency. "There's been a lot completed," Harris told the supervisors and county staff has been working hard to meet their objectives.

"I really look at much of what I'm doing as community engagement," she said, "and many of the things here [on the list] have to do with how we are keeping citizens informed on things."

Among the completed projects she highlighted was the recent broadband expansion agreement with Central Virginia Electric Cooperative (CVEC), several new digital media channels to alert citizens to county meetings and

events, and Municode, a program accessible through the county website that allows the public to look at local ordinances.

She's also hoping to conduct both internal and external communications surveys in near the future, and said a 2020 citizens survey was likely next year.

Finally....

Anyone who has ever been driving down Rt. 53 and had a hankering for barbeque might soon be in luck.

Supervisors approved a special use permit for Wahoo BBQ to set up a small restaurant at the former Cunningham Market. Applicant Kevin Smith also plans to put in some outdoor seating and eventually to reopen the gas pumps.

Training Emergency Medical Technicians to save lives

PAY CLOSE ATTENTION!- You may meet these graduates under less than ideal circumstances.

From Jan. 19 until graduating on Aug. 3, a total of 14 Emergency Medical Technician students have been receiving an academy-style training in the saving of lives. With 1,458 hours of education, 187 patient contacts, and boasting a 95% course average grade, the graduating class has proven themselves ready for the challenge of serving their communities.

For lead instructor Nancy Shrewsbury, this date marks the last class before her official retirement. A total of 927 students have come through her courses, and she has made it a point to not only prepare each student to take the EMT exam, but also to learn how to save lives. She encourages a support network to form around her students. "This graduating ceremony is to honor the graduates, and to help their friends and families understand the whole picture of what the students go

through to get to this day." Besides the intensive coursework, students received courses in emergency vehicle operations, participated in vehicle extraction scenarios, rode on ambulances calls and received a full array of on-the-job-training. EMTs see people on their worst day; they experience traumas and the loss of life firsthand, and family and friends often have to be engaged and ready to help them work through those experiences.

Many chiefs from other companies were in attendance at the Mineral firehouse in Louisa County to honor the graduates. They have trusted Shrewsbury through the years by sending their people to her for training. Also in attendance was guest speaker Tom Joyce, executive director at Thomas Jefferson EMS Council of Charlottesville, who has also trained hundreds of EMTs. Joyce gave a moving speech, encouraging each student to take the knowledge they have received and then figure out how their unique personality can

be used to deliver help during a call.

"Have realistic expectations for doing good. You will take each situa-

tion and use your gifts to leverage for the best outcome. If you come into this business thinking that no one

else will be shot, no one will hurt little kids on your watch, or that all life lasts forever, you will be disappointed."

While EMT courses exist to prepare a student for a comprehensive state exam, the real learning will begin in the field; hundreds of experiences that will teach them what they don't know. Tom exhorted the graduates, "Be curious, never be satisfied with not knowing - find the answers and educate yourself constantly. Be good, be kind, and even when everything is horrible, don't take it personally." Joyce told the students not to be surprised when they see and hear conduct on the boundaries of acceptability. The EMT is not to be a judge, he offered, but to make it better than it was before they were called. "We see things people should not see. It's not that you shouldn't be affected by those things; it is how you manage it."

Recurring themes with Shrewsbury and Joyce were admonitions to the graduates to rely on training, and emotional preparedness. When all hell is breaking loose, don't get excited. Go back to the basics. Shrewsbury asked her graduates, "Okay everyone...out loud...what is rule number one?" The graduates strongly answered back: "The emergency is over when we get there!"

Letter to the Editor

Every morning I take my dog to run at our wonderful local gem, Pleasant Grove. Walking in nature, hearing the birds, and seeing the glorious sky, is one of the best ways to start a day. Anniversary of Louisa Co. Earthquake is a Reminder for Virginians to be Prepared

August 23 marked eight years since the 5.8 magnitude earthquake in Louisa County. The anniversary and July 7.1 and 6.4 magnitude earthquakes in California are a reminder to Virginians to take steps now to protect and prepare their property.

According to the Insurance Information Institute, the 2011 Louisa, Va. quake ranked #10 in the Top 10 Costliest US Quakes and caused an estimated \$150 million in damage across multiple states. Only a small portion was insured. Locally it destroyed two schools and put a power plant offline for three months.

Standard homeowners, condo owners and renters' insurance policies don't cover earthquake damage to property or personal belongings. Earthquake insurance is sold as a separate endorsement.

The premium varies based on several factors including: age of home, building materials and proximity to known fault lines.

Your auto insurance will typically provide coverage for damages caused by an earthquake, if Comprehensive Coverage is carried on the policy.

The best way for a consumer to get more information about earthquake insurance is to visit their local agent to discuss their individual needs.

Earthquake Preparation:

A few weekend projects may help protect your home and family from an earthquake.

First, take care of your family and pets by developing an emergency plan and survival kit. Consider evacuation routes and a meeting spot. Equip your survival kit with non-perishable food, water, clothing, blankets, flashlights, a battery powered radio and plenty of batteries. Bring water and food for your pets as well as veterinarian records and proof of vaccinations.

Next, protect your belongings by creating a home inventory list. Use a digital camera or phone to take pic-

tures or video of each room in your house. Pay close attention to items on walls, in closets and in drawers.

Third, take a look at appliances and furnishings in your home. Attach tall furniture and appliances to walls, use an earthquake strap to secure your water heater and make sure all hanging items like lamps, mirrors and picture frames are well secured.

During Earthquake:

Be mindful of your surroundings and know where to go when an earthquake strikes.

Indoors – Drop to the floor, make yourself as small as possible and get under a sturdy piece of furniture.

Outdoors – Stay outside, do not run into a building. Instead move away from trees and tall structures like utility poles.

Driving – Pull over away from bridges and other structures.

Always follow the instructions of local officials to remain safe during and immediately following a quake.

Post Earthquake:

After the quake it is important to follow the instructions of local officials and seek out resources from local evacuation centers and aid stations.

Always make safety the #1 priority when inspecting damage or making temporary repairs.

Be mindful of the risk of aftershocks and follow instructions of local officials.

Make temporary repairs to protect your home from further damage and save all receipts. Coverage may be available for these expenses.

Love for aviation soars to Papua New Guinea

Along the 700-mile Sepik River in Papua New Guinea live 220,000 people without roads, electricity, and little to no access to emergency medical care. The only hospital in Wewak serves 500,000 people in the East Sepik province, excluding those in the west province. It could take someone anywhere from five to seven days by way of dugout canoe to get to hospital care.

When Mark Palm, co-founder of Samaritan Aviation, visited Papua New Guinea for the first time in 1994, he was only 19 years old. He was attending college in Florida when he and a friend decided to take this trip together. The purpose of this trip was to find what the biggest needs are for the people in Papua New Guinea and Palm saw a huge need there, specifically medical needs.

One month after this trip, he started flying, a skill that runs in the family. Palm's grandfather flew in World War II and his cousin was a Prowler pilot in the Marines and is currently a pilot for Delta. In 2000, Samaritan Aviation emerged and provides emergency medical services, such as life flights, medical supply delivery, disaster relief, vaccination outreach, and hospital ministry, to remote areas of Papua New

Guinea. There are currently two float planes and three pilots.

"I felt God reached out to me and say, 'Mark, I want you to use your love for aviation to help others,' and that is exactly what I am doing," said Palm. "It feels good to give back without expectations."

Almost 80 percent of patients suffer from pregnancy complications and illnesses and the remaining 20 percent from trauma. And of those living along the Sepik River, 80 percent suffer from malaria. Now, with two float boats, Palm and his team made it possible to reduce the time to travel to this hospital in Papua New Guinea from five to seven days to a 45-minute to a one hour-long plane ride.

On Aug. 11, Palm visited the Cavalry Chapel in Fluvanna County.

"We have friends here in Palmyra and we were here back in 2008," said Palm. "We also have good support here, so it is always nice to come back."

Palm shared his journey with the people at Cavalry Chapel and told the community of their work in Papua New Guinea. Guests were able to hear of the stories about the lives they saved and hope that



is brought to its people.

Geographically, the country is located north of Australia on the southern hemisphere. Palm lives in Papua New Guinea with his wife, Kristen, and his three kids, Sierra, Drake and Nolan. Samaritan Aviation's mission is to demonstrate God's love by providing aviation and medical services in the country's remote areas.

Palm is currently on his Hope in Action city tour, where he visits areas to talk about his life-changing story and the stories of

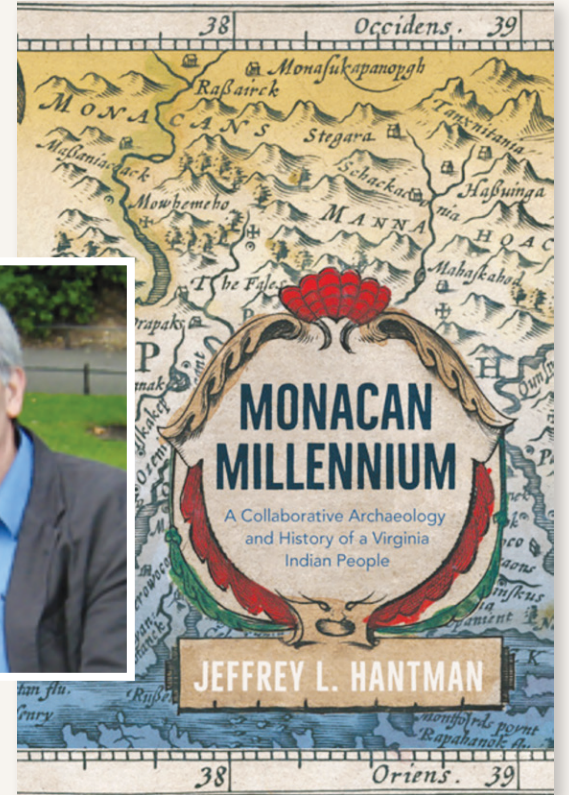
those living in Papua New Guinea. Palm and his team are hoping to touch hearts and seek help. People can donate one time or monthly for \$25, \$50, \$100, \$500, or \$1000. Each tier helps in emergency services and hope to villages. In addition to donations, Samaritan Aviation gets 40 percent of its funding from the National Department of Health in Papua New Guinea.

Artist discusses passion for portraits

At the monthly meeting of the Fluvanna Art Association artist Bryan Trent Fair discussed his passion for portrait painting. Many of the artists were impressed with his work as they listened to him talk about his artistic journey.

A Buckingham County native, born in Richmond, Fair started drawing during his early years and took art classes in high school. The love of drawing the human face and figure were more appealing than landscapes, which the majority of FAA artists prefer to paint. Many novice artists are afraid to draw figures, which appear more challenging to them than landscape.

This attraction to the human form and delving deeper into the essence of his subject was uppermost in his mind when he chose to study graphic art at Virginia Commonwealth University in the 1980s.

"The idea of sitting in a cubby somewhere and drawing fashion illustrations appealed to me but then computers came along and changed everything and what I did became obsolete," he said. After graduating, he was an adjunct professor, teaching fashion design and

figure drawing. He had no further interest in graphic arts and the calling to be a portrait painter became strong and he followed his heart's desire to northern Virginia and the Torpedo Factory, where he studied with renowned artist Rob Librace and Danny Dawson.

"I learned about skin tones and how to identify color, including flesh tones, using bright saturated colors, no earth tones, like bright greens, purples and, golds for darker skin," he said. To pay the bills and support his art, he did administrative work but devoted every spare moment to taking workshops and promising himself he would learn to master and utilize what he had learned.

His art eventually fell by the wayside as work took over his life, but remained on the fringes. But it wouldn't be long before it became front and center in his life. Recalling his favorite artist, John Singer Sargent, who inspired him, he moved to Los Angeles and studied with well-known California figurative painters, including Jeremy Lipking and Morgan Weistling. These artists are known for their realism.



While living in California, he exhibited his work in galleries in West Hollywood, North Hollywood and throughout the San Fernando Valley. His award-winning work has been used by independent filmmakers for film projects as well as television. A classic film buff, his paintings of actors from the golden age of Hollywood and beyond feature the influence of Sargent with a soft, loose and impressionistic style.

"My Hollywood pieces were a favorite at regular shows held at a local gallery in L.A.," he said. While studying art in California, Fair learned a different color palette with muted, low-key and muddy colors. He said edges were also important.

"These artists were all about edges, everything does not have to be resolved and have a hard line." He showed the members that by simply blending, objects fade softly into the background, avoiding the hard lines.

After living for 13 in California, Fair returned home to Buckingham with his partner to care for his mother. He is currently working as an executive assistant at Sentara Martha Jefferson Hospital. He continues to work in art with commissions and exhibiting throughout Virginia.

He discussed his process with interested members. Painting mainly in oil, Fair favors clay board with gesso to give it tooth and hold the brush strokes. He likes a limited palette which adds to the

overall unity of the painting.

"Always start with a good drawing, a solid foundation, the bones," he said. "Painting from life is important and using a photograph is acceptable but knowing what is lifelike helps shape the subject in reality.

"Remember, not everything has to be rendered, loosen the edges and smooth them out. This is an area for looking at turning forms, looking at which direction something is turning, the light and the edges. Watch for the transitions in the face. Always soften the eyes and mouth and never use harsh straight lines when drawing or painting children, it ages them."

A member commented that his work resembled a photograph.

"Saying an artist's work looks like a photograph is not a compliment," he said in a lighthearted way but explained that his goal is to capture the inner essence of the subject, particularly in the eyes and mouth in a single, quiet moment through his slightly impressionistic and realistic style.

"It is my intention to represent my subjects in a way that is evocative and resonant with the viewer."

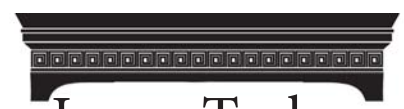

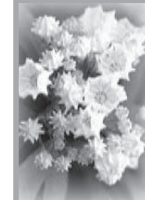

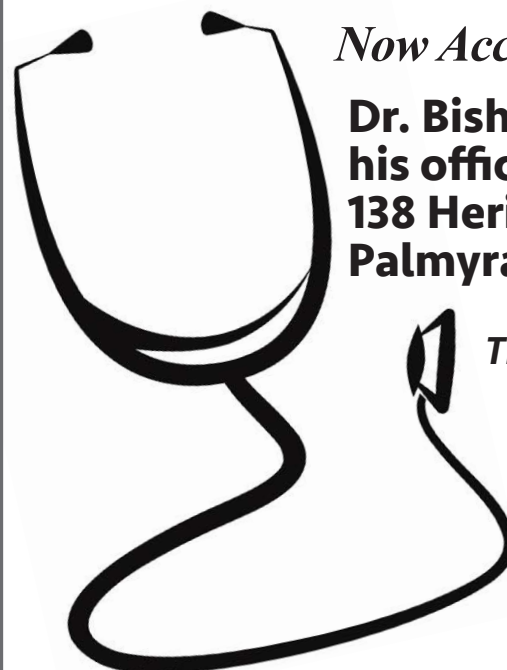

A Garden for The Ages

Should you ask any gardener about the soil being gardened, you'd better be ready for the tale that will follow. Freshman gardeners will often go on about the great results provided by the organic dirt, which they purchased at a local garden supply center and shoveled into raised beds. More seasoned practitioners can be mordantly self-deprecating as they describe their seasons of trial and error. Talking with old-timers is like talking with an actuary, or statistician. You'll get trial and error quantified, with decades of daily temperature, precipitation, and hours of daylight records; soil analysis data, and fertilization schedules.

It is the rarest of gardeners who can take the story of her soil back to its Ur moment, but that's the kind of gardener Bernice Thieblot is. With her husband Armond, she has created a sight to behold: The Quarry Gardens

at Schuyler, located along Salem Road just across the Rockfish River from the Schuyler village in Nelson County. Bernice shared her garden's sights, and its story, with the Scottsville Monthly on a recent, warm summer morning.

"It's all because of the soapstone," she says. "You know, it has a unique composition; mostly talc and magnesium. You can find soapstone all around the world, but there are three sites on earth with enormous deposits. Those are in Brazil, Finland, and here in Schuyler."

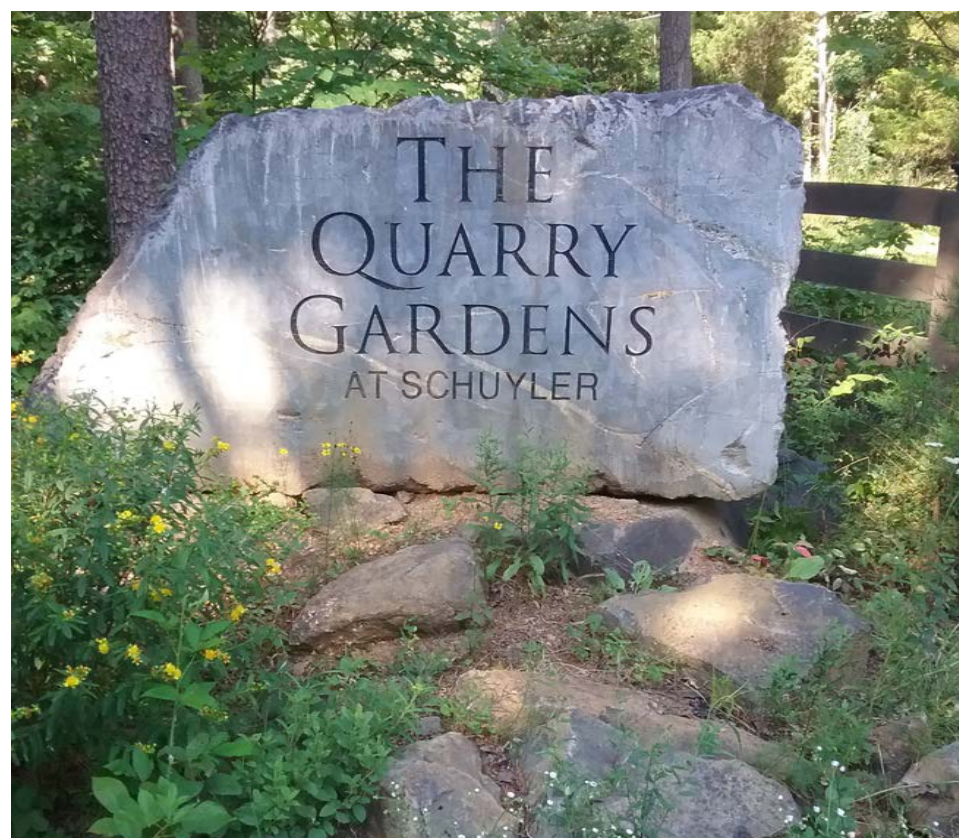
Since it's not uncommon to think that "enormous" describes a slice of cake that's larger than requested, it might be useful to consider the word in its geological sense. Imagine Australia's Ayers Rock, the Rock of Gibraltar, and Yosemite's El Capitan, tipped over and draped in scrub pine and laurel, and lying around in

someplace like Schuyler, Virginia: just a few more hills in our hilly part of the world. Actually, innumerable such chunks of soapstone - larger or smaller; up-thrust or buried - are scattered across the Piedmont Plateau, forming a band which stretches from Northern Virginia down to the Lynchburg area. Those chunks are scattered thick around Schuyler. Not enormous enough? Try this.

According to Thieblot, "Geologists believe that the three great soapstone deposits were once connected. They separated when Pangea broke apart."

And there it is, the Ur moment. Long before Finland rode its tectonic plate off to the northeast, or Brazil headed south, there occurred a convergence of materials and events which resulted in a vast inclusion of soapstone in the earth's crust. Then, about 200 million years ago, the only land mass on earth tore itself apart, formed its bits into continents, and left the middle of its big soapstone pile in our backyard.

Fast-forward to 1991: Armond and Bernice were working in the Baltimore area, he as a university professor, she as a consultant. They were looking for some land where Armond could go hunting. One likely parcel

enjoyed frontage on the Rockfish River and had just been clear-cut of its timber. The price was reasonable. After all, with its flooded quarry pit and massive junk piles it could qualify as an industrial wasteland. Cleared of its dense monoculture, and knee-high in field weeds without number, the land was a potential deer and turkey magnet. The Thieblots took it. A few years later, looking toward some off-the-grid improvements, Armond found a used hydroelectric generator at a good price. In order to house the generator and its related equipment, a Quonset hut was erected. But plugging a generator into a river, even when it's the Rockfish which had long been dammed for that purpose, is easier said than done. So the generator was sold, leaving the steel half-pipe structure mostly empty. About that time Armond left academe and joined Bernice in her consultancy. They wound up traveling extensively as their business thrived. Their rural getaway grew as well. By then, maturing saplings overshadowed great patches of the property. A smaller adjoining parcel, including a rustic dwelling, was purchased. Then, in 2013, the Thieblots retired. For a while, they took to the road, traveling for pleasure. One stop along the way proved to be a lightbulb moment for them: The Butchart Garden, once a booming limestone quarry on Vancouver Island.

"It was so beautiful. Just spectacular!" says Bernice. "It gave us something to think about." The Thieblots had planned to build a new home and settle down on their Schuyler tract, tear down the old weekend getaway place, and...then? After seeing such a wonderful example of quarry restoration, that plan changed. They spruced up the rambling, eclectic camp house, moved in for good, and turned their focus on the land.

"We needed something to do." says Bernice, "We had no idea where this would take us."

First up was getting the junk hauled away. There was lots of it to haul, from old quarry equipment, to abandoned vehicles and appliances, and household trash, because rural land can attract more than just wildlife. Some of the refuse was all natural, which sounds nice, but a quarried block weighing 8 to 10 tons, that is in your way, is big trouble no matter how it is categorized. Much of the dreck had to be dredged from the depths of the

quarry. Overseeing this first step convinced the Thieblots that they needed a master plan.

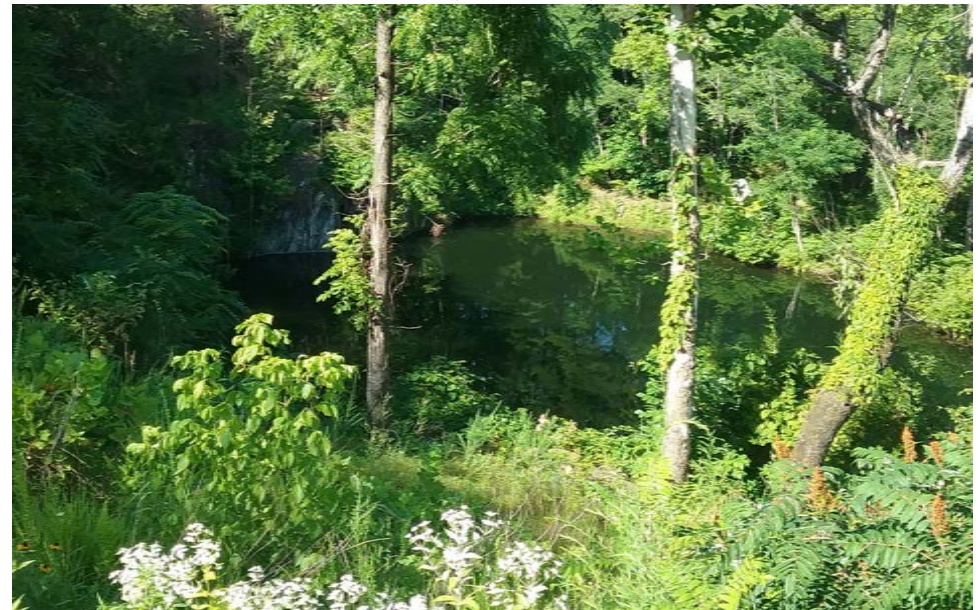
In 2015, The Center for Urban Habitats (CUH) and its founders, Rachel and Devon Floyd, entered the fray. CUH offers landscape design services, with a specialty in environmental restoration. Their plan for the old quarry included a sensible site lay-out - parking, trails, water coursing, maintenance facilities, and the like - but also called for the identification of both the specific habitat zones, and the plant and animal species present on the site. The old Quonset hut was repurposed as a contemporary, and attractive visitor's center. Our tour began there with a short introductory film about Quarry Gardens. There's a gallery featuring gorgeous nature photographs, displays of found artifacts, and couple of outstanding dioramas, built by Bret Jones of Rail Tales, which depict a Schuyler quarry, and the village of Esmont back in their heydays.

The Thieblots can't say enough about the value CUH has added to their project, or the kind of people Rachel and Devon Floyd are. The feeling is mutual. According to Devon, Quarry Gardens presents a unique challenge. "The site is globally rare," he says. "The soil there contains more magnesium than calcium. I can't think of another place where that happens." He especially likes the approach that Armond and Bernice have taken. Unlike the Butchart Garden, or other well-known formal gardens, Quarry Gardens is full of, well, weeds. That is, if almost any of the plants growing there sent up a shoot in your garden - and some surely have - you would uproot the creature without a second thought. By contrast, if a SeedCo Best Beefy Boy tomato vine sprouted at Quarry Gardens it too would be swiftly yanked. "Weeds" are in the eye of the beholder. Says Floyd, "There is a beautiful logic behind using native species to restore devastated landscapes. Armond and Bernice have chosen to host a very rare biological community." So far CUH has identified over 600 plant and 250 animal species, and over 40 distinct habitat zones.

So what's the criteria for a habitat zone? Floyd says, "Soil type and mineral content, amount of sunlight, types of species in or near the zone: it's everything." Floyd's passion for this place and his enthusiasm for the

Thieblot's vision, as realized and as yet to come, is contagious. "It's like they gave us a playground. We get to match the existing landscape to a natural community of species, rather than cultivating specific plants or essentially altering the quarry grounds.

During our tour, Bernice points out the numerous galleries along the rustic paths we stroll. Here the soil is rich, almost to saturation, with natural zink. There is a bluff covered in Reindeer Lichens. She points to a cleft in the quarry face, where a great vein of clay divides the soapstone. We break out of the trees and come upon a lovely sunny spot where a floral riot has broken out. Bernice knows them all. "Quill Fameflower. Pickerel Weed. Shrubby St. John's Wort. Eastern Prickly Pear. Natural Liatris..." she says, as if she were pointing out Impressionist masterpieces. You won't see a formal flower bed any prettier than this one. Bernice notes that every plant has its season. "It can be beautiful whenever you come."

On this day the blooms are as alive

with black bumblebees as the air is with their scents. We bide near a natural weir and listen to the garden as if it were a sleeping child. It is rich with sounds; all of them gentle. No aircraft's grumble or appliance's hum intrudes. The sounds of distant highways - engines droaning, tires hissing - have not found this spot. Damselfly wings don't vibrate at Dominion's 60 Hz, nor do the breeze-rustled leaves echo the hubbub of the town. Across the clear, still water one of those epic chunks of soapstone shows its quarry face: grave and serene, and now ignored by the friction of commerce.

To be still in this garden is to be taken by it.

As it turns out, Armond and Bernice Thieblot found something to do. Summing it up, she says, "This is a labor of love."

The Quarry Gardens at Schuyler is open for tours and welcomes new friends. Their colorful website has the details. This visit is worth the trip.

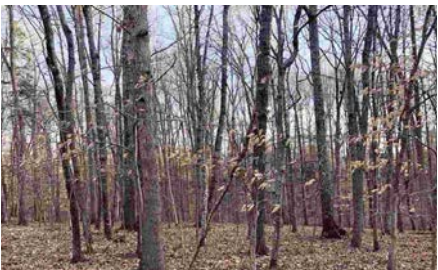

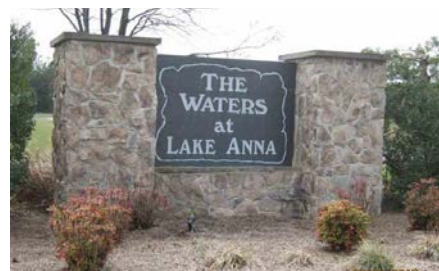
