Many kids in our community rely on the free and reduced-price meals they receive at school. These meals may be the only nutritious food that they'll receive on a given day. Therefore, FCPS is continuing to offer grab and go meals free of charge to children, 18 years and under, from low-income areas.

Each child will receive 5 breakfast and 5 lunch meals that meet USDA meal pattern requirements. Beginning April 21 bags will consist of 7 breakfast and 7 lunch meals. The meals consist of items that parents can prepare at home, as well as ready to eat items. Food safety guidelines and food preparation instructions will be included with the meals.

Meals may be picked up at the Fluvanna County High School cafeteria weekly on Tuesday & Wednesday from 7 am to 4 pm. Per updated USDA guidelines, children no longer need to accompany adults to receive the meals.

Your child(ren) are eligible to receive home-delivery only if they have qualified for free or reduced price meals. All children, 18 years old and younger, residing in your home are eligible to receive meals. Fluvanna County Public Schools needs your consent in order to deliver these meals to your home. Your child(ren) do not have to be present at the time of delivery but there must be someone available to accept the delivery. Meals cannot be left outside if no one is home. # Supervisors struggle with fallout from the pandemic

With a couple of technical difficulties and a few awkward pauses, the Fluvanna Board of Supervisors livestreamed their public hearing on Wednesday night (April 8) on the proposed \$84 million budget for Fiscal Year 2021 (FY21) and advertised increase in the residential real estate taxes from \$0.925 to \$0.945.

The hearing was closed to public attendance but was broadcast live on YouTube. Members of the public were invited to submit comments by email or call in during the meeting.

Supervisors Donald Weaver (Cunningham) and Tony O'Brien (Rivanna) were physically present for the meeting, while the others called in via phone or Zoom. Supervisors Mozell Booker (Fork Union) and Patricia Eager (Palmyra) have preexisting health conditions; Chair Mike Sheridan (Columbia) may have been exposed to someone with Covid 19 and chaired the meeting from his home as a precaution.

At the top of the hearing, Director of Finance Mary Anna Twisdale gave an overview of the FY21 plan.

"The proposed budget is about 0.5% higher than the adopted FY20 budget," she said. "The total increase is \$318,314 as it is proposed."

Many departments asked for modest increases over the previous year, ranging for \$5,000 to \$268,000. The largest increases were in the school budget, which asked for an increase of \$1 million over FY20, and in infrastructure, with an increase of about \$3 million for the completion of the Zion Crossroads water and sewer project and the Fork Union Sanitary District (FUSD).

## **Public comments**

The public hearing included four emails from residents that were submitted to the county ahead of the meeting. These were read into the record by County Administrator Eric Dahl and Supervisors O'Brien.

"As residents struggle without income and many without health benefits, I believe [supervisors] should vote a significant drop in our tax rate," wrote George Graf of Palmyra.

Perrie Johnson of Fork Union, chair of the Fluvanna County School Board, wrote to "encourage you to pass the advertised rate and come as close as you can to fully funding the school budget" and capital improvements.

O'Brien read an email from a constituent worried about the potential burden of the upcoming June 5 personal property tax burden on residents reeling from Covid-related job losses. "Anything local governments can do to show they understand what their constituents are going through, and they have a willingness to work with them, the better," she wrote.

Patty Reynard of Broken Island, who has spoken frequently during public comments in recent months, renewed her request that supervisors "reduce overspending and overfunding requests for unnecessary items." She cited what she feels as "tremendous waste in the school and around the county," which she believes burdens the 30 percent of citizens who pay 70 percent of the county's real estate taxes.

## Tax talk

The public hearing was held on the advertised real estate tax rate of \$0.945 per \$100, which would have



added about \$40 to the annual tax bill on a home assessed at \$200,000.

But after the rate was advertised, "we've had work sessions, we got some new revenue projections, and the board has gone through and considered some expenditures," said Dahl. "And after some of these deliberations, ended last week's budget work session with a tax rate of \$0.925, which is the current tax rate."

That left a shortfall in the proposed budget of \$51,347.

Twisdale said she and her staff had spent much of the week on the phone with state officials "trying to come up with some kind of theory on what revenue is going to do" in light of the pandemic. "The problem is, no one knows."

There are any number of factors, from a drop in local sales tax revenue to residents not being able to pay their property tax bills, that could push the shortfall to over \$500,000 and potentially force the county to dip into reserves to pay for critical expenditures.

"Everyone thinks this is going to be a [20]21 problem," said Twisdale. "And '21 is going to be bad. But FY20... there's really not going to be a lot to carry over from '20 to '21," reducing the county's fiscal cushion as the economic impact of the pandemic begins to take hold.

Supervisors went through and looked at some areas where they might make some cuts, including suspending cost-of-living increases for staff and canceling the purchase of replacement fire vehicles. At the \$0.925 tax rate, even after substantial cuts, they were still faced with a \$137,000 shortfall in the proposed budget.

"The board has to decide if it wants to target a [tax] rate, or does it want to have a budget that is sustainable," O'Brien argued at one point in the discussion.

# **Vote delay**

Supervisors were scheduled to vote on the tax rate and budget at their April 15 meeting, but as the discussion continued, it was clear that there were too many unknowns, particularly when it comes to how pandemic-related changes in the state's budget might affect Fluvanna County. The legislature will resume its session on April 22 to begin discussing these issues. County Treasurer Linda Lenherr said the latest date that April 29 or 30 was likely as late as she could wait for the setting of the tax rates and still get bills out to residents for the June 5 due date.

In the homestretch of the meeting, consensus built among supervisors to delay the vote until April 29, at which point they might have a better sense of which way the state was going with funding and where the pandemic was going in Virginia.

County Attorney Fred Payne recommended the board meet on April 15 to deal with other agenda items, then adjourn until April 29 to make that final decision on the tax rates.

All members agreed to the date change as the best choice for the county.

"I think if we sit down right now and try to find something, we're going to look back tomorrow and say'doggone it..." said Sheridan.

# **Key Coronavirus Tax Changes** What every taxpayer should know

lus payments, the IRS is implementing many changes in response to the coronavirus pandemic. Here are some of the major topics that could affect you and your family.

#### **Early distribution penalty** waived

The 10% early distribution penalty on up to \$100,000 of retirement withdrawals for coronavirus-related reasons is waived during 2020. New provisions allow tax liabilities on these distributions to be paid over a three-year period. The new rules also allow individuals to return these distributions to the retirement account over a three-year period and not be subject to annual contribution limits.

Action: This could be a great way to handle emergency payments until you receive a stimulus check, unemployment payments, or a pending small business loan.

#### **Required minimum distributions** (RMDs) waived for 2020

Required minimum distributions (RMDs) in the year 2020 for various retirement plans is suspended. The corresponding 50% penalty associated with not taking an RMD is also suspended in 2020.

Action: Taking out distributions when the market takes a tumble can hurt retirement income for many years. This change allows you to wait to let the value in your retirement account rebound before you withdraw funds.

#### **IRS installment agreement** suspension

The IRS announced suspension of payments of all amounts due from April 1 through July 15, 2020 and will not be in default on any IRS installment agreement during this period. Interest will

In addition to filing delays and stimu- continue to accrue on these installment agreements.

Action: Being on the bad side of the IRS is never fun. If you currently have an IRS installment agreement, look to take advantage of this delay.

#### Enforcement activities suspended? Not so fast...

The filing and enforcement of liens and levies will generally be suspended. However, IRS Revenue Officers will continue to pursue high income non-filers and initiate other actions when warranted.

#### No new audits

The IRS will not initiate new audits during this time, but will act to protect the statute of limitations.

Much is happening during this unique time in our country's history. Rest assured, as changes are made you will be informed. In the meantime, please keep yourself and your family safe.

#### Finally...

Remember that Virginia has chosen not to conform with the Federal Extension of July 15<sup>th</sup>, Instead, they have extended payment deadline from May 1<sup>st</sup> to June 1<sup>st</sup>. What this means for you as a taxpayer is that if you owe Virginia, you must still file and pay your Virginia taxes by June 1<sup>st</sup> to avoid penalties. The filing deadline may or may not change based on the actions by the General Assembly during the veto session. So effectively, if you owe Virginia, you should plan to file by May 1st!



# Tax, spend, borrow and tax more

Four of The Fluvanna County Board of Supervisors are proposing all funding request be fully funded. Since Fluvanna County doesn't have enough revenue to actually fund all the request, four of the five supervisors want to borrow the money, and just increase the taxes to pay for these requests, many of which are not necessary.

Things I have learned from attending the Board of Supervisors meetings over the last few months: the schools receive over 50 percent of the county's budget, the county chooses to continue to loose over \$150,000 of tax payers money in the Fluvanna landfill that is only open three days a week and don't really seem to seek details on ways to cut expenditures. The county loses millions each year to land use by allowing this tax loophole for over 110,000 of the 183,000 acres of Fluvanna land. The county continues to fund hundreds of thousands in additional funding to non-profits that are already funded.

The Fluvanna County schools, teachers, administrators and higher-

level employees, and the Fluvanna County employees are very carefully and thoughtfully considered as priority for raises, and benefits at the taxpayers' expense. Keep in mind many of the tax paying residents are working in positions that don't provide them with healthcare insurance, or cost of living raises, and many positions are hourly, which will likely end as the result of the COVID-19 pandemic. It appears most supervisors never considers the hardships the increased taxes placed on residents, only how the schools, and county staff should get raises and benefits afforded them by the tax paying residents.

Just think what a tax increase, an increased assessed property value, cost of living increases, such as healthcare insurance, medication cost, as well as utilities and living expenses, are going to mean for all tax paying citizens. It is even scarier to think that many tax paying citizens are going to be dealing with serious financial issues as a result of the COVID-19 virus, and many losing their jobs.

# School Board meets online to discuss pandemic-related issues

Vowing to deal only with time-sensitive and pandemic-related issues, the Fluvanna School Board met remotely Tuesday (April 7).

Covid-19 cut short the 2020 school year causing food, education, sports, extracurricular activity and Internet connection problems.

Public schools are charged with making education accessible to all.

Students who don't have computers or online access can't do "distance learning."

Connection issues played out during the meeting.

Two school board members, Charles Rittenhouse (Cunningham) and Andrew Pullen (Columbia), who represent the most remote, rural areas of Fluvanna, experienced access problems.

Pullen's video connection was spotty and he finished the meeting using the audio from his cell phone.

Rittenhouse accessed the meeting via a phone connection at the school admin-



istration building.

Superintendent Chuck Winkler announced some decisions about grades.

"For the most part, students will get a combination of three-quarter grade or pass/fail," Winkler said. "If the student is failing they have an option of doing work to bring up the grade. Anyone with an A, that will be recorded."

Teachers are putting together learning packets geared to keeping skills sharp, and not introducing new learning.

Winkler said students who need Chrome books should call their school. They'll make arrangements to pick one up or take one to students with no transportation.

Students with connectivity problems can access the Internet outside any of the school buildings.

Details on how to do that can be found through the school website, Facebook or by calling the school, Winkler said.

While no firm decision has been made regarding end-of-year sports, prom and graduation, they are considering:

- Sports once the social distancing orders are lifted, having a final game or meet in each sport, even if it is just among Fluvanna students. There is some talk statewide of giving students one extra year of eligibility.
- Prom/Graduation current thought is possibly holding prom and graduation on the same weekend as Homecoming "We have not cancelled graduation.

We have not cancelled graduation. We have postponed it," Winkler said. "We may align it next year with Homecoming. We could have Homecoming and Prom then graduation on Saturday."

Students will be missing about three to six weeks of new instruction. Because of inequity in access, the school can't do distance learning so that instruction must be made up somehow.

One way to get it back would be to extend next year's instructional days to pick up learning gaps. They've made no final decision on that.

Chair Perrie Johnson (Fork Union) urged Winkler to consult with the calendar committee.

Through a needs assessment Winkler said they found about 40 people who needed child care.

A couple local businesses have offered to help a few of those children, but public schools won't open to provide childcare.

Winkler said they've been offering meals for pick-up since the second day of school closure. That distribution continues but is now available to any Fluvanna family in need.

James Kelley (Palmyra) said: "To me it's the number one priority to make sure those who are in need aren't doing without. Thank you for doing that."

Concerning this year's school budget, Winkler said he expects less sales tax revenue. There is enough money to pay staff throughout the year.

The Board voted 4-1 (Johnson against) to pay all contracted hourly and assignment employees in full including spring coaches and long-term subs who've been given a letter of assignment.

Johnson said she voted against the motion because she wanted to pay coaches at half their rate because their work is extracurricular.

The FY2021 budget is now down to \$43,230,198 because of a nearly \$300,000 reduction in local funding. Winkler said after holding employees harmless in health care costs since FY2015, increases next year are inevitable.

"We're looking at 15% cost increase," he said. "We have no choice but to raise rates. If we picked it all up it would add \$1 million (to the budget)."

Keeping the same provider, BPA, starting July 2020, a single employee with the \$500 deductible plan would see their monthly premium rise from \$53



to \$74.16. Family coverage for the same plan would go from \$743 per month to \$877.41.

The Board approved the health insurance rate sheet 4-0. Kelley was not present for the vote.

They also approved the Virginia School Board Association policy services agreement 4-1; Pullen against.

Pullen abstained from approving World Languages textbooks. It passed 4-0.

They approved the Special Education Annual and Career and Technical Education annual plans 4-0; Pullen abstained. In final comments Pullen stressed the Board's obligation to seniors for "not just graduation but anything they may miss because of the pandemic: proms, games, ceremonies. We want to make sure we do everything within our power to fulfill our obligation to them."

All board members agreed.

Shirley Stewart (Rivanna) thanked the staff for "all the work they're doing during the troubling times for our community, especially feeding our families."

Rittenhouse said, "I've been here almost 50 years and nothing has ever affected public education like this but I know we'll get through it."

# Making Covid-19 masks: the new hobby

Before the CDC made the recommendation to wear face masks to reduce spreading Covid-19, people ventured out into public wearing medical face masks that were to be reserved for medical staff and rescue squads. Some still are using medical-grade masks. Others are using makeshifts masks with bandannas, looking like old West robbers, while some simply wrap a winter scarf around their face.

But Fluvannians have addressed this problem, jumping right in and sewing, making their own and those for friends and neighbors and anyone else who needs one.

Diana Pickral modeled a very stylish mask made by her daughter, Molly Pickral. Molly's husband, Marc Perdue, and seven-year-old son Nick also contributed to the endeavor to make masks to give to family and friends. With Nick being home from school, this was a worthwhile project to get him involved as well.

For those who do not know how to sew or don't care to, Sandra Uribe shared this link on how to make a no-sew face mask https:// youtu.be/1r2C1zGUHbU. To sew one for beginners, check out this link at https://www.youtube.com/ watch?v=\_6UcIDaxfqk. For other patterns, the CDC has a couple of versions at https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/ diy-cloth-face-coverings.html.

Face masks can become a conversation piece based on your style and color preferences. Artist Tom Tartaglino's wife made him one with a paisley design which Tartaglino was happy with. Scraps of fabric or even an old T-Shirt can be used, provided it is clean.

The other question some might ask is if one mask is enough? According to one medical expert, she suggests a set of five, but this depends on your laundry habits and how often you are going out in public and so on. She adds that two is advisable. This way you can have a variety of masks with various patterns. To clean, it is recommended to wash masks with the regular laundry, hot water, regular detergent, and the hottest drying setting. After this is behind us, we will look back on one fashion trend we never expected so many would model but one that brought community members together and saved lives.
