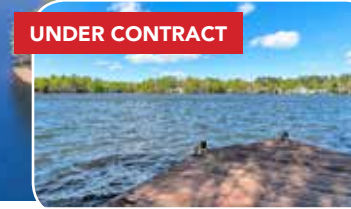

# Summer and Fourth of July activities during COVID-19 in Fluvanna County

As the official season of summer arrived and the state of Virginia moved into Phase III as of July 1, more options and activities are becoming available. With Phase III in effect, caps on the capacity for nonessential retail businesses and restaurants will be listed and social gatherings of up to 250 people will be allowed. Gyms and fitness centers can open at 75 percent capacity and museums, zoos and other outdoor venues can open at 50 percent capacity with a cap of 1,000 people. Since the number of people hospitalized with positive or pending COVID is declining, more and more business will start to open their doors to the public while keeping customers and community members safe.

So here are some things to do in the summer of COVID-19:

Enjoy the sun and the outdoors with Fluvanna's Park and Recreation. Their July calendar brims with activities for both kids and adults. There is a \$20 registration fee per program as well as a 20-person limit registration per program. They will be practicing safe protocols such as face masks and social distancing and participants will be required to take a temperature check upon check in and check out each day. Hikes and Crafts will be hosted at Pleasant Grove for ages seven to 12 and the kayak programs will meet at beach four in Lake Monticello (kayak, paddle and lifejacket provided). Another way to soak up some sun and support local business is to visit the local winery, Cunningham Creek Winery (CCW), which is now open and can accommodate parties up to eight people, including children. Following the Center for Disease Control and Prevention (CDC) and phase II guidelines, people are asked to bring a face mask to wear at all times except when within their reservation area. If guests do not have a mask, CCW can also provide a single use face mask. Another way CCW is accommodating during the pandemic is by allowing guests to purchase a CCW logo glass for \$1.50 each, bring their own glasses, or use a compostable single use plastic cup. Be on the lookout for any changes going into phase III on

their website in relation to guidelines and capacity rules.

An additional local activity would be to visit the Lake Monticello Golf Course. Currently, the course is open to lake residents, property owners, golf members, and accompanied guests, although, with Phase III into effect, things may change, so check back for updates on their website. The Pub Restaurant, located near the course, will still be doing takeout orders and continue to seat people outside and inside while following guidelines with social distancing. Food and Beverage manager Carl Lasley also said that The Pub can now host private events since gatherings of 250 people are now in effect.

For those who want to venture a little away from Fluvanna, Shenandoah National Park has reopened access and the entire park is open 24 hours a day. Explore more of what Central Virginia has to offer this summer by visiting the campgrounds, which are open at a limited capacity to meet the Forward Virginia guidelines of a 20-foot separation between campsites to encourage distancing. Campgrounds are operating on a first come first serve basis and at about 50 percent capacity. If hiking and/or camping are not ideal, the Blue Ridge Parkway is open along with certain locations for picnic area, including restroom facilities throughout Virginia and North Carolina (if the adventure takes you that far).

In relation to July 4<sup>th</sup>, while the Lake Monticello Owner's Association made the difficult decision to cancel the Fourth of July fireworks show due to the ongoing pandemic, they are still hosting other patriotic events to help the community spirit. One event is the Lake Monticello's Plan B Virtual Race Challenge, a walk or run to support the Lake Monticello Fire and Rescue (LMF&R). Instead of an entrance fee, participants are encouraged to make donations with 100 percent of the proceeds donated to the LMF&R.

The second July 4<sup>th</sup> event that the Lake Monticello Owner's Association is hosting is the Patriotic Porch and More Tour to help spread community spirit. Community members are encouraged to decorate their houses, porches, lawns, mailboxes, and driveways with a patriotic theme. Deco-

## RUDY TALKS TAXES

### IMPORTANT! July 15th is LOOMING! Your return needs to be filed and you may owe a tax payment this month!

Remember, July 15 is now the tax filing due date because of the pandemic! It also means you may have a tax payment due on or before July 15. You may owe the IRS a tax payment for your 2020 tax return and not know it.

Most Americans have income taxes withheld from their paychecks, with their employer sending a tax payment to the IRS on your behalf. This year, however, many more Americans will have to write Uncle Sam a check to pay a portion of their 2020 taxes on or before July 15. You may be one of these people!

#### Who needs to pay now!

You may need to make a payment if one of the following situations applies to you:

- **Paychecks are under-withheld.** If your employer doesn't withhold enough to cover your entire tax liability, you may need to write the IRS a check.
- **Unemployment compensation paychecks are under-withheld.** Unemployment compensation is subject to federal income tax and while you may have taxes withheld, it may not be enough and this may mean you need to write the IRA (and the State!) a check..
- **Self-employed workers.** Unlike employees, self-employed workers don't have income tax withheld

from pay and must make four estimated tax payments over a period of 12 months. Self-employed workers include gig economy workers, freelancers, S corporation shareholders and partners in a partnership.

- **Retirees.** You may owe tax on Social Security benefits, as well as income from investments distributed to you or other unearned income. A portion of pension plan distributions may be withheld, but if the amount withheld does not cover your entire tax liability, you may need to write the IRS a check.

#### What you need to do

Estimate your total income for 2020, then calculate your total 2020 tax bill and divide it by 2. Compare this amount to how much has been withheld from your paychecks, unemployment benefits and any other payments you've made to the IRS. If you're short, consider making an estimated payment by July 15 to make up the difference. This payment is made with Form 1040-ES. Failing to pay on time may result in the IRS imposing a penalty plus interest on top of the underpaid taxes.

## Fluvanna Business Corner

### F.R.O.M.: FLUVANNA Small Business Grants

There has been tremendous headache and heartache for businesses from Fluvanna because of the health crisis. There has been miss opportunities, changes in structure and so much more. We are operating in an environment no one could predict eight months ago.

Fluvanna County received \$2.379 million from the federal government as part of the CARES Act. The Board of Supervisors acted quickly to commit \$350,000 of the money for small business grants. This money will go directly to help businesses with operational changes, new health protocols or lost revenue from closures. The program is the Funds for Recovery and Operations Management (FROM): Fluvanna Small Business Grants.

The FROM: Fluvanna grants are tiered to help employers from part-time operation to an operation with

50+ employees. Every for-profit business or private school from Fluvanna can participate. We will have instructional videos on what you can request the funds for, who is eligible, and for how much. The key is this is a cash grant program for businesses from Fluvanna.

A local neighbor who has a full-time job elsewhere and operates a part-time operation that's dependent on festivals is eligible for \$2,500. The sole proprietor who suddenly went from face to face meetings to having to buy online interfacing accounts is eligible for \$5,000. The store with 2 to 20 employees that now had to order large quantities of PPE is eligible for \$10,000. The school with 21 to 50 employees that closed during Phase 0 is eligible for \$15,000. The operation with 51 or more employees that had to complete rework the manufacturing floor for safety protocols is eligible for \$20,000.

All businesses from Fluvanna are eligible for the FROM: Fluvanna Small Business Grants. All businesses from Fluvanna are encouraged to request the grant. ### Trump has failed

I suppose we're lucky to be living in a state where the COVID-19 virus is more or less contained by the practices of social distancing and self-quarantine. But it is alarming to see a drastic rise in new cases of COVID-19 in 30 states as reported by Johns Hopkins University data. The U.S. reported more than 40,000 new cases on Thursday (June 25), the second consecutive day with a record total. A swathe of southern states including Florida and Texas may be pushed to the limit in terms of hospitalizations. Trump has clearly failed the leadership test and is more interested in being reelected than taking action to curb a pandemic. Yesterday Trump announced his latest scheme to abolish the Affordable Care Act which provides health insurance for more than 20 million people. In the midst of a public health emergency, this raises an important question: Whose interests does Trump really serve? I'm convinced Trump only cares about his own

ego and destroying his predecessor's policies instead of building new ones.

At least a few elected leaders are taking a stand against Trump's insane political machinations. Joseph Biden, the presumptive Democratic nominee for president, scolded Trump's behavior by saying "He's like a child who can't believe this has happened to him. All his whining and self-pity. Well, this pandemic didn't happen to him. It happened to all of us. And his job isn't to whine about it, his job is to do something about it. To lead."

### Just vote

I have been an Election Officer (EO) for every election/primary since 2013. I love doing it and speaking with hundreds and thousands of voters who are excited about participating in our democracy. It is my joy and honor. My experience shows me how safe election day is from foreign interference or fraud. If that happens, it happens outside of your polling place. EOs take their jobs very seriously.

This year for the June primary I was very hesitant to volunteer. I was nervous about safety and unwittingly bringing COVID-19 home. I did not volunteer, but watched with interest the primaries across the country, the lack of polling places and the shortage of EOs. I hoped there would be enough EOs to get the job done, and privately told myself if the Board of Elections called I would do it and, if I was uncomfortable about exposure to the virus, I would self-isolate for 14 days after the primary.

The board called and I did it. This letter is to congratulate every person involved in the primary. The Slice gate firehouse had eight EOs. On Monday we set up the polling place, taped dozens of six-foot social distancing markers, so many I dreamt about them on Monday night. Plexiglass shields were set-up as appropriate, EOs were provided with PPEs/ and visors, one person was assigned to sanitize in addition to an outsider who came in and wiped down surfaces several times during the day. Interestingly, the first person who came in without a mask arrived after 2 p.m. - eight hours into the day. We had less than a handful of voters who did not wear masks. Fully everyone paid attention to social distancing. I was very relieved and very grateful.

Which brings me to November. After this experience I will be work that election. We will be very short-handed, but I know the Board of Elections will take every precaution for the safety of all involved.

What can voters do? They can take advantage of absentee voting, apply for a mail-in ballot, or vote early. Details will be available and I will make it my mission to remind every about this. Vote, Vote, Vote.



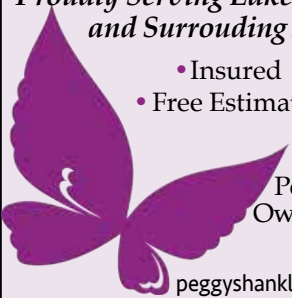

# Fluvanna Arts Council has new president

After nearly ten years at the helm of the Fluvanna County Arts Council, Adele Schaefer stepped down and Sharon Harris was named the new president of the Fluvanna County Arts Council. Schaefer had been instrumental in the metamorphosis of FCAC by strengthening collaborations with local groups.

"I feel so much support from our board. I am looking forward to building on the great work that was done by our previous president," said Harris. "Adele has done such a great job and has dedicated so many years and many hours to the job of fostering and supporting the arts in Fluvanna. I am so blessed to be able to step into the role with such a strong and solid foundation from which we can continue to grow."

Harris' goal is to not only build on past success but move FCAC and the arts in a different direction

"The arts are such an important part of making community connections. My hope for the FCAC is that we can play a greater role in bringing together members of the community to experience a wonderful diversity of artistic expression, as we work to raise the standard for accessibility and inclusion in the performing arts."

Over the past few years, Harris says FCAC has been looking for ways to

engage with the community by expanding community outreach through social media and newsletters, and surveys and has been successful. Audience size has grown over time. She feels that FCAC's partnership with Empowered Players has helped them bring new and younger audiences to the Carysbrook Performing Arts Center.

"I hope we can continue to build on this as we bring a variety of musical, performance, and theater groups to the Carysbrook stage."

Harris' vision is supported by the board that sees the future of FCAC as not only a steward of Carysbrook Performing Arts Center but as an umbrella group that supports and collaborates with all the arts in the area, including the visual arts. The Center has already begun a relationship with the Fluvanna Art Association.

"It would be wonderful to feature more local musicians and to expand our efforts to highlight the work of local artisans and visual artists. I hope to continue partnering with the Fluvanna Art Association, the Fluvanna County Singers, and the Persimmon Tree Players," she said. "The arts play such a critical role in the health and well-being of individuals and communities. I would like to see us continue to expand our reach in Fluvanna County and surrounding areas by con-

necting with local businesses and civic groups and engaging even more with the community."

Harris sees the arts as more than mere entertainment but as instruments that bring the community together in a deeper and more meaningful way. She envisions arts organizations and performing artists owning their power to connect with communities, to educate, to celebrate, to entertain, and to support.

"In a time when arts organizations have struggled with funding cuts and have had to spend so much time defending and advocating for the importance of community arts programs, we also see so much research documenting the many benefits of the arts. As arts advocates have always known, the arts not only entertain but bring so many other wonderful benefits," she said. "Participating in the creative arts gives a sense of purpose, gives a social outlet, and helps with physical and emotional health and well-being. The arts help build communities and support local economies. Students involved in theater do better in school. So, while this message is not a new one for arts advocates, the message is being delivered to wider audiences."

Becoming president during a global pandemic, means the FCAC has challenges in finding ways to experience the

arts in our community. She said that at a time when we would all benefit from the diversion that entertainment can provide, when we are all so isolated and can benefit from the communal experience of watching a play or listening to a concert together, it is not safe to do so.

"Arts groups around the country are exploring how to connect with our communities through music and theater in ways that protect performers and audiences. We are no exception as we consider new and innovative ways of presenting arts programming in our community."

In the light of current events regarding equal rights and Black Lives Matter, she feels strongly, as do many in the arts, that this is the time when the arts can shine a light on a delicate subject in a respectful and thought-provoking way through theater and music.

Under Schaefer, FCAC took bold steps to be more inclusive and embrace diversity, particularly with the African-American community. It was Warren Johnson, former president of PTP, who adapted "To Kill A Mockingbird" to the stage with African-American actors rounding out the cast.

FHS choral teacher and former director of the Fluvanna Community Singers, Horace Scruggs, began his series on African-American music which became a staple of FCAC's seasonal line-up. Last year, FCAC welcomed Chris Lewis and other gospel singers from area churches to perform at Carysbrook and blew the crowds out of their seats.

FCAC recently joined other area theaters and performing arts centers in supporting that diversity when they made the following statement;

*condemn systemic racism and violence against people of color. We commit to listening, to learning, and to using our resources to support change in our community and in our world. We believe that Black Lives Matter.*

"Equity, diversity, and inclusion in the arts are so important as the arts have the power to unite us and to bring individuals and groups together. It is important to recognize and acknowledge what we are facing as a nation right now. We cannot heal and move forward without acknowledging the inequities and injustice that have been a part of our nation for far too long," said Harris. "The performing arts can create a space for honest discussion that can lead to understanding and serve as a source for healing wounds and crossing divides."

Harris recognizes that on a deeper level, through struggle, beauty emerges and that writers, musicians, artists, and others are the visionaries that have for centuries shaped and influenced cultures through the arts.

"This is what the arts can do so well - be the catalyst that brings together individuals and groups to share stories, to listen, to learn, to celebrate the diversity of expression that exists in our communities, and to foster understanding. As arts

organizations, we can use our resources to create a space to address issues and promote inclusion, healing, and unity."

She said that whether it is through music, dance, visual, or performing arts, participating in the creative aspects or as audience members, we see that the arts are able to change people's perspectives, moods, relationships and overall health.

"Not only can the arts unite people by offering new perspectives and breaking down barriers, but the arts and specifically music can play a significant role in physical healing. There is some exciting research being conducted by the National Institutes of Health in collaboration with the Kennedy Center and renowned soprano Renée Fleming which explores how listening to, performing, or creating music involves brain circuitry that can be harnessed to improve health and well-being."

"The impact of the arts is so multi-faceted. The arts are so important for individual health and well-being, education, community health, and economic development. In Fluvanna, we are so fortunate to have a wonderful 270-seat community performing arts center. I am so fortunate to be able to work with a very dedicated arts council with a history of commitment to promoting the performing arts and cultural enrichment in our county."
