#### Sheridan, O'Brien re-elected to BOS Leadership

Supervisors Mike Sheridan (Columbia) and Tony O'Brien (Rivanna) will serve another year as Chair and Vice-Chair of the Board of Supervisors, after each was unanimously re-elected by fellow supervisors during their first regular meeting of 2021 on Wednesday night (Jan. 6).

Members also voted to keep the meeting times and dates the same, with biweekly Wednesday meetings held at either 4 p.m. or 7 p.m. With the county courthouse still closed to meetings due to COVID-19, they will continue to meet at the Fluvanna County Public Library for the foreseeable future.

#### **Strategic initiatives**

Deputy County Administrator Kelly Belanger Harris gave a progress update on the county's list of strategic initiatives. This list of objectives focuses on improving county government functions in areas like service, communication, economic development, financial stewardship, and project management.

"The upshot is, there is very little that hasn't been done, and so much of what was on that list has become part of normal operations now," she said. "It's just part of what we do."

Supervisors revisit and revise the list of objectives during their regular leadership retreats. There was no retreat in 2020, and normally do not have one in election years like 2021. But with critical issues like statewide redistricting on the horizon, County Administrator Eric Dahl suggested they look at some sort of special meeting to discuss big-picture goals and objectives at some point in the coming weeks and months.

#### **Revenue review**

With Fiscal Year 2021 (FY21) approaching the halfway point,

Finance Director Mary Anna Twisdale gave a brief update on the state of the county's progress on revenue collection.

The FY21 budget projected \$50.8 million in revenue from local, state and federal sources. Thus far, the county has collected \$22.6 million, or 44.45 percent of projected revenue, as of January 4. Twisdale said this is comparable to collected revenues at the same point in FY20.

#### Burn building update

The effort to construct a "burn building" for training Fluvanna firefighters is stretching into another year, as county staff continues to seek ways to balance first responders' needs with funding.

The county won a \$480,000 grant to cover part of the project, but a request for bids issued last year put the cost of construction at \$988,000. Last fall, supervisors voted to rewrite the proposal and put it out for a new round of bids in the hope of coming in at a lower cost. In the interim, members of the Burn Building Committee visited a facility in Harrisonburg that cost that community about \$650,000 to construct.

"It's very different from what we originally looked at," said Lake Monticello Water Rescue Chief John Lye, "but, quite honestly, this building would do very well for what we want."

Supervisors agreed that the county should draw up a new project agreement around the Har-risonburg model and issue another request for bid later this year.

#### New Habitat Home dedication held

The new homeowner has given over 150 hours of education and service time over the past year. Fluvanna Habitat's team of Rusty Nailz, who are seasoned volunteers, worked in small groups between September and December to complete this house.

"This build was unlike any other we have ever accomplished due to the pandemic. Our goal of building a home while ensuring the safety of our volunteers was hugely successful. God blessed each of us", said Mike Himes, Fluvanna Habitat Board president and construction supervisor.

This house, like the other homes in Fluvanna Habitat's subdivision of High Mountain Acres and Cedar Ridge, is built to energy efficient and environmentally responsible standards. This saves homeowners considerable amounts in home energy costs.

#### Neo-Nazi fliers found in Fluvanna, Scottsville

Several Scottsville residents on both sides of the Fluvanna and Albemarle county lines report receiving neo-Nazi literature outside their homes overnight on Friday. Images of the flyers, headlined "White and Proud!" circulated on social media over the weekend.

The flyers were purportedly from The New Order, a Wisconsin-based hate group that defines itself as "heirs of Hitler" and calls for an all-white society.

This is the second time in two years that racist literature has been distributed in Fluvanna County. In January 2019, several households along the James Madison Highway found flyers from the Loyal White Knights of the Klu Klux Klan.

Late-night drops of racist literature are a common recruitment tactic for hate groups. Just in the last six weeks, communities in California, Indiana, Kentucky, and Texas have reported similar incidents.

While the groups differ, the tactic is

the same: flyers are folded and placed in a plastic bag, often with a small rock as a weight.

Major David Wells of the Fluvanna County Sheriff's Office said in a statement on Monday that they were working with Scottsville Police Chief Jeff Vohwinkel in investigating the case. They have also reported the incident to the Virginia State Police Fusion Center for intelligence tracking.

"While we fervently condemn white supremacy and the spreading of such hate-based material, the flyers in and of themselves are Constitutionally protected speech and not unlawful," he said in his statement. "The means of distribution could make them subject to littering laws."

He requested that any resident who finds the flyers to report them to the sheriff's fffice.

Wells also asked that people not circulate images of the flyers to social media, "as it circulates the message and organization."

#### **PPP Loan Expenses May Now** Be Tax Deductible

As I mentioned last week, the Emergen- The Dilemma cy Coronavirus Relief Act of 2020 made additional money available from the Small Business Administration (SBA) for a new round of PPP loans. The new loan program is targeted to businesses that need the funds. To qualify, your business must have 300 or fewer employees and have seen a drop in revenue of 25% or more during any quarter in 2020. Some of the money is earmarked for very small borrowers, underserved communities, and small lenders. There are even simplified requirements for forgiveness if the loan amount being applied for is less than \$150,000.

More importantly, for those businesses that from the Paycheck Protection Program (PPP), the recently passed will help to dramatically cut your tax bill. Here's what you need to know:

#### Background

The PPP program was created by the CARES Act in March 2020 to help businesses which were adversely affected by the COVID-19 pandemic. Qualified businesses could apply for and receive loans of up to \$10 million. Loan pro-ceeds could be used to pay for certain expenses incurred by a business, including salaries and wages, other employee benefits, rent and utilities.

If the business used at least 60% of loan proceeds towards payroll expenses, the entire amount of the loan would be forgiven.

While the CARES Act spelled out that a business's forgiven PPP loan would not be considered taxable income, the legislation was silent about how to treat expenses paid for using PPP loan proceeds if the loan was ultimately forgiven.

Congress intended for these expenses to be deductible for federal tax purposes. But since the legislation was silent on this issue, the IRS swooped in and deemed these expenses to be nondeductible.

There was considerable debate over the latter half of 2020, with Congressional politicians explaining that their intent was that the expenses be deductible and the IRS responding "Too bad, they're nondeductible."

#### **The Solution**

Congress overruled the IRS's position in the Emergency Coronavirus Relief Act of 2020. The legislation officially makes deductible for federal tax purposes all expenses paid for using proceeds from a forgiven PPP loan.

Pause for a moment amidst all the stresses of the day and take a look out of your window. If you feed the birds or watch the shrubs and bushes you will notice something unusual going on that occurs in our area every 3-4 years. You will see all your familiar winter birds, like the beautiful Cardinals, the

orful Bluebirds but this year you will see masses of Finch-like birds invading your yard. Such species as House Finches with their splash of red, Pine Siskins, Red Polls, Purple Finches, Juncos, Evening Grosbeaks and the beautiful Red Breasted Nuthatch. These birds are visiting us this winter in far greater numbers than seen in the last 20 years.

The answer for the increase lies in the cold north. Ron Pittway, a noted Canadian ornithologist from Toronto has studied finches for many years as an employee of the Algonguin Provincial Park. He started publishing his annual count in 1999. No question, these birds of the north are moving south, as far as North Carolina in what has been labeled a "Finch Irruption".

These northern small perching birds are moving south due to a scarcity of food stuffs that are part of their routine diet in the boreal forests of Canada. Finches and their relatives prefer pine nuts found in conifers, which are also found in our Piedmont area.

An interesting phenomenon has been studied which identifies a cy-

crease with the abundance of food in that year, inhibiting the trees ability to reproduce. The trees respond in mass by not producing as many seeds in the next year. The squirrels in particular reduce the size of their litters due to the shortage of food. The following year the trees rebound producing an abundance of seeds in order to reproduce amongst the smaller squirrel population. The seed-eating birds head south in the lean years and that in part is what we are experiencing here this winter. And thus, the cycle continues. This year there is a greater scarcity of seeds in the north. This also may answer my question as to why only in certain years there are acorns on the ground everywhere causing me to "roller-skate" on my garden path.



#### Nantucket the subject of author's new book

Anyone who has ever visited Nantucket Island, recalls a picturesque fishing village steeped in history, clapboard or shingled houses, with widow walks and colorful manicured gardens and cobblestone streets lined with boutiques and restaurants with names reminiscent of its Quaker-Puritan roots and its 19th-century thriving whaling industry. It is the quintessential New England coastal village, a blend of its maritime past and legends with the progress of present-day modernism.

"Nantucket became one of the great whaling centers of the world and many of the world and the buildings and architecture still exist from that time. You can still walk Nantucket Center and its cobblestone street and be surrounded by two-hundred-yearold banks and lovely retail stores and, just around the corner the Athenium, perhaps one of the most beautiful and historical libraries in America," said Bigelow.

In his new book "Waiting on Nantucket, Season of 78," Alden Bigelow as his alter-ego Norton, recalls his experiences living alone on the island for a year with his only companion, his dog Mystery.

"I have had a lifelong affection for the island of Nantucket. Who could not fall in love with an island 30 miles out to sea from the coast of Massachusetts, only 14 miles long and less than 4 miles wide, yet offering 55 miles of some of the finest and most pristine beaches anywhere," said Bigelow. "My family began coming to Nantucket in 1964, bought some land in the uninhabited moor off Cliff Road. They built a small cottage and it became our summer vacation home for more than 50 years. It was a magical getaway we came to enjoy every year."

Bigelow was not only drawn to its charm but like many, also to its history, which is something locals take pride in preserving. "Nantucket is steeped in history, most notably going back to 1654 when the Quakers discovered it, only to find more than 500 Wampanoag Indians already living there and



whose friendship and prowess helped the white settlers survive their first winter there."

He says though Nantucket Center has not changed that much over the years, the influx of summer residents and tourists, up to 55,000 a summer, sometimes swamp the natives who live there year-round and number approximately 5,000.

"But since tourism is now a major part of Nantucket's commerce, the locals have learned to adapt quite well. You will find some of the world's best restaurants, some quite pricey, to serve anyone's appetite. Although there are crowds everywhere, you can always find a private beach if you know your way around," he said."I have many favorite memories of Nantucket that go beyond the beauty of the beaches, the uniqueness of an island nation. All the beaches, all the sailing, the big boats, and little boats, the many hideaways."

Bigelow's book strips away the touristy facade to show the essence of the people who inhabit it year-round -- those rugged New Englanders who can endure the harsh, bleak winters in solitude. People like Mr. Reed, who is the owner of the Chicken Box, a confident man, wearing his Greek fisherman's cap, and sporting a closely cropped beard, and a pipe. Robert, a tall, African-American built like a brick wall who worked for Mr. Reed, became Norton's "family" while on the island.

"I have long wanted to write a book about Nantucket, but life and other work, other books, got in the way. Finally, three years ago, I plunged in. I wrote about the full year I spent in Nantucket in 1978." He adds that 1978 was the year he made his escape from his mainland job and life to see if he could write and get lost in the magic of Nantucket and overcome a recurrent depression which had taken over his life. He spent that year in Nantucket, working as a waiter, getting to know the island inside and out while finding himself.

"Nantucket is forgiving and welcoming to seekers, rebels, and those who just need to get away for a while. Most of the characters in "Waiting on Nantucket" are based on real life people, a few are composites, but the events by-and-large are true, not all, but all designed to offer a larger truth."He refers to the suspenseful stories surrounding rape, suicide, murder, and the famous Chicken Box brawl. Bigelow's writing is character-driven and the characters are always vivid and convincing, making the reader wonder where the line is between reality and fiction.

"It is true for example, that in 1978 once again, Nantucket's Red Sox nation was in a frenzy. They were consumed by the inevitability of the Sox winning it all. As we all know now, the dreaded Yankees got in their way once more." He adds that he used the rise and fall of the 1978 Red Sox as a kind of amusing timeline of events while living in Nantucket.

'I hope that my readers are entertained, and become acquainted with the fantastic and unique beauty of this island. There is also another underlying theme which runs through the book, that of learning to deal with and manage one's depression." He says that anyone facing sadness and depression or any other deep-seated maladjustment, could not find a better place to lift their spirits than Nantucket. For him, it was magic, a healing moment in his life. "It welcomes and accepts you as you try to learn and get through any inner challenge you face and you will probably have a good time despite yourself. The orphan island of Nantucket will heal you."

# 102-Year-Old WWII veteran keeps history alive with stories from the trenches

It was a cold December night in France, 1944. Climeth Layman lay awake in a bunker. His only job was to call in the artillery should the Germans arrive.

Two days earlier, Layman's lieutenant had stopped by and given him the supplies he needed to call in an artillery barrage. The lieutenant told the young staff sergeant to keep watch because they didn't know what the Germans had up their sleeves. He told Layman to "be prepared for anything."

"That night," Layman said, "everything was so quiet and so dark outside and I was just sitting there in the bunker. Then, I heard a motor start up." He described the sound with a shudder. "Then I heard another engine. And another." Then, he heard a sound he'd trained himself to listen for, the last thing he wanted to hear at that moment.

It was the sound of men's voices speaking German.

"I heard guys calling. It sounded like they were giving orders in German. But it was so black you couldn't see your own hand in front of you."

Layman scrambled to his feet. He needed to call in an artillery barrage to take out the Germans before the Germans could take out the supplies his unit was in To advertise call: 434.207.0223

charge of bringing to the men on the front. What happened to Layman next was just one of many stories that this 102-year-old has to share with today's youth.

Layman was born in a small town in Missouri during the Spanish Flu Pandemic of 1918. Life then was a far cry from today's world. He tells how one Easter in 1922 he and his family heard a strange noise in the distance outside their home.

They ran outside and to their amazement, saw a speck in the sky. "It looked like it was coming toward us and it was getting bigger. The noise was getting louder too, but we had no idea what it was."

Later that same day, at Easter Sunday service, it was all anyone was talking about: the first plane to fly over their county, a one-man biplane. "We wondered if someday they'd be able to fit two men in one of those things," says Layman.

The WWII veteran says things were different back then. "Everyone had a job. Even kids as young as 10 years old. We all worked to help the family."

When the U.S. entered World War II, Layman joined the fight, along with millions of Americans.





He served in the U.S. Army's 10th Armored Division.

At first, he started out teaching other soldiers how the different guns worked, but he didn't do that for long. His superiors, who were impressed with his leadership skills, gave him promotion after promotion. Although most soldiers would jump at the opportunity to get a promotion, Layman was content with the lesser responsibilities that came with his initial position.

"Just give me a pick and a shovel and I'll go out there and dig the ditches," he remembers saying when he was first promoted. "They shook their heads and told me, 'We know what we're doing."" Eventually, he found himself in the position of staff sergeant in charge of an anti-tank unit.

It was sometime not long before the infamous Battle of the Bulge (the last major German attempt to reclaim the lead in the war) when Layman found himself in that dark bunker, listening to the sounds of German tanks and enemy soldiers shouting orders in a language he couldn't understand.

The voices kept getting closer and Layman decided he would have to call in the artillery barrage his lieutenant told him was at the ready. He got up and rushed to call it in. At first, he recalls, he had trouble getting through. Eventually, he did get through and called for support from the air.

"I waited for so long," Layman said, "I started to think they'd missed the mark." Finally he heard the shells screaming in overhead. "It was nice to hear that sound when you knew it was from your side." Layman said the artillery barrage lit up the night for miles around. "After a while everything went real quiet and I never heard no tanks or hollering for the rest of the time I was there," he added. The next day, Layman and his unit were relieved of their post and rotated off the line.


He said he regretted never looking out over the countryside to see the effects of all that artillery he'd called in. "I don't know why, but I wish I saw what it looked like down there," he said. "I never did know exactly what I did when I called that in, but I know it was a big deal."

Eventually, Layman was sent home due to a bad case of trench foot, a common condition among soldiers during the war which could result in painful, damaged feet. Now, he lives in a small town in Missouri and he continues to share his stories with new generations.

Layman has received countless awards and honors for his exceptional service, including a World War II Victory Medal, and a Bronze Star.

What advice does Layman have for young people today? "Stay honest and don't get into drugs," he said, "[and] appreciate your freedoms and do not let them be taken away from you."
