Sheriff's office seeking help locating man missing for 10 years

Authorities are seeking information on the whereabouts of Robert Lee Hourihan who was last seen April 08, 2011 – ten years ago. Foul play is suspected in his disappearance.

Fluvanna County Sheriff Eric Hess, in a press release, said the cold case remains open "and we need the public's help to bring closure for the family. We are hopeful that someone out there may have that vital piece of information needed to help us close this case."

Hourihan was last seen by his wife on April 08, 2011 when he left for work at 6:30 a.m. He was seen later that morning around 7:40 a.m.

"Hourihan has not been seen or heard from since then," Hess said in the press release.

Hourihan was driving a white 2004 Chevrolet Cavalier with Virginia personalized license plates of "TARAMAE". The vehicle also had a

Winnie the Pooh sticker on the back window.

Hourihan's vehicle was later discovered abandoned in a Target Store parking lot in LaPlata, Maryland on May 28, 2011. Even though ten years have passed, investigators still believe that there are persons out there with critical information regarding this case.

"Robert Lee Hourihan's family are still seeking answers...We are sorry we have not been able to provide the family any closure in this case," Hess said.

The sheriff's office is asking anyone with information to contact Crime Stoppers at 434-977-4000, or Major David Wells, or Lieutenant Aaron Hurd of the Fluvanna County Sheriff's Office at 434-589-8211. A cash reward is available for information that leads to the whereabouts of Hourihan.

Supervisors approve list of new goals

The Fluvanna County Board of Supervisors approved 2021 Strategic Initiatives during its meeting on Wednesday (April 7).

First introduced in 2018, the Strategic Initiative document set out a list of goals focused on improving county services in areas like communications, service delivery, community development and tourism, and financial stewardship and efficiency.

COVID prevented supervisors from updating the list with new priorities in 2020, but they did have the opportunity to hold a work session in February of this year and add some items based on both their concerns and those raised by citizens.

Some of the new initiatives include:

- Implementing an annual recognition ceremony for community volunteers;
- Assessing the need for a professional fire chief;
- Adding a Frequently Asked Questions page to the county website;
- Enforcing the Spot Blight Abatement program;
- Reviewing county subdivision ordinance on cluster subdivisions;
- Planning for the implementation and standardization of capital improvement programs.

Supervisor Mozell Booker (Fork Union) raised concerns that the wording of the document was vague in terms of when items would be completed, saying that "unless you're going to have an implementation schedule somewhere to say when we will get this done, [and] who is pushing it forward, it's a good statement," but doesn't give the community a feel of when things might happen.

County Administrator Eric Dahl said that, in general, the initiatives would be completed by the end of 2021, but it might not be possible to get all items on that list cleared in just eight months.

Supervisors voted 5-0 to accept the plan.

Transfer of fire truck

The delivery of a new fire truck for the Kent's Store Fire Department has left one truck as surplus, and the supervisors were asked to forgo the usual practice of selling the vehicle at auction in favor of transferring it directly to the Cartersville Volunteer Fire Department for \$30,000.

Cartersville, located in Cumberland County, has an urgent need for a truck and reached out when they heard one might become available some months ago. Purchasing Officer Cyndi Toler said transferring the vehicle, rather than

auctioning it, was outside the county's normal procedure but did not violate any regulations.

Asked by Supervisor Donald Weaver (Cunningham) if they could get a better price at auction, Toler said "finding a value for a used fire truck is really difficult," and while they could theoretically get more at auction, they could also get far less. Dahl added that there was some benefit to helping a neighboring county if possible.

Weaver was concerned about stepping outside their normal procedures and perhaps getting less for the vehicle than they could but said he wouldn't vote against the resolution.

The final vote for 4-0-1, with Chair Mike Sheridan (Columbia), a volunteer with the Kent's Store Fire Department, abstaining.

Budget transfers

Supervisors approved a \$6,500 transfer from remaining CARES Act funds to the Children Services Act office for a new DocuSign system. CSA coordinator Bryan Moeller said that being able to sign and approve purchase orders and other documents electronically would not only be safer in terms of COVID, but would also save the office a significant number of staff hours in the processing of documents.

They also approved a transfer of \$88,527 in leftover funds from a roofing project at Carysbrook Elementary School to a smaller roofing and window repair project at Fluvanna Middle School.

Awards and proclamations

At the top of the meeting, supervisors voted unanimously on a community service award for Shawn O'Neal Collins. The late Mr. Collins was "a true gift to Fluvanna County's community," noted the proclamation, having devoted years to mentoring children and helping families across the county.

The Board also passed a resolution observing Child Abuse Prevention Month.

In a recent story on the proposed \$25 million capital improvement package, the Fluvanna Review reported the cost of a new county office complex at an estimated \$16.5 million.

At Wednesday's meeting, Eric Dalh broke down the costs for the entire project, with the cost of a new county administration building estimated at \$5.5 million and a new social services building estimated at \$7.4 million. Renovations to the current county administration and social services building would cost \$1.6 and \$2 million, respectively.

New Tax Breaks Changes the Tax Deadline and Benefits Millions

In addition to extending the Federal Tax Filing Deadline from APRIL 15TH to MAY 17TH, the recently passed American Rescue Plan Act contains several tax breaks for you and your family. Here are the major provisions of the bill that could mean more money in your pocket during the 2021 tax year.

- Child tax credit (CTC)**
- The CTC for 2021 increases from \$2,000 to \$3,000 for kids ages 6 to 17 and \$3,600 for kids ages 5 and under.
 - To receive the full tax credit your adjusted gross income must be under \$75,000 (Single); \$150,000 (Joint); or \$112,500 (Head of Household).
 - If your income is above these thresholds, you can still receive \$2,000 per child if your income is less than \$200,000 (Single, Head of Household); or \$400,000 (Joint).
 - You may be eligible to receive up to 50% of your 2021 child tax credit in 6 monthly payments starting July 2021.

- Child and dependent care credit (DCC)**
- If you and your spouse work and have children in daycare, or have an adult that you care for, you may be eligible for a larger tax credit in 2021.
- You can now spend up to \$8,000 in dependent care expenses for one qualifying dependent and get a 50% tax credit. This results in a maximum credit of \$4,000 (up from \$1,050).
 - If you have more than one qualifying dependent, you can spend up to \$16,000 in dependent care expenses and get a 50% credit. This results in a maximum credit of \$8,000 (up from \$2,100).
 - To receive the full tax credit, your adjusted gross income must not exceed \$125,000.
 - Dependents can include people of all ages, not just kids, as long as they meet the dependent qualifications.

- Earned income tax credit**
- If you're a household with no kids, the maximum earned income tax credit increases from \$543 to \$1,502.
 - More taxpayers qualify for the credit. The lower age limit for receiving the credit decreases from age 25 to age 19. The upper limit of 65 for receiving the credit is eliminated. There is no upper age limit for 2021.
 - You may use either your 2019 income or your 2021 income when calculating your credit to obtain the maximum credit.

- Stimulus checks**
- A third round of stimulus payments in the amount of \$1,400 is being sent to qualified taxpayers.
 - The payment phases out for income over \$75,000 for single taxpayers, \$112,500 for head of household taxpayers and \$150,000 for married couples.

- Action to take**
- **Look for updates on the advance payments for the child tax credit.** The IRS is sorting out how to get half of your child tax credit to you in 2021.
 - **Consider increasing dependent care expenses.** Look ahead to the rest of 2021 and consider if you should increase your dependent care expenses to take advantage of the significant increase in this credit.
 - **Conduct a tax forecast.** With the dramatic increase in these credits, you may want to estimate next year's tax bill. It may make sense to adjust your withholdings to account for a lower tax obligation.

Documentaries a passion for Lake resident

Joe Fabiszewski Jr., better known as "Joe Fab", is a producer, writer, and director, who has had the privilege of working with many well-known performers and public figures, including Tina Turner, Cher, Alison Krauss, Aretha Franklin, Maya Angelou, President Jimmy Carter, Senator Sam Nunn, Senator Howard Baker, James Carville, Mary Matalin, Placido Domingo, and Renee Fleming. And that is only a fraction of the list.

No doubt Fab, who lives in Lake Monticello, has many stories to tell about his encounters with these people but what is more intriguing is his creative mind delving into the lives and stories of ordinary Americans -- less glamorous but infinitely more provocative.

Born in Baltimore and growing up in the Maryland suburbs around Washington D.C., Fab dropped out of college to work at a theater in Rockville, MD.

"It was my version of running away to join the circus," said Fab, smiling. Since 1972, he built a career in entertainment and not long after married his wife, Kay in 1978. He continued working in live theater in management and producing. In the early 1980s, he was general manager of the Wax Museum Nightclub, which at the time was the largest club-style venue in Washington, DC, featuring many well know bands and entertainers.

As a freelancing producer, he produced live events, including theater as well as special events, in such diverse venues as the Kennedy Center, RFK Stadium, Ford's Theater, the National Theater, the Source Theater, and other locations in DC. For almost two decades he wrote, produced, and sometimes staged the Lighting of the National Christmas Tree, in which Presidents George H. W. Bush, Bill Clinton, and George W. Bush participated. These shows were an hour long and produced live for television. Fab said these were a production challenge since they had internationally known artists on the program before the president delivered an address and the lighting the tree.

But it was in the late 1980s, Fab began embarking on a career in documentary film. His award-winning documentaries include "NOT The Last Butterfly," "Bedford: The Town They Left Behind," and "Paper Clips."

In 2016, "NOT The Last Butterfly" focuses on The Butterfly Project, a non-profit organization using lessons of the Holocaust to educate people about the dangers of hatred and bigotry. There are 1.5 million painted butterflies dis-

played throughout the world, symbolizing the renewal of life.

"Bedford: the Town They Left Behind," about the Bedford Boys from the Virginia town of the same name who lost an entire National Guard unit during World War II. But his best-known documentary, titled "Paper Clips," was screened in over 160 theaters and was on HBO for a year, garnering over a dozen awards and an Emmy nomination.

"I became passionate about films in high school, where my drama teacher introduced me to classic films, from the silents through the golden age of movies. I began enjoying documentaries as a viewer after high school. My first film was "A Cry in The Woods," about the struggle between environmentalists and the timber industry," he said. "My work is inspired by fascinating people, people on a mission, people living out their purpose in life. I like to tell stories that stay with the viewer long after the last frame of the film has faded from the screen. These are stories that have a chance of changing lives." Feb is not about celebrity, that's obvious. He is about finding those extraordinary people who go the extra mile to make a difference in someone else's life.

"Paper Clips," is the story of children in a middle school in rural Tennessee.

"Because everyone in the tiny town is white and Christian, the principal realized that the students weren't being prepared to go out and succeed in a much more diverse world. She looked for something to add to the curriculum that would teach them about other cultures. She chose the Holocaust because it would teach about Germans and Jews, none of which lived in the town, and about perhaps the worst example of what can happen when two cultures are unable to live together peacefully," he said. "When the program began, one of the first things the students learned was that Hitler killed six million Jews. It was a number unfathomable to the students, who decided that to understand it they would try to get six million of something in front of them."

One child found on the internet that some Norwegians would wear a paper clip under their lapel during World War II as a silent symbol of their resistance to the Nazis. So the students set out to collect six million paper clips.

"That is about the first five minutes of the film. What happens after that is inspiring and kind of miraculous. I was nominated for an Emmy for the film, and, while we lost out to a PBS film, I can tell you that it is an honor just to be nominated."

His current documentary, "When My Time Comes" is a single one-hour program that will be broadcast on most PBS stations nationwide beginning this month.

"The film is about the controversial subject of medical aid in dying (MAID). MAID is an end-of-life option by which terminally ill patients who meet certain legal criteria can request medication from their physician to end their lives when they find their suffering unbearable. It is currently authorized in nine states and the District of Columbia, with a tenth state - New Mexico - expected to adopt it soon, possibly by the time this is printed."

He made the film with Diane Rehm, the Peabody Award-winning NPR journalist, whose husband died a painful death in 2014 and for whom MAID was not available where he was living.

"We crossed the country interviewing people both pro and con — patients, family members, doctors, lawmakers. All of us will die, and COVID-19 has forced us all to consider death as something that could come sooner than we had thought," he said. "This awareness makes the questions of how we die come into greater focus. Which in turn raises questions of patient autonomy: how much control will I have over my death? Who determines how much I'm suffering - me or my doctor? If my suffering is more than I can bear, what are my options, if any?" Check local listings for dates and times and it will also be streaming on most PBS station websites.

Though Fab has been around celebrities and public figures, he is more impressed by the children in Tennessee, the heroes of the first day of the D-Day invasion, which he says were both courageous and humble, and Holocaust survi-

vors inspiring teachers.

"All of these people and many others from my other projects taught me that ordinary people can often rise to surmount challenging obstacles."

Fab is taking a break for a few months.

"There are a few documentary projects I'm considering and also a book and screenplay that I'd like to write. I haven't decided what to do next, but there are plenty of possibilities."

Fluco golfers end strong season – host Jefferson District meet

High school golf in Virginia is normally a fall sport. This year, due to COVID-19, the golf season was moved to early spring. The Fluvanna County golf team had an impressive, abbreviated season, finishing with a 5-1 record in dual meets. On April 7, the Flucos hosted a seven team Jefferson District regular season final match over the difficult Lake Monticello course.

The format for high school golf matches is that each team enters its top six players and at the end of the match the four best scores for each team count in determining the winning team. Accordingly, with Fluvanna County, Charlottesville, Albemarle, Western Albemarle, Monticello, Louisa County and Orange County all compet-

ing, 42 golfers would have been expected, but Charlottesville only fielded a team of four, so forty golfers participated.

While the match was to determine the order of finish in the Jefferson District tournament, the Flucos were also involved in a match within the match. Coach Bryan Searcy explained that only four of the competing teams are in VHSL Class 3C and the top two of these four in this tournament go on as a team to compete in the Region meet. The two teams that do not make this cut send only their top four finishers who compete on an individual basis at the Region meet.

The Jefferson District meet was won by Western Albemarle with a four player score of 330. The Flucos finished fifth with a four player score of 380. The Flucos did not manage to come in second in the match within a match, as they were edged out by Monticello. Therefore, the Flucos will not compete as a team at the Region match but will send their top four players to compete individually. Those players are: Killian Donnelly, who shot 83 in the District match, the fifth best score, Jared Williams whose 87 was 11th best, and Cohen Purviance and Mason Chiovara. The other two competitor for the Flucos were Kessler Potter and Sarah Beth Robinson.

The high school golfers play from the regular men's and women's tees which are a challenging test. The boys playing from the white tees are confronted with a course of 6,296 yards. The girls playing from the red tee play a course of 5,350 yards. The Lake Monticello course is tight and it

has quite a bit of water. There are no places where an errant shot can go into an adjoining fairway, as is sometimes the case even on courses played by the PGA pros. In fact, the starter at the first hole reminded the players that "there is out of bounds on every hole here."

It is impressive to see how far these young athletes can hit the ball with various clubs. On the second hole, a short 315 yard par 4, Donnelly hit his tee shot to the front fringe of the green and got down in two for birdie.

It is certainly the hope of all concerned that these golfers will be back out competing in August/September of their year for the 2021-2022 school year.

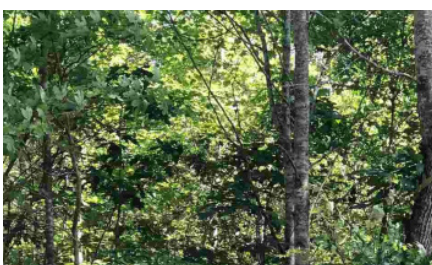

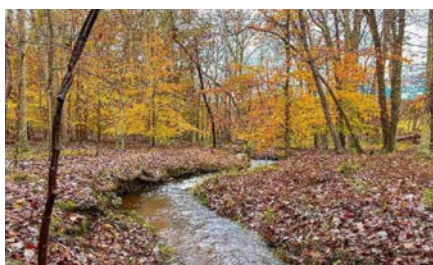
