**Cross-Training: Essential** for Small Business Survival

Have you considered cross-training your employees to ensure more than one person knows all key functions? Cross-training can be a win-win situation for you and your employees. Large companies often use it to prepare managers for future promotions. But in small companies, it can be the difference between success and failure.

#### Why companies cross-train

Cross-training provides greater flexibility in scheduling, especially when dealing with unexpected workload and staffing issues. It also helps employees develop expertise in other areas and increases their awareness of the company's roles and functions, helping them better understand where they fit into the big picture.

For employees, some of the biggest advantages of cross-training include:

- Learning new skills
- Working more efficiently and effectively with other departments
- Feeling more invested in the company
- Enjoying growth opportunities

#### **Create your cross-training plan**

your team understand why the company is cross-training employees. Reasons may be to prepare for organizational growth or new industry standards, to cover functions when someone is impacted by the pandemic, or to adjust to a changing structure around roles and responsibilities. Then continue to communicate with your team throughout the program with status updates and team meetings about progress and next steps.

Present cross-training as an opportunity. Your employees may be more resistant to cross-training if it feels like it's an obligation or a threat to their roles. You can help them feel motivated by highlighting the benefits, like developing different skill sets and having a better understanding of how their contributions positively impact the business.

Start with a small pilot program. Test the waters with a select group of employees to get a better understanding of what works and what needs to be tweaked. You can then expand the program later as you gain insight and experience.

Determine cross-training hours. Figure out how much time can be dedicated to cross-training for each team to still run efficiently. This may include setting aside a few hours each day, or setting aside full days for a certain period of time to focus on cross-training. If your business is seasonal, ramp up cross-training during your low seasonal period.

Listen to feedback. You may learn that some employees have already started cross-training on their own. You can use this kind of valuable feedback to fine-tune your official cross-training program.

Keep in mind that some employees may resist having to train others, and productivity may suffer in the short-term. But remember the cost of not cross-training. If ou lose a key employee and no one else knows how to do their tasks, your business may have trouble finding a replacement.




### Piper LaRochelle joins elite soccer team

### Walter K. Lindenmann



Oct. 26, 1936 - May 1, 2021

Walter K Lindenmann died on Saturday, May 1, 2021, at the age of 84. Walter was born in Brooklyn, N.Y. on October 26, 1936, the son of the late Karl and Elsie Lindenmann.

Walter started his career as a newsman for United Press International and was the education editor for the Denver Post and the Hartford Times. As a public relations executive, he managed the research departments. He was director of Survey Research of Hill and Knowlton, Inc. and President of its research subsidiary, Group Attitudes Corporation, from 1976 to 1985. He created the Research Department of Ketchum Worldwide and served as the company's Senior Vice President/ Director of Research from 1987 to 2000. He also served as Director of University Relations at Hofstra University, and as Assistant Director of Public Information for the Connecticut State Department of Education, as a public relations account supervisor at Hill and Knowlton Inc. and as manager of Opinion Research Corporation.

Walter lectured extensively in the United States and also Austria, Canada, Denmark, France, Germany, Great Britain, Hong Kong, Italy, the Netherlands, Puerto Rico, Singapore and Spain.

In 1999, Walter was named by PR Week as one of the 100 most influential public relations professionals of the 20th century.

Walter earned a bachelor's degree in English from Queens College in New York City, a master's degree in journalism and a PhD in sociology from Columbia University. While at Queens College, he was elected to Phi Beta Kappa and was a member of the Lutheran Club, where he met his wife, Ellen.

Walter and Ellen lived in Denver, West Hartford, Port Chester and Dix Hills, N.Y. The couple retired to Lake Monticello, Va. in 2000. Walter was active in Grace and Glory Lutheran Church, the Fluvanna FlutterWheels square dance club and the Friendship Force of Charlottesville, Va.

Walter loved the opera, traveling, and camping with his family. He loved sports and was an avid fan of Notre Dame.

He is survived by his wife of 58 years, Ellen Ann, a former New York city teacher and guidance counselor; four children, Melanie Brooks, Paul and his wife Cathy, Mark and his wife Karen and Meredith and her husband James Wankel; eight grandchildren, Christine, Renee, Kathryn, Eve, Gage, Max, Julianna and Jessica; sister, Annemarie Noto; and sister-in-law Arlene Benzmiller. He was preceded in death by two grandchildren, Keith and Alyson Brooks.

There will be a memorial service to celebrate Walters' life at a later date.

### Dominion plans to move coal ash at Bremo to lined landfill

Dominion Power held a public meeting at the Fork Union Community Center on Thursday night (April 29) to provide an update on its plans for the 6.2 million cubic feet of coal ash stored at their Bremo facility.

About a dozen residents, masked and socially distanced, attended the meeting.

The toxic ash, a byproduct of Bremo's eight decades as a coal-fired power plant, is currently stored in what's called the North Ash Pond near the now-idle facility. Because this pond has no bottom liner, toxic material and heavy metals can potentially leach into the groundwater and the nearby James River.

Legislation in 2019 required Dominion clean up the 27 million cubic feet of coal ash held at Bremo and other facilities across the state within 15 years, either through recycling or removal to fully lined landfills, or a combination of both.

Sarah Marshall, External Affairs Manager for Dominion, explained that the company had decided that the "safest and most economical" option for Bremo was to move the ash into a lined landfill not far from its current location. Because the transfer would happen entirely within Dominion's property, they would not have to use public roads to haul it from one place to another. A short internal road will connect the two sites.

On April 1, Dominion filed with the county for a special use permit as the first step in that process.

If all goes according to their current plans, it will take a couple of years to get the needed county, state, and federal permits before construction can actually begin. They anticipate it will take until 2030 or 2031 to build the pond and move the coal ash. Once completed, the landfill will be capped and covered with soil.

The tentative budget for the project is \$500 million.

Of that amount, they have made a proffer of around \$47 million for the Fork Union Sanitary District (FUSD), \$500,000 to Parks and Rec for a recreation facility, and \$2 million to VDOT for road improvements around Bremo Road (Rt. 656).

"We've had a lot of conversations with the county and with VDOT," said Marshall. "We want to be good neighbors."

The project will not, however, be invisible to local residents. Dominion believes that there will be a daily increase of about 100 construction-related vehicles on and around West Bottom Road for about 3 <sup>1</sup>/<sub>2</sub> years during the digging of the new landfill.

Included in the state legislation is a requirement for Dominion to monitor water quality of wells and household water supplies around the plant. Wells are tested once a year for the first five years, then every five years for the next three decades.

Asked what Dominion would do if they found contamination of a homeowner's well, Marshall said they were required to provide drinking water until the issue was resolved, and would pay for the homeowner to connect to the FUSD water line, dig a new well, or otherwise reestablish a safe water supply.

The Fluvanna County Planning Commission will discuss the special use permit and rezoning request at their March 11 meeting.

### Local woman helps to design water system in Uganda

If you ask most young women in high school what they want to do with their lives and what career they plan on pursuing, chances are they will sometimes lean toward a career in nursing or becoming an English professor or education or child studies - all solid and noble professions women often undertake. But Nicole Kent chose a different path not often considered by young women, civil engineering.

For those who hold their nose while taking math and science to get college credit, Kent embraced her courses and developed a passion for them.

"I was a little hesitant entering into college and not knowing what civil engineering encompassed, but I had always loved studying math and science, so I figured I would enjoy it and I have," said Kent.

A graduate of Fluvanna High School in

2017, she will be completing her degree in engineering at the University of South Carolina. During her junior and senior years of high school, Kent had begun thinking about pursuing a degree that would allow her to enter into developing nations to help them physically while being involved with missions.

"I started paying more attention to the issues that were being faced internationally, which is when I first heard more about the global water crisis. It was crazy to hear about people who had little to no access to clean drinking water and I decided I wanted to be able to help make a difference through engineering solutions in water infrastructure."

She was able to get involved with a wide range of engineering opportunities while working on her degree at the University of South Carolina, including joining the student chapter of Engineers Without Borders, doing undergraduate research in water resources engineering, studying abroad in Thailand, and taking on a few internships. All of that confirmed to her that civil engineering was what she wanted to do.

Through Engineering Ministries International (EMI), which is a Christian non-profit organization, Kent will be involved in a program to help design a water system in Uganda. The group is composed of design professionals who use engineering and architecture to meet peoples' physical needs while engaging in Christian relationships

"EMI has offices around the world, but the Uganda office is specifically working on a few projects right now, including dormitories for a boarding school, an addition to a hospital, and a living facility for disabled orphans," said Kent. "I will get to help with the design of some of these projects that are still in the design phase as well as assist in overseeing construction management for projects in that phase. In addition to the engineering work, I will have the opportunity to volunteer with local ministries, schools, churches, and other non-profits to serve in that capacity as well."

After this program, Kent said she will be returning to Columbia, South Carolina, where she attended the University of South Carolina to work for a regional private engineering consulting firm.

"Over the next four years, I will be pur-

suing my professional engineering (PE) license in water resources engineering. My long-term goal is to work for a nonprofit on projects assisting the global water crisis," she said. "I would love to be able to spend more time abroad in doing this and could even see myself working in disaster relief either through volunteer work or even as a career. I know I will always continue to have a passion for developing communities and my hope is to always be partnering in some way with them, but I think it will just depend on whether or not I am doing that in a volunteer role or career role throughout different seasons of life."







## **Keeping the books**

Scottsville has been home to a number of banks over the years, and it is interesting to think how records were kept and accounts totaled before the advent of computers. In Irene Dorrier's collection of items from her grandfather, Walter S. Dorrier, is a clever little gadget produced by the C.E. Locke Manufacturing Company of Kensett, Iowa. Called a 'Locke Adder,' it was touted by the company as the "American Abacus," an improvement "on its rustic Asian cousin." It was a slim metal device, 11" by 4" with a row of sliding bars labelled from "cents" at the bottom to "1,000,000 dollars" at the top.

The adder was described as "visually pleasing, with elaborate Victorian scrollwork stamped into aluminum sheet metal painted black or copper bronze." The ads suggest that you lay it down on your ledger and move it down line by line as you enter the items for calculation.

Walter S. Dorrier worked for the Scottsville National Bank, eventually succeeding David Pitts as its President. We don't have a photograph of the Locke Adder in use at the bank, but we do have a picture of Susie Powers Blair and her sister, Lucy Powers, "tending the bank books" at the National Bank, apparently without the assistance of the adder.

Adding machines were available but were expensive--the Burroughs machine debuted in 1892 at \$475. The price eventually came down to \$175, but the Locke Adder could be had for \$5 and was easily portable.

The instructions for the Adder admonished sternly: "Remember that the adder can make no mistakes. If you ever get an incorrect result it will be because you have failed to operate it properly."




