



# **Hi-Tech Travel -Just Around the Corner?**

Happy August! Where has 2021 gone? I can't seem to recall another year that has rolled past as quickly as this one has. We are finally getting an opportunity to attend to some much-needed downtime and will be traveling to upstate New York for the 109th edition of the Pendorf Family Reunion! Great fun ahead with the NY cousins of my wife.

As befits our upcoming plans, I felt this month we would have some fun so here we go...

Living in the information age, we are accustomed to new and innovative tools that change the way we live. We can control everything in our homes with our voice. We can talk face-to-face, albeit digitally, with anyone, anywhere in the world. We even carry supercomputers with all knowledge known to man in our pockets.

As we celebrate summer vacations, why not explore some hi-tech travel changes that could be coming over the next few years. Enjoy!

• You might be trading in your vehicle **for a self-driving car subscription.** Autonomous cars have been around for a few years now. You can grab a self-driving Lyft in Las Vegas or utilize Telsa's autopilot software to allow your car to accelerate, steer and brake on its own while staying in its lane. While they're out there, autonomous cars are still considered somewhat of a novelty. According to intellectual property company GreyB, every car manufacturer is working to change that.

At some point soon, self-driving cars will be commonplace. And some time after that, they will be the standard. Once that happens, rideshare programs will offer subscriptions that guarantee a car will pick you up and get you where you need to be. Instead of buying and maintaining a vehicle, all you'll need is an app and a credit card to get around town.

• Magnets and a large vacuum might be the preference over airplane travel.

From the beginning of time, the force of friction has been the biggest puzzle to solve in order to move something from point A to point B. Enter the Hyperloop. Originally diagrammed by Tesla and SpaceX CEO Elon Musk, the idea is to build a pod in a tube that eliminates ground friction with the use of magnets and reduces air resistance by creating a vacuum.

The result? Ground travel at 700 miles per hour with very low operating costs. It could get someone from San Francisco to Los Angeles (380 miles) in 30 to 35 minutes for about \$20 according to Discover Magazine! The first test drive involving passengers was successful at the end of 2020. The hope is the first one will be fully operational within the next five years.

More hospitality services will be per**formed by robots.** In many hotels around the world, everything from front desk support and luggage assistance to room cleaning is being handled by artificial intelligence. In China, you can check into FlyZoo hotels with facial recognition, according to CNBC. In San Jose, you can order snacks or blankets to be delivered by a robot right to your room. In New York, a robot will collect your things and deliver it to your room when you check in. Hotels that utilize this technology are considered early adopters, but it won't be long before it's mainstream.

Like all new technology, there are kinks to work out and new problems to solve, but one thing is certain - big changes are right around the corner! Who know, maybe we will be offered tax credits for this new technology like we have in place for electric vehicles and solar panels! Have a safe rest of the summer! See you after Labor Day. 

In all your queerness and uniqueness and difference, you are wonderfully made. If your family or friends or church rejects you, there are folks in this community who will welcome you with open arms. I am one, but there are many more. I promise to take every opportunity to stand up for you and your rights. You are a beloved child of God. No person, no vote, no policy can take away that fundamental truth.

#### **Take down bird feeders**

As the dangerous heatwave continues, many compassionate people have been putting out food and water to help birds survive. And while the fresh water is certainly giving avian visitors and other wildlife an opportunity to cool down and hydrate, bird watchers might want to consider taking down their feeders.

High temperatures are causing the jelly in oriole feeders to thicken, which can turn these food sources into deadly glue traps capable of ensnaring and killing birds. And scientists are still struggling to determine the cause of the deadly disease that is blinding and claiming the lives of songbirds throughout the eastern and midwestern U.S. Until more information is available, wildlife agencies are urging homeowners to take down their feeders to prevent birds from congregating and to help slow the spread of the disease.

Wildlife enthusiasts can continue to provide food sources for birds by planting berry- and seed-producing trees and shrubs and allowing native plants and flowers to grow wherever possible. For more information on living in harmony with birds and other wildlife, visit www.PETA.org.

# Treat children with respect

At a recent FCPS School Board meeting we heard vitriol and misinformation. We heard disturbing demands for FCPS to break the law. We saw no attempts to find common ground or workable solutions.

There is common ground!

We all want our children to be treated with respect. We all want our children to have access to great teaching, to be guided on a path to success, and to have equitable access to resources.

All parents/guardians, regardless of race, gender, ethnicity, or religion share these views! There are basic truths!

Transgender students are more likely to feel unsafe in school, more likely to be bullied, and three times more likely to attempt suicide (American Academy of Pediatrics).

Critical Race Theory is not a K-12 curriculum or course in FCPS.

CRT is a legal framework to understand the impact of race on systems in our society.

Teaching history and talking about race is not CRT. All children can and should learn the complete history of our nation to help them understand each other and our world.

Our students, parents, staff, and community want all children to be treated fairly and have equal access to resources. Our children benefit from an inclusive school system, respects them as individuals, and provides a nonthreatening learning environment.

At this meeting, we also heard a concerning revelation that the school board deals with issues involving "sexual contact in our schools on a monthly basis in closed sessions." We understand the need for closed sessions to address these confidential concerns. However, the community must be advised on any actions or new policies that result. Because our students are our top priority we expect future communication from our board leaders, on these concerns, to be truthful and transparent.

And as a community, let's also expect that our leaders work to seek solutions and search for common ground rather than use social media to divide us. Let's expect assurances that student safety will be a true priority.

Finally, let us embrace civility as we work with our school officials and community leaders to create a school division capable of addressing the needs of all children.

#### New superintendent, new teachers, new school year

Even though students aren't due back until Aug. 11, school started for new staff Monday (Aug. 2). More than 40 attended first day orientation at the Fluvanna County High School.

They met new Superintendent Peter Gretz and many Fluvanna leaders.

While they ate lunch, Executive Director of Human Resources, Operations and Student Services Don Stribling presented Fluvanna's constitutional officers: Tristana Treadway, clerk of the circuit court; Mel Sheridan, commissioner of the revenue; Jeff Haislip, commonwealth attorney; Eric Hess, sheriff and Linda Lenherr, treasurer.

After introducing herself, Lenherr joked with the new staff.

"You'll get to know my name because it's on your paycheck," she said.

Also present was Aaron Spitzer, parks and recreation; Bryan Rothamel, economic development and Eric Dahl, county administrator.

"And I'm the one who distributes the money for your paychecks," Dahl said, laughing.

During the morning session, Stribling told the group they can count on good evaluations by keeping three things in mind:

- · Build relationships with your students and their families;
- · Communicate;
- Focus on instruction.
- "Think of what is in the best interest

of your student," Stribling said. "Think of how you want to be treated. (How you handle a situation) may not be how you would do it at your house, but do what's best for that student."

After lunch, Gretz voiced some thoughts. "We have a lot of work to do, to be sure, "he said. "There were academic gaps within our student groups before the pandemic, and when schools had to close and move through the various forms of operation over the past year, those gaps in some cases widened. We intend to work intensely to make sure all of our learners are maximizing their academic potential."

"But our first, most important task is to re-engage our students and begin cultivating the transformational relationships that will pave the way for deep learning to happen. Our students in many cases have been isolated, without structure and routine and without connection. That's our top priority - to ignite the spark of curiosity and inquisitiveness by building relationships marked by trust, care and relentless pursuit."

Gretz's first school board meeting was eventful as about 40 people made their thoughts known about masks, transgender policy and urging the board to not allow teaching that might make their white students feel bad about being white.

Gretz will give his recommendation on how to address the state recommendations on transgender inclusion at the







#### Fluco fall sports are back - we hope

Amazing as it may seem, the Fluvanna County High School fall sports schedule has come out and and it looks like a normal year is about to begin.

First up is varsity football. Coach Mike Morris returns, and the season starts with two scrimmages on Aug. 13 and Aug. 20. The regular season has the Flying Flucos traveling to the Valley on Aug. 27 and Sept. 3 to take on Broadway High and Spotsylvania. The first scheduled home game for the varsity football squad is not until Sept. 10 when they host Brookville High. Sept. 17 is a bye week, followed by the beginning of play against Jefferson District opponents. Perennial powerhouse Louisa County High will host Fluvanna on Sept. 24. On Oct. 1 and 8, the Flucos will host Goochland and Monticello. On Oct. 15 they will play at Orange County. On Oct. 22 they will host Western Albemarle. On Oct. 29 they will travel to Charlottesville. The regular season ends on Nov. 5 when the Flucos host Albemarle. In light of current health conditions, all of these dates and all of the dates listed below are subject to change at any time and on short notice.

The golf team under Coach Bryan Searcy opens its season early and ends early as golfers must contend with the end of day light savings time. This week, the golf team will host the Bockman Invitational on Aug. 5. The tournament is named in honor of George Bockman, an outstanding golfer, a former coach and assistant coach in several sports, a bus driver and the builder of the baseball and softball dugouts. On Aug. 9, there is a district tournament on the schedule. Then back-to-back on Aug. 11 and 12, the Fluco golfers will travel to a three way match against Monticello High and Charlottesville and a two way match against Louisa. They then return home for three-way matches, on Aug. 17 against Goochland and Staunton and against Monticello and Nelson County on Aug. 19. At that point the golf team will be about halfway through its season and the football team will still not have played a regular season game.

Volleyball is a sport in which the Flucos have traditionally fielded strong teams. It is a sport with a grueling schedule. The Fluco girls open their season on Aug. 26 with a scrimmage against Chancellor High, at home. They are scheduled to play in scrimmage tournament two days later. On Sept. 2, they start a 17-game schedule by traveling to Waynesboro. Waynesboro then comes to Fluvanna on Sept. 7. In eleven days, they then travel to Louisa, host Monticello, travel to Chancellor and host Orange County.

The cross country teams (boys and girls) have their first meet on Aug. 25 at Madison High. They then will compete in the Ragged Mountain event on Sept. 7. They then run on Sept. 15 at Goochland, on Sept. 18 at Fork Union Military Academy (FUMA) and on Sept. 22 at Albemarle. The teams do not have scheduled home meet all season.

Field hockey is a comparatively new sport for the Fluco female athletes. Like volleyball, field hockey has a tiring 17 game schedule. The team starts it sched-

ule against non-traditional opponents for Fluco sports squads. On Aug. 24 they will play at EC Glass High. Then on Aug. 26 and Sept. 2 they will take on Highland Springs High away and then at home. On Sept. 3 they will travel to Collegiate to take on the JV there. On Sept. 7, they will host EC Glass. Not until Sept. 9 will they play a Jefferson District rival, when they travel to Louisa.

The competition cheer squad will host a cheer invitational on Sept. 25, travel to Harrisonburg on Oct. 2 and compete at Goochland on Oct. 6.

The Flucos field JV teams in football, volleyball and field hockey. In volleyball and field hockey the JV schedules are the same as the varsity with the JV contests preceding the varsity matches. The JV football team generally plays the same opponent each week as does the varsity, but the JV games are on Wednesday or Thursday rather than Friday and when the varsity is home the JV is normally away and vice versa. The Flucos also have a sixgame middle school football schedule.

#### Youth learns success by playing the drums

Aiden Kraft graduated this year from Fluvanna County High School after what was for him and other students a trying year due to COVID and its restrictions.

"His interests in music were particularly impacted by remote learning and social distancing requirements. It severely limited his participation in several art-related activities during his junior and senior years of high school. This included involvement in the school plays, music, and band, as well as the marching band," said his mother, Melissa.

Aiden tried a variety of sports but none of them appealed to him. Music sparked his interest and while his father played guitar in the church praise band, Aiden became interested in trying his hand with many different instruments with the church's youth praise band.

"Percussion seemed to be of particular interest with him. Kids like to hit things with sticks, so why fight it? Eventually, Santa brought him a drum set to get started on. This led to experimenting with the Cajon (box drum), bongos, and marching snare," said Melissa. "The seed was planted and his interest in percussion and has been a driving force with him ever since."

He started playing percussion instruments in middle school which included the drum set and marching snare.

"He made the marching band his freshman year of high school but was extremely disappointed that he did not make it for marching snare. He wanted to quit. We told him that once he quits, there is no going back," said Melissa. "We made a deal with him. We told him that we would make every effort to provide him with the tools needed to succeed, including formal lessons with his instructor in Charlottesville if he put in the time and effort to better himself and his talents."

His pursuit of the drum and bugle corps stemmed directly from his drum instructor in Charlottesville. His instructor marched in several drum corps in his youth and even played in President Nixon's drum corps at the White House while in the armed forces.

"Aiden's instructor explained that it To advertise call: 434.207.0223

was an extremely beneficial way to grow as a percussionist and learn from and bond with other musicians from across the country," Melissa adds that through countless hours of practice and dedication, he worked his way up to snare the following year and guad (tenor) drums that he currently plays. "He experienced first-hand how hard work and determination leads to success."

Aiden became heavily involved in the FHS marching band but in the last year, all practice and performances were remote due to COVID. They were forced to perform via compilation videos that were posted to YouTube for viewing.

This summer, he auditioned for and was accepted to three different drum corps in New Jersey, Iowa, and Minnesota and was accepted into the River City Rhythm Drum and Bugle Corps in Minneapolis, Minnesota. Because of COVID, the number of drum corps actively having a summer season has been reduced. Because of this, competition was intense with more musicians looking for a spot in a reduced field. River City had 80 percussionists audition from across the country and only 24 were accepted and Aiden was one of only five tenor players to be accepted by River City. The other percussionists consisted of snare and bass drum players.

In addition to the reduced number of drum corps, the season itself was also shortened. A normal season can be up to three months long. Since this season is only five weeks. Aiden is working to learn an entire season's worth of material - music and marching - in that time. During those five weeks, he will be practicing seven days a week and performing in Minnesota, Wisconsin, Iowa, and Indiana. Normally, there is a competition for all of the drum and bugle corps at Lucas Oil Stadium in Indianapolis, Indiana at the end of the season but due to COVID, there will not be a competition this year. instead, it will be a celebration and con-

Aiden also performed most of the percussion parts in the live band performance of the FCHS play "Shrek" in his sophomore year. The band was required to play in a completely different room with monitors showing the play performance to stay in sync. He played 42 different percussion


"It was amazing to see him surrounded by instruments as well as see the preparation and organization that he put into playing each instrument in time with the play."


Aiden will be attending PVCC this year in the hopes of transferring to a four-year university in the future.

"I am not sure what I want to do as a career which is why I am choosing to do the community college route, in the hopes that it will provide me some insight on potential professions that I may be interested in," said Aiden. Drumming has taught him never to be a quitter and what it takes to persevere. He has learned valuable skills that will help him to succeed in whatever he chooses in life.

As for drumming, he thinks it will remain a hobby.

"The age out for most drum corps is 23 years old but there are other drum corps that do not have age restrictions, so that might be something to do in my spare time."

#### Scottsville's old oak silent witness to history

Century Oak was a cross section of an enormous, old tree cut down some time around 1930 and installed in the principal's office of Scottsville High School, a gift of the Class of 1935. The tree rings were marked with corresponding events in U.S., Virginia, and Scottsville history. The oldest date was 1492, indicating that our tree was more than 400 years old.

For Virginia history, 1619 marks the arrival of the first shipment of African slaves and the meeting of the first representative legislative assembly in the New World. Also noted are the founding of four institutions of higher education: William and Mary (1619), University of Virginia (1819), Randolph Macon (1832), and Virginia Military Institute (1839). The Scottsville events noted include the founding of Albemarle County (1745), the moving of the county seat to Charlottesville (1762), the building of various churches in Scottsville beginning with the oldest, the Presbyterian Church (1830). Also marked are the construction of the James River bridge (1907), Victory Hall (1918), and



the opening of the new Scottsville High School (1927), the latest date of a tree ring.

A less familiar event is the Webster-Hayne debate, here cited as 1823, though it actually took place in 1830. The debate focused on the meaning of the Constitution, particularly on the issue of states' rights. Students back in the day probably had to memorize Daniel Webster's words: "Liberty now and forever, one and inseparable." Another error is the date (1716) of Patrick Henry's speech ("Give me liberty or give me death!"). Since he was not born until 1736, this date is unlikely. Actually it should be 1775. Still the tree offered a silent witness to the many years of our history.

Alas the tree is no longer with us. It came to the museum when the high school closed in 1967 and eventually was put outside the Barclay House, where it quietly crumbled and was hauled away.

#### **Family Educational Rights** and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students."

- Parents or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies.
- Parents or eligible students have the right to request that a school correct records which they believe to be inaccurate or misleading. If the school decides not to amend the record, the parent or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent or eligible student has the right to place a statement with the record setting forth his or her view about the contested information.
- Generally, schools must have written permission from the parent or eligible student in order to release any information from a student's education record. However, FERPA allows schools to disclose those records, without consent, to the following parties or under the following conditions (34 CFR § 99.31):
  - School officials with legitimate educational interest;
  - Other schools to which a student is transferring;
  - Specified officials for audit or evaluation purposes;
  - Appropriate parties in connection with financial aid to a student;

  - Organizations conducting certain studies for or on behalf of the school;
  - · Accrediting organizations;
  - To comply with a judicial order or lawfully issued subpoena;
  - Appropriate officials in cases of health and safety emergencies; and
  - State and local authorities, within a juvenile justice system, pursuant to specific State law.

Schools may disclose, without consent, "directory" information such as a student's name, address, telephone number, date and place of birth, honors and awards, and dates of attendance. However, schools must tell parents and eligible students about directory information and allow parents and eligible students a reasonable amount of time to request that the school not disclose directory information about them. Schools must notify parents and eligible students annually of their rights under FER-PA. The actual means of notification (special letter, inclusion in a PTA bulletin, student handbook, or newspaper article) is left to the discretion of each school.

Policy for Providing Free Meals for School Divisions Participating in the Seamless Summer Option for all Schools in the Division (Divisionwide)

Date: July 1, 2021

FLUVANNA COUNTY PUBLIC SCHOOLS today announced its policy for providing meals for children served under the National School Lunch, and/or School Breakfast Programs. All schools in the division will be participating in the Seamless Summer Option (SSO) as implemented under the Healthy, Hunger-Free Kids Act of 2010. Enrolled students will be provided a nutritious meal for breakfast and lunch each day at no charge to the household. Households will not be required to submit a meal application form to receive meals at no charge. Each household will receive a letter informing them of the program, including contact information for any questions. Each school and/or central school nutrition office has a copy of the policy, which may be reviewed by any interested party.

The new school year requires a new meal application. Although school meals will be provided free to all children, school funding and eligibility for other programs depends on completed meal applications. A new meal application must be completed if you have not already turned in an application for the new school year. School meal eligibility does not roll over from year to year. It is important to submit a completed meal application as soon as possible.

- Only one meal application is needed for each household.
- Applications are available online at http://fluco.org/food-services-home/.

Household size and income will also be used to determine eligibility for Pandemic Electronic Benefit Transfer (P EBT) benefits for children who are not enrolled in a Community Eligibility Provision (CEP) school. Children from households whose income is at or below the Federal Income Eligibility Guidelines, shown in the chart below, may be eligible for P-EBT benefits.

Children who are members of households receiving Supplemental Nutrition Assistance Program (SNAP) benefits (formerly the Food Stamp Program) or who receive Temporary Assistance for Needy Families (TANF) may be automatically eligible for P-EBT. Children who are homeless, migrant, or runaway may also be automatically eligible for P-EBT. Foster children, who are the legal responsibility of a welfare agency or court, are eligible for P-EBT regardless of the income of the household with whom they reside. Children who are members of households participating in the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) may also be eligible for P-EBT based on the household's income.

Application forms will be distributed to all households with a letter informing households of the availability of P-EBT for their children. Applications are also available at the principal's office in each school and at the central office. To apply for P-EBT, households must only fill out one application per household and return it to the school division. Applications may be submitted at any time during the school year. The information households provide on the application will be used for determining eligibility and verification of data. Applications may be verified at any time during the school year by school or other program officials. For school officials to determine eligibility for free or reduced-price benefits, households receiving SNAP benefits or TANF only have to list their child(ren)'s name and SNAP or TANF case number and an adult household member must sign the application. Households who do not list a SNAP or TANF case number, including WIC households, must list the names of all household members, the amount and frequency of the income received by each household member, and the last four digits of the social security number of the adult household member who signs the application. If the household member does not have a social security number, the household member must indicate that a social security number is not available. The application must be signed by an adult household member in order to be approved.

Under the provisions of the free and reduced-price meal policy, Gwendolyn Jones, Food Service Supervisor will review applications and determine eligibility. An application cannot be approved unless it is complete. House-holds dissatisfied with the ruling of the eligibility determining official may wish to discuss the decision with the official on an informal basis. Households wishing to make a formal appeal for a hearing on the decision may make a request either verbally or in writing to: Don Stribling, Executive Director of Human Resources, Opera-

Households may apply for P-EBT at any time during the school year. If a household is not eligible now but has a change, such as a decrease in household income, an increase in household size, becomes unemployed or qualifies for SNAP or TANF, the household should contact the school for an application. Such changes may make the children of the household eligible for benefits if the household's income falls at or below the Federal Income Eligibility Guidelines.

Households that receive SNAP or TANF benefits may not have to complete an application for free or reducedprice student meals. School officials will determine eligibility for free meals based on documentation, obtained directly from the Virginia Department of Social Services, that a child is a member of a household currently receiving SNAP or TANF. School officials will notify these households in writing of their eligibility. Households who are notified of their eligibility, but who do not want their children to receive free meals, must contact the school. SNAP and TANF households must complete an application if they are not notified in writing of their automatic eligibility within the first 10 days of the new school year.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

The Fluvanna County Public Schools are committed to providing all children with opportunities to benefit from public education. Child Find is the process of identifying children with potential special education needs and educating the community about child development and the importance of early intervention.

Students are identified and placed in special education programs in accordance with the Virginia Board of Education's Regulations Governing Special Education Programs for Children with Disabilities in Virginia. These guidelines, as well as the comprehensive Standards of Quality and the Objectives for Public Schools in Virginia, provide the organizational framework for all education programs and related services.

Each student, ages 2 through 21 inclusive, receiving special education services has a program designed to meet his or her individual needs. These programs are discussed and planned by school personnel, parents, and the student involved. Often, instructional programming is carried out in both regular and special education classrooms. The student's progress is reviewed at least yearly and his or her need for special education services is reassessed at a minimum of every three years. Disabling conditions include the following: autism; deaf-blindness; visual impairment; developmental delay; emotional disability; hearing impairment/deaf; intellectual disability; specific learning disability; multiple disabilities; orthopedic impairment; other health impairment; speech or language impairment; and traumatic brain injury.

If you suspect that your child has a disability, please contact the principal of the school that your child attends or would attend if he/she were enrolled in public school. You may also contact the Office of Special Education at (434) 589-8208, and you will be directed to the appropriate school employee.
