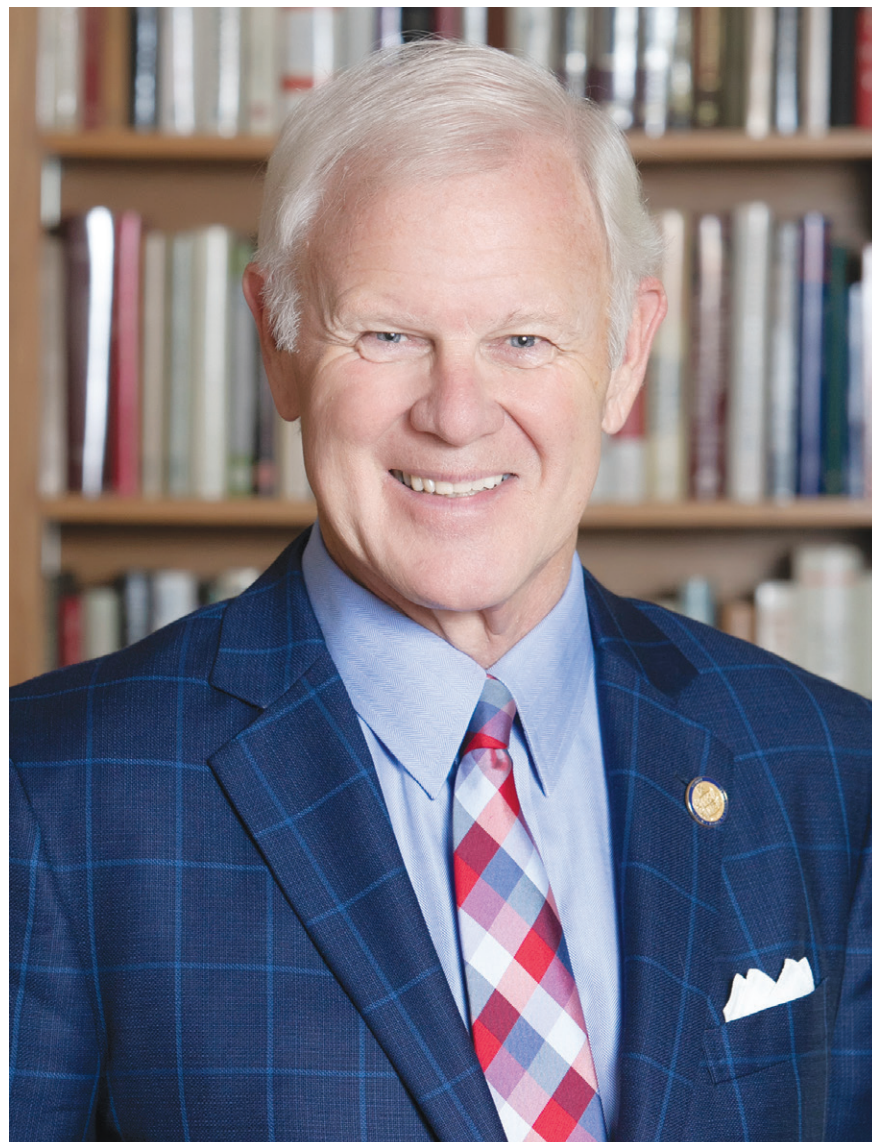

October: Domestic violence month

"October is Domestic Violence Awareness Month. It is more important than ever that members of the community know where and how to get help if they or someone they know is experiencing intimate partner violence.

It is estimated by the National Coalition Against Domestic Violence that 1 in 4 women and 1 in 6 men will experience abuse by a partner. The abuse can be physical, sexual, emotional, or financial. Issues like a lack of housing options, high rent costs, and need for transportation in and out of rural parts of the county can make a survivor's attempt to leave abuse even more difficult.

The Shelter for Help in Emergency is here for folks experiencing abuse in a relationship. SHE offers free and confidential services including emergency shelter, legal advocacy, case management, and prevention programs for youth. During October, we also have many events and awareness opportunities for community members to participate in and learn about our work.

League of Women Voters and NAACP talk about the importance of voting

With so much on the line in upcoming elections, both state and local, those who volunteer and help to get voters out and support them with education and information want the community to understand their vote matters in this ever-changing political climate,

Many recall the first time they voted and remember never taking that ability to vote for granted. As chair of the Voter Empowerment Committee of the NAACP, Barbara Cary helps eligible citizens of Vir-

ginia to access and exercise their constitutional right to vote in a free, safe, and fair election.

"As a child, I would go to the polls with my grandparents and understood the importance of voting. As parents, we taught our children the importance of exercising their rights," said Cary. "People need to get more involved with the process, such as working at the polls, talking to your church members and people in your community to encourage voting. Help

people to understand that their vote is their voice."

Both Cary and Pat Cochran, president of the League of Women Voters for the Charlottesville area, believe that educating voters and rallying interest can potentially be the key to breaking down the barriers and allow people to have a voice in the political system that is supposed to serve them. Cary talked about empowering voters yet cited "a lack of interest and education, not understanding the importance of their rights, and removing old myths and untruths."

"I would love to see local media give more coverage to their efforts as a way of reinforcing voter confidence in this time of eerie and unsettling misinformation," said Cochran.

Cary tells the story of one voter she spoke with while trying to get her to register to vote.

"She finally told me that she was told that she would never be able to vote because she stole an item. That happened 14 years ago. Her rights were probably already restored or paperwork could have been done for restoration, she said. "The steps to help this person were very simple. A few steps could have been taken on a cell phone, rights restored, and later registered to vote at the next election. This is a big concern of mine that people did something irresponsible at an early age, got into trouble, and do not understand that it may be a simple fix to get their rights restored, to make them feel good about themselves."

Cochran looks at it from a different angle, making the system easily accessible but like Cary, educating voters about the system and how it works is also crucial.

"I think the biggest obstacle to getting people to vote is getting out the latest information for "how to vote," said Cochran. "For instance, during the June primaries, witness signatures were not required for absentee/ mail-in ballots. This November that has changed back to the former rule that mail-in ballots must have a witness signature."

She added that voters are unsure of what ID they need to have and what district or precinct they live in.

"Getting that kind of information out to citizens is expensive and ever-changing." She said she hoped that local papers, like the *Fluvanna Review*, get all the information to voters they need.

Many wonder how to reach voters. Cary says it is making them understand that every vote counts.

"Help people understand that their vote is needed to elect local officials that will affect our everyday life as well as at the state and federal level. Inform people that they can be a positive example leading others to vote," she said. "We have assisted people to vote and have seen a few of them go to the polls with their chests all

poked out like they were on a mission and come back outside from voting and see nothing but big proud smiles. That's truly a great feeling for that person voting and for the person that assisted. That gives you the motivation to help even more."

Cochran thinks information along with motivation makes a strong alliance and has been the mission of the League of Women Voters for the last 100 years.

"We have voter registration drives, print voter education pamphlets, host candidate forums, study current issues of concern in our local communities with a keen effort at sorting fact from myth or fiction. Getting 18-year-olds to start voting leads to an increased occurrence of voting over the long term," she said.

One of the concerns of many voters has been gerrymandering and Fluvanna is in the process of redrawing its district lines. Cary views gerrymandering as having a negative impact on communities of color.

"It eliminates voting for candidates of your choice or representation to fight for your concerns," she said.

The LWV strongly supports the bipartisan transparent public process of creating new district lines every ten years.

"Once gerrymandering is eliminated, impacts will be felt. I also believe that the elimination of gerrymandering will reinforce voter confidence in the electoral process and encourage more voting," said Cochran.

Virginia does not have the negative political environment that other states are experiencing, surrounding voting. Cary believes that encouraging voters to "stand up and speak out for what is right," will continue to influence future elections in Virginia.

"This coming week members of our LWV will be giving testimony at the Virginia Redistricting Commission hearings specifically about our central Virginia area," said Cochran. "The recent extension of both in-person and mail-in ballots is real progress in making it easier to vote for all of our citizens. Voter ID requirements are easier to manage. Automatic voter registration at the DMV is terrific."

She also added that our Board of Election officials undertake very vigorous precautions and adhere to strict standards to ensure a fair election outcome.

To give more choices and a collective voice to voters, Cochran would like to see the model of ranked-choice voting adopted in all elections where there are more than two candidates. Redistricting for fairness and making progress through change for the future, including ranked-choice voting, are ways that Cary and Cochran hope will empower voters and give them the tools they need to have their voices heard.

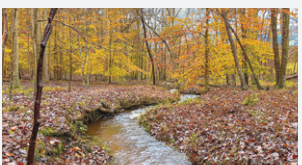

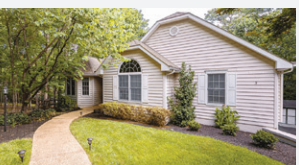

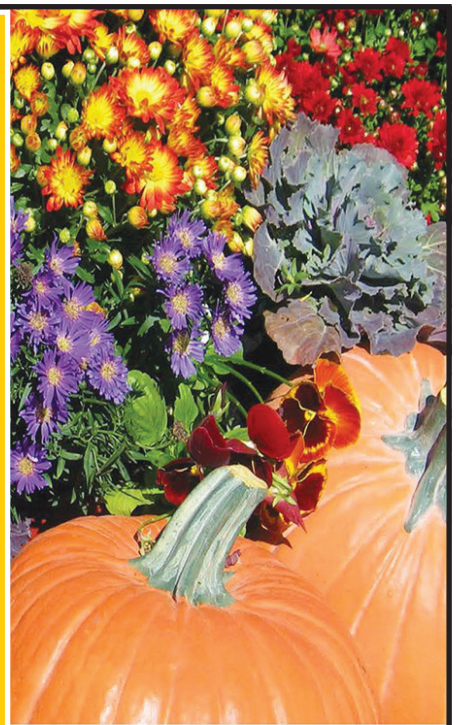

What's Lurking in Your Backyard?

Found any skeletons in your backyard lately? It can happen! While doing yard work a few years back, a man on Evergreen Lane discovered a private gravesite. "There are at least four other cemeteries at Lake Monticello: the Boston Family by the Marina, the Houchens Family on the Golf course, and mystery graves near Vine Ridge Drive and in the Riverside section," says James Scott, our resident expert on the community's graveyards.

All the cemeteries hold historical tales and secrets. At the Houchens' plot, the white crosses are not set where the bodies are buried. Did someone move the crosses? It is a mystery!

Fifteen marked graves and about eight unmarked graves lie in the Boston Family cemetery, dating back to the 1800s. One only needs to read the tombstones to get a real sense of how rough life was back then. Of the seven children buried there, only two lived beyond 34. Despite fighting in some of the Civil War's fiercest battles, the brothers Colonel Reuben Boston and Captain F. C. Boston outlived their poor sisters. The ladies

passed away at the ages of 17 and 18, the latter probably dying in childbirth. And Captain F.C. Boston died on his brother's birthday! Other things you may find in your yard are Spencer carbine bullets from the Civil War and gold. It is thought that some 5 - 8 tons of gold were mined in these parts. Whether you go searching for gold or hunting for spirits, remember, it is illegal to enter a cemetery without the owners' permission after sundown in the state of Virginia!

Firefly, What to Expect

Get excited, Firefly Fiber Broadband is underway! Reliable, lightning-fast internet via fiber to the premises is available to all of Lake Monticello, regardless of the electric provider. Firefly is a wholly-owned subsidiary of Central Virginia Electric Cooperative (CVEC), headquartered here in Fluvanna County.

Using a revolutionary method called microtrenching, Firefly installs fiber quickly while limiting

disruption to other utilities and homeowners. Fiber is placed in a small trench less than one inch wide that is cut in the street pavement. In yards, contractors from S&N Communications install fiber alongside the electric lines, which are mostly underground.

They start on October 11, with connections made possible by the end of 2021. The entire build, including in-home installations, will

take 6-8 months. Firefly strives to minimize disruptions, but residents can expect some traffic pattern changes during the fiber placement. Microtrenching will begin on Jefferson Drive, Slice Road, Out of Bounds Road, Locks Road, Locks Court, Bunker Boulevard, and Spoon Terrace. Work will contin-

ue into Section 9 of the Lake in November.

The Flucos utilized sophomore half-back Eisryell Johnson, senior full back Chase Paschall and junior quarterback Owen Leydig to pound out yardage, gaining first down after first down on the ground. He praised the following linemen: center Matthew Banton, guards Grant Brown and Scott Fulton, tackles Jared Morris and Matthew Panas and tight end Austin Moore. Banton and Morris are juniors. The other four are seniors.

This game started with the Flucos making a slow sustained drive down the field without ever putting the ball in the air. The drive appeared to end on a short touchdown run by Leydig, but an offensive holding call nullified the touchdown and the Flucos were unable to push it in from the 13-yard line. The Mustangs took over on downs with only 3:22 left in the quarter. The Fluco drive had consumed more than eight and a half minutes. Monticello went three and

out and punted. The quarter ended with no score.

On their second possession the Flucos were able to take the ball in for a touchdown. Leydig had a good gain on a roll-out and Johnson ripped off a big gain that ended with a horse-collar tackle. The ensuing penalty put the ball at the Monticello five-yard line. Leydig scored on a five-yard quarterback sneak. This play and a subsequent five-yard sneak for a touchdown demonstrate the strength and power of the Fluco offensive line. A quarterback sneak at the five is normally considered a success if it gets you halfway to a touchdown. The Fluco extra point try failed. Monticello responded quickly with a beautifully thrown 49-yard touchdown pass. They also failed to convert on the extra point try. The half time score was 6-6.

On the first possession of the second half, Monticello was forced to punt and Fluco junior wide receiver Addison Patchett made a good return to the Monticello 37-yard line. Two first downs later on two runs by Paschall, one by Johnson and one by Leydig the Flucos were at the five. Leydig took it in on a sneak. Leydig then completed a pass to junior wide receiver Jacob Seymore in the corner of the end zone for a two-point conversion, making the score 14-6. That was the score at the end of the third quarter.

As the fourth quarter started, the Flucos were threatening again. Johnson ran a sweep left and outraced the Mustang defenders for another Fluco touchdown. The extra point try failed and the Flucos led 20-6 with 10:16 left in the game. On their possession the Mustangs broke a runner loose and it looked like he was going all the way, but Fluco junior safety Andrew Sheridan made a touchdown saving play knocking the runner out of bounds. Monticello was then called for offensive holding and the Mustangs were forced to use up clock before pushing in a touchdown at 4:32. Their two-point conversion try was good and the score was 20-14. A 42-yard run by Paschall was the highlight of the Flucos' final drive. It ended with Johnson scoring again on a sweep to the left. Leydig ran in the two-point conversion for a 28-14 lead with only thirty-nine seconds remaining. The Mustangs got in one last jab however, as they returned the kick-off for a touchdown. The game ended after the Flucos recovered the Mustangs' on-side kick.

The Flucos have tough remaining schedule. On Oct. 15 they are at Orange. On Oct. 22, they have their homecoming game against Western Albemarle. On Oct. 29, they travel to Charlottesville and on Nov. 5 they host Albemarle.

Witness signature required on absentee ballots

The Virginia Department of Elections wants to remind voters that witness signatures are required on all absentee ballots being cast in the 2021 general election.

If a general registrar finds after examin-

ing a returned absentee ballot envelope that the witness signature is missing, the voter will be notified within three days after receipt in the registrar's office that the ballot requires modification. The voter will have until noon on the third-day after the election (November 5, 2021) to correct their ballot in order for it to be counted.

ELECT encourages voters to return their absentee ballot at their earliest convenience. A voter may return their absentee ballot by delivering it to:

The USPS or a commercial delivery service (such as FedEx or UPS). All absentee ballots include pre-paid postage through the USPS;

A drop-off location listed on their county or city's official website;

The Office of the General Registrar in their county or city; or,

Any polling place within their county or city on Election Day.

Completed absentee ballots must be postmarked by Election Day and received by local registrars by noon on Friday,

Nov. 5. If a ballot is personally delivered, it must be returned to the general registrar's office or drop-off location by 7 p.m. on Election Day.

Voters who have requested an absentee ballot can track their ballot here: <https://v2.ballotscout.org/virginia/search/state>.

If a voter is concerned that they do not have enough time to return their ballot by mail, ELECT encourages voters to personally deliver their ballot to their local general registrar's office, a ballot drop-off location, or vote in-person.

Supervisors to raise pay for underpaid deputies

Sheriff's Office lost 14 deputies, 17 dispatchers in last two years

Pay for Fluvanna County Sheriff's Office deputies is set to rise, as the Board of Supervisors voted on Wednesday night (Oct. 6) on a series of measures they hope will allow the department to attract and retain law enforcement officers and staff.

Raising the pay for deputies has been a long-running discussion between the Supervisors and the Sheriff's Office. Pay for deputies in Fluvanna is lower than in surrounding counties, making it harder to recruit and retain deputies.

For example, Louisa County has raised its starting pay for non-certified candidates to \$51,000. Goochland County's starting salary is \$53,000. By comparison, a recruit in Fluvanna starts at \$38,000.

Sheriff Eric Hess said his department had lost 14 deputies and 17 dispatchers in the last two years. The department has lost nearly \$575,000 in training and equipment alone.

Hess and Major David Wells presented two plans: one would raise starting salaries for deputies in training to \$44,500 and then increase to \$47,500; the other would start at \$46,000 and raise to \$49,000. There would also be a \$2-5 an hour increase in pay for deputies depending on seniority and other factors.

They said the second plan, in particular, would make Fluvanna County most competitive with surrounding agencies.

County Administrator Eric Dahl said the increase was projected to cost the county \$240,645 in FY22 and \$320,860 in FY23.

There was little debate among the Supervisors over the need to raise the salaries for the Sheriff's Office, although Supervisors Donald Weaver (Cunningham) was uncomfortable with the

idea of making the change outside the normal budgeting process.

"To me, this should have been brought up along with the budget, so everybody can compete," he said. To step outside the normal process wasn't fair to other county employees or to the taxpayers.

Hess and Wells said they did not realize that counties like Louisa were going to raise their salaries so dramatically until after Fluvanna's budgeting process was completed, and there was now some urgency to raise their own rates so as not to find themselves critically understaffed.

Dahl recommended drawing the \$240,000 needed for FY22 from the unassigned fund balance, but the Supervisors ultimately decided to draw that money from American Rescue Plan Act (ARPA) funds, and then debate make the increases part of the permanent budget in FY23.

Both motions passed 4-0-1. Weaver, who will be retiring before the start of the next budget cycle, abstained in both votes.

Deputies will also receive a one-time hazard pay bonus of \$3,000 under a bill passed by the legislature. The state will pay for 22 Fluvanna County deputies whose positions are state-funded. For the 15 deputies who are not state-funded, supervisors voted unanimously to pay them the bonus out of ARPA funds, at a cost of \$45,000.

Redistricting

Long-delayed 2020 Census data has finally arrived, and supervisors now have until Dec. 31 to decide what to do with it.

The main options on the table are to redraw existing district lines to equalize the number of residents served by each

supervisor or to add one or more districts to the existing five.

The federal census data needed for redistricting is usually available in April, giving localities in Virginia time to draw new lines and add new districts well ahead of the elections in November.

Three seats on the Board will be decided in November, with Sheridan and O'Brien running uncontested and Weaver retiring, but there are questions about what happens if their districts are redrawn between Election Day and the start of their new terms. There is also no clear path for adding new members by special election.

Jason Hamshar and Chris Fairchild are running for Weaver's seat.

"There's a lot of challenges," said Sheridan during the discussion. "But we also want to try to get this right for ten years down the road."

The public will be able to attend work sessions and give comments on redistricting between now and mid-November. The county will release a full schedule of meetings and hearings in the coming days.

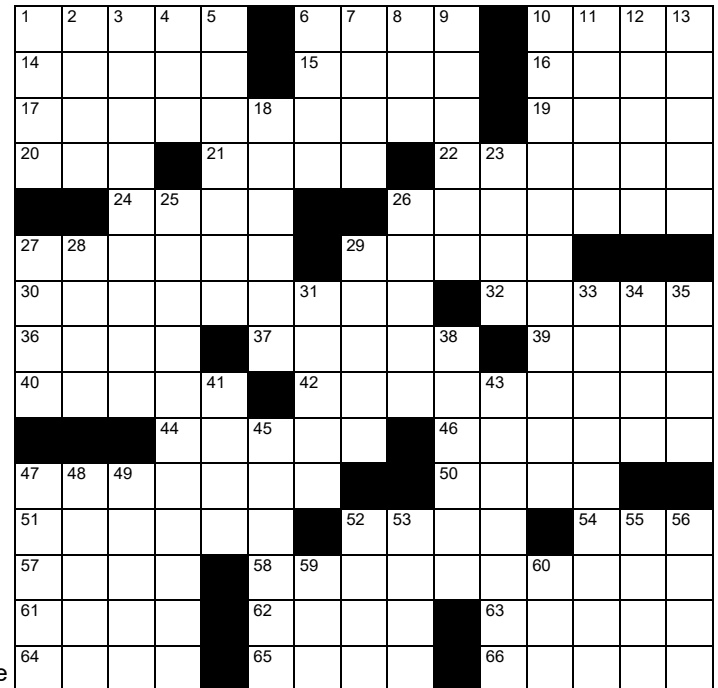

hal--see this poster above. Also advertised was the availability of "1000 Acres for Parking & Camping."

The memories of Woodstock were still fresh in local minds, and there was an immediate flurry of negative responses, mostly focussed on traffic. Leonard F. Jones, Fluvanna County's commonwealth's attorney, opined, "This is a predominantly rural county, and even if it were a very orderly gathering, the additional traffic and so on would be very difficult to handle. I certainly would be opposed to it." By the first of April 1970, Conrad C. Strickland, president of the Fluvanna County Chamber of Commerce, said he had been "bombarded with telephone calls and insulting letters." Another resident said churlishly, "I hope it rains."

The property in question was said to be located off Route 6, and owned by Charlie Kidd. Local rumor says that after a drive-by shooting, Mr. Kidd's relatives talked him out of hosting the event. So it never happened.
