Public hearing on redistricting set for Dec. 1

Supervisors split on number of districts

With around six weeks to go until the deadline for redistricting, the Board of Supervisors seems far from a consensus on the best way to redraw the county's electoral map.

A public hearing has been set for Dec. 1 at 7 p.m., and as part of the formal notice for the hearing, they were tasked with choosing from one of five maps presented at earlier meetings.

This was not meant as a final decision, but as more of a placeholder or starting point for public discussion.

As their own discussion continued, it became clear that there are different ideas about what that final map should contain.

There are three basic options under discussion: staying at the current five districts but redrawing the current boundaries to balance the number of residents living in each district, increasing to six districts, or moving all the way to seven districts.

County staff has prepared five maps, with two options each for five and seven districts, and one for six districts.

Tony O'Brien (Rivanna), who sits on the redistricting committee, proposed one of the five-district maps. Holding at five, he argued, limited significant changes for residents, was unlikely to face any legal challenges, and still allowed for some flexibility.

"I like the idea of being supervisor for some rural areas and some urban areas," said Mozell Booker (Fork Union). Her district would pick up some of the areas around Lake Monticello under a five-district plan. She said that part of her role as supervisor would be to bridge some of the divides between rural Fluvanna residents and those at the Lake.

Both Don Weaver (Cunningham) and Patricia Eager (Palmyra) voiced their support for six districts. Weaver pointed to a period in the early 2000s where the Lake had two supervisors in one district "and it worked well then," he said. Eager said six districts gave the Lake area representation proportional to its population.

Chair Mike Sheridan (Cunningham) maintained his support for seven districts, saying none of the other scenarios would represent residents equally.

O'Brien's motion for five districts failed by a vote of 3-2.

Eager than moved that they adopt the six-district map.

"Again, I think six is an enormous mistake," said O'Brien. "It does not serve the residents of the county very well. If we're not going to be at five, then I'm in favor of seven. But I think six is a terrible idea for the county and a terrible idea for the Lake."

Booker agreed, referring back to the period before the 2010 redistricting when Rivanna had two supervisors. Not only were there deadlocks on the board, but other county residents had been angered by the Lake having two representatives.

The motion then passed 3-2.

Residents will still be able to speak on any of the five maps under consideration at the public hearing on Dec. 1. These maps can be viewed on the county website.

Falun Gong

At the start of the meeting, supervisors passed an unusual resolution "to educate Fluvanna residents and the medical community on the risks of traveling to China for organ transplants in light of recent reports of state-sponsored organ harvesting from prisoners of conscience."

Falun Gong is a religious movement established in China in 1992. Hundreds of thousands of people around the world follow the practice, which combines mediation, exercises, and philosophy.

The government of China sees Falun Gong as a threat and has arrested and has jailed hundreds of Chinese practitioners since the 1990s. By the early 2000s, there were multiple reports that some of these prisoners were being killed and harvested for their organs.

Several international investigations judge claims to be true, although the true number of victims is unknown.

Virginia-based Falun Gong practitioners Tiny Tang and Jinsun Bae have been visiting localities around Virginia to talk about the issue and encourage supervisors to pass these resolutions. They spoke in Fluvanna during public comments at the Oct. 20 meeting.

On Wednesday, supervisors voted 5-0 in favor of the resolution.

Fairchild, Rittenhouse and Murray-Key win

Chris Fairchild will represent Cunningham on the Fluvanna Board of Supervisors.

Fairchild was opposed by write-in candidate Jason Hamshar but carried the district on Nov. 2 with 2,071 votes or 86.62 percent of the vote, according to unofficial returns. Hamshar received 320 votes or 13.38 percent.

Charles Rittenhouse (Cunningham) easily defeated challenger Eric Anderson. Anderson said this morning, "I want to congratulate the winner in the Cunningham district, Charles Rittenhouse, on his re-election to the School Board."

Anderson added, "I hope the new Board can find ways to come together and do the work needed by the students and the people of Fluvanna County. My profound thanks to my many supporters in the community, to my friends and family for all they have put up with through the campaign season."

Rittenhouse received 1,662 votes or 64.10 percent to Anderson's 881 votes or 33.98 percent.

Gequetta "G" Murray-Key claimed victory over Darrell Byers in the race for the Rivanna district seat vacated by Shirley Stewart's retirement. Murray-Key received 1,397 votes or 52.9 percent to Byers' 1,225 votes or 46.44 percent, according to unofficial returns.

Incumbent supervisors Mike Sheridan (Columbia) and Tony O'Brien (Rivanna) ran unopposed and will return for fouryear terms. Andrew Pullen (Columbia) ran unchallenged for a seat on the school board.

Ah, school board races: long the ugly stepsister to gubernatorial, mayoral, and council races. But not in 2021, not since culture-war influencers decided to target school boards and other ultra-local races.

Pullen and Rittenhouse cast themselves as a team standing strong against a tide of what they frame as radical ideas that can be harmful to children. Pullen is a firefighter and Rittenhouse is a contractor.

Byers, a captain and division com-

mander with the Albemarle County Sheriff's Department, aligned himself with Pullen and Rittenhouse championing parents being more included in educational choices. All three have spoken out against mask mandates, transgender policies and teaching Critical Race Theory.

Murray Key and Anderson are both teachers; Murray Key is an adjunct professor of criminal justice studies at Piedmont Virginia Community College and Anderson teaches engineering at the University of Virginia. Both promised transparency, pledged to work with other school board members and to keep the students' best interest at the center of decisions.

In many minds - school boards, held under a microscope as they've been make decisions that can ruin America or insure children are taught only the right stuff that meets the approval of every child's parent. A key part of the Virginia governor's race, which Glenn Youngkin won, was the role of parents in public school education.

School board meetings across the state have been full of people speaking their minds during public comments: most lining up with views of progressives or conservatives, the left or the right, Democrats or Republicans. And even though school board elections are required by law to be non-partisan that doesn't mean political parties can't endorse or support a candidate, according to the Virginia School Boards Associations candidate's guide.

The Point of Fork DAR Chapter, NSDAR laid a wreath at Point of Fork in Columbia on Oct. 12. A brief presentation about the Point of Fork arsenal included the story of a ride made by Jesse Thomas from his plantation (Royal Oaks) in Cumberland to Point of Fork on June 2, 1781 to warn General Baron von Steuben that the arsenal was about to be raided by the British. This was a ride similar to Jack Jouett's ride from Cuckoo to warn Thomas Jefferson that the British were on their way to Charlottesville. Jesse Thomas learned of the raid from a prisoner who had escaped from Cornwallis and had arrived at Royal Oaks with the news. Thomas immediately had his stallion, Fearnaught, saddled and sat out in a pouring rain to Point of Fork, a distance of about 12 miles. The James River was swollen and the ferry was not able to run, so Thomas swam across the James on the back of his horse to warn von Steuben of the raid being planned by the British. The British did raid the arsenal and captured quite a few men and supplies, but von Steuben was also able to hide guns and supplies both in the James River and in the surrounding woods so all was not lost.

Fluco volleyball squad hit by turnaround loses 3-2 in playoffs

The Fluco volleyball squad hosted Spotswood High on Nov. 2 in the opening round of the 3C volleyball play-offs. The Flucos got off to a strong start and it looked like they might have an easy time. Fluvanna won the first game by a convincing score of 25-11. In the second game, the Spotswood Blazers started to look more competitive, but the Flucos prevailed again 25-18. The third game of the match was a huge battle and with the score tied at 25-25, the Blazers managed to win two points in a row for a 27-25 victory. In the fourth game, the Blazers jumped into an early lead and the Flucos battled back, but ultimately fell 25-18. Since the teams split the first four games a final fifth game was in order and this game is played only to 15 points, win by two.

In the deciding contest, the Blazers again ran out to an early lead, but the Flucos came back strong to tie the game at 11-11, scoring their tying point on a block at the net by senior Khania Brassfield. The Blazers called time-out and came back to win the next four points for a 15-11 win. Unfortunately for the Flucos, who are coached by Christi Harlow-Garrett, a play-off loss ends the season.

In the first game of the match, the Fluco front line of Brassfield, senior Sophia Denby and junior Kayla Gentry appeared to be simply too powerful for the Blazers to handle. However, as the contest progressed, Coach Harlow-Garrett noted the Blazers got more comfortable and started to find openings in the Fluco defense. They also started blocking more effectively at the net to fend off some of the Flucos kill shots. Another factor may have been a Blazer injury. Late in the second game, their libero made a diving dig and injured her elbow. She did not return. This may have charged up the Blazers as they outscored the Flucos from that point on. Because the first game was a lopsided Fluco victory, Fluvanna actually scored eight more points than Spotswood on the night. But, Spotswood was able to gain three wins.

It was a long contest with a very high number of points recorded. As a result, the Flucos posted some very impressive statistics. Denby, who is the number one front line player for the Flucos, recorded a very impressive 20 kill shots. She was also voted Homecoming queen and was honored as such at the Homecoming football game. Gentry also had an outstanding game. She recorded 13 kill shots, had four blocks at the net and served five aces. Brassfield had six kills and four blocks at the net. The Flucos' primary setter is junior Faith Shields. She had a very impressive 40 assists. She also chipped in with two kills, 18 digs and two aces. I guess in addition to playing my accordion and embracing books, my greatest stress reliever has become my workouts at the Spectrum Fitness Center, where I get that free and legal drug called dopamine. And quite honestly, I see a counselor on a regular basis, which has helped immensely. I highly recommend it for all human beings.

Back in the 1970s and '80s, Springtree Community ran a Friday night movie program at the Scottsville Library. One night each month was reserved for children's movies and always drew a big crowd. On the first night of each month, we showed films in a series. Over the years we watched all of Kenneth Clark's Civilisation. Jacob Bronowski's history of science series, Ascent of Man, not to mention a complete run of the Flash Gordon movies. Most of our films came from the Virginia State Library collection. Our Friday night programs came to an end in 1990, as more and more people acquired their own video machines, and when the State Library stopped sending out movies to us.

The all-time biggest crowd we ever had was for "The Making of Star Wars," a documentary. I particularly enjoyed the wildlife movies: "Castles of Clay," about termites; "Caravan du Sel," the salt caravan that traversed the Sahara desert; and the many films by Joan and Allan Root. We once watched a film about coral reefs with long, lulling footage of fish swimming slowly back and forth. That time, not only the youngest children fell asleep, but most of the adults as well. We were awakened only by the flapping of the end of the film reel.

Board to Explore Solutions for Security

Can we save the Lake Monticello Police Department, affected by staff shortage? Nationwide, police departments have experienced a decline in recruitment. LMOA salaries are not competitive, making our police force unattractive to new recruits. During the regular Board of Directors meeting on October 28, our Directors voiced the need to explore effective solutions, including the option of contracting private security.

During a visit to Lake of the Woods, LMOA Staff and BOD representatives witnessed firsthand several of the benefits of contracting out security. At Lake of the Woods, contractor Allied Universal Security Services provides security 24 hours a day. Their registered Special Conservators of the Peace (SCOP) officers are authorized by the Orange County Sheriff and appointed by a Circuit Court to perform specific duties within the specified LOWA geographic area as defined by the Circuit Court. SCOP officers must complete regular training and reregister annually through

the Virginia Department of Criminal **Justice Services** (DCJS). Their training and registration permits them to carry a firearm and their duties include enforcement of local and state laws, including traffic violations. Other duties include controlling entrance access, providing seasonal boat patrols, investigating member complaints, and providing assistance to the Orange County Sheriff's Office and other law enforcement agencies. It provides more officers, including

850 hours of Lake patrol and a mix of both conservancy (armed officers) and compliance officers at a similar

cost to what we budget for our police depart-

ment. Additionally, the contractor offers programs such as a successful youth engagement program and hires, trains, and

insures the officers, relieving our membership of that responsibility. This is just one option the Board wishes to explore. Another option may be to raise the salaries for police officers significantly. In the coming months, LMOA will provide its members with a comprehensive comparison

Lakers Unite to Protect Surrounding Greenspace

The conclusion is undeniable: as a community, we strongly oppose the proposed Village Gardens development. Thanks to the hard work of our Community Developments Working Group, our feedback was effectively consolidated, leading to the Board's decision to authorize President Larry Henson to express LMOA's opposition to the proposed project at all relevant County hearings. This was truly a community collaboration. The group consisted of Board and LMOA Staff representatives as well as several LMOA members who met multiple times in the month of October. Many residents took the opportunity to attend meetings and submit feedback via email. The message was loud and clear: LMOA http://lmoa.news we hear from some of our neighbors who can't wait to attend. Here's a short summary:

"I will definitely attend," says the 13-year-old Max Kofler. "I love to paddle and wakeboard. I want to make sure I can continue to enjoy all of my water sports in a way that is safe for everyone."

According to his father Joe, wakeboarders and wake surfers are some of the most mindful and respectful boaters on our Lake. "As a parent and experienced boater, I take safety seriously," Joe shares. "To wakeboard, you have to go in a straight line at a maximum speed of 19 mph. Also, wakesurfing is a safe, child-friendly sport with a top speed of 10mph. It takes a high level of skill to do it right. Tubing and water skiing need higher speeds, up to 36 mph. I feel tubers are most responsible for close proximity to docks and shorelines due to the zigzag travel needed to maximize their pull."

Close to Van Buren Cove, waterfront owner Judy Strock witnesses the same sort of behavior. "Someone needs to address the lack of respect for safety by motorized boats, especially some boaters who

members are against Village Gardens, a proposed development that could hold up to 355 residential units on approximately 120 acres that touch Tufton Pond. The group found that the proposal

carries significant, negative impacts on our community such as increased traffic volume, an overwhelmed water and sewer service, erosion want their tubers and skiers to enjoy a high-speed, bouncy thrill at this final turn buoy. During one of the holidays, my dock got such a pounding my 300 lbs. wooden steps came loose. I'm afraid to swim there."

She suggests the turn buoy at the Van Buren Cove in front of her property be moved half a mile to give her and her neighbors, 'slow' boats and swimmers more room. "If my request isn't a good fit, I hope better and more frequent water safety patrol is considered before someone gets seriously injured. State laws are being ignored that need to be enforced." The Board of Directors is determined to give all Lakers a fair chance to get involved. LMOA Vice President Judy Fish says, "We know that if we work on water safety as a community, we will come up with a plan that will help us move forward to allow many more safe and happy seasons on Lake Monticello," she adds.

Plentiful harvests expected for Va. cotton, peanuts

Following a year plagued with wet weather and numerous setbacks, Virginia cotton and peanut farmers are anticipating a successful fall harvest.

In its crop production forecast released Oct. 12, the National Agricultural Statistics Service reported Virginia farmers expected to harvest 133 million pounds of peanuts this year, up 19% from last year. Cotton production also is projected to increase drastically at 160,000 bales, a 26% upturn from 2020.

In Southeast Virginia, "we caught some showers and rain on a regular basis that areas west of us missed, which helped to fill out those crops," said Mike Parrish, a Virginia Cooperative Extension agent in Dinwiddie County.

"It's been a good season for peanuts nice and dry for easy harvesting," he added. "There've been a few challenges with some cotton growing again due to the hotter weather, but other than that, we're just waiting on the bolls to open up and the lint to fluff out. Farmers should be out picking in the next week or so."

According to the NASS crop progress report from Oct. 17, Virginia's entire peanut crop is in fair or better condition, with 85% rated good or excellent.

Fifty-five percent of the state's peanuts have been harvested this fall—a 31% in-

crease from this time last year and a 3% increase over the five-year average.

Dell Cotton, executive director of the Virginia Peanut Growers Association, said it could be a banner year for peanut farmers.

"I don't see why our farmers can't match what USDA has us projected at, which is to produce 4,600 pounds to the acre," he noted. "This year has been very similar to 2019, which was when we set the current record at 4,650 pounds produced per acre. Give us one more week, and I expect we'll be close to that number again."

Cotton said Southeast Virginia has avoided drought conditions that have affected most of the state throughout summer and early fall, and that has created suitable growing conditions for peanuts and cotton.

Virginia's cotton harvest is only 18% complete, but 97% of the crop is in fair to excellent condition, and 69% is in good or excellent condition.

Suffolk farmer Joseph Barlow, who serves on the Virginia Farm Bureau Federation Cotton Advisory Committee, explained it's too early to predict how the state's cotton crop will pan out.

However, he mentioned an above-average crop year is within reach if dry and mild weather continues, which would be a boon for growers who took a loss last year.

"That would be phenomenal," Barlow said. "There were many people, ourselves included, who were hurt bad last year. And with prices where they're at right now, there's money to be made with a decent crop."


