

### Fluco football loses 48-21 to Spotsylvania Knights

Fluco junior running back Isaac Lewis electrified the crowd twice with kick returns for touchdowns, but the Knights from Spotsylvania displayed a running attack that the Flucos simply could not contain.

On the first possession of the game, the Knights marched 53 yards for a touchdown. The extra point was good and the Flucos trailed 7-0 with 9:25 remaining in the quarter. The Flucos were forced to punt on their first possession. The Knights made a couple of first downs, but fumbled at midfield and the Flucos recovered. The Flucos moved the ball into Spotsylvania territory but turned it over on an interception. Spotsylvania had a long run called back due to a penalty, but then ripped off another long run to the Fluco two-yard line. A plunge up the middle resulted in the Knights' second touchdown. The extra point was good, and it was 14-0.

The Flucos made a couple of first downs behind the running of senior backs Jacob Morris and Clayton Cannady, both of whom are in the 200 pound range and are hard to bring down. Cannady then ran hard into the secondary, made a good cut back, broke a tackle and scored on a run of 31 yards.

The extra point try by junior kicker Cullen Long was good and the Flucos were down by a touchdown 14-7. After receiving the kick-off, the Knights fumbled the ball away to the Flucos on their third play. Unfortunately, the Flucos returned the favor by fumbling the ball back to the Knights on the Flucos' first play.

On the Knights' first play after recovering the Fluco fumble, a sweep was successful for a 31 yard touchdown run and the Knights were ahead 21-7 with 5:48 left in the first half. The Flucos were unable to generate offense and the half ended with the Knights up by two touchdowns.

Spotsylvania recovered a Fluco fumble on the kick-off to open the second half. On their fifth play from scrimmage, the Knights made another long touchdown run, this time from 32 yards out. The extra point was good for a score of 28-7 and it looked like the outcome of the game was no longer in doubt.

However, Lewis did provide some fireworks for the Flucos. The ensuing kick-off was taken by Lewis at around the 25. He shot up the middle straight through the oncoming Knights' tacklers and was in the clear in no time for his second touchdown return of the season. The Knights now led 28-14, and that was the score at the end of the third quarter.

On the second play of the fourth quarter the Knights ran the ball in for their fifth touchdown of the night and a 35-14 lead. On this kick-off, the ball was bouncing around on the ground at around the thirty and it looked like that would be where the Flucos would start from. At the last second, Lewis dashed in and scooped up the ball. The Knights defenders were already down field at this point and Lewis quickly dashed past them. Once he is in the clear, there is little chance that anyone will run Lewis down. The junior scatback is listed on the program as 5'7" and 150 pounds. But, he can fly. Lewis now has three kick returns for touchdowns in two

The Knights added two more touchdowns in the latter part of the fourth quarter, the last one coming in the final ten seconds. The game was closer than the final score would indicate. After the game, Coach Michael Morris noted that his defense played strong, but that it had some troubles adjusting to the Knights backfield fakes, which resulted in some mistakes that cost big yardage. The Flucos will next travel to Brookville High on Sept. 9. They will host Louisa County on Sept. 16. After a bye, they will travel to Goochland on Sept. 30.

Other than waxing nostalgic about their youth they are also celebrating by giving back to the community. Their goal was to raise \$1,000 among the 28 alumni left and donate it to the Palmyra Volunteer Fire Department.

"With our limited numbers, we set a

modest goal of \$1,000 to be funded by donations from the class. I am excited to report that we have exceeded our goal by \$260. I anticipate there will be several more donations before we party on the 30th," said Jack Stoughton, one of 36 members of

The idea of a legacy gift came up at the 50th reunion in 2012.

"It was a great celebration and the focus was on us. When I was asked to organize this reunion, I approached my classmates to consider paying homage to and giving back to this place we call home," said Stoughton. "Further, our goal was to set an example for future class reunions to consider their legacy gift. We considered several worthy possibilities. We quickly settled on the Palmyra Volunteer Fire Department (PVFD)."

Stoughton says the "selection of PVFD made sense in two ways." PVFD and the two other county volunteer fire stations provide a service to all Fluvanna citizens and funding comes from grants and dona-

"The second reason is personal. When the county created the Fluvanna Volunteer Fire Department in 1953, the cinderblock station house provided a home base for a new Boy Scout Troop (54) that several of my classmates and I joined. My classmate, Mary Wills Tilman, and I had family members who served with the unit. Mary's youngest brother, "Boots" Wills served as chief." As for looking back 60 years to a different time, their memories are entwined with a historical moment.

"At the time we graduated, Fluvanna was still in a "separate but equal" education mode," he said. "Fortunately, Fluvanna and Virginia have moved on. Certainly, the kids in Fluvanna today have advantages we didn't have with an awesome new high

# **Student Loan Forgiveness**

weeks from FALL? How in the world did that happen and how did we get to September already!?!?! You have probably heard by now that there may be forgiveness of some student loan debt on the horizon.

While there may be legal and Congressional challenges around the recent presidential executive order, here are some questions and answers about what is known so far about the announced student loan forgiveness program.

#### Can the President forgive this debt?

Who knows how this will play out, but maybe not. Only Congress has spending authority. And the forgiveness of debt is considered income in the eyes of the IRS. So to avoid any long-standing legal battle, Congress may need to authorize this estimated \$1 trillion dollar program. Whether it does is up for debate.

#### If approved, who qualifies for the forgiveness program?

Here's a checklist of qualifications in the executive order:

- Loan Type. You have student loans that are held by the U.S. Department of Education (DoE), including Pell Grants, Federal Family Education Loans, and Direct Loans such as Parent PLUS and Grad PLUS loans. Certain loans from the Federal Perkins Loan Program may be excluded. All private student loans are
- Loan Issue Date. Student loans taken out after June 30, 2022 are not eligible for for-
- Income Threshold. Your income does not exceed \$125,000 if single and \$250,000 if married based on your 2020 or 2021 federal

#### What are the limits?

- \$20,000. Recipients of a Pell Grant can have up to \$20,000 in student loan forgiveness.
- \$10,000. For non-Pell Grant loans, the maximum student loan forgiveness is \$10,000.

#### Is the forgiven student loan taxable?

• Federal Level. Per the executive order, forgiven student loans will not be considered

Can you believe we are less then three taxable income on federal tax returns. The approach the executive order takes is by using the American Rescue Plan that prevents taxation on student loans forgiven through 2025.

> • State Level. While many states follow the federal law that excludes student loan forgiveness from being considered taxable income, several states currently do not conform to federal law. Details are being worked out in these states to try and keep student loan forgiveness from being considered taxable income. For now, it looks like Virginia will not consider it taxable income, but that could change.

#### What you need to do

Stay alert to any twists and turns regarding challenges to this executive order. In the

Watch for the forgiveness application. An application for student loan forgiveness on the Department of Education's website, ed.gov, will be the next step. There may be exclusions to this application requirement, with many borrowers potentially receiving automatic forgiveness if the Department of Education already has your income data.

Double-check your loan balance. Take a screen shot of your loan balance the day you submit your forgiveness application and compare it to your balance after the forgiveness is eventually applied to make sure the forgiveness is properly applied to your account.

There are still lots of unanswered questions about this student loan forgiveness program, including whether it is even legal. So stay tuned for future updates.

\*NOTE: While the Department of Education typically uses your adjusted gross income (AGI) number when determining eligibility for other loan programs, the White House did not confirm whether AGI will be used to determine the \$125,000 and \$250,000 income thresholds.

Just one final reminder! If you have filed for an extension and have not yet completed your return for 2021, NOW is the time to act! The deadline is October 15th! Call or email us for an appointment. 434-442-4044, info@ rwftaxservices.com.

school including strong academic and sports programs. At Carysbrook, we never had night ball games because there were no lights. However, we did have excellent, caring, patient, old-school teachers who provided a steady hand and discipline. The original Fluvanna High School was built in 1934 and two years later the Abrams High School for African-American students was built. Integration did not occur until the 1960s.



### Latest inspection of prison medical unit shows signs of progress

Medical services at the Fluvanna Correctional Center for Women (FCCW) are meeting most of the metrics established in settlement of a 2015 Federal lawsuit, according to a report filed by the court-appointed monitor in June.

Dr. Homer Venters, an expert on medical care in correctional facilities, has been making periodic visits to the Troy facility for several years. His most recent visit in mid-April included an inspection of the medical facility, a review of records, and interviews with both staff and detained women.

The 2015 lawsuit brought by women held at the prison showed that medical care was so lacking that it violated their Constitutional protections from "cruel and unusual" punishment. A 2016 settlement laid out 22 areas of compliance the prison had to meet, including maintenance of adequate staffing, inmate access to medical care and treatment, and prompt response to medical emergencies.

FCCW had been slow to fix persistent problems within the medical unit, leading to at least two inmate deaths from undiagnosed health crises in July 2017. The case returned to court in 2018 and the prison was ordered once again to meet the compliance standards.

In his April visit, he found the medical unit was compliant or partially compliant with all but two of the metrics. These two areas of non-compliance were maintenance of durable medical equipment - which includes everything from wrist braces to wheelchairs to hearing aids - and

access to diagnostics and treatment. Those areas failed to meet the threshold of 90 percent or greater compliance with the settlement's auidelines.

Other areas of concern for Venters were the lack of routine screening for lung cancer and diagnosis and treatment of opioid use disorder. "These two health problems represent significant causes of mortality in the State of Virginia and are not measured in other parts of this settlement," he wrote.

FCCW said they are in the process of finalizing a pilot program that would address and treat opioid use, which should be in place sometime this year.

Other areas were showing some improvement. In a previous report, he had noted concerns about the medical unit's practice of holding women with mental health issues and those being evaluated for possible self-harm in what amounted to "de facto segregation units," which he called a "harmful and counterproductive approach!

The medical unit has since added at least one mental health office. "I was able to meet the first officer trained and now functioning in this role and was impressed with her understanding of the benefits of out-of-cell time and the need for clinical engagement. Speaking with her, as well as patients and other staff, made clear that the facility has made substantial progress in securing more out-of-cell time for these patients and also helping patients who had become accustomed to a lock-in approach to gradually increase their time out of cell

as well as their social and therapeutic engagement."


The prison has seen several waves of COVID-19 since the start of the pandemic in 2020. He found that the facility's efforts "to mitigate the impact of these infections, and detect, treat and prevent future illness from COVID-19 to meet or exceed CDC quidelines."

According to the Virginia Department of Correction (VDOC) records, more than 1,100 women at FCCW have tested positive since the beginning of the pandemic. There have been no reported deaths from the virus

Among the women he interviewed and those who have written him letters since his previous inspection, the process of lodging medical grievances remains a source of stress for many inmates. If they feel they haven't received an adequate response to a medical issue, they must first lodge an informal complaint, and if that isn't addressed, they can then issue a formal grievance. Some reported that it could take 3-4 weeks to receive a reply to the informal complaint, at which point their formal grievance was rejected because they didn't submit it "in a timely manner."

He was also concerned by a notice that had recently been posted in clinic areas that if a patient was found to have used a meeting with a medical provider for anything other than the stated purpose, they could be charged with a violation of prison rules. "This notice reflects a potentially harmful approach to delivery of health services because it seeks to punish patients for the predictable and routine scenario in which a health problem either changes in presentation, or potentially, when new or apparently unrelated health problems poses serious risk to health," he wrote.

Earlier this year, VDOC canceled a longstanding contract with Armor Correctional Healthcare, which has managed healthcare in most of the state's prisons, including FCCW, since 2014. Over the next couple of years, health care at FCCW will come under a partnership between VDOC and UVA Health.
