## A look at the history of Scottsville's mills

Mills were once a common sight in Virginia, and you can still see the ruins of many along the rivers feeding into the James River. One of the oldest, Jefferson Mills, was established in 1820 on the Hardware River about 3 1/2 miles northeast of Scottsville. Originally called Albemarle Mills, it changed its name when it was sold to Peter Fields Jefferson in 1857. In 1919, it was purchased by William Thomas Moulton and handed on to his son, John Adkins Moulton. It kept on grinding until 1945 when the last miller, William Williams, retired. The fine, four-story brick building still stands as does the dam. The mill race, however, has been filled in.

Recently Jefferson Mills applied for a permit to modernize, "repowering" its hydroelectric system. Let It Go, LLC, that oversees the operation, is building a fish passage for American eels and sea lampreys. The company is also replacing the turbines with ones that are safer for fish who get sucked into them. "I think they're making it better than the existing dam," said Bill Fritz, development process manager for Albemarle County.

The masonry dam is nine feet tall from the river bottom and 140 feet wide--the width of the river. "This dam is totally amazing," said Joseph Head, a civil engineer with Natel Energy. "These guys that built this dam did it by hand 200 years ago with just rock and mortar, and it's still there. If we're messing with the dam, we have a standard to meet here."

Most mills have been dismantled, but a few are still working, grinding wheat and corn. Check out Woodson's Mill on Piney River for some quality stone-ground products.

### A different kind of mill

The mill which opened on East Main Street at Ferry Street in 1908, was not a water-powered mill. Though near the James River, the James was too big to dam, and the new mill had the latest equipment, a coal-fired boiler that provided the steam to run the mill. The business was started by a consortium of Scottsville merchants, including Luther and Captain John Pitts.

This new mill was a complicated machine, and someone knowledgeable was needed to run it. The Pitts' found their man in Arthur Thacker, who was running a mill of this type in Stuart's Draft. By offering him more money, they were able to lure the Thacker family to Scottsville. It was on this occasion that young Raymon Thacker came to the town in which he was to spend his life.

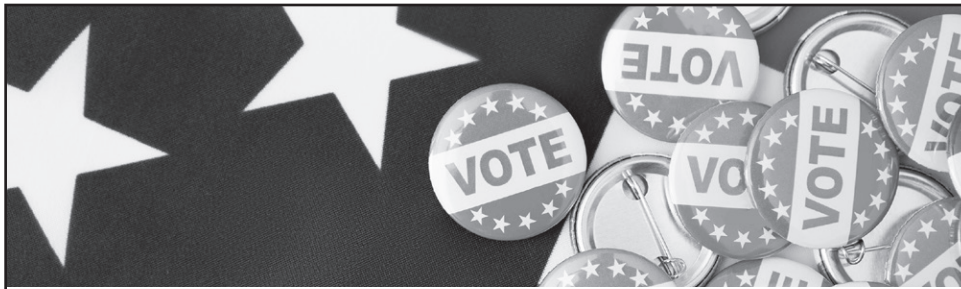
"It is still interesting to me how my father could pick the right stones to grind corn and wheat correctly," said Raymon Thacker. "It was intricate work, and he had to dress the stones frequently with a small hammer." Next door to the mill was a cooperage, where barrels for the flour were made. People brought wheat and corn, the produce of local farms, to the mill to be turned into feed for livestock and flour for the household. Richard Nicholas recalls that the mill was "a big operation." He remembers "riding there with my father with wheat to be ground around 1940. The loading, traveling from the farm in Buckingham County, and unloading at the mill would take most of the day."

The Scottsville Flour Mill was a vital part of Scottsville until it was destroyed by fire in the middle of the night on February 28, 1977, just one year after fires had leveled a good part of downtown. Despite promises by the Albemarle County Service to upgrade the hydrant system, nothing had been done, and trucks going to the river for water got stuck in the mud.

Where the mill once stood, the James River Reeling and Rafting now hums with activity, launching rafters and kayakers on pleasant days to float down the river.

### Key Retirement Account Rules to Remember

While the definition of retirement may change from person to person, the key to qualified retirement plan savings are centered around three key terms. Knowing them and what they mean to you BEFORE you retire are some of the keys to a successful retirement.

• **Catch-up contributions.** When you're age 50 or older, you can choose to make additional contributions to your retirement plans above the usual annual limits. For 2022, maximum catch-up contributions are:

*Planning tip: Each year is a separate savings opportunity. If you fail to take advantage of the catch-up contribution this year, the tax opportunity is lost forever. So to help find the money to take advantage of catch-up contributions, track your monthly expenses and identify where you can save a little money. Use this extra savings to fund your catch-up contribution.*

- \$6,500 when you participate in a 401(k), 403(b) or 457(b)
- \$3,000 for your SIMPLE IRA or SIMPLE 401(k)
- \$1,000 for traditional or Roth IRAs

• **Hardship withdrawals.** The IRS defines a hardship withdrawal as taking money from a qualified retirement account for an immediate and significant financial need such as medical or funeral expenses. While a hardship withdrawal is defined by the IRS, the availability of the distribution still resides with the program administrator and the rules of your particular plan. This is your employer with 401(k)s and 403(b)s.

It is important to note that hardship withdrawals are separate from the early withdrawal penalty. The amount you withdraw is not a loan, so you won't be able to pay the money back to your account. Instead, hardship withdrawals are income to you and may be subject to an early withdrawal



penalty. They may also limit your ability to make contributions to your account for some time after taking the hardship distribution.

*Planning tip: There are several exceptions to the 10% penalty that may or may not align with the reasons for hardship withdrawals. For example, you might be able to avoid the penalty on early distributions from a 401(k) to pay emergency medical expenses, but not to pay your child's college tuition for the upcoming school year.*

**Rollover.** A rollover is a transfer of assets from one retirement plan to another. To keep the transaction tax-free, you generally must deposit the assets into the second plan within 60 days. Not all withdrawals are eligible for a rollover, however. Hardship withdrawals are an example of rollover-ineligible funds.

*Planning tip: Consider a direct rollover to avoid taxes and penalties. An indirect rollover (when you request a lump-sum distribution and then take responsibility for completing the transfer, rather than instructing your assets to be sent directly to your new employer) typically has harsh tax consequences.*

specifically to support students with and without disabilities, interacting and creating with one another. Harris intends to devote additional resources and provide programs for theater education that not only unites communities but creates a welcoming space for everyone.

“We also wanted to foster an inclusive experience that brings together students of various abilities, rather than keeping them sidelined,” she said. Harris modeled

her program after similar programs, such as Live Art in Richmond. “They do this tremendous inclusive arts education work.” After about nine months of planning, surveying local parents, and families, meeting with experts in the field, and creating a comprehensive curriculum; Harris launched the EP All Stars program.

## Lake Monticello men's travelers golf team nearing the end of its season

Starting in May and running through late October, the Lake Monticello golf travel team has been playing matches against teams from other golf courses around the region. The travel team plays each opponent twice, once at home and once away.

Traveler's coordinator Karl Bergstresser said that generally, the home team wins most matches. This is not because the home team has wildly cheering fans that are intimidating to opposing players or possibly even officials. In fact, there are no fans or officials. However, familiarity with a golf course is a fairly big advantage. Every golf course has its own idiosyncrasies and reading greens is a lot easier when you have played a course many times.

As of this writing the Lake Monticello Travelers team is 4-1 at home and 0-6 on the road. The Lake squad was scheduled to host a sixth home match on Oct. 13, against Dominion Club from Richmond, but the match was postponed due to threatening weather.

The Lake squad opened its season on May 12 with a decisive 23 1/2 - 12 1/2 home victory over Glenmore Country Club. The Lake Travelers then played three consecutive road matches and suffered losses to Ironwood in Harrisonburg, Dominion Club, and Orchard Creek in Waynesboro.

On July 7 and July 21, the Travelers topped Orchard Creek and Richmond Country Club in home matches to even their record at 3-3. Both of these wins were by decisive scores. They did not play again until Aug. 9 when they traveled to

Glenmore for a rematch of their opener. This time Glenmore won fairly easily. On Aug 18 and 25, the Travelers played back-to-back matches against the Wintergreen squad. On the 18th, playing at home, the Travelers lost by a single point, 15 1/2 to 14 1/2. Bergstresser said that this is the closest match he has seen in his seven years with the Travelers. On the 25th, Wintergreen won 17 1/2 to 12 1/2.

On Sept. 7, the Travelers played at Richmond Country Club and lost big, dropping its record to 3-7. On Sept. 29, the Travelers rebounded at home to beat the team from Birdwood, in Charlottesville.

On Oct. 19, the Travelers headed to Charlottesville to take on the Birdwood squad. The Birdwood course is home to the University of Virginia golf team and the course was recently redesigned to lengthen it for the big hitting college golfers. The final regularly scheduled match of the season will have the Ironwood team coming to the Lake on Oct. 27. The match with Dominion club that was postponed on Oct 13 may be re-scheduled.

No set number of players are involved in the Traveler's matches, and there is no set roster. Bergstresser had 33 regular players available plus six substitute players who he could call upon, if needed. The Travelers are mostly the better players from the 18-hole Gray Foxes at the Lake, but there are a number of other low handicap players on Bergstresser's roster.





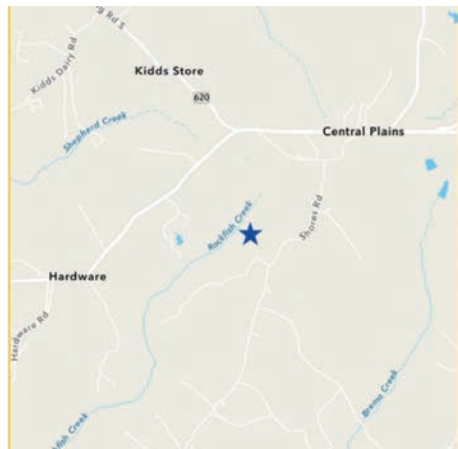

## Solar generation project proposed near Kidds Store

A Richmond-based solar startup held a community meeting at The Light Academy on Wednesday night (Oct. 12) to introduce its plans for a new solar generation project near Kidds Store.

CEP Solar hopes to develop the 355-acre site as White Oak Solar Farm. The 38-megawatt facility would produce enough capacity to power approximately 4,100 homes.

Manager and founding partner Tyson Utt said the property, which sits between Shores Road and Hardware Road just south of Kidds Store, is currently used for timber harvesting. The landowners reached out to CEP Solar to see if they

were interested in developing the site.

A major bonus of the property is its proximity to Dominion Energy's transmission lines. Utt said the solar farm could be connected to the power distribution system.

Utt and CEP Solar co-founder Richard Wright said White Oak Solar Farm would be almost entirely hidden from view by existing vegetation. Solar panels rarely exceed 15 feet in height. Once in operation, they are virtually noiseless and require little or no staff.

The project is currently in the very early stages of development, and the company has not yet formally filed its plans with the county. Utt said they anticipate the whole process of getting the project approved and built would realistically take around three years.

Solar is a growing segment of Fluvanna County's energy development. In 2018, Central Virginia Electric Cooperative (CVEC) dedicated the Palmer Solar Center in Troy and is currently constructing a small facility near the Cunningham substation near Lake Monticello. Fluvanna County Public Schools is one of a number of Virginia school districts to turn to solar to keep energy costs down through a partnership with Sun Tribe Solar, which has installed rooftop panels on several county school buildings.

## Gequetta Murray-Key dies of leukemia Andre Key, husband, appointed to fill her school board seat

The Fluvanna County School Board held a special session on Monday morning (Oct. 17) to take the next steps in filling the seat left by Gequetta Murray-Key, who died on Oct. 11 after a brief battle with leukemia. She was 46.

Ms. Murray-Key was elected to represent the Rivanna District in November 2021 and her term would have ended in November 2025. The sole item on the agenda was how to fill her seat for the remainder of that term.

Under Virginia law, the board must petition the Fluvanna Circuit Court to call a special election to elect a new representative. That election will not happen until November of 2023.

Between now and the special election next year, either the school board or the court can appoint someone to serve as an interim representative. They could also choose to leave the seat vacant.

On Saturday, Ms. Murray-Key's husband, Andre Key, announced on her public Facebook page that he had petitioned the circuit court judges that he would like to be appointed in her stead.

"When G knew that her illness would prevent her from filling her school board duties, she asked me to carry on her legacy and run for her seat," he wrote.

Key is a 1993 graduate of Fluvanna County High School and is currently the Pretrial Program Manager for Jefferson Area Community Corrections Office's Offender Aid and Restoration (OAR) program.

Several people spoke in support of Key's appointment during public comments at the start of the meeting, including Super-

visor Mozell Booker (Fork Union), who said she was "very, very proud" to know the Murray-Key family and to be a part of their lives.

Murray-Key's daughter, Bree, spoke of the shock of losing her mother and of the family's desire to carry on her work. "I would be very proud to have my dad serve after my mom," she said. "And she would be very proud, too."

Superintendent Peter Gretz outlined the board's options and potential timelines. A petition for a special election had to be filed within 15 days, and the board can appoint an interim representative within 45 days of the vacancy.

"The school board chooses the process by which you want to make the appointment," Gretz explained. "There's not a lot of guidance, but you have a lot of latitude as to how you do that."

He said his experience was that school boards often use an application process. A theoretical timeline would have an open period for receiving applications from Oct. 18 to Nov. 12, with the board selecting an applicant no later than Nov. 25.

Over the weekend, the school's lawyers confirmed that the board also had the right to simply make a direct appointment without any application process if they so choose.

At the start of the meeting, Andrew Pullen (Columbia) introduced an agenda item to appoint Key using that direct method.

Chair James Kelley said there were "infinite possibilities for how this could all play out and some of them lead to

under-representation for Rivanna both in the short, medium, and even long term. One of the worst outcomes for this county is to have a vacancy until January 2024, so I am primed for expediency."

In making the motion to appoint Key, Pullen said he was less concerned with politics than the fact that the people of Rivanna district had selected Ms. Murray-Key to represent them. "I so got to think, honestly, they would have supported her husband."

"Who better to have the same like-mindedness in a home than a husband and wife?" Charles Rittenhouse (Cunningham) added.

Kelley said, between the shock of her passing and the inevitable leap to politics and the intractable deadlines for action set by the state, he had lost some sleep over the past few days. "I would have preferred to step back for a moment and just be a human first and respect the humanity and take a moment to both mourn and celebrate."

While Kelley said he might prefer a more structured process, Key was qualified for the position, and appointing him immediately meant Rivanna would have representation for the next 18 months. It also eliminated what he described as his "biggest fear" - that 20 percent of Fluvanna's population would be under-represented in that long interim.

The motion to appoint Andre Key passed on a vote of 4-0, as did the motion to petition the Circuit Court for a special election.

"I'm glad we've completed this so that loved ones can get back to the mourn-

ing process," said Pullen. "I agree with Mr. Kelley that this whole timeline doesn't seem very empathetic."

Pullen also pushed back on emails and social media posts that had circulated over the weekend that he and Rittenhouse were "trying to steal the election" or doing things behind closed doors to replace Murray-Key. He said he didn't know how those rumors got started, but said they were untrue.

"We don't always agree on everything," he said of his fellow board members, "but we agreed today and we agree more than we disagree."

Andre Key did not speak during the meeting, but posted on Facebook that he was "both truly grateful and humbled by the trust and faith" shown by the board.

He said he loved this community and "although G's shoes will be hard to fill, I would like for our schools, our staff, our students and for all community members to know that I will endeavor to the best of my ability to serve Fluvanna schools with professionalism and integrity."

## Fall wildfire season is here

Leading source of wildfires in Virginia: Burning yard

Virginia's fall wildfire season began Oct. 15. The Virginia Department of Forestry (VDOF) reminds everyone to be extra careful when burning yard debris, or enjoying a campfire or backyard fire pit.

VDOF has forestry staff assigned to every county across the state who work with local fire departments to provide emergency response to protect people, property and our natural resources. While there is no statewide 4 p.m. burn ban this fall, be sure to always check with local fire officials in your area for possible regional restrictions or bans.

In Virginia, debris burning is the leading cause of wildfires. This time of year, burning leaves, branches and other yard waste is common. Dry grass and leaves, low humidity and windy conditions create favorable conditions for wildfires.

When planning to burn yard debris, always keep safety in mind:

- Avoid burning on dry, windy days;
- Keep your pile small;
- Have a rake or shovel on hand;
- Keep a charged water hose nearby;
- Have a phone ready to call 911 if a fire escapes your control;
- Stay with your fire until it's completely out (drown, stir, ensure it's cool);
- Consider a "green" alternative to burning yard debris: compost your organic yard waste for your garden or yard.

"Virginia's fall wildfire season runs from mid-October through November," said VDOF Director of Fire and Emergency Response John Miller. "As we see all too often with natural disasters and emergencies, the time to prepare is long before a crisis hits. Create a plan now that you can quickly put into action if you need it."
