Stamper talks about painting

Nance Stamper's work is suggestive, celebrating those quiet moments people love, like the image of a lone kayaker on tranquil waters in the early morning. Her forms and moods emerge out of light and bright colors, solidifying her style as an artist. The people in her paintings use subtle movements to convey stillness and solitude, mostly drifting along the water in a kayak.

Her still lifes feature the same quietness, whether it is a bicycle leaning up against a barn or a large thumbtack. Stamper uses a variety of subjects for painting and anything is possible.

It was in the ninth grade that Stamper took her first art class and she said she was hooked though she never pursued art then. When she moved to the lake 41 years ago, she started silk-screening and signed up for a drawing class in the county. The class was canceled so she took an oil painting class instead. Like many artists, she favors oils for their flexibility. Because they do not dry immediately, they can be worked with over time.

"I loved the smell and mixing the colors. I now use mostly acrylics, but love to mix it up - acrylics and oils - even in the same painting," she said. She is not afraid of experimentation.

Stamper is mostly a self-taught artist, learning to paint using books, videos, formal and informal courses, "and trial and error." She has been painting now for about 35 years but said she is still looking for that drawing class.

Stamper's work is classified as modern impressionistic and she said that artists, including Mary Cassatt, influenced her work.

"I like how she lovingly portrays women with children and women with women and everyone is wearing a hat. So many hats. But my two favorite paintings are Springtime and The Storm by Pierre-Auguste Cot. I don't know too much about this artist but these paintings are so big and magnificent," she said. "The young girl's white dress and the couple's infatuated faces are so incredibly painted. These are paintings that I want to jump into. This is whimsical realism." She added that if she could meet one of her favorite artists, it would be Cot so she could learn how he created his works of art.

Like those she admires, Stamper's work has realism, mostly through the mood she creates using light and color.

"Life inspires my art. All of God's awesome creations. The lake, the sky, birds, flowers, trees, people, boats, colors, words, music, old and worn-out things, new things — I could go on and on. Hence, I paint many different subjects," she said. "My friend says that if you stand still too long around me, I'll paint you. Many of my paintings come with stories and are of places that I want to jump into before, during, and after I have painted them. Someone once said that my style is whimsical realism. I like that."

Artists often have several ongoing projects but then there are moments when nothing comes to mind.

"I now have a blank canvas staring at me on my easel, but the paints are out."

9 Key Changes for the 2022 Tax Year!

Here are some key changes to the tax code for 2022. Use this information to help understand your 2022 tax obligations and how it may change from last year's tax return. If you're interested in minimizing your tax obligations and maximizing your savings, consider the helpful tips and ideas you'll find in this newsletter. Call if you would like to discuss how any of this information relates to you. If you know someone that can benefit from this newsletter, feel free to send it to them.

By the way, October 15th is right around the corner! If you filed an extension you only have a few days to complete the return!

New in 2022

- **Increased teacher deduction.** The deduction for out-of-pocket classroom supplies for teachers is \$300, up from \$250. If you're married, you can deduct up to \$600.

- **Electric vehicle credit extended.** The \$7,500 tax credit for purchasing an electric vehicle has been extended through 2032. The problem, though, is that there are many, many more hurdles you'll have to clear before you can claim the credit.

- **High efficiency home improvements credit extended.** Qualifying high efficiency home improvements now qualify for an annual \$1,200 credit, up from a \$500 maximum lifetime credit. Energy efficient heat pumps, heat pump water heaters, central air conditioners, wood stoves, and natural gas or oil furnaces or boilers qualify for a \$2,000 credit.

Last chance for small business tax rules

Two popular business rules are currently set to expire at the end of 2022 unless extended by Congress. Both involve small business expense deductibility.

- **100% meal deductibility.** Business meals are typically only deductible at 50%. To help aid restaurants recover from the

pandemic, you may deduct 100% of qualified meal expenses thru 2022.

- **100% bonus depreciation.** This is the final year that qualified business assets can be completely expensed using the 100% additional first year bonus depreciation deduction. The bonus depreciation deduction decreases to 80% in 2023, 60% in 2024, 40% in 2025 and 20% in 2026 before expiring after December 31, 2026.

Some other key changes

- **Charitable giving deductions.** The deduction for charitable giving for taxpayers who don't itemize is no longer available in 2022. This \$300 reduction in income for single filers (\$600 for married taxpayers) is now expired. You may now only deduct qualified charitable deductions if you itemize deductions on your tax return AND all qualified deductions exceed \$12,950 if single and \$25,900 if married filing jointly.

- **Child tax credit.** The advance payment of one half of this credit is gone and the dollar amount for each qualifying child rolls back to 2020 limits of \$2,000 per child. Last year you could receive as much as \$3,600 per child.

- **Dependent care credit.** The maximum tax credit you can earn for qualified childcare expenses is \$1,050 for one qualifying individual (down from \$4,000) or \$2,100 for two or more qualifying individuals (down from \$8,000).

- **Mortgage insurance premium deductibility.** This itemized deduction is back on the shelf for 2022 unless it is again extended by Congress. The 2017 Tax Cuts and Jobs Act eliminated this deduction, but it was reinstated by Congress as an itemized deduction through the end of 2021.

Supervisors adopt new economic development blueprint

The Board of Supervisors approved a strategic plan for economic growth at their meeting on Sept. 21 – but not without a serious debate about the role of housing in Fluvanna's future growth.

The plan is designed as a blueprint for economic development over the next five years.

PlatinumPR, a Maryland-based public relations firm, collected data and conducted interviews with supervisors and community members in the first quarter of 2022, and a draft of the plan was discussed at the board's leadership retreat in late August.

Jennifer Schmack, Director of Economic Development for the county, outlined the three main sections of the plan, grouped into the areas of "People," "Prosperity," and "Placemaking."

The primary goals are to improve "opportunities to elevate businesses," to "attract and retain industries that advance our communities," and to "enhance the spaces where people live, work, and play in Fluvanna County."

The plan includes a wide range of initiatives that would help train the local workforce, attract talent from other areas, support entrepreneurs, create more busi-

ness space and shovel-ready building sites, streamline the business application process, and expand the county's tourism, agribusiness, and artisan sectors.

During the discussion following Schmack's presentation, Supervisor Chris Fairchild (Cunningham) said he had "real concern" with one item in the plan designed to "showcase real estate to attract, retain and grow available talent."

He said that during his time on the county's economic development commission, its mandate was to "get businesses to subsidize the burden on the rooftops – and that's what we always hear in Fluvanna, to get more businesses to take some pressure off residences – but then we talk about bringing in more residences so we can get more businesses," creating an endless loop. "I'm not one to say let's attract and try to bring more people to live in Fluvanna County"

He cited language used by the Thomas Jefferson Planning District Commission (TJPD) that encourages outlying counties to absorb some of the "burden" of providing affordable or workforce housing to relieve pressure on Charlottesville. "I don't buy into [the idea] that we need to bring more people to create prosperity, especially when it's being dictated to us by TJPD."

asked if he was speaking specifically of growth around the Lake Monticello area, or county-wide. "I would like to bring in more people to Fork Union," she said, arguing that there was a clear correlation between people and services. "We have developments that haven't been developed because we can't get people there. We can't get a grocery store because there are not enough people."

Vice Chair Tony O'Brien (Rivanna) argued that creating a wide range of housing opportunities did not necessarily mean replicating the problems sometimes seen in Charlottesville and other cities.

He noted that population growth in the county has been very low over the last two decades, with the 2020 Census showing an anemic 1.6 percent increase over the past ten years.

"The idea that we can just close our doors and not have any further growth in terms of housing in Fluvanna County...it's frankly a little bit absurd," he said.

He disagreed with Fairchild that the economic plan shouldn't include references to housing, because along with good-quality schools and amenities, it's one of the key things people want to know before moving to an area. The details of how to manage housing growth could be refined in the comprehensive plan currently under development.

"I didn't say 'stop growth' in any way, nor did I even suggest it," Fairchild countered.

He mentioned the new Colonial Circle

development under construction at the intersection of Rts. 53 and 618. Along with single-family homes and retail space, the county has approved two buildings with 124 subsidized apartments set aside for working families whose combined income is below 60 percent of average median income (AMI).

"Plenty of citizens are saying 'I'm uncomfortable with that,' he said. "We're bringing on this workforce housing that's going to create a substantially greater financial burden."

Later in the conversation, O'Brien said he thought Colonial Circle was going to be a success story, adding "I don't think we should be afraid of embracing different types of housing needs."

Chair Mike Sheridan (Columbia), who works for Fluvanna County Public Schools, said that he favored showcasing a variety of real estate as a way to convince young Fluvanna residents to stay in the area after graduation or to return after college.

The debate grew heated at times, as members talked over one another in their effort to make their points, and then admonished each other for the interruption. After about 30 minutes of discussion, Sheridan asked if any members other than Fairchild were in favor of striking the language. O'Brien, Booker, and Supervisor Patricia Eager (Palmyra) indicated they wanted to keep the plan as it was.

The motion to approve the plan passed on a 4-1 vote, with Fairchild voting nay.

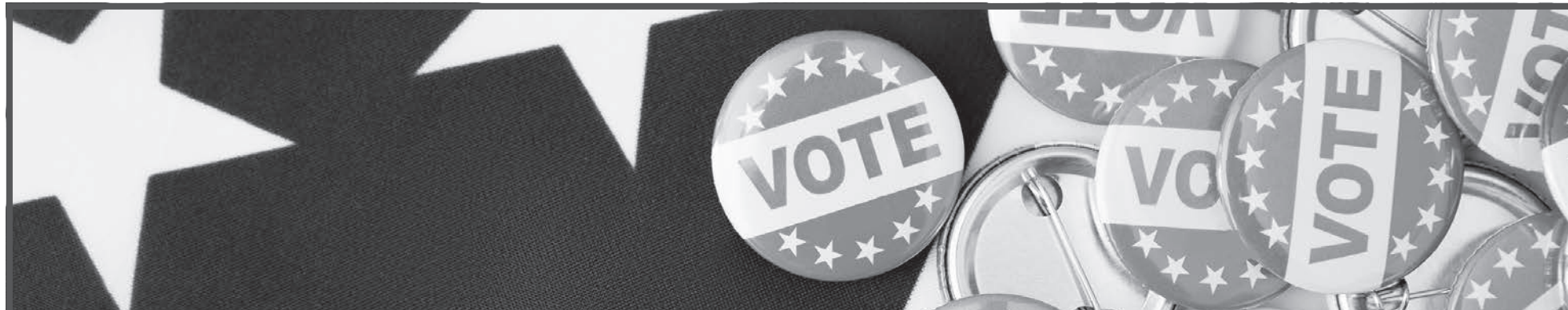

This year marks the 100th Anniversary of Fire Prevention Week. The Lake Monticello Fire Department has hosted a community fire prevention event for more than 20 years now, according to the top fire official.

This year the Fire Prevention Day at the Lake Monticello Fire House at 10 Slice Road in Palmyra is Saturday, Oct. 15, from 11 a.m. to 2 p.m. The year's event includes a bounce house, food, games, face painting and lifesaving knowledge, according to Lake Monticello Fire Chief Richie Constantino.

"Our Fire Prevention Day has gotten a lot more elaborate over the years," Chief Constantino said. "The highlight of the day is the fire demonstrations, the contests for the kids and the fire trucks, of course." He said that while the day is fun for all ages, the emphasis is on educating

the community to help save lives and property.

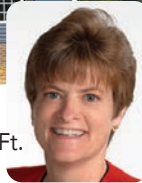

Fluvanna Faces: Bob Kenward

Tell us about your occupation prior to starting Fluvanna Sports Photography.

I began my career with the Department of Defense in 1984 as a communications engineer for the Air Force at Griffiss AFB, NY. In 1991, we moved to Fluvanna County and I started work with the Army. I retired from that career in December 2018.

When did you start this unique business?

Fluvanna Sports Photography started in 2006 and was initially focused solely on action sports photography. We are now the premier choice in the area for small leagues, clubs, and travel teams for individual photos, team photos, and banners.

Why photography?

I've always had an interest in photography and when my son began playing travel soccer, I started taking action photos during the games. After a couple of years, it turned into a business.

Tell us about why you specialized with sporting activity.

I enjoy the challenge of capturing peak action and my technical background helped me to understand the mechanics of photography and the equipment. As I moved more into team photos, I found it very enjoyable to try and capture the pure joy of being on a sports team.

With cell phones today, nearly everyone takes their own pictures. So, why should they consider the pictures you provide?

Cell phones have definitely affected the industry. That's one of the main reasons that I moved away from action photography and turned my focus to team and individual (T&I) photography. The T&I photos that we produce use dynamic lighting that a mom or dad with a cell phone can't reproduce. We also incorporate cutting edge graphics and we produce a composite team photo. This makes our photos unique from anything that you'll get using your cell phone.

As a professional photographer, is it costly to have the equipment needed to provide your customers with quality pictures which are far better than they can do themselves?

To put it simply, yes. We use professional grade cameras, lenses, lights, and support equipment. None of these are what I would call inexpensive.

When cell phones became almost the norm for taking pictures, many camera stores closed their doors. Did this also affect Fluvanna Sports Photography?

Not at all. We purchase our equipment

online through camera stores and servicing is always done by the manufacturer's service center. All of our customer ordering is done online and once paid, the order is immediately transferred to a professional photo lab. Completed orders are shipped directly to the customer in just a couple of days.

Please explain how you take group pictures.

Back in the day, we posed the groups kneeling, sitting on benches, and standing and prayed that we could get them all looking at the camera when we took the shot. Now we use Enhanced Composite Photography to produce a team image using individual images. This ensures that each athlete is properly lit and properly posed. It also allows us to easily produce dynamically posed team images that would be very difficult to reproduce traditionally. Parents also love this because it means that if their child is late for photos or sick that day, we can still get them into the team photo just as if they were there with the rest of the team.

Do you advertise in order to gain new clients or do you just rely on your web site?

Most of my business growth has been based on customer referrals and targeted business outreach. We do get a lot of traffic on the web page too. (www.fluvannaphotos.com).

Is your business a 9 to 5 job, five days a week?

Due to the sports focus of the business, most of our photo sessions are on Saturdays and weekday evenings. Other than that, I strive to keep standard 8 a.m. to 4 p.m. hours, but, as a small business owner focused on customer service, I'm almost always available to answer customer inquiries.

Does your business offer products other than photography? If yes, what are they?

Just about everything we offer is photography based, but we also do a lot of senior recognitions...yard signs, banners, and garden flags that don't necessarily involve photography.

Would you recommend to high school graduates to seriously consider photography as a profession?

It can be tough to make a living doing it. Newspapers have really cut their staffs and everyone with a cell phone or basic camera is photographing weddings, babies, and seniors. You have to find some aspect of photography and set yourself apart from everyone else. That's what we've done with Fluvanna Sports Photography.

Anything else?

One of the things I'm most proud of is the work we do with travel teams...mostly baseball and softball. We setup extended photo sessions and get lots of different poses for the parents to choose from. We also work with them to produce cutting edge vinyl banners that showcase the team and often their sponsors. Teams take these banners with them to tournaments and hang them on the fence. It's a great way to show off the team!
