



#### Worries about potential hazardous waste

I attended the public hearing of the Planning Commission on March 11 to hear the discussion about amending zoning ordinance 22-22-1, removing the word "municipal" from the definitions of "Solid Waste Material Recovery Facility" and "Solid Waste Collection Facility."

This amendment would broaden the definitions of "Solid Waste Material Recovery Facility" and "Solid Waste Collection Facility" to include non-municipal waste.

I raised the question of what this change could mean in terms of the types of waste that might be included in "non-municipal waste" that might differ from "municipal waste". My concern was that "non-municipal waste" might be at greater risk of including potentially hazardous waste, the presence of which we might not be aware of, nor of the level of risk to our local environment.

My personal concern raised enough interest with the Commission that until more information could be obtained about potentially hazardous waste that might enter our county, the vote on this requested action was deferred to the next Planning Commission meeting on April 8 at 6:30 p.m. in the County Administration Building, 132 Main St, Palmyra.

I think we would want to be fully aware of the potentially hazardous waste that could be received from private companies. Another way to look at it may be to be fully aware of hazardous waste that could not be included (banned).

Comments that the DEQ monitors waste facilities did not settle anyone's concerns since, as we all know, the federal cuts taking place presently trickle down to the state level and often have negative effects on performance by monitoring agencies such as the DEQ.

I will be doing my homework to find out more on this subject, as will the Planning Commission, but I think the Board of Supervisors should look into this as well.

#### Concern about future of Palmyra post office

I am writing in my capacity as president of the Fluvanna Historical Society to express my own and the Society's concerns about the U.S. Postal Service potentially closing the current Palmyra Post Office or relocating it. This was announced not to the public put to the box holders at the post office. The Fluvanna Historical Society commented to the USPS that it has concerns both about closing the existing facility and in possibly building a new facility "...within a radius of three miles from the present facility."

I cited in my letter to the postal service the effort citizens living in Palmyra have made over a period of many years to protect the village's unique character and to improve the quality of life there, an effort very much supported by the Historical Society and its members, In addition, the county too has invested In Palmyra by committing substantial money to the courthouse and a new VDOT streetscape project. I believe that keeping the post office in its present location would be the Society's first preference. There may be room there to expand the present building. I also urge that any proposed new facility be located close to the village.

The Society has over the years made use of the post office easier and more accessible by allowing customers to park in its lot at the Village Park adjacent to the post office.

The citizens of Fluvanna County have indicated their commitment to retaining the integrity of the Village of Palmyra and have supported the efforts to protect its historic legacy.





It's always nice to welcome a new neighbor. Actually, not so long ago, many of us were the new neighbor that was welcomed. Fluvanna County population continues to grow noticeably.

Sometimes, though, along with the furniture and family treasures, folks bring along their favorite plant from back home. And that could be the beginning of a serious problem.

Many new residents say they chose to relocate to Fluvanna County because they appreciate the natural ambience of trees and fields along the winding hilly roads. But introducing new plant species, even in backyard gardens, can have a negative impact on the environment that attracted people here in the first place.

Non-native species can cause considerable damage to the Fluvanna ecosystem. They can spread quickly from the backyard to invade and overtake native vegetation on roadsides, streams, fields and forests. This interruption not only displaces the natural balance, it can also become a serious economic threat to the agricultural base of this area.

With this in mind, the Fluvanna Master Gardeners are hosting an informative event at the Fluvanna Public Library Saturday, April 12, from 3:30 to 5 p.m.

"Invasive Plants in your Landscape and What You Can Do" will be discussed by Lauren Taylor, executive eirector of the Blue Ridge Partnership for Regional Invasive Species Management (PRISM), Virginia's first Cooperative Weed Management Area (CWMA).

Taylor's involvement with invasive plants began when she was a volunteer to create the Patagonia National Park, one of the largest grasslands restoration projects in the world. She now works with organizations to remove invasives on both public and private lands, and she has built a web app that can be used for field identification of the 103 plants on the Virginia Invasive Species List.

The program which is free and open to the public will look at how to identify invasive species in the lawn, garden, and neighborhood and how to remove and control them. Gardeners and hikers will find the information pertinent to their interests.

The Fluco baseball team won the Class 3 State championship in 2019, just before COVID. Last year with a roster that coach Joel Gray described as "youthful, but very talented" the team went to the State quarterfinals and posted an 18-6 record. This year Gray is looking to get back to the State final four, which will be played at Fluvanna. Of course, reaching the State finals is a lofty goal and anything can happen in a long season.

Nonetheless, it doesn't look like this goal is unreasonable. The Flucos are deep, experienced and talented. The talent starts with junior shortstop Sam Loving, a multi-sport athlete. Loving was Jefferson District Player of the Year in 2024 as a sophomore. Gray notes that Loving batted an astonishing .500 last season which made him only the second player in Gray's extensive tenure to hit .500 or better for a season. Shortstop is a good place to start in building a championship team, but pitching is usually what decides the matter.

Two All-Region 3C senior pitchers will be returning to the mound for the Flucos. Caden Harris posted a 7-1 record last year and Cam Via was 6-1. They can pitch and hit. Both are power hitters who will bat in the middle of the order. Relief pitchers include seniors Logan Horner and Christian Lounsbury and junior Tremayne Minor. The pitching should be solid as long as there aren't a lot of "ninety-foot freebies," Gray's term for walks. Due to Sste rules designed to protect young arms, pitchers are limited as to how many pitches they can throw per day, so pitching staffs need to be deep.

Joining Loving in defending the middle of the field will be Brody Shields at second base. Gray says Shields may be "the best glove we have ever had in the program." Three seniors will be called on to handle first base. When not pitching, Caden Harris or Via will be there. Another senior first baseman will be Thomas Custer, who is recovering from an injury to his throwing arm. Custer is expected to be available by the fifth or sixth game. Third base will be handled by junior Kyle Harris who Gray describes as a solid defender and a "grinder" at the plate. Junior Carson Raines will handle the catching, with sophomore Noah Washington as his back-up. Raines is another of the team's power hitters.

Gray believes that his outfielders can fly. Senior Jackson Fields is a track athlete and has committed to play in college at Bridgewater. He has a strong arm and will bat in the middle of the order. Other outfielders who have impressive range are Senior Jayden Hoy, Junior Carson Melton and freshman Jacob Loving. Minor will also be in the mix in the outfield, when not on the mound.

According to Gray, Jefferson District contenders include Louisa County and Orange County both of which have solid pitching, and Western Albemarle which has a strong baseball program. Nevertheless, the Flucos are probably heavy favorites to repeat as Jefferson District champions.

Gray is assisted by Stacy Barringer, Don Fields and Josh Barringer.



As the School Board discussed its budget proposal during its monthly meeting on Wednesday (March 12), the Board of Supervisors was holding its own meeting, debating how much – or how little – of the proposal they would fund.

In February, the School Board approved a budget requesting \$24 million in local funding, an increase of about \$1.9 million over the previous year.

Of that funding, approximately \$1.5 million would go to a three percent increase in staff salaries and to cover some increases in health insurance rates. Roughly \$500,000 would go to four new staff positions, including a human resources director, a behavioral specialist, and coordinators of instruction and alternative education.

After a work session with the Board of Supervisors the previous week, where they had faced questions about staffing and compensation relative to other localities, Superintendent Peter Gretz and Director of Finance Brenda Grasser presented some new data to the School Board that they intended to send on to the supervisors.

The data showed that Fluvanna County Public Schools has the lowest assistant-principal-to-student ratio among surrounding divisions.

They also presented information on teacher-to-student ratios, insurance rates, and teacher salaries relative to nearby districts.

"So that means the highest caseloads on top of the lowest pay with the highest insurance," said Danny Reed (Fork Union).

Grasser said that was

why she felt so strongly about advocating for staff. "I feel like we have people that are very loyal and they stay here for many, many years, and sometimes

we punish them for being loyal," she said.

Reed and James Kelley (Palmyra) stressed the urgency of getting this new data to the supervisors.

"Kind of sucks to be here when they're making some pretty big moves down the hill right now," said Kelley.

At the work session, the supervisors could not see a path toward funding the entire request.

The budget they discussed allocated only \$761,000 of the \$1.9 million under the proposed real estate tax rate. Funding the full amount would mean cutting \$1.2 million

from an already lean budget or raising the real estate tax rate.

They are open to allocating more. Supervisor Mike Goad (Fork Union) said they "really need to dig deep here and figure out what we're looking at, but I would like to get closer to at least a number where the teachers are able to have that increase."

No decisions were made at the work session, and the debate over funding will go on for the next several weeks.

"I know things are tough down the hill," said Kelley. "I know that setting a tax rate is difficult. That's the job they are elected for, and we are elected to advocate and tell the Board of Supervisors what we need."

If the supervisors provide only partial funding, the School Board will have to figure out what parts of their budget they can fund.

"Ultimately, cutting corners and not funding education leads to terrible outcomes for our kids," Kelley said.

"We have kids that are doing fantastic work with less," said Reed. "So imagine what our teachers and students could do with more. They would be amazing."

# Wildlife Tips for March

March is a month with nature days to celebrate: the first day of spring, daylight savings time, International Day of Forests, and World Wildlife Day. Many migratory birds are flying north again to their breeding grounds.

Mark your calendar for a program by the Virginia Wilderness Committee to be held at Ashlawn Clubhouse on Sunday, March 23 at 2 PM. Ellen Stuart will discuss native plants and their benefits for our yards and natural habitats. Our Wildlife Committee sponsored this program.

Bearwise.org tells us that in March, some black bears leave their dens to stretch their legs and then go back to sleep. Other bears leave their dens for good. Bears emerge skinny, groggy, and thirsty. They eat lightly at first and look for old berries, acorns, and winterkill carcasses. Now is a good time to make sure anything around your property that could possibly attract a hungry bear is stored out of sight, smell, and reach.

Learn how to select a tree for your property that will have the best chance to survive. Charlottesville Area Tree Steward Tim Maywalt, discussed best practices for planting and demonstrated how to care for your newly planted tree and your other trees for the long term on March 11. You can still watch that program by visiting the Charlottesville Area Tree Stewards website which provides past presentations and helpful advice.

Per Virginia Code Section 58.1-3321, notice is hereby given that the Board of Supervisors of Fluvanna County proposes to increase property tax levies.

(1) Assessment Increase: Total assessed value of real property, excluding additional assessments due to new construction or improvements to property, exceeds last year's total assessed value of real property by 22.55 percent.

(2) Lowered Rate Necessary to Offset Increased Assessment: The tax rate which would levy the same amount of real estate tax as last year, when multiplied by the new total assessed value of real estate with the exclusions mentioned above would be \$0.689 per \$100 of assessed value. This rate will be known as the "lowered tax rate."

(3) Effective Rate Increase: The County of Fluvanna proposes to adopt a maximum tax rate of \$0.750 per \$100 of assessed value. The difference between the lowered tax rate and the proposed rate would be \$0.061 per \$100 or 8.85 percent. This difference will be known as the "effective tax rate increase".


Individual property taxes may, however, increase at a percentage greater than or less than the above percentage.

(4) Proposed Total Budget Increase: Based on the proposed real property tax rate and changes in other revenues, the total budget of Fluvanna County will exceed last year's by 8.78 percent <sup>1</sup>.



## Commissioners defer action on municipal waste ordinance change

Shifflett steps down as Rivanna commissioner

Concerns about a single word being struck from a county ordinance led the Planning Commission to defer action at its monthly meeting on Tuesday (March 11).

Planning Director Todd Fortune and County Attorney Dan Whitten had recommended striking the word "municipal" from an ordinance that regulates waste facilities in the county.

"The intent here is basically to give some more flexibility on the source," said Fortune. "The term 'municipal' indicates it has to be a public entity from which the facility collects its waste."

The public hearing on the change was first advertised for earlier in the year, but was delayed due to bad weather.

Before the cancellation, some community members raised concerns that the amended ordinance could open the door to all types of waste being transported into Fluvanna – including industrial, medical, and perhaps even nuclear waste.

"I'm surprised," said Paul Crowther, the only speaker during the public hearing. "I thought I was going to have trouble parking."

Crowther's concern was the vague wording of the ordinance and the lack of clarity over what private companies could ship into the county. "I don't want to start bringing that stuff into our backyard."

Whitten explained that any non-municipal waste was monitored by the Virginia Department of Environmental Quality (DEQ), but Crowther did not find that comforting.

"With what is going on in this country right now with everything being cut – who knows if there's going to be a DEQ next week?"

Whitten felt that was unlikely, but Commissioner Kathleen Kilpatrick (Fork Union) said that as a former director of a state agency, she thought it was possible that loss of federal grant funding could indeed limit oversight.

"Impacts to state agencies are an issue," she said, "including employees' capacity."


Commissioners voted 4-0 to defer action until its April meeting to give

the Planning Department time to look into the matter or make some suggestions on how to strengthen the ordinance.

Earlier in the meeting, Fortune noted that Rivanna Commissioner Eddie Shifflett had resigned from his position. No reason was given at the meeting for the resignation, and he was not present for the session. Shifflett was appointed by the Board of Supervisors to an unexpired term in May 2024 and had more than a year left to serve.

Supervisors will appoint a replacement at an upcoming meeting.





## Safety initiative launched to prevent farm vehicle accidents

Spring is when drivers will be sharing the road with farmers moving oversize equipment. And when normal traffic meets up with larger, slower vehicles, there's an increased risk of accidents.

That is one of the reasons the Virginia Farm Bureau Farm Safety Program started a new initiative—Safety Awareness for Farm Equipment on Roadways, or SAFER.

The initiative kicked off with a contest to raise awareness of slow-moving and large farm equipment on the roadways, and the potential dangers involved in transporting them.

The Farm Bureau safety program is inviting community groups and civic and youth organizations to create visual displays depicting the size difference between farm equipment and regular vehicles. The goal is to have displays in high-traffic public areas that will help make drivers more aware of farm equipment on the roadways.

"If you can't see a farmer, then they can't see you," noted Matt Nuckols, chair of Farm Bureau Farm Safety Advisory Committee. "And besides, it's illegal to pass on a roadway with a double solid line-even if the driver ahead of you is going extremely slow." Additionally, one contest category is

involve a physical display, and another is for the most effective use of media channels to educate drivers about the presence of farm equipment on roadways.

Many Virginia farmers don't have the luxury of cultivating all their acreage on one farm. They often have to move equipment from field to field as they plant, tend and harvest crops.

Springtime in Virginia is when farmers are planting corn and soybeans while also harvesting barley, rye and wheat. Some of them also start cutting hay in May, Nuckols explained. The equipment needed for planting and harvesting includes applicators, balers, combines and sprayers, some of which can be up to 16 feet wide. When the average highway lane is 10 to 12 feet, that means there's not much room for maneuvering.

Drivers shouldn't assume that a farmer can pull over to let someone pass. Shoulder conditions may make it unsafe to pull heavy equipment to the side of the road.

intentions before passing.

Farmers with large equipment are usually easy to spot. Virginia law requires vehicles that travel slower than 25 mph and are being driven on public roads to be equipped with rear-mounted triangular slow-moving vehicle emblems. These reflective orange signs act as a warning to approaching drivers to slow down.

Farm equipment can't stop quickly. For example, if the equipment is traveling 15 mph, it would take a car traveling

55 mph 5 seconds to brake 300 feetthe length of a football field-to avoid a collision.

Often drivers think they can quickly pass farming equipment, but what if the farmer is planning to make a lefthand turn while you're passing?

"It could be disastrous," Nuckols said. "And because farm equipment is so large, the car may take the brunt of the damage."
