

Accusation of land use program mismanagement dominates supervisors meeting FUSD billing error led to \$102,000 revenue shortfall

Accusations of mismanagement by a candidate for commissioner of the revenue may have led to a lengthy presentation on Fluvanna County's land use assessment program at the Board of Supervisors meeting on Wednesday night (Aug. 20).

Palmyra residents Donald and Patti Reynard, who have criticized the land use program and Sheridan's management of the program for the past several months, have repeatedly asked for the board to hold a town hall or public meeting on the subject.

Land use taxation is a system that offers landowners the ability to have their property assessed based on its use-agricultural, horticultural, forestal, or open space-rather than its market value.

Fluvanna County was an early adopter of land use valuation, which the state first approved in 1972. The system incentivizes conservation by giving deep tax breaks to owners who keep their property undeveloped.

County Attorney Dan Whitten said 107,000 acres in Fluvanna are currently in the land use program. Combined with 17,000 acres in conservation easements, that means over 65 percent of

Fluvanna's total acreage is protected from development.

"I think it is one of the singular programs, in tandem with conservation easements, that helps us maintain the rural character of this county," said Commissioner of the Revenue Mel Sheridan, whose office administers the land use program.

Whitten delved deep into the details of the program, which is regulated by multiple layers of state and local bureaucracy. Guidelines for use values are set annually by the State Land Evaluation Advisory Council (SLEAC). Counties do have some discretion over how to apply these values; for example, Fluvanna uses a weighted average method, which prevents land from being valued at \$0 per acre.

If a landowner falls out of compliance, decides to subdivide or develop or rezone their property, they pay "rollback" taxes for the current tax year plus the previous five years, including interest.

Unlike many presentations, this one presumably did not tell the supervisors much they did not already know. All have voiced support for the program in recent months, and some have property in the county currently under land use valuations.

Some in the community have raised questions about the fairness of the program, which benefits those who own large tracts of land and shifts the tax burden to residential homeowners with plots of less than five acres, and who thus do not qualify for the program.


Few have been as vocal as the Reynards. With Sheridan set to retire on December 31, Donald Reynard recently announced his candidacy for commissioner of the revenue.

Sheridan was clearly angered by the repeated accusations of mismanagement and malfeasance, saying, "it is a thoroughly and professionally administered program. I stand solidly behind that, regardless of what may be inferred from time to time."

If the presentation was designed to quell the criticism, it was unsuccessful.

Both Mr. and Mrs. Reynard made comments at the end of the meeting, accusing supervisors of personally benefiting from the program and failing to file legally required forms, arguing

that the county's use of the open space designation violated state law, and calling once again for a full audit of Sheridan's office after his departure.

"Set me down with the auditors. We can expose it. I'm here to expose the truth and the facts, and nobody wants that," said Patti Reynard. "And that's how rumors start when people are afraid of the truth and the facts being exposed. We create rumors, false accusations, and character assassination. That's what I'm against."

Supervisors did not respond to the accusations, as they do not generally respond directly to speakers during public comments.

FUSD RATES

An administrative error in the county's utility billing system led to a \$102,000 revenue shortfall in the Fork Union Sanitary District's (FUSD's) budget over the last year.

Instead of being charged \$11.22 per 1,000 gallons, customers were charged \$11.20 per 2,000 gallons.

Combined with two \$70,000 pump replacements, FUSD has a budget shortfall of close to \$166,000.

To remedy the shortfall and get the utility back on track, county staff is proposing new rates. The base rate for the first 2,000 gallons would rise from \$24 to \$27, and pricing per 1,000 gallon after the first 2,000 could climb from \$11.22 to as high as \$15.

Supervisors were asked to approve a notice for a public hearing on the proposed rates.


Fork Union Supervisors Mike Goad renewed his opposition to rate hikes without putting in place a 5- to 10-year planning process to assess the needs of the aging system.

"Annual increases are becoming the norm, but I believe we need a clearer, more comprehensive plan to articulate to FUSD residents as we continue to work on the more long-term Fork Union water project over the next few years," he later said on Facebook.

He was the single 'no' vote on the

Moss to cap his historic impact on Fluvanna at Sept. 28 event

Marvin Moss will step down as president of the Fluvanna Historical Society after a Sept. 28 special event, capping his decades as what one county native called Fluvanna's "president of everything."

That's hardly an overstatement. Moss has been chair of the Fluvanna County Board, president of the Fluvanna Historical Society for 25 years, president of the Fluvanna Heritage Trail Foundation, chair of the Rivanna River Commission, president of the Fluvanna Friends of Rural Preservation and a member of numerous committees and commissions at the state and national level

Among the Fluvanna projects Moss led or worked with groups on are the new high school, restoring the historic courthouse, designing the new courthouse and library, creating the Palmyra Village Park, designing the Rt. 15 bridge in Palmyra, the Heritage Trail organization, the picnic shelters at Pleasant Grove, getting \$750,000 in funding to restore the Pleasant Grove House, the Palmyra Fire Station, helping raise almost \$300,000 for the Fluvanna Farm Heritage Museum, convincing county landowners to place more than 5,000 acres of open space under conservation or historic easements, buying the CSX rail right-of-way in Palmyra to convert into a walking trail, Maggie's House, the Holland-Page Place log cabin museum, and with Fathers Mefodil and Kyrill establishing the first Eastern Orthodox monastery in the county at Glen Burnie..

For all of that, Moss was named Virginia's "Unsung Hero" of 2016, an award given annually statewide to a volunteer leader who has had a major impact on their locality. "None of what I've done here would have been possible absent the enthusiastic support of the non-profits and our elected officials," Moss said.

"It is remarkable to think about the impact Marvin Moss has had on the extensive positive developments in the county," said friend Kathy Swenson-Miller. "Things would be tremendously different if he had not been here," noted Judy Mickelson, the first

executive director of the Fluvanna Historical Society. "He is a visionary -- not in the details so much as his ability to recognize how things can be better and more beautiful."

One key role Moss played has been developing public-private partnerships with the county and using them to raise money for county projects, much of it from federal and state grants, but also from individuals and foundations. Moss estimated his efforts helped net more than \$3 million for Fluvanna projects, which he noted is money Fluvanna taxpayers didn't have to spend. "No other county our size has done anything like that," he said. "I'm very proud of that."

"Marvin helped Fluvanna become stronger in many ways, both as a visionary and a fundraiser," said multi-generation Fluvanna native Overton McGehee. He and others said one of the keys was Moss' long experience on Capitol Hill, often working with grants and grant-giving organizations, so he knew where money might be and how to apply for it. "He knows how things work and the things you need to do to get them," Mickelson said.

The Fluvanna Historical Society, whose membership significantly expanded under his leadership to over 400, has been Moss' longest-running interest in the county. Mickelson said he has been key to all the historic building restorations, as well as to obtaining the many historic easements that keep Fluvanna rural.

Moss said he didn't plan to work that hard when he retired from a top Capitol Hill job to move to Palmyra, though he didn't want to get bored either.

Having restored his historic Glen Burnie country home near Palmyra and placing it on the National Register of Historic Places. Moss' interest in history led him first to the Fluvanna Historical Society.

It was actually a form of kismet that brought Moss to Palmyra in the first place. He had been looking to buy a historic home in his native Maryland,

Maintain the status quo

Due to safety and quality of life issues, over 60 Beach 4 area residents and users have signed a petition asking the Lake's Board to consider alternatives to the proposed contract dredging of the lake. We fear for the safety of our children as a 5 axle dump truck makes 50-70 trips per day in our community, and we don't want to live in a construction zone with contractors that have little regard for our Lake's rules, both on land and in the water

After talking to others, we realize these concerns aren't the only problems associated with this proposal and instead propose we maintain the status quo.

Yes, the contract dredging removes more sediment, but we don't know how much sediment is coming into the lake, therefore we don't know how much should be removed. And most importantly, this new sediment comes in mostly from the streams that feed the smaller coves, which will not be properly maintained with contract dredging. Two different hydrologists, the chief hydrologist with the USGS in Richmond, and one with Virginia's DEQ, say to maintain a

healthy lake, the maintenance of the small coves is a priority!

Contrary to what is being said, the Lake owned dredger that dredges smaller coves is not in danger of sinking and will last the more than 18 months needed to get a replacement dredger delivered.

The cost to replace it is \$300,000. If we assume a generous \$100,000 per year for a new Lake employee, fuel and maintenance and repair, over a 10-year period, with three percent a year inflation for operations, the total cost is less than \$1,500,000. The yearly cost of contracted dredging is \$250,000 plus the additional cost to dredge smaller coves (\$4,000 to \$10,000 each). Just the base rate and three percent inflation for 10 years, cost is a little under \$2,900,000, almost twice the cost of in-house dredging. This difference gets worse if the purchased dredger lasts more than 10 years as it should.

For the above reasons, safety, quality of life, respect for the community, cost effectiveness, and especially lake health, please maintain the status quo.

but none were easily available. A realtor told him about Glen Burnie and he decided to take a look in 1991. He happened to arrive when the property's field of daffodils was in full bloom. and it was love at first sight, he said. He admits he may not have fully anticipated the years of renovation that would return the house to its historic roots. He didn't move in fulltime until 1995.

"It became apparent to me almost immediately that the county was struggling to deal with the challenges of rapid growth," Moss said, noting only Loudoun County was faster-growing in Virginia in the early 2000s. "That's when I realized I could be very useful for Fluvanna."

"I had a vision of what could be done and knew how to bring the resources together to make it possible," Moss said. He cited the many public-private partnerships that he helped create, and their ability to generate support from all the organizations involved.

Restoring Fluvanna's historic old courthouse is among the most important ongoing projects, Moss said. Called the "Acropolis of Palmyra" by one art historian, the courthouse dates from 1830 and was designed by John Hartwell Cocke as the first Greek Revival county courthouse in Virginia.

The courthouse has sustained some structural damage, and the full restoration will cost nearly \$3 million, only a small percentage of which will be paid for by county taxpayers. In another private/public partnership with the county, Kathleen Kilpatrick, who will replace Marvin as president of the society in October, led efforts to restore it and has raised over \$1.1 million for it. "The average taxpayer just doesn't understand how important these public-private partnerships are in getting things done while protecting taxpayers," Moss said.

Some of Moss' focus has also been on master planning for the county, primarily assuring that its rural aspects be preserved while providing room for appropriate business and other

growth. "We had a golden opportunity to develop a logical plan for development," he said.

Moss isn't worried he'll get bored as he reduces his community involvements, he said, saying he "will continue to help in any way I can. Few people recognize what the historical society, the heritage trail and other community organizations have done to make Fluvanna a more interesting and connected community. We should all be proud of what they have done."

One major new development is the historical society's Marvin Moss Legacy Endowment Fund, which will begin serious fundraising efforts at the Sunday, Sept. 28, Celebration of Marvin, 1-4 p.m. at Pleasant Grove. The family-friendly celebration will include musical entertainment, refreshments, tributes to Moss, and an opportunity to contribute to the fund. 1995 - Retired from Senate staff and moved to Palmyra fulltime;

1995-2002 – Presidential appointee to National Historical Publications and Records Commission at the National Archives, chairing its Executive Committee for two years:

1997- Execute Director of comprehensive study of the U.S. Naval Academy;

1999-2004 – member, Virginia Capital Square Preservation Council;



LMOA BOARD MEETING HIGHLIGHTS AUGUST 2025

We apologize for not being able to provide live streaming/broadcasting of the LMOA Board of Directors' meeting on August 21, 2025. The Broadcast Group faced a technical issue when a piece of equipment failed. We're actively looking into the best replacement options and hope to resume live coverage for the September meeting.

At the meeting, the General Manager, Tom Schauder, reported on Lake Health, VDOT, and Staff:

- LMOA is working with Dominion Energy and Clean Flo to prepare for the Tufton Pond Oxygenation & Bio Dredging Project. This is a proactive plan to prevent algae growth. If successful, it could lead to a similar, but much more expensive project on the Main Lake.
- In 2026, LMOA plans to use Harbor Dredge & Dock again for the dredging of the Main Lake. This time, we plan to start in February or March to prevent cloudy water during boating season. We are also exploring a plan to extend dredging options for residents. More on this soon!
- Lake health reports can always be found at Imoa.org but are now posted at the Marina too! Did you know that the Marina also sells worms, fishing rods, ice, sunscreen, oil, flags, and a whole lot of other boating

- needs? Go check it out! The Marina Team - Denice Flynn, Jim Luxhoj, Jeremy Hall, and Josh Myers - are happy to help you.
- LMOA accepted an offer from VDOT for small easements and right-of-way access to land needed to complete the turning lane at the Lake Monticello Road- South Boston intersection. The "600/618" Project is set to begin in December 2026 and is expected to last about a year.
- Laura Payne, the LMOA Finance Director, and her team successfully completed the 2023 & 2024 audit fieldwork, restoring our schedule to the annual timeline.
- William Patrick completed the CompTIA A+ certification, teeing him up to become LMOA's qualified IT Specialist. He will continue training, supported by OFM Computer Systems in Charlotteville, and should have all of the necessary credentials by next summer. Congratulations
- 16 public-facing Team Members received an exciting FISH! training and team-building opportunity from Gib Kerr, our neighbor and Volunteer Water Safety Team Co-President. He donated an entire afternoon to give LMOA Staff a fun refresher on creating positive work environments. Our team does

a fantastic job managing the daily needs of our community. We strive to provide excellent customer service and welcome opportunities to improve. Thank you, Gib, for making the training possible!

LMOA Treasurer Plans to Report Monthly

As LMOA's newest Treasurer, Director Scott Murdoch aims to provide a monthly report that breaks down LMOA finances for Lake residents with the goal to make it easier to understand. At the August meeting, he gave his first presentation, which featured lots of positive news. His slides can be found on the Member side of Imoa.org under that GOVERNANCE ->Board Meeting Details. He welcomes feedback - what would you like to see at future meetings? Lake residents can reach him through the Contact the Board option on the website (log into Imoa.org and navigate to the brown toolbar at the top).

Lake Monticello Golf Club is a Fluvanna County Staple

At the August Board Meeting, Golf Committee Chair Jim Beach emphasized effective efforts to boost revenue through initiatives like public play, course improvements, and diverse programming. The course had a surplus last year, a significant achievement that had not been reached before. He discussed working with staff, maintaining course features, assessing sprinkler system needs, and planning future

renovations. LMOA has over \$2 million in reserves for replacing the irrigation system within three to five years. Tournament updates included successes like the Peggy Kirk Bell Tournament, where young women from all over the country come to play. Public Play remains a major revenue driver. Troon - LMOA's partners for managing golf and pool operations - reported earlier this month that the cold winter and hot, wet summer impacted revenue and affected the grass, but discussions on short- and longterm solutions look promising. Golf Course Director Mark Marshall highlighted that our course is more than just a daily fee course. The Lake Monticello Golf Club plays a vital role in the community and county, hosting numerous programs for all demographics as well as tournaments, many of which are charity and Fluvanna Public School events where use of the course is donated.

Romance writer to speak to Friends of the Library

Sarah Henrik (writing as Sara Read) will discuss her contemporary romance novels on Sept. 3 at 7 p.m. at the Friends of the Library monthly meeting. She is the author of *Johanna Porter is Not Sorry* and *Principles of Emotion*—novels that bring a fresh and edgy perspective to romance and feature unconventional, vulnerable female protagonists on journeys of transformation and self-discovery.

In her debut, *Johanna Porter is Not Sorry*, focuses on a 40-something

soccer mom who faces regrets over her shelved art career and finds her life transformed by a man from her past. *Principles of Emotion* centers on Dr. Meg Brightwood, a mathematical genius sidelined by academia, who reclaims her work and confidence with help from a man from her past.

Henrik grew up in Washington D.C. Before Henrik began writing fiction, she earned a degree in women's studies from the University of California-Santa Cruz.

"I tried the nine-to-five life for about a nanosecond before moving to rural Virginia, in Nelson County to become a flute-maker's apprentice and traditional fiddle player." During those years Henrik co-founded the Blue Ridge Irish Music School (BRIMS) which is still in operation 25 years later. In 2007, she graduated from UVA with a master's in nursing and has been a nurse for 15 years. She worked in labor and delivery, oncology, and as a professor at PVCC. She currently works as a nurse educator in nursing professional development at UVA Health.

"While I dabbled a fair amount in college and after, I started taking writing seriously about ten years ago, and have been balancing the two careers, plus being a mom of two (21

and 18)," she said. "I have never done a formal degree in writing, but I've done just about everything else I could think of to learn how to do it well."

"Funny thing is, I never intended to write a romance. I wrote the story I wanted to write, which I knew was love-story, and I was very interested in exploring the difference between conditional and unconditional love on a person's life, choices, and happiness," she said. Her publisher was familiar with the advantages of marketing it to romance readers since it has many of the elements of a romance.

"I'm a very genre-agnostic reader as well as writer, and I know that real romance readers know their stuff when it comes to the genre, unlike a writer like me who is just sort of looking in from the outside," she said. In addition to the competitions at Lake Monticello, there will also be racquet sport competitions at multiple other venues. The Brooks YMCA will be the only indoor venue. Other locations include: ACAC, The Farmington Country Club, The Club at Glenmore, Boar's Head Sport Club, Forest Lakes, Greencroft Club and Keswick Club. If inclement weather causes cancellation, entry fees will be deemed to be contributions. Rescheduling will not be practical, as the October weekend was picked instead of a normal September weekend because it did not conflict with college football home games. Of course, donations in excess of entry fees are always welcome.

School Board selects Sheridan as interim Fork Union representative

The Fluvanna County School Board unanimously voted to appoint Nikki Sheridan as interim representative for Fork Union during a brief special meeting on Wednesday (Aug. 20).

Sheridan, who was previously appointed by the school board as a citizen representative to the Library Resources Review Committee (LRRC), was one of four residents to apply for the interim position following the resignation of Danny Reed on July 18.

Charles Rittenhouse (Cunningham), who nominated Sheridan at the start of the special meeting, said he "thoroughly enjoyed the interviews" with Sheridan and fellow applicants Ashleigh Crocker, Anthony Edmonds, and Faith Stuart, but felt that Sheridan was the most qualified for the position.

James Kelley (Palmyra) said he had also enjoyed the interview process. "I thought some really interesting ideas came out of each and every one of them," he said.

Sheridan will serve as interim member until Dec. 31, with a permanent replacement selected in a special election in November.

Reed's mid-term departure means that four of the five School Board seats will be on the ballot in November.

Scottsville resident Jenn Butler announced on Friday that she will be on the ballot for Fork Union. Chair Andrew Pullen is not seeking another term as Columbia representative, with Sean Brennan running for the open position. Andre Key is running unopposed for a fresh term as Rivanna's representative, while Charles Rittenhouse is facing a challenge from Sarah Johnson in Cunningham.

The special elections will be held along with the general election on Nov. 4. Early voting begins on Sept. 19.


