



I have spent my adult life serving this community from answering 911 calls to protecting citizens in uniform to representing Virginia in the United States military. Service, not politics, defines me. Leadership means showing up, listening, and doing what is right, even when it isn't easy.

League of Women Voters host Listening Tables

The League of Women Voters of Charlottesville will be hosting its Listening Tables on Oct. 29 from 6-7:30 pm at the Fluvanna County Library. The LWV-CVA recently held a series of "Listening Tables" in September and is continuing them throughout central Virginia in October. These were small, informal events where community members and candidates can discuss important local issues in a conversational, rather than a debate-style format.

Fluvanna will have candidates from the Cunningham, Columbia, Rivanna, and Fork Union districts. Candidates for county Supervisor, School Board, and Commissioner of Revenue will attend. The only one who declined to attend was Charles Rittenhouse. For a complete list of candidates attending, visit https://www.lwv-cva.org/listening-tables/.

The purpose of the Listening Tables is to allow residents to voice their concerns and give candidates an opportunity to hear directly from voters in advance of the Nov. 4 election. Unlike traditional candidate forums, the Listening Tables focus on informal conversation and respectful dialogue, not formal debates. The LWV-CVA announced that it was using this new Listening Tables initiative to replace the usual candidate forums and debates for the 2025 local elections. If it proves successful, we could be looking at a new tool to get to know our candidates better in the future.

Animal rescue groups awarded funds at Creatures Great & Small festival

Last Sept. 21, 11 animal rescue groups from throughout Central Florida gathered at the Scottsville Pavilion to participate in the third annual Creatures Great & Small Festival. The groups came to promote adoptions and find foster homes for the dogs, cats, bunnies, goats, donkeys, geese and horses that the groups have rescued. Each went home with a check for up to \$700 from the Festival for their participation in its Best-of-Festival Competition.

A total of \$3,200 was awarded to the groups. The funds came from a Festival Benefit Raffle and from donations by ten Festival Program advertisers. The distribution of the funds was determined by ballots cast by the more than 300 people that attended the Creatures Great & Small Festival.

The top 3 vote getters in the Best-of-Festival Competition Caring for Creatures from Palmyra (\$500 third place), Feel Better Farm from Esmont (\$600 second place) and Gallastar Equine Center from Scottsville (\$700 first place). Awards ranging

from \$100 to \$400 were given to Almost Home Adoption Center (Lovingston), Camp Fuzzy Nuzzles (Scottsville), Cat Action Team (Charlottesville), Fluvanna SPCA (Troy), Green Dogs Unleashed (Troy), the HOWS Project (Charlottesville), Madison-Greene SPCA (Ruckersville), and Northern Virginia Sheltie Rescue (Charlottesville).

In addition to the Best-of-Festival competition, Festival visitors were treated to live music by Scottsville's Four Hits and Ethan Hamburg, a Nature's Creatures Art Exhibition by Marti Reed of the Shenandoah Valley Art Center, a Blessing of the Animals by Scottsville Methodist Church Pastor Laura Stratton, and a host of opportunities to pet, hold, cuddle and even kiss many adoptable animals.

Cyber Security Awareness Month

The more we are online, the more we surf the net, the chances of getting scammed increase. All online activity leaves a trace. Scammers continue to find more sophisticated and complex ways to obtain personal and financial information, using this trace, or "footprint," to learn more about you.

The larger your digital footprint is, the more likely you are to be a target for cyberattacks and fraud. Cyber-enabled fraud was responsible for almost 83 percent of all losses reported to the FBI in 2024. A focus on minimizing your digital footprint will help reduce the risk of identity theft, fraud, and other online threats.

Vanishing from the internet entirely is not the solution. You should be cautious about sharing personal information with a stranger; it's important to be intentional about the data you share online. Taking steps to protect your privacy helps ensure your digital presence remains secure and well-managed.

One example: the Fluvanna County Sheriff's Office has warned residents about an unknown individual claiming to be "Deputy Davis" of the Fluvanna County Sheriff's Office. The scammers tell you to call a certain number. If you call the number, there is an answering machine claiming to be the Fluvanna

County Sheriff's Office. This is a scam. There is no deputy named Davis, and that is not the number for the sheriff's office. The sheriff's office suggests that if anyone receives a call from someone claiming to be deputy Davis, do not provide any personal information. Hang up and report the call to the actual sheriff's office at 434-589-8211.

Banks, including Atlantic Union Bank and Trust, and investment firms like Merril Lynch have been warning their customers and passing along tips to stay safe online and protect information. They cite a variety of scams, including an investment scam trend or the "pump and dump" scams, email compromise scams target businesses, bank imposter scams and more. All of them are online and designed to get money from you. Some are straightforward others are more elaborate and complex.

Three flags to look for:


If you are searching for a website, and sponsored links come up first. Sponsored links could be fraudulent. Avoid phishing attempts by bookmarking your trusted websites. Second, you receive an unsolicited text or pop-up instructing you to click on a link or to install security software. Clicking on unsolicited links or downloading software could result in malware on your device. Third, if someone has contacted you requesting a one-time authorization code, never share authorization codes with someone who has contacted you, as it could result in account compromises. Other tips include:

Ask yourself "why?" before sharing information online.

Disable location services on your mobile devices.

Do not overshare your personal details on social networking sites.

Help yourself and avoid becoming a victim of cyber fraud, and take time to research and don't feel pressured to act immediately. Always use reputable malware protection on your devices and keep your operating systems up to date. Enroll in multifactor authentication options for enhanced security. When in doubt, talk to your local banker or investment advisor when you suspect fraud.



Meet the FSPCA'S Hopeful Hearts Club

Shelter offers reduced adoption fees for animals most in need of a home

Call them the hidden gems of the Fluvanna SPCA: a group of dogs and cats that have been at the shelter for six months or more.

They've been dubbed the "Hopeful Hearts Club."

"They have a bad connotation because people are wondering why they haven't been adopted," said Diana Galarreta Aima, president of the FSPCA board.

It is, however, a false assumption. These dogs are no different from others that pass through the shelter. Like all potential adoptees, they have been spayed or neutered, have all their vaccines and medical checks, "so they're ready to go," she said.

All that's missing is their forever family.

Harder to place pups

There is a hierarchy to shelter adoptions. Kittens and puppies go faster than adult cats and dogs. Calico cats are often snapped up while black cats linger. Pitbulls and hounds are harder to place than smaller breeds, as are older animals or those with medical conditions.

And since all animals have their own needs and personalities, it can take time to find the right fit. "Large, strong animals, or animals that need to be the

only pet or the only dog in the home," she explained.

Then there is the photogenic factor.

Many of the FSPCA's adoptions begin online. A good photo, one that truly captures the animal's personality, can make a significant difference - and some adoptees are just hard to capture in those Instagram-worthy poses.

The first meeting can also be crucial. "Some animals don't show well," said intake and placement manager Caroline Jones. "They might be barking or stressed, and that makes it harder."

But not always. "We do same-day adoptions. They meet, vibes are good you go home with a dog," said Galarre-

The team works to make sure each potential adoption is a good fit. "We'll ask, 'what's your household like? Do you have kids? Do you have other pets?' And try to steer them towards dogs that would be a good fit," Jones said.

Members of the Hopeful Hearts Club would follow the same process, but at a reduced fee.

Facility needs

Moving as many pets as possible into homes is always essential, but is especially critical at a time when the shelter is facing overcrowding and a lack of resources

"We really need a new building," said Galarreta-Aima. They have long outgrown their current facility.

The biggest issue at the moment is that they can only have space for one isolation room, which must accommodate both cats and dogs. "That is just so wrong," she said. "The main stressor for cats is dogs."

She said they need more funding from the county, more donations, and more grant money.

Another need? Volunteers and foster families. "For everything we do, we need volunteers. We don't have the capacity to have enough staff, so we need people," she said.

But there is a reward for volunteering to help these animals. "You get calm when you get all sorts of love."

Carryover choices, student voices

Fluvanna school board weighs safety, curriculum and trust

"Carryover" was the word of the night at the Fluvanna County School Board's monthly meeting on Wednesday (Oct. 8)

Carryover funds are the dollars left unspent at the end of a fiscal year. The School Board can decide to return the money to the county's general fund or request to keep it for use towards the division's unmet needs.

This year's expected carryover is around \$443,000.

With the county's Nov. 1 carryover deadline approaching, Superintendent Peter Gretz laid out some possible scenarios and a wish list that spanned security, curriculum mandates, and some long-deferred technology upgrades.

Safety first

School security was at the top of the

The division currently has only two School Resource Officers (SROs), which is well below the five needed to adequately cover all the county schools.

This has led to some out-of-the-box thinking, including a new idea of partnering with the Virginia Department of Wildlife Resources to help with school staffing.

"We've been in communication with

individuals from the Department of Wildlife Resources to discuss the possibility of those officers offering security services to the schools," Gretz said.

Members also discussed Fauguier County's model, which employs retired law-enforcement personnel as armed School Security Officers, or SSOs.

"My position continues to be, as we have an SRO program, I want one in every single building," said James Kelley (Palmyra). "There is a huge difference in community building and in relationships between us going out and hiring run-ofthe-mill cops, versus us having an SRO program in which our sheriff's deputies are embedded in our schools."

Curriculum, attendance, hardware

Beyond safety, Gretz raised another looming cost: the adoption of new curriculum under the Virginia Literacy Act.

"It's going to have to be done, and we'll have to pay for it somehow," he said, estimating a possible \$800,000 price tag to update K-12 math, science, and social studies materials.

Other possible allocations included adding attendance staff to address chronic absenteeism and funding long-overdue technology upgrades.

The high school's network switches, installed in 2011, are nearing the end of their lifespan. Replacement costs hover

around \$80,000-\$100,000 each, with seven to refresh. A single \$20,000 Cisco 9500 fiber switch was proposed as a backup to prevent system outages.

For classrooms, Gretz suggested a thriftier fix for the county's aging Promethean interactive panels: swap out only the internal computing units. "They actually just came out with a new computer module," he explained. "They're going to be very inexpensive... I think we could get a lot more bang for our buck."

The proposed pilot—20 to 25 panels would cost about \$60,000-\$70,000 and potentially modernize the district's instructional tech without buying all-new equipment.

The decision on what to do with the carryover requests and where these upgrades and changes would fit in the upcoming FY27 budget package will continue at the board's annual budget seminar on Oct. 14.

Safety & ethics

Wednesday marked the final School Board meeting before the November elections, where four of the five seats are up for election.

During public comments, Tracy Smith urged the board to expand its idea of "safety" beyond metal detectors and security officers.

"As a community, we've been focus-

ing a lot on how to protect our students and improve security, especially when it comes to SROs, but safety is only physical," she said. "It's about the integrity of those making decisions for our schools."

Smith pressed for higher ethical expectations for elected officials and asked the board to coordinate with the Virginia School Boards Association on a statewide standard for disclosure.

"Ethics expectations are a public statement of standards," she said. "I encourage the board to partner with the VSBA's legislative committee... and consider asking the General Assembly to review and establish statewide background disclosure standards for school board candidates."

Student representatives

Dr. Gretz introduced the board's newest student representatives: seniors Natalia Merchant and Amina Seiden.

Merchant opened with good news from the high school stage.

"Our theater department is getting ready to perform The Curious Incident of the Dog in the Nighttime on Oct. 29 at 6 p.m. The cast has been working really hard, and I know the student body is really proud of them." She also celebrated the Speech and Debate Team's

Planning Commission hits pause on Tenaska permits Defers key actions for 90 days

Following weeks of increasing public concerns about energy giant Tenaksa's plan to build a second gas-fired electrical power station near Scottsville, the Fluvanna County Planning Commission finally had an opportunity to weigh in at its monthly meeting on Tuesday night (Oct. 7).

Its decision? Slow down. Wait.

After nearly six hours of presentations, technical debate, and often emotional public testimony, the five-member commission voted unanimously to defer action on two major permits until Jan. 13, 2026, giving staff and the public more time to evaluate the sprawling 'Expedition Generation' project.

The proposed 1.5 gigawatt facility would sit on more than 400 acres near Tenaska's existing Branch Road plant.

Company representatives described the plan as a state-of-the-art, low-emissions natural gas installation designed to help stabilize Virginia's strained electric grid.

But commissioners and residents alike questioned whether the company had earned the right to expand its footprint in Fluvanna, given ongoing complaints about noise and transparency.

Tenaska makes its case

The commissioners had three Tenaska-related items on the agenda: a special use permit for a major utility; a zoning amendment that would allow the Board of Supervisors to waive height restrictions and will enable the

plant to build smokestacks up to 85 feet higher that the ordinance allows; and a "substantial accord" determination to test if the plant fits within the county's Comprehensive Plan.

Tenaska representatives, led by project developer Jarrod Pitts, laid out a polished presentation designed to reassure both regulators and residents.

The company emphasized that the new facility would use existing natural gas lines, substations, and water infrastructure, minimizing land distur-

bance and avoiding new construction through sensitive areas. Of the roughly 400 acres involved, only about 50 acres would be developed; the remainder, they said, would be placed in conservation to protect the rural character of the site.

Pitts stressed that Tenaska has been a "good neighbor" since its first plant went online in 2004, paying over \$35 million in property taxes to Fluvanna County and providing 29 permanent jobs, most of them local.

Expedition Generation would pay an estimated \$250 million in taxes over

30 years, and create another 19 jobs.

But some answers left commissioners and residents uneasy.

When asked about ongoing complaints that the existing plant produces a low, mechanical hum audible for miles. Pitts conceded that Tenaska had studied mitigation measures but found no practical fix.

"Retrofitting the existing facility would cost hundreds of millions of dollars," he said, "and we don't believe it would result in a meaningful reduction of sound levels."

Instead, the company floated a potential compromise: creating a fund for nearby homeowners to soundproof their own homes, including new windows and insulation at Tenaska's expense.

The presentation also leaned heavily on regulatory assurances.

Pitts told the commission that the new facility would comply with all Virginia DEQ air-quality standards. The taller smokestacks, for example, were required by state to better disperse emissions. He cited the project's alignment with the regional energy grid operations PJM's reliability goals, positioning it as part of a regional effort to prevent rolling blackouts and meet rising energy demand driven by data centers.

Still, the company offered few specifics on emissions levels, monitoring plans, or long-term community oversight. While Pitts pointed repeatedly to DEQ and EPA standards, he offered no independent verification mechanisms or third-party studies—only the company's internal modeling

health, and accountability.

Commissioner Lorretta Johnson Morgan capturing the unease that had been building throughout the night.

"I do understand the tax benefits that the county can receive from Tenaska,"



she said. "But to me, the health and safety of our people are more important to me than the tax benefits we're receiving."

From there, a steady stream almost two dozen residents took turns at the podium, voicing frustration that the county was being asked to accept the potential environmental and health costs of a massive industrial expansion with limited local benefit.

"I didn't move down here to live with my windows closed," said Sarah Hernandez, who came with an audio recording of the hum she often hears from the existing plant. She said Tenaska's offers of soundproofing were "not helpful at all."

"Are they good neighbors?" Donna Daguanno asked. "Did they show up tonight prepared with their information for everybody that came here? And we had a good attendance. But I don't think they did, because they're a powerful corporation and they know that they are strong, and they thought they were going to waltz in."

There were some supporters of the

project. Amber Kidd stepped up to say that her husband's employment at the existing plant had been " a foundation for our family's life," a good paying local job that allowed them to good quality of life.

Not yet

Comment after comment raised issue after issue, about conservation easements that may never materialize, about air quality and water safety, about noise, transparency, and the long-term health risks of living beside another industrial plant.

As the clock ticked past midnight and then past 1 a.m., there was little left for the Planning Commission to do but hit nause

After each public hearing, they voted unanimously to defer all three of Tenaska's requests.

The substantial accord was deferred until the November meeting, and the special use permit and zoning text amendment until its Jan. 13 meeting, giving county staff, state agencies, and the public more time to scrutinize what

would be the largest industrial projects in Fluvanna's history.

For now, the message from the county was simple: not yet.



Dryers Are Dangerous, Says Fire Chief Constantino

Remember, a fire can double in size every minute, so early detection is crucial. Leaving your clothes dryer unattended is a very risky move. The Lake Monticello Fire Department warns that many problems can occur if you leave your clothes dryer running without supervision. The following tips will help you keep your house and family safe from dryer disasters.

- Clean the lint trap before every load. Make sure to remove lint from the screen after each drying cycle. Maintain the dryer vent and ductwork. Lint can build up in places you cannot see, restricting airflow and creating a fire hazard. By cleaning out the dryer vent and ductwork you will clear out any blockages and reduce the risk of overheating. You can do this yourself once or twice a year or you can hire a professional. If you are a "Do-It-Yourself" person like me, you can accomplish this task fairly easily.
- Do not overload the dryer. Too many clothes in the dryer make the motor and heating element work harder, increasing the risk of overheating. Use separate

- loads to dry heavier items.
- Inspect electrical cords and connections. Inspect your electrical cords and connections often to be sure cords are not frayed, bent, or trapped under heavy appliances. A faulty connection can spark or overheat.
- Give the dryer a few inches of space. When installing your dryer, make sure there is space behind it for all of the components to function without restriction and so you can visually inspect it.
- Schedule professional maintenance. Have a technician inspect your dryer and vent system every year, especially in the case of gas dryers.

Message from LMOA Field Inspector, Reese Peck:

"Let's clean up autumn leaves one bag at a time! The dreaded leaf fall is here—a chore many of us dread. But like most things in life, breaking it into smaller tasks makes it manageable. GFL allows up to five bags of leaves to be collected with your regular trash. Start now and tackle it weekly, and the leaf fall won't feel overwhelming. A little effort each week goes a long way!"
