

#### Fluco football wins big again

#### Score 50-26 over the Black Knights

The Black Knights from Charlottesville High School came to Fluvanna County on Oct. 24 with some confidence after a close win over the Monticello High Mustangs from Albemarle County. They ran into a buzz saw. The Fluco did not disappoint a large Homecoming crowd. They had eight possessions in the game and never punted. The Flucos recorded seven touchdowns and had one turn-over.

The Flucos took the opening kickoff and marched down the field. They opened the scoring after less than three minutes as senior quarterback Will Lambert passed to junior tightend Kenny Klein for a 14-yard touchdown. Dawson Raines added the extra point for a 7-0 lead. The Black Knights managed one first down but a penalty set them back and they were forced to punt. The Flucos started at their own 24. They simply ran it down Charlottesville's throat. In seven plays the Flucos covered 74 yards with senior Sam Loving running it in for a second Fluco touchdown with 2:48 left in the guarter. A two-point conversion try was good and Fluvanna led 15-0 at the end of the opening quarter.

On the first play of the second quarter, the Black Knights tried a fake punt on fourth and fourteen. They gained twelve and the Flucos took over on downs. Fluvanna marched down the field again. This was the only drive on which the Flucos faltered. A Lambert pass was intercepted near the goal line and a long return and a face mask penalty put Charlottesville on the Fluco 16. On six running plays the Black Knights scored. A missed two point extra point made the score, Fluvanna 15 and Charlottesville 6, with 7:11 left in the half.

Junior running back Kevin Jordan

ville 47. A run by Loving, a run by senior Matt Rea and a face mask penalty put the ball on the 16 yard line. Lambert ran for five yards and Rea ran the ball in for the Fluco's third touchdown. The extra point was kicked by Raines and the Flucos led 22-6 with 5:14 left in the half. Charlottesville managed one first down but was forced to punt. A screen pass to Jordan and quick sideline pass to junior wide-receiver Brody Shields moved the Flucos to the 16-yard line. Lambert and Loving each gained eight yards with Loving scoring the touchdown with 0:54 left in the half. The extra point made it 29-6, and the game was well in hand.

returned the kick-off to the Charlottes-


The Black Knights took the opening kick-off of the second half and scored after a long drive. The two point PAT attempt failed again and the Flucos led 29-12. That was as close as Charlottesville would get. The Flucos marched 65 yards on their ensuing possession with senior wide receiver Tremayne Minor scoring on a 16-yard end around. The PAT made it Fluvanna 36 and Charlottesville 12. Charlottesville promptly fumbled on a bad snap and the Flucos recovered at the ten-yard line. The Flucos quickly scored and kicked the PAT for a 43-12 lead at the end of the third quarter.

In the fourth quarter, the Black Knights scored twice on long runs by their quarterback. Between the two touchdowns by Charlottesville the Flucos scored their seventh touchdown of the night when Jordan ran for a fifteen-yard score. The Flucos have now scored 92 points in their last two games.

The Flucos' last two regularly schedules game are Oct. 31 at Goochland County and at home on Nov.7 against Albemarle. The Flucos are 5-3 with four wins in a row.

#### **Obituary**

#### Donald (Don) W Payne



Donald (Don) W. Payne lived an active life with little idle time. In the early part of his high school senior year, Don joined the Navy and attended Naval Reserve meetings. He left for active duty after his graduation in 1966. Raised as a rural farm boy, he had never seen the ocean until he reported for duty. His previously sheltered life, however, was soon to change drastically. Two years of active service took Don to ports in France, Italy, Crete, Sicily, Spain, Malta, England, Scotland, and Nassau.

After being honorably discharged from the Navy, he gave serious thought to becoming a merchant seaman but opted for college instead. Don attended Virginia Commonwealth University from 1971 to 1974, then returned home to Fluvanna County in Virginia with his new bride, Shirley.

Even though his professional career as an environmental, health, and safety consultant and trainer kept him quite busy, he had a wide range of hobbies, including raising Black Angus cattle, playing guitar and other string instruments, and artistic wood carving. In the

early 1980s, he and his wife purchased a historic 1891 farm on the Rivanna River in Albemarle County, Virginia. The peaceful solitude of country life continued to be a passion for them both.

Don always had an intrigue and respect for the past, especially in relation to rural life and his family. Beginning in 1989, he encouraged his father to tell stories about the old times while Don quietly jotted down notes. Those interviews evolved into similar note-taking visits with his Uncle Willie and Aunt Dot Payne and numerous other senior citizens in the community. He soon had gathered hundreds of pages of text, collected dozens of old pictures, and recorded many hours of audio tape.

The value of this information being so evident to him, Don decided to author a book for his family. Later, it became clear that others, regardless of their own heritage, would enjoy the stories as well. His first book was published in 2008. Having developed a true passion for writing, other books quickly followed and are described at legacyvirginia.com.

He also applied his deep knowledge of rural living by helping design and maintain exhibits for the Farm Heritage Museum at the Pleasant Grove Park in Fluvanna County. Beginning in 2021, he also served as Museum Chairperson. For details see findfluvanna.org/ preserving-fluvannas-past-farm-heritagemuseum.

Don was even more passionate

about helping those in need. Over five decades, he volunteered for and, in most cases, served on leadership boards of community service organizations such as the Virginia March of Dimes, the Jefferson Board of Aging Volunteer Advisory Council, Meals on Wheels, and others. He often said this work gave him some of the greatest rewards in his life. Finally, Don was a religious man. Although a Protestant himself, he felt strongly that it did not matter what faith or God a person embraced if the chosen religion worked for the good of all humanity.

He will be missed by so many.

On Saturday, November 1st at 11:00am, a gravesite service will be held at the Monticello Memory Gardens Cemetery, 670 Thomas Jefferson Parkway, Charlottesville, VA 22902. In addition to Don's family, his friends and acquaintances are welcome to attend.

# **Key Tax Planning Topics to Consider**

last year might not work this year. If you're not keeping your tax strategy up-to-date, you could be inviting a bigger bill from the IRS. As always, should you have any questions, please call. And feel free to forward this information to someone who could use it!

The U.S. tax code is constantly changing. What saved you money last year might cost you this year. Between shifting income thresholds, changing deduction rules, and overlooked credits, you now need to stay focused on your tax plan throughout the year. Here are several bits of tax wisdom that can help you lower your bill to the IRS.

Phaseouts matter (a lot). A lot of tax breaks, such as child tax credits, tax benefits for college costs, or the new senior deduction don't disappear all at once. Instead, they phase out slowly as your income rises. This means earning a bit more could quietly cost you some of these benefits.

What you can do: Keep an eye on how much income you're showing on paper and how it will impact these phaseouts. You might be able to stay in the sweet spot so you don't lose the value of your deductions or credits by putting more into your retirement account or timing when you receive certain payments.

Are itemized deductions going the way of the dinosaur? Not so fast! Yes, the standard deduction is now higher than ever (\$31,500 for married couples, \$15,750 for singles in 2025), which has made itemizing less common. But with an increase of the state and local tax (SALT) deduction from \$10,000 to \$40,000, you may be shifting back to itemizing your deductions without realizing it.

What you can do: Don't assume you'll be taking the standard deduction again this year. Add up your potential itemized deductions, especially if your expenses vary, to see how close you are to being able to itemize. Consider bunching charitable contributions or property taxes into one year to clear the standard deduction hurdle.

Timing is everything (especially with capital gains). If you sell assets held longer than a year, you'll likely qualify for long-term capital gains rates (0%, 15%, or 20%). But miss that time by

Tax rules aren't set in stone...what worked even a day and you could pay ordinary income rates, which can be nearly double. Strategic timing can also help you harvest losses to offset gains and reduce your overall tax bill.

> What you can do: If possible, hold investments that are profitable for at least one year and a day before selling to qualify for lower tax rates. Use end-of-year tax-loss harvesting to offset gains, and stagger sales across tax years if needed.

> Don't sleep on the Qualified Business Income deduction. If you're a small business owner, self-employed, or even a gig worker, you may be eligible for a 20% deduction on your qualified business income. Planning how and when revenue hits your books could make or break your eligibility for this significant deduction.

> What you can do: Review how your business is structured and how much income you're reporting. You may be able to reduce taxable income through retirement contributions, shifting income between years, or reclassifying your business activities.

> Tax-deferred doesn't mean tax-free. Traditional 401(k)s and IRAs offer tax deferral, not tax elimination. When you withdraw funds in retirement, you'll pay ordinary income tax on the distributions. If you expect to be in a high tax bracket in retirement, it may be a better idea to contribute to a Roth account now and pay taxes up front.

> What you can do: Schedule a planning session to discuss whether diversifying your retirement accounts between traditional and Roth makes sense for your situation. Also consider planning for the timing of distributions from these accounts to be as tax efficient as possible. Run long-term tax projections to decide which type of contribution makes sense today. Consider partial Roth conversions during lower-income years.

> Tax planning isn't a once-a-year scramble, but rather a year-round strategy. And with these pieces of prevailing tax wisdom, you can be better prepared to cut your tax bill. #### Pavilion push back

In a fourth attempt to get their desired result, the LMOA Board plans a new survey of the community about a Lake Monticello Community Foundation "pavilion gift" at Ashlawn Clubhouse. As a resident living near the clubhouse, I would like to clarify two aspects of the pavilion that the survey might omit.

First, the pavilion champions have clearly said it is to be a large, 40 foot x 30 foot amplified live music venue, not the benign multi-purpose music/ picnic/wedding pavilion described on paper. Indeed, neither LMCF nor LMOA will fund picnic tables. LMCF has rejected use of their gift for picnic pavilions at playgrounds, and LMCF has rejected smaller dimensions. The intent is to host outdoor, large, amplified music events frequently throughout the year on the clubhouse grounds.

Second, these events will directly impact nearby residents with unwanted sound that will certainly violate the Fluvanna County Noise Control ordinance. The ordinance prohibits sound audible to involuntary listeners within their home with windows and doors closed. Any impacted resident can easily have an LMOA police officer verify the violation, shutting down the performance and incurring a penalty to LMOA of \$25 to \$500.

Like many of my neighbors, I purchased property near the clubhouse fully aware and accepting of occasional community events, such as swim meets and triathlons, that generate sound audible within my home. But I do not want a miniature Ting Pavilion regularly playing amplified loud music impacting the neighborhood.

I have heard some say that those of us living near the clubhouse should put up with the noise for the benefit of the rest of the community. But I say that LMOA should not discard the rights of a few for the desires of many, including the LMCF. Fortunately, the Fluvanna Noise Control Ordinance will preserve our rights even if LMOA will not.

#### SNAP payments could be delayed if federal shutdown continues

Here is where to find assistance

Fluvanna County residents who rely on SNAP benefits could face delays in receiving their monthly payments if the ongoing federal government shutdown extends past Nov. 1.

The Supplemental Nutrition Assistance Program (SNAP) helps low-income families and individuals buy groceries. In Virginia, the average individual payment is about \$232; families with children average \$575 per month.

Previous shutdowns have rarely disrupted SNAP payments because the U.S. Department of Agriculture (USDA), which administers the program, typically uses a contingency fund to keep it running. This time, however, the USDA has said it will not tap into that fund during the current shutdown.

In response, states have begun developing their own emergency plans. Gov. Glenn Youngkin declared a state of emergency on Oct. 23, allowing Virginia to access emergency funds if needed to protect the health and safety of residents.

About 828,000 Virginians—roughly 9.4 percent of the state's population receive SNAP benefits, including ap-

proximately 1,750 residents in Fluvanna County, according to the most recent

#### Fluvanna Art Association celebrates 50 years

The Fluvanna Art Association celebrated 50 years at the Ashlawn Clubhouse at Lake Monticello on Oct. 23. The well-attended event was catered and featured a large sheet cake, designed and donated by Food Lion, commemorating the 50th anniversary. The show's theme, All Around Fluvanna, included a surprising mix of county icons, history, and nature. As a result, the show was not what one would have expected.

Normally, onlookers would see iconic buildings, including the historic courthouse built by General John Hartwell Cocke, Pleasant Grove, the Haden House, the Holland-Page House, or the Dunbar Schools. However, the only building well represented was the Old Stone Jail. Despite this, all of the pieces were inspirational, unique, and unexpected.

Instead, artists chose different aspects of Fluvanna County, including a beautifully carved alabaster horse's head, Jim Wilkin's piece of curled wood, William Snow's painting of a noble owl perched on a tree branch, or Tom Ellis' wood sculptures of a majestic eagle or his humorous frog. Pam McKinnon's Out of the Woods was a beautiful natural piece of gnarled wood she found in the woods, and created a mixed media piece.

Paintings ranged from various elements, including a montage of history and historical figures like Texas Jack Omohundro, who left the county and traveled out west, where he joined Buffalo Bill Cody. The piece also featured a bateau, a tobacco plantation, the Monacan Indians, fishing on the river, paddling on the lake, and cattle farming. Alyce Walcavich's print of an abandoned meeting house in the woods with the ghostly children surrounding it was impressive and thought-provoking.

Others focused on a single theme or landscape, such as Joanne Braniff's oil painting of A Tranquil Harvest, and William Snow's watercolor of a few autumn leaves hanging on a branch, or

Diane Wilkin's graphic print Roadside Virginia, which centered on a single branch and leaves by the side of the road. Many artists shared the beauty of the county with sunsets on the lake, rushing river water in the late morning, and open fields and pastures in the afternoon.

Lisa Daniel offered up a witty wet hen. The viewer can see the sour expression on the bird's face and the unpleasantness she was experiencing. Ande Kirchenheiter recreated the old riverboat paddle wheel behind the Old Stone Jail. The story tells about a riverboat that sank in the early 19th century on the Rivanna and all that remained was its paddle wheel.

Windy Payne, one of the last remaining original members of the FAA, stated it had been a pleasure to work with all the different artists throughout the years since she joined in 1975. Looking back through the scrapbooks Payne had kept over the years, she recorded the accomplishments and the evolution of the art and artists. Patty Stoughton, June Wiehe, Alice Clifford, Caroline Brackett, Martha Rossi, Coy Roy, and Peg Redd are gone, but their legacy of continuing to move the association into a new age is not forgotten.

The exhibit will be moved to the Flu-

vanna County Public Library and can be viewed during library hours from Oct. 28-Dec. 8.



#### **LMOA Settles PPP Loan**

On October 13, 2025, LMOA signed the final settlement agreement and is required to pay back the loan within 30 days to the US Government. The LMOA Board of Directors will decide on a permanent funding source at their mid-November review of the cash projections, with a resolution proposal to be discussed at the November meeting.

#### **Tufton Pond Oxygenation Details Finalized**

In May 2025, the Facilities and Lake Operations Committee proposed a plan to the Board to install an oxygenation system and introduce bio-dredging at Tufton Pond. This aims to prevent Harmful Algae Blooms and increase oxygen levels, promoting healthier pond conditions. Since then, contracts with Clean-Flo and Pyramid Paving have been awarded, and staff have coordinated with these vendors and Dominion Power to create a detailed plan. The Board approved using the Property Transfer Fee (PTF) funds to cover the initial startup costs. PTF can be used for new capital improvements.

#### **LMOA** to Survey Community **About Pavilion Donation**

The LMOA Board will ask staff to conduct a community support survey for the pavilion donation. They also suggest that the Lake Monticello Community Foundation provide a complete turnkey plan. LMOA plans to send out the survey next week via email, Fluvanna Review, etc.

#### **Aqua Virginia Applies** to Raise Rates

Aqua Virginia has again applied for state approval to raise water

and sewer rates. The utility company states the increase is necessary to pay for infrastructure upgrades, operational and capital improvements, meet new PFAS (forever chemicals) regulations, and address inflation. The case will be heard on April 28, 2026. LMOA's Community Development Committee Chair, Tom Diggs, has offered to lead the committee's advocacy efforts again; he contributed over 100 hours previously. #### Big projects mean big needs for fire department fund drive

Nearly a half million dollars in much-needed capital spending in the past few months has made this year's Lake Monticello Volunteer Fire & Rescue annual fund drive more important than ever, said board President John Lye.

"This was stuff we just had to do, but it was really expensive and all coming at the same time," Lye said. "These things had practically been held together by bubblegum and duct tape." He said the fire and rescue service is hoping this year's fund drive can more than double

the typical \$120,000 or so it normally raises.

The big projects included replacing the leaking 40-year-old roof for the fire department buildings at a cost of \$282,000 and repaving all of the parking area for more than \$200,000. The parking area had to be re-surfaced largely because of semi-trucks and moving vans that can't get in the Slice gate using the fire department lots to turn around, heavily damaging the surface, Lye said.

#### Fun events to view in November

November offers us the opportunity to see not just one meteor shower but two showers; the Northern Taurids appear in early November, while the Leonid shower will occur in mid-November. We can witness other exciting events including noteworthy planetary and lunar conjunctions (remote objects visually appear close to one another) and learn interesting facts about this month's full moon. Hopefully some of these events capture your interest and motivate you to spend time observing the night and early morning dark sky this month. So let's get ready to engage in observing these events by setting up your star gazing equipment, charging your cell phones and linking to Sky Guide, Sky View Lite, or any other star gazing applications that you find useful, and settling into your favorite viewing spot to witness the magic of the night and early morning skies!

#### Weeks 1-2 (November 1-8)

On November 1, the moon will be in conjunction with the planet Saturn within the constellation Pisces. On the morning of November 2, star gazers will be able to see the planet Venus close to the star Spica within the constellation Virgo.

The full moon appears on November 5 near the constellation Aries. This full moon is a Supermoon, the second of three supermoons to occur in 2025. This Supermoon looks larger and brighter than other full and Supermoons this year because it is actually closest to Earth this time of the year. This full moon is known colloquially as the Beaver Moon because Native Americans, and early Colonists found this time of year to be good for trapping beavers for

their pelts; beavers have thick winter fur and are scurrying about in their preparation for winter hibernation so they are a bit easier to trap. This month's moon is also known as the Deer Rutting Moon (Dakota, Lakota); the Digging/Scratching Moon (Tlingit) when bears prepare their dens; and the Whitefish Moon (Algonquin) when these fish spawn.

On November 6, the moon will be in conjunction with the star cluster Pleiades (aka the Seven Sister or Messier 45) within the constellation Taurus.

#### Week 3 (November 9-15)

On November 10, the moon will be in conjunction with the planet Jupiter and the stars Castor and Pollux within the constellation Gemini

On November 11, the moon will be in conjunction with the Beehive star cluster (Messier 44) within the constellation Crab. Additionally, the moon will be in its last quarter, illuminated on the left side of the surface that faces Earth. The planet Mercury will be in conjunction with the planet Mars in the early evening sky. Later this day, the moon will be in conjunction with star Regulus within the constellation Leo in the late evening sky.

One final event between November 9 and 12 is the possible viewing of meteors from the Northern Taurids meteor shower (Class III Minor meteor shower). This meteor shower emanates from the constellation Taurus and can generate about 5 meteors per hour. This year, the Southern and Northern Taurid showers occur around the same timeframe; this makes it possible there may be an increase in the number of meteors seen in the night sky.

#### Week 4 (November 16-22)

On November 17, the moon will be in conjunction with the star Spica within the constellation Virgo. The highlight on this date will be the peak of the Leonids Meteor Shower (Class I Major Meteor Shower) that may gen-

erate as many as 15 meteors per hour. The meteors, created by the comet 55p-Tempel-Tuttle, emanate from the sickle of the constellation Leo but might be seen anywhere in the sky. The best viewing time for this shower is early in the morning (around 1am) on the 17th.

On November 20 the new moon phase will occur, a time when the moon will no longer be visible except as a ghostly sphere in the sky. This moon phase gives us the opportunity to better view the night sky since there will be no moonlight to obstruct views of stars and planets

On November 21, the planet Uranus may be visible with sky binoculars as it moves through the constellations Taurus and Gemini high in the evening sky. Uranus will be in opposition and it will visible from sunset to sunrise as an aquamarine disc. Using a telescope with magnification around 100x should permit better viewing of this planet.

#### Week 5 (November 23-30)

On November 25, it will be possible to view both Mercury and Venus planets around 20 minutes before sunrise. Venus will be the most noticeable planet; to view Mercury, you will probably need binoculars. These planets will also be visible on Novem-

The moon moves into the first quarter on November 28; the right side of its face will be illuminated. The final event in November is the moon in conjunc-

tion with the planet Saturn in the constellation Pisces on November

#### In Summary...

So ends another star gazing experience this year. Although some of this month's events suggest the need for sky binoculars, there are a significant number of events that are equally useful to look at with the naked eve.

A final story of interest this month is the launching of the Sentinel 6B satellite that will use radar to create ocean topographic measurements and maps. This mission is being conducted by NASA, the ESA, and the European Organization for the Exploration of Meteorological

For information about noteworthy events, visit NASA's homepage: the ISS phone app that tracks ISS movements; the aurora borealis website where flare-ups are noted that might be visible in Fluvanna county; and other space related websites noted below that provide information about rocket and satellite launches.

With the perpetual motion of planets and stars, the daily changing sky promises to entertain you for a lifetime! Until next month, keep your eyes facing the morning and evening sky to see the wonders of our universe as we Earthlings travel through it!
