

Supervisors confront school budget unknowns, NDA concerns

School officials brought more questions than answers to Wednesday night's Board of Supervisors meeting (Dec. 3), outlining a budget picture that remains largely uncertain without key information from the state.

Superintendent Peter Gretz, his leadership team, and several School Board. members walked supervisors through the pressures that are already taking shape for the FY27 budget, which the School Board will finalize and send to the county during budget season in early 2026.

Gretz said the division still lacks two critical pieces of information from Richmond: the governor's proposed budget and the state's annual budget template.

Until both are released, he said, the schools cannot calculate projected revenue, determine staffing needs, or estimate how state-level changes might affect local funding.

One loss the division can already count on is the end of roughly \$360,000 in "all-in" state funding, a temporary block of money that has helped cover several school-based positions over the past few years.

Gretz said those roles, which include classroom support positions and other instructional or student-service staff, will either have to be cut or moved onto the local budget.

There are also broader staffing pressures taking shape.

In recent years, the School Board has worked to raise teacher salaries and benefits to keep Fluvanna competitive with surrounding divisions. Gretz said that progress has begun to slip, and the division is once again falling toward the bottom of local pay scales, a trend that could make it harder to recruit and retain qualified teachers.

Palmyra School Board representative James Kelley noted that compensation remains a major concern in staff surveys.

"When we survey our community, we survey our staff, salary matters tremendously," he said. "But it can't be the deciding factor for all of them because they're staying. And it's the lowest."

He warned that the division risks leaning too heavily on employees' loyalty and ties to the community if salaries continue to lag behind neighboring divisions.

A recently completed enrollment study adds another layer of urgency. The analysis projects Fluvanna will gain about 400 students over the next five to seven years, with most of that growth expected at the elementary and middle school levels.

Gretz said the high school still has some room to absorb additional students, but the lower grades are already so tight that "I don't know where we would put 10 kids."

He and the School Board members agreed that the division will need a full capacity study to determine how, or where, those future students could be accommodated.

Chronic absenteeism emerged as one of the division's most pressing concerns. School leaders said the rate of students missing large amounts of school time has climbed sharply and now exceeds that of neighboring counties.

The district had previously added extra staff to support attendance interventions, but one of those positions was cut last year due to budget constraints, a move officials now believe set them back.

To regain ground, the division plans to request funds to restore two attendance-focused positions as part of its upcoming carryover request.

Administrators warned that without staff dedicated to tracking and working with chronically absent students and their families, the problem will continue to worsen, especially as cuts to state and federal programs reduce access to services that help keep vulnerable students stable enough to attend school consistently.

Despite the uncertainties, school leaders pointed to some encouraging signs, including steady instructional progress, strong staff commitment, and available space at the high school to help absorb part of the projected enrollment growth.

As the conversation wound down, both boards acknowledged that many of the biggest questions won't be answered until later this winter. For now, supervisors will have to wait for Richmond to weigh in before the county can begin shaping its side of the FY27 budget.

Nondisclosure agreements

Twice in the past year, supervisors have signed nondisclosure agreements with companies exploring projects in Fluvanna County.

While the agreement with Tenaska has largely expired, the NDA covering Amazon's proposed warehouse, known publicly only by the code name "Project Hoops," may remain in effect for another two years, even as construction moves forward.

Supervisors said the prolonged secrecy creates awkward situations when residents ask for information about visible or widely rumored developments.

"I literally stood on the property beside it yesterday with people, and I couldn't tell them what the sign said at the entrance to the property," Chris Fairchild (Cunningham) said.

County Attorney Dan Whitten told the board the NDA allows only a narrow, preapproved script. "You can say Amazon," he said. "You can say the word. We have a specific sentence we

can say, but that's all we can say is that particular script. We can say the word."

Economic Development Director Jennifer Schmack said the restrictions stem in part from how Virginia handles economic development incentives.

Projects receiving state incentives must remain confidential until the governor makes the formal announcement, and early disclosure can jeopardize those incentives. Companies "can lose all of their incentives." she said, noting that such losses "have happened in several cases throughout the state."

Fairchild urged the county to create its own guidelines for future NDAs so boards are not bound by open-ended or overly restrictive terms written by

He said the county should insist on clear time limits and release conditions to avoid situations where supervisors cannot respond to constituents' questions about projects already underway.

He asked Whitten to draft proposed language, saying the goal was to protect both the current and future boards from being placed in what he described as a subservient position with no clearly defined parameters.

Other matters

- Supervisors voted to approve a new reassessment contract with Cowen Services, LLC, at a cost of \$6.95 per parcel, or about \$120,691 for the 2027 assessment cycle. Staff also briefed the board on imagery options for 2029, including the possibility of using EagleView aerial photography, but no vote was taken on that item.
- ·Supervisors unanimously approved a resolution asking the Virginia Tourism Corporation to recognize Go Virginia Region 9 as its own tourism region, to be designated "Virginia's Piedmont Region." Schmack said the change would better reflect how visitors engage with the area and strengthen regional marketing
- Parks and Recreation Director Aaron Spitzer used the first round of public comment to rebut accusations made by Donald and Patti Reynard at previous meetings. Spitzer said the Reynards had incorrectly accused him of election interference during Mr. Reynard's campaign for Commissioner of the Revenue and misrepresented his interactions with them at senior programs and county events.

Fluco boys win home opener in overtime 56-52

In a four-minute overtime, the Fluco boys failed to score a basket, but their free throw shooting was good enough to carry them to four-point victory over visiting Heritage High. An additional factor in the win was the defensive play of senior forward Andre Key. He only scored one point in the game, but Coach Heath Bralley assigned him to be the "one" defender in a box and one defense that the Flucos went to in overtime. Key stuck to the top Heritage scorer like glue and the Heritage offense was completely disrupted. The only basket Heritage scored in overtime was a put back on a rebound with 13 seconds left. Heritage came to play all the way from Lynchburg. Their long

ride home was probably not a happy one.

The game started with Heritage taking the lead. The first quarter ended with the Flucos down by three at 12-9. Fluco junior Antwon Carter had six in the quarter including a three-point basket. and he would go on to record 28, exactly half his team's points. He shot 11 for 14 from the field.

The second quarter started with senior Amir Toney driving the length of the court for a lay-in cutting the lead to one. Senior Tramayne Minor then recorded an impressive blocked shot, but Heritage responded with a three pointer to regain the lead. The Flucos out played Heritage in the quarter and out scored them 14-6 for a 23-18 half time lead, Carter had six in the quarter.

In the third quarter, the Flucos got

three-point baskets from Toney and junior Isaiah Thompson, while Carter added five points. Carter ended the quarter with a lay-in on a nice pass from junior Quinton McCloud. The Flucos led 38-31 after three quarters.

Early in the fourth quarter Heritage outscored the Flucos 7-2 to tie the score at 40-40. Two quick baskets by Carter took the Fluco lead back to four, but Heritage scored a free throw and then a late three-point basket to knot it up at 48-48. The Flucos got off a desperation shot at the buzzer that went in but, the referees ruled it was just too


The overtime started with two for two from the foul line by Carter and two for two by Fluco sophomore Kayron Douglas. In four more instances, the Flucos went to the line and made one of two. They shot eight for twelve in overtime and won by four. The Flucos had small leads over Heritage in crucial team statistics, leading 38-32 in rebounds and 10-7 in assists.

The Flucos had eight players in the scoring column, but no one except Carter had more than seven. Carter is a player with great balance and body control. He scores mostly from the inside where he gets off shots that are often blocked when other players of his height attempt them.

The Flucos traveled to Amherst High on Dec.6 and hosted Chancellor High on Dec. 9. They start Jefferson District play on Dec. 11 at Monticello High and then host Monticello on Dec. 12. On Dec 16 and 19 they play at Albemarle and Louisa.

Obituary

Melvin (Mel) Clifford Hinkley 1934-2025



Melvin Clifford Hinkley ("Mel") died peacefully on November 16, 2025, just six days before his 91st birthday, in his beloved wife's arms and with his family by his side.

Mel, an only child, was born on November 22, 1934, in Gardiner, Maine to parents Clifford Melvin Hinkley and Beatrice Inez Welch Spaulding. Following his parents' divorce when he was four years old, he encountered difficulties in his relationship with his stepmother. Learning to fend for himself, he quit school at 16 and joined the United States Air Force (USAF) at 17. While stationed at Pinecastle Air Force Base (AFB), Mel met and married the love of his life, Joan Ann Harrington Hinkley, on July 22, 1955, at Broadway Methodist Church in Orlando, Florida. After 70 years of marriage in July 2025, it was clear to all who knew them that their bond was unique and their love remained strona.

He served during the Korean War and later graduated from the Non-Commissioned Officers Leadership School at MacDill AFB, Tampa Florida in December 1967. His specialty was Ophthalmology Surgical Technician, Medic. Mel served two tours as a member of the Pacific Air Forces (1965 stationed in Thailand and 1968 at Cam Ranh Bay AFB, Vietnam). During his years of overseas service, Joan managed the family and Mel communicated frequently with her relying on delayed communications such as reel-to-reel audio tapes, letters and telegrams. Mel retired as Technical Sergeant from the U.S. Air Force in January 1970.

After retiring from the Air Force, Mel settled in Bowie, Maryland for 30 years, where his children graduated high school. He served as a civil servant with U.S. Army Intelligence before advancing to Operations Chief at the Federal Communications Commission, where he remained until his retirement in 1997. Mel was also active in local organizations, including the Civitan Club and Masonic Lodge.

In 1997, he moved to Clearwater, Florida where his passion for woodworking and turning began. He worked for Woodcraft and pursued his interest in making exquisite furniture, pens and works of art with domestic and foreign wood. Mel referred to himself as "Wood Maestro", and his hobby took him into a small part of a world of his own, where he could get lost in the intricacies and splendor of his craft.

Mel continued his involvement in community organizations and served as Worshipful Master of the Free and Accepted Masons, Clearwater Lodge No. 127 in 2002.

In 2004, Mel moved to Lake Mon-

ticello in Palmyra, Virginia. He continued his woodworking and adorned his home with furniture, scrolled artwork, bowls, ornaments, pens, walking sticks, and cutting boards made in his garage woodshop. Mel also enjoyed bird watching, always looking for a new bird feeder or feed to attract new residents for his personal aviary, from his favorite hummingbirds to blue birds, cardinals and more. He and his wife were members of the Cunningham Methodist Church, Palmyra, VA and supporters of the Fluvanna County SPCA, Troy, Virginia.

On October 1, 2025, Mel and Joan relocated to Washington, DC. Shortly after their arrival, Mel experienced a fall while walking their dog, Ollie, resulting in six fractured ribs and subsequent medical complications.

Mel opened his home to both cats and dogs, finding joy in reading, writing poetry, telling jokes, working on Sudoku puzzles, and bringing laughter to those around him. His quick wit frequently caught others off guard and brought them delight.


Mel was a devoted and loving husband, father, and friend who proudly supported his loved ones, always being there for his family, day or night, just a phone call away. He will be remembered for his dry wit, jokes, humor, laughter, woodwork, loyalty, trustworthiness, perseverance, honesty, and the reassuring wink and twinkle in his eye.

Mel is survived by his devoted wife Joan Hinkley of 70 years, son Wade Hinkley (Ruth) of Arnold, Maryland, daughter Amy Neuenschwander (Joe) of Lothian, Maryland, and daughter Susan Fitzgerald (Gary) of Washington DC. His son, Brian Hinkley (Karla) of Waverly Hall, Georgia predeceased him in 2013. Recount upholds election results in Cunningham District

Election officials, observers, and candidates assembled at the Fluvanna County Circuit Court on Tuesday (Dec. 2) for a rare event: a full recount of the Cunningham School Board race.

With only 20 votes separating incumbent Charles Rittenhouse and challenger Sarah Johnson, Johnson petitioned the court for a recount shortly after the Nov. 5 election.

While over 9,000 ballots were cast in the Cunningham District on Election Day, only about a third of those voters marked a choice in the School Board

This meant that three teams of two poll workers were assigned to feed all 9,000 ballots back through the scanners to ensure no votes had been missed during the initial count. The recount began at about 9:30 a.m. and lasted more than eight hours.

Both candidates had the right to appoint official observers to monitor the teams during the count. Johnson appointed several observers, including a team of trained "voter protection" officials from Albemarle County. Rittenhouse chose not to appoint observers and spent much of the day walking from machine to machine.

Also in the courtroom were two voting officials from Rockingham

County. One of their School Board races had come down to a 16-vote difference, and this was an opportunity to see a recount in action.

None of the election officials could recall the last time Fluvanna County had conducted a recount in a local race.

Recounts rarely change the outcome of an election, even where the vote is close. According to the Virginia Public Access Project (VPAP), in eight state legislative recounts since 2017, only one changed the Election Day results.

Johnson funded the recount at a cost of about \$5,000. While she knew the odds were against her winning, she felt it was worth doing, both because of the closeness of the final vote and to show future candidates that the recount process was not as daunting as it might seem.

At the end of the day, only three votes shifted: Rittenhouse picked up two, and Johnson lost one.

Circuit Judge Claude Worrell read the results from the bench - Johnson, 1,227 votes; Rittenhouse, 1,250 votes.

"Mr. Rittenhouse wins this election." he said.

Next steps

Rittenhouse will begin a new fouryear term in January, but the story of the 2025 election may not be over.

Several irregularities were reported at the Antioch Baptist Church polling place on Election Day, including allegations that Rittenhouse and his wife, County Treasurer Debbie Rittenhouse. criticized Johnson for wearing a rainbow-striped hat while standing outside the church.

The incident has led several residents to call on the Electoral Board to relocate the Antioch and Beaver Dam precincts from their current church locations to more neutral sites.

Hodge urges engagement amid rising distrust

Development, safety, transparency concerns dominate town hall

About a dozen residents gathered at the Fluvanna County Public Library on Thursday night (Dec. 4) for a town hall hosted by Palmyra Supervisor Tim Hodge.

Over the nearly two-hour meeting, residents pressed Hodge for answers about taxes, economic development, public safety, and what several described as a growing sense of distrust in county lead-

Development concerns dominate

While the proposed Tenaska expansion surfaced throughout the discussion, most of the focus centered on industrial growth in the Zion Crossroads area.

Amazon is pursuing construction of a warehouse on Rt. 15, which Hodge said would likely operate as a local delivery hub rather than a full-scale distribution center.

"What is that Amazon warehouse going to do to the land value residential around that warehouse?" one speaker asked. "I'm right next door."

Hodge said he could only speculate on the impact. "I would say, something industrial, you wouldn't want a residential property next to it. So I'd say it probably will lower it."

Many in the room said they felt steam-

rolled by a development process that leaves them learning about projects after key decisions have already been made. Longtime resident Suzy Morris said the past decade has left citizens feeling un-

"All that glitters is not gold," she said. "Developers come in promising everything, and we end up paying the price."

Others echoed warnings that the rural character that drew them to Fluvanna is slipping away.

Hodge did not defend the status quo.

The county, he said, has "ordinances that don't match the comp plan" and loopholes that allow projects through despite mismatched zoning. He also criticized nondisclosure agreements around the Tenaska and Amazon proposals and the attitude some companies bring to the

"Don't take us for fools," he said he tells developers and staff. "Be honest and be transparent."

Fire and rescue unease

Residents also raised concerns about slow response times and chronic understaffing in fire and rescue.

"If I dial 911, I want to know someone's coming for me," said Tracey Smith.

Hodge, a volunteer first responder, agreed that the county must take a hard

look at growing emergency needs.

He said the volume of calls in southern Fluvanna now supports building a new station in the Kidds Store area. That region has been served partly by surrounding localities, but "Albemarle has already said, 'We're not going to be running the calls in your county."

That, he said, points to a larger budget issue. County staff often try to "make the budget work" by limiting requests instead of laying out what staffing and funding are actually needed.

"If you don't ask for the staff you need, then you're only going to hurt yourself and the county," he said.

Residents raised several additional



concerns over the course of the evening.

Polling places

Some questioned why precincts remain located in churches, citing both perception and accessibility.

Hodge said supervisors cannot order a relocation on their own; any change would require action by the Electoral Board. Still, he emphasized that residents should feel secure and respected at the

School budget transparency

Several attendees urged the county to produce a more detailed school budget. Hodge agreed, noting that Albemarle County's budget runs nearly 800 pages.

"Mine's about 40 pages. I can digest it in an hour. Albemarle's takes a week," he said. He added that he has asked Superintendent Peter Gretz to move toward a more itemized format. "It makes it a lot easier to justify the spending if people can see where the money's going."

The upcoming budget season may be contentious. Hodge said the school division's request is expected to be sig-

nificant, and political pressure is already building.

"There's been at least two school board members [who] said they would actively campaign against anyone that disapproved of the Tenaska project," he said.

If approved, the new Tenaska plant is projected to bring \$70 million in tax revenue over the first five years and \$250 million over the next 30 years. Some of these new funds could be allocated towards the annual school budget.

Stay engaged

Hodge said he holds town halls periodically and wishes his fellow supervisors did the same. He said he has urged colleagues to show up, answer questions, admit when they don't know something, and follow up.

"When you avoid talking to people, then people start getting ideas in their heads," he said.

He encouraged residents to stay engaged even when the process feels slow. "Talk to your elected officials. Come talk to me. Just don't give up."



LMPD Issues Scam Alert

The Lake Monticello Police Department (LMPD) reports an increase in cases of fraud targeting especially senior citizens. Victims often get calls from someone pretending to be from their bank's "fraud department." They're tricked into converting their money into cryptocurrency for 'security,' which results in stolen account details, with recovery being next to impossible. One recent case involved losses of over \$150,000. LMPD recommends not answering unknown calls. Instead, let those calls go to voicemail and verify any suspicious messages by calling your bank directly or visiting them in person. If you're a victim, don't hesitate to contact law enforcement for assistance.
